A COURT CASE FROM PITT COUNTY

BEING ARGUED IN SUPREME COURT OF THE STATE.

The Atlantic Coast Line and Its Relief Department Involved—Of Special Interest to Railroad Employees

The Raleigh News and Observer contains a synopsis of a case from Pitt county that went up on appeal to Supreme court, that will be especially interesting to all employes of the Atlantic Coast Line as well as to the public. It says:

"A case of much interest to railroad men generally and especially to employes of the Atlantic Coast Line will be argued this week in the Supreme Court, the question at issue being the legality of certain provisions of a contract entered into by employes of the railroad with the Relief Association of the Company.

"It appears that the A. C. L. maintains a relief department, under the operation of which every employe contributes a certain per centage of his wages every month, the proceeds being used to indemnify such employes as are incapacitated either by sickness or injury received in the course of their employment. When an employe is injured or becomes sick he is paid an amount per day, graduated upon the amount of wages he receives, for the first month of his incapacity and afterwards at half the per diem paid during the first month of such incapacity.

"Under the contract or application which the employe signs when he becomes a member of the relief department, he agrees that the decision of the advisory committee of the department—who may be appealed to from the decision of the Superintendent of the division on which the employe was working when the incapacity occurred—shall be a final determination of the question of his right to draw from the fund. In the case that will be argued, the plaintiff was paid for several months and afterwards examined and his allowance stopped. He appealed to the advisory committee and the superintendent's decision was affirmed. Thereupon he sued the company, or, rather the relief department.

The point involved in the case is whether or not the agreement as to the final decision resting with the advisory committee is constitutional, the plaintiff's contention being that it seeks to prevent the employes bringing an action in the courts upon a contract. On the trial of the case in the lower court this view was upheld and the appeal is by the railroad, or relief department.

"It is stated that on the A. C. L., there is practically in force a rule requiring all employes to have membership in the relief society and to sign the application referred to. Under the operation of these societies, the employe has the option, when injured, of accepting the relief offered as indemnity or looking to the road for damages. The case in point is whether, when he has decided to look to the relief department for compensation, he can sue it upon its contract notwithstanding the fact that he has agreed that the decision of the advisory committee shall be conclusive.

"The plaintiff in the case is represented by Senator Fleming, from Pitt, and the defendant by Hon. Geo. Reuntree, from Wilmington."

Mr. A. P. O'Brien Dead.

Mr. A. P. O'Brien, one of Pitt county's most successful farmers, died at his home near Grimesland on Wednesday night of last week, of spinal meningitis. He had been confined to his room only for a few days before the end came, and all that loving hands could do to alleviate his suffering and restore him to health was done, but God knew best, and now he is resting under the shade of the trees on the other side.

True to his friends, and they were many, charitable and kind hearted can truly be said of him, and his death will be greatly mourned.

Mr. O'Brien was born in Granville county 64 years ago and moved to Eastern Carolina in 1895. He was an ex-Confederate veteran, entering the service in 1861, when only 16 years of age, and served throughout the entire war. He was one of the bravest men in his company and was made a sharp shooter.

He leaves a wife and seven children, among them being Mrs. C. G. Morris and Mrs. B. E. Ross, of this city, also two brothers and two sisters to whom we extend our deepest sympathy, and trust that when they are called they will be prepared to meet him in his Heavenly home.

The funeral service was conducted from the Methodist church Friday afternoon at 2:30 o'clock by the pastor, Rev. A. P. Tyer; interment in Oakdale cemetery.—Washington Progress.

In 1760 the United States produced what was at that time a record breaking crop of cotton—4,660,000 bales, and the cry was "over production." This season's crop is slightly under that production. Notwithstanding these facts, with increasing demand for the raw material, the exports on American cotton manufactured last year were worth but \$32,305,000, while we imported cotton manufactures valued at \$73,405,000. What we most need, it is obvious, is increased and sustained marketing facilities.—Atlanta Journal.

President Roosevelt sees more trouble ahead in the reduction of wages of employes by the railroads, in that it is regarded by many as a further result of the policy of his administration. In the hope of checking the rebuke hanging over his party as a result of this he has written a letter to the inter-State Commerce commission asking that an investigation be made.

President Roosevelt may use his end of the administration in behalf of the candidacy of Secretary Taft, but Cannon sentiment took a big jump in the hall of congress Wednesday. Congressman Boutell, of Illinois, stood on the floor and nominated Speaker Cannon for president, and the announcement produced great applause and cheering. THE ROMAN SENATE.

It Was Purely Executive, With No Authority to Make Laws.

The senate of Rome, which was an ancient institution, said to have been established by Romulus himself, was a purely executive body, having no authority whatever to make laws. The senate of the United States is almost purely legislative in its functions, having no power to make appointments outside of the body itself, but only to agree to those made by the president. And this is largely a formality, as it is regarded as a very discourteous thing to refuse to confirm a presidential appointment.

The Roman senate as instituted by Romulus consisted of 100 members. An additional hundred were added when the Sabines migrated from Rome. The first Tarquin increased the number of senators to 300, at which number it continued for a long time. Julius Caesar increased the number of senators first to 700 and afterward to 900 members. Augustus at first added another hundred, making an even 1,000, but afterward reduced the number to 600.

Senators were supposed to be men of special merit. They were at first selected by the monarch, but the duty was afterward intrusted to the consuls and latterly to the censors. No man was eligible to the office who had not been previously knighted and who had held the inferior offices of quaestor, tribune of the people, edile, praetor and consul.

The senate met regularly on the 1st of January and also on extraordinary occasions when called together by the consuls, tribunes of the emperor.

A Roman senator during the early days of the republic made a virtue of poverty and gloried in the simple life. But when wealth, vice and corruption became more common it was decreed that no man could be a senator whose wealth amounted to less than 80,000 sesterces, or about \$35,000, because, it was argued, he could not support the dignity of the office on a less amount. Therefore when a senator's fortune was reduced below this sum he was dropped from the rolls. Under such an arrangement in this country a man like the late Senator Hoar, who lived in a boarding house, would not be eligible.—Punxsutawney (Pa.) Spirit.

A Wise Guy.

In a New York street a wagon loaded with lamp globes collided with a truck, and many of the globes were smashed. Considerable sympathy was felt for the driver as he gazed ruefully at the shattered fragments. A benevolent looking old gentleman eyed him compassionately. "My poor man," he said, "I suppose you will have to make good this loss out of your own pocket." "Yep," was the melancholy reply. "Well, well," said the philanthropic old gentleman, "hold out your hat. Here's a quarter for you, and I dare say some of these other people will give you a helping hand too." The driver held out his hat, and several persons hastened to drop coins in it. At last, when the contributors had ceased, he emptied the contents of his hat into his pocket; then, pointing to the retreating figure of the philanthropist who had started the collection, he observed: "Say, maybe he ain't the wise guy! That's me boss!"

A Point of Interest.

In a certain county of Arkansas a man named Walters was put on trial for stealing a watch. The evidence had been very conflicting, and as the jury retired the judge remarked suavely that if he could afford any assistance in the way of smoothing out possible difficulties he should be most happy to do so. Eleven of the jurors had filed out of the box, but the twelfth remained, and there was on his countenance an expression indicating great perplexity.

"Is there any question you'd like to ask me before you retire?" asked his honor, observing the juror's hesitancy.

The man's face brightened. "Yes, your honor," he replied eagerly. "I'd like to know, your honor, whether the prisoner really stole the watch."
—Harper's Weekly.

The Crooked Genesee.

Do you ever stop to think what a crooked old river the Genesee is? It is said that by way of the river it is twenty-eight miles from Genesee to Mount Morris against six miles by the road. It runs along the west side of the valley until it nearly strikes Piffard, then crosses the valley to Genesee, runs on the east side about a mile and a half, then turns and runs back again nearly to the village of Piffard. The two points at Piffard are only about half a mile apart, but to follow the course of the river from one point to the other a person would travel from five to six miles. It is a crooked stream, all right enough.—Livingston Democrat.

A YOUTHFUL HERO.

How Major Croghan Won Fame in the War of 1812.

Only a few names escape oblivion, but Aug. 2, 1813, insured lasting fame for Major George Croghan. Ninety-three years later, on Aug. 2, 1906, the remains of this youthful hero were reinterred on the site of his great victory.

During the war of 1813 Croghan, a handsome, spirited Kentuckian, was sent by General Harrison to take command of a poor little stockade, Fort Stephenson, at Lower Sandusky, now Fremont, O. The place was important only because it guarded the approach to Harrison's headquarters and stores up the Sandusky river.

On the morning of Aug. 1 General Proctor, the British commander, with 500 regulars, veteran troops who had served under Wellington on the peninsula, sailed up the river in gunboats of Commodore Barclay's fleet and landed cannon and howitzers, with which they began to bombard the fort. Meanwhile Tecumseh, with 700 Indians, swarmed through the woods and began the attack from the opposite side. To one of a less sanguine temperament or of less courage than the young commander the situation must have seemed hopeless. But Croghan not only showed confidence himself, but inspired it in those under him.

Croghan had 160 men and one small cannon, which he moved about from place to place to induce the belief that he had several guns. Late in the afternoon of the 2d the enemy made a united assault. So valiantly and effectively was it repulsed that the whole British and Indian force made a precipitate retreat into Canada.

"It will not be the least of General Proctor's mortifications," wrote Harrison, "to know that he has been baffled by a youth who has just passed his twenty-first year. He is, however, a hero worthy of his gallant uncle, General George Rogers Clark."

Croghan himself wrote just before the battle: "The enemy are not far distant. I expect an attack. I will defend this post to the last extremity. I have just sent away the women and children with the sick of the garrison, that I may be able to act without incumbrance. Be satisfied I shall, I hope, do my duty. The example set me by my Revolutionary kindred is before me. Let me die rather than prove unworthy of their name."

The battle of Fort Stephenson was the first really brilliant effort of the war of 1812. General Sherman said it was "the necessary precursor to Perry's victory on the lake and Harrison's triumphant victory at the Thames, which assured to our immediate ancestors the mastery of the great west, and from that day to this the west has been the bulwark of the nation."

For his exploit Croghan was brevetted lieutenant colonel by the president of the United States, and congress awarded him a gold medal.—Youth's Companion.

Queer Eyes.

Nature makes some strange provisions for fish that have to feel or see their way at great depths. Deep soundings in the Caribbean sea bring up really uncanny specimens of this kind. Among them is a fish that has two convex lenses in place of eyes. These lenses are very bright, of a golden hue and gleam in the sunlight. Another fish, a large one, has eyes that grow on stems sticking out several inches from the head. Another has an eye on a stem about half a yard long. The stem is flexible and may be waved in any direction. Some of the Caribbean sea fishes have eyes that shine like lanterns.

A Question of Names.

On one occasion a bishop who prided himself on never forgetting either the name or face of any clergyman in his diocese happened to be traveling somewhere by rail when at a certain station a clergyman got into the same carriage in which the bishop was.

The bishop recognized the man's face, but could not remember his name, and, not wishing to acknowledge his forgetfulness, leaned forward and, with a charming smile, said:

"Excuse me for forgetting, but how do you spell your name?"

"J-o-n-e-s, my lord," was the reply.—Illustrated Bits.

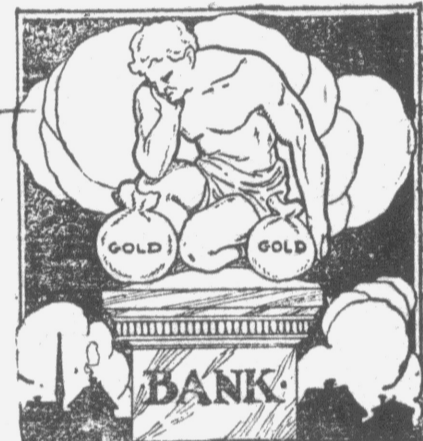
