GREATLY INCREASED EARNINGS.

SHOWN IN REPORT OF SOUTHERN RAILWAY.

Business of Railroad Was Better Under Low Passenger Rate.

The quarterly report of the Southern Railway of its business done in North Carolina for the three months of last year, October, November and December, was received by the Corporation Commission yesterday, having been due since February 1st.

Although the effects of the the panic are plainly reflected in report for the quarter ending December 31st, 1907, as compared with earnings shown for the previous quarter, ending September 31st, a significant fact is that earnings from intrastate passengers and intrastate freight for a quarter during which there was general business depression show an increase over earnings from the same sources for the corresponding quarter of 1906.

These increases amount to \$34,699.15 from passengers and \$18,362.87 from freight, considering only intrastate business, as indicated by the following digests from the reports for the last quarter of 1907 and 1906 respectively.

For the quarter ending December 31, 1907, the earnings from all sources of intrastate business, including passengers, freight, express and mail and express and miscellaneous, were greater than those of the corresponding quarter of 1906 by \$41,230.53 these totals of intrastate earnings being for the two quarters respectively:

RAILROADS HAVE ROBBED PEOPLE

OF \$70,000,000.00 IN CARRYING MAILS.

This is the Charge Made by Representative Lloyd, of Missouri.

Washington, D. C., March 3.—The charge that the government had been robbed of over \$70,000,000 since 1880 by the railroads carrying the mails was made on the floor of the House today by Mr. Lloyd, of Missouri. He referred to the new system of weighing the mails recently introduced by the Postmaster-General and declared that it was an admission that the Postoffice Department had allowed the people of the country to be mulcted out of the sum stated. He demanded to know why suits had not been instituted against the railroads to recover this money. No suits, he said, had been filed and none suggested. "I call upon the chairman of the committee to audit and control the expenses of the postoffice," he exclaimed, "to investigate the department and ascertain whether there is anything wrong in it".

Mr. Wanger, of Pennsylvania, the chairman, pledged a careful investigation into the subject.

Mr. Loyd, referring to the retirement of Mr. Madden, the Third Assistant Postmaster-General, and the proposition to drop twenty-two post-office inspectors, declared that they were from the beginning all "marked" men because of their connection in one way or another with the suppression of certain publications. "We have too much bureaucracy," he exclaimed, "We need more laws and less departmental rules."

HAPPENINGS IN NORTH CAROLINA

ITEMS TOO SHORT FOR SEPARATE HEADING.

Linwood Postoffice Robbed—Disastrous Fire at Spring Hope.

Salisbury, N. C., March 3.—Unknown robbers looted the postoffice at Linwood, a small station six miles north of Spencer, last night. The iron safe was blown open and about two hundred dollars taken. The robbers did their work at midnight and escaped before the crime was detected. There is no clue to the guilty parties.

Louisburg N. C., March 3.—News of a disastrous fire at Spring Hope last night reached here this morning. One store belonging to Mr. Spivey was totally consumed. The buildings and stocks of goods of Brantley-Marshburn Co., Wheelless, Turner, Ciebman and others were badly damaged. Loss is estimated at \$10,000 to \$15,000.

Superintendent W. J. Hicks to Leave Oxford Orphan Asylum.

Today at Oxford Superintendent W. J. Hicks and his wife will celebrate their golden wedding anniversary, and with this happy event there comes the news that he is to retire from the superintendency of the orphanage as soon as his successor is chosen and has been shown his duties. Mr. Hicks has been superintendent ten years. He tendered his resignation some months ago, but agreed to remain until his successor had been selected and also to initiate him into the various and arduous duties of the position. Two men are in view, one A. C. Davis, of Goldsboro, who for a number of years was at the head of the Davis Military School, the other being Leon Nash, of Winston-Salem. It is probable that the choice will be made some time in the spring.—Raleigh News and Observer.

Seacoast and Civilization.

Investigation will show that Europe has a mile of coast for every 164 square miles of its land area, while the Americas, which rightly come next, have 359 square miles of land to every mile of coast. Asia has 376 miles and Africa 530 square miles to each mile of coast. The low order of culture still prevailing on the dark continent, though its history is as old as that of any other portion of the world, is almost indisputable evidence of the correctness of this theory.

PALINDROMES.

Words and Phrases That Spell the Same Backward and Forward.

"There are in the English language certain words and sometimes whole sentences of which the letters composing them; taken either in direct or in reverse order, read the same. Such combinations are called palindromes, a name derived from two Greek words meaning to run again—that is, the letters run or read backward as well as forward.

"When the first man met the first woman—whose name, Eve, by the way, is a palindrome—he may have introduced himself to her thus: 'Madam, I'm Adam.' In this supposed case I assume that he spoke English and not a garden of Edenish dialect, and if my supposition be correct he made use of a palindromic expression.

"Among the simple words of this kind or instances of whole sentences are deed, defied, gog, Hannah, level, minim, redder, nun, repaper, revolver, rotator, sexes, shabs and tat. 'Was it a cat I saw?' is palindromic.

"Barring the spelling the following sentence may be given: 'Lewd did I live & evil I did dwell.' Another example is, 'Desserts I desire not, so long no lost one rise distressed.' It is said that Napoleon was once asked whether he could have invaded England, when he replied, 'Able was I ere I saw Elba.' This is a good specimen of a palindrome, but of course the reply was never made, as he would have answered in French. Here is one in Latin, 'Subi dura a rudibus.' 'Endure hard things from the rude.'

"The following list of five words furnishes a remarkable combination of letters. With one exception they are all Latin words in good repute, and the letters are capable of many regular transformations:

SATOR
AREPO
TENET
OPERA
ROTAS

"The first letter of each word, read downward from the top of the list, spells the first word, and the second letter of each word, read in the same way, spells the second word, and so on through the list. Beginning at the top each word, read backward, spells the corresponding word in the list under it—that is, the top word spells the bottom word, the second word from the top spells the second word from the bottom, and so on. Again, beginning at the bottom of the list, the last letter of each word, read upward, spells the word at the top, and in the same way the second letter of each word spells the second word from the top, and so on through the list again."
