NEWSPAPER VALUATION.

There Are Two Dozen Papers Which Are Held at \$1,000,000 or More—The New York Herald Worth \$10,000,000—Good Will is a Paper's Chief Asset.

The sale of the Baltimore News to Frank A. Munsey for \$1,500,000 calls attention to the high values now placed on newspaper properties in the United States. It was not so very long ago that The New York Herald was considered the only daily worth a million dollars. Now there are at least two dozen newspapers that are held at that figure or more.

The New York Herald could not be bought at any price, but if it were for sale it is doubtful if Mr. Bennett would part with his property for any less than \$10,000,000, as it is earning more than 10 per cent. on that capitalization, and is generally regarded as the most valuable of all newspaper properties in America. The New York World is a close second.

Besides these there are in New York City at least six others worth from two to eight millions each. Chicago, Kansas City, San Francisco, St. Louis, Pittsburg, Philadelphia, Buffalo, Cleveland, Cincinnati, Boston and Washington are the homes of newspapers that will fetch from one to five million dollars.

Probably there are not six in the entire number whose plants alone are worth more than half a million dollars. Wherein, then, lies the great value of these publications?

The greatest asset any newspaper can have is that intangible and yet exceedingly valuable thing known as good will. Nothing is harder to get or so easily lost. Some publishers have spent millions of dollars trying to gain it, but have failed utterly. Others have won it practically without the expenditure of a single dollar. The successful newspapers of today were not born yesterday. They were established—the most of them—many years ago and have attained their present position by patient, persevering and intelligent hard work. Good will is based on public confidence and confidence comes only after trial.

Hence no newspaper can expect, under ordinary circumstances, to have the loyal support of its public as soon as it is launched. It must be tested in the crucible of experience; it must prove its right to exist. Promises count for nothing; it is their faithful performance that inspires confidence and wins support.

The newspaper that touches the goal line is the one that is honestly conducted in the interests of the community it serves. It stands for political as well as moral righteousness. It protects its public from fraud, graft and evil whenever it has the opportunity to do so. It wears no collar, is no man's organ, and doesn't flinch when danger threatens. It does its level best to help the people to think right, to do right and to get the best there is out of life. It supports good men for office and opposes the unworthy even though they may be the nominees of its own party.

A newspaper of this kind after awhile wins the confidence and esteem of the public. People believe in it and take it to their hearts. It comes to them every morning or evening as a friend

laden with good things. They feel that the news it brings is reliable and that its editorial opinions are honest even though they do not always agree with them.

Out of this intimate relationship comes good will, that most important of all newspaper assets which often represents nine-tenths of its value.—The Editor and Publisher.

WILL TRY RACE FOR CONGRESS.

MR. W. M. BOND, OF EDENTON, WANTS MR. SMALL'S PLACE.

Mr. Small Agrees That People Decide in Primary Who Shall Represent Thom.

Hon. John H. Small has been congressman of this district for ten years, and has made a faithful representative. The district has never had a more useful congressman.

Mr. W. M. Bond, of Edenton, recently wrote Mr. Small that he would enter the race and try to secure the nomination this year. We have not seen a copy of Mr. Bond's letter, but Mr. Small's reply to him was as follows:

Washington, D. C., Mar. 15.
Hon. W. M. Bond,
Edenton, N. C.

My Dear Sir:—

I received your recent letter stating that you would seek the Democratic nomination for congress this year. You further stated that you would attend each court in the district and make a speech in advocacy of your claims and inferentially inviting me to meet you and participate in a joint discussion. My public duties will not permit me to be absent each week and, besides, I think the Democrats of North Carolina do not look with favor upon joint discussions between candidates of the same party.

I accepted the Democratic nomination for this position in 1898, when every one regarded Democratic success as impossible, but the nomination was ratified by the people. Since my first election, I have endeavored to maintain the essential principles of the Democratic party. I have tried, with industry and zeal to serve with loyalty the interests of the people, and to bring to the people substantial benefit from the administration of the general government. Whether I have lived up to this high ideal and have earned the confidence of my constituents and am worthy of a re-nomination, is a matter to be determined primarily by the Democratic voters of the district. It is not a position which any number of politicians may bargain away. The time has happily passed when a few men in a county or district may control nominations and elections.

I am not only willing, but am anxious, that the question of who shall be the Democratic nominee for Congress in the first district this year, shall be determined in Democratic primaries in the several counties in the district, and I suggest to you that we join in a request to the Democratic congressional executive committee to have such primaries held, in so far as they may be authorized to do so. The district executive committee, or their chairman, could in any event make such a request of the several Democratic county chairmen. I respectfully request your concurrence in this proposition.

STAGE REALISM.

Humor and Courtesy of Irving in a Reply to a Critic.

The late Sir Henry Irving's famous London production of "Henry VIII" ended with the christening of the infant Princess Elizabeth; for which, of course, a large life-like doll was used instead of a real baby. The play had run a good many nights when one day the actor received a letter of protest from one who made it plain that he was a firm believer in realism on the stage.

"The complete success of 'Henry VIII' was marred last night," the letter ran, "when the king kissed the baby. The whole house tittered.

"Herewith I offer the hire of one real baby—my own—for the purpose of personating the offspring."

It was a delicate matter for Sir Henry to decline the services of a man's own baby, but with the help of his manager, Mr. Bram Stoker, the famous actor composed a reply which combined courtesy and humor and which has been incorporated in "Personal Reminiscences of Henry Irving."

"Mr. Irving fears," wrote Mr. Stoker, "that there might be some difficulty in making the changes you suggest with regard to the Princess Elizabeth in the play.

"If reality is to be achieved it should of necessity be real reality and not seeming reality, for that we have already on the stage. A series of difficulties then arises, any of which you and your family might find insuperable.

"If your real baby were provided it might be difficult or even impossible for the actor who impersonates King Henry VIII. to feel the real feelings of a father toward it. This would necessitate your playing the part of the king and further would require that your wife should play the part of Queen Anna Boleyn. This might not suit either of you, especially as in reality Henry VIII. had afterward his wife's head cut off.

"To this your wife might naturally object. But even if she were willing to accept this form of reality and you were willing to accept the responsibility on your part Mr. Irving would, for his own sake, have to object.

"By law if you had your wife decapitated you would be tried for murder. But as Mr. Irving would also be tried as an accessory before the fact he, too, would stand in danger of his life. To this he distinctly objects, as he considers the end aimed at is not worth the risk involved."

The Novelist's Mission.

The neglect of Disraeli's writings may be in part due to the fact that most people think it is below the dignity of a statesman or of any man following what is called a "serious" profession to compose works of fiction. Certainly many do not yet understand that the man who writes novels may be a very wise man. They do not realize that accurately to portray human nature and to present pictures of life is not only a most worthy but also a most difficult task, requiring for its performance an intelligence far above the average acute powers of observation and a keen sense of humor, for surely the great novelist is the observer sounding the depths while others glance at the surface and examining the mysteries of life while others are content to overlook even the obvious.—Melville's "Victorian Novelists."

His first idea is one of surprise that the children should so often choose this particular spot to store their toys, but presently he learns that the dolls are put up as a sign to announce to wayfarers that a marriageable daughter dwells in the house. The idea is to remind acquaintances from other villages who may have forgotten her existence. PREJUDICE.

It is Not Always Merely an Unreasonable Judgment.

What is prejudice? Is it always something unreasonable? Is it to be regarded as necessarily an intruder among the more sober activities of the mind? Is it an enemy of clear thinking—the counterfeit of a true judgment? On the contrary, there is a certain form of prejudice which admits of defense. There is a prejudice which has a proper place in the mind and must be reckoned with as a natural factor in our thinking and not as an abnormal and disturbing element. It is very easy to insist that reason should be free of prejudice. But no one maintains consistently and continuously so high an ideal in practice. It is not merely that prejudices will steal in despite our most vigilant guard and in the face of protest and serious effort on our part to drive them out. But in a certain sense there is a true function for prejudice to perform amid the varied activities of the mind. A prejudice is not always an unreasonable judgment. It may be merely unreasoned. And there is a vast difference in this distinction, for the judgment which is simply unreasoned may prove in the course of events to be eminently reasonable and as such, even in its unreasoned form, may serve a most useful purpose in our thinking.

These unreasoned judgments are absolutely indispensable in the economy of our mental life. If we excluded all judgments which are not accompanied by a satisfactory proof of their validity, a tremendous waste of time and energy would result, for it is a fundamental law of our intellectual activity that the processes of reason by which we arrive at certain conclusions often drop out of memory. But the conclusions themselves remain as a permanent deposit of knowledge. The proof which we once knew and perfectly understood may be forgotten, but the truth which it established is lodged permanently in the mind. The history of its origin we no longer remember. It appears, therefore, as a detached judgment.—Scribner's Magazine.

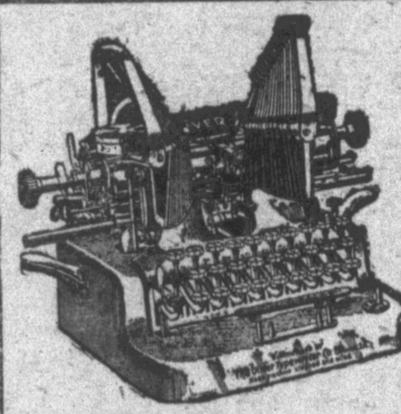
