## AS TO WATER TRANSPORTATION.

### CONGRESSMAN SMALL ADDRESSES CHAMBER OF COMMERCE.

Heard by Large Number of Interested Citizens. Mr. E. A. Daniels Speaks on Same Subject.

There were a large number of the Chamber of Commerce and business men of Greenville and community at the opera house, Monday night, to hear the address of Congressman John H. Small on the subject of water transportation. Such a large attendance well indicated the interest of the people here in this matter.

Mr. E. A. Daniels, of Washington, was also here and first addressed the meeting. Mr. Daniels spoke of the interest other nations had taken in the matter of water transportation, and by comparison showed how their commerce had increased as their transportation facilities were developed. He showed the advantage of water transportation in giving shippers the lowest freight rates that can be had. Not only is it advantageous to shippers but it is profitable to the promoters, as is shown by the fact that the most successful financiers of the world seek investments in transportation lines. If the capitalists North make money out of such investments, there is no reason why the people of the South cannot do likewise. Somebody is going to reap the benefit that this section of Eastern North Carolina offers for establishing profitable lines of water transportation, and our own people should be the ones to do this.

After introduction by Representative J. J. Laughinghouse, Congressman Small spoke with great interest for nearly an hour. He went back to the history of transportation and showed its growth and development through succeeding periods. As to relative cost he showed that transportation by water is three to ten times cheaper than over land and that water transportation is the great regulator of freight rates. Where the large steamship lines are controlled by the railroad trunk lines there is no competition, but what is needed is independent boat lines. The railroads are not going to give low freight rates except where they are forced to do so by effective competition, and we need to make use of the highways nature has given us to bring the low rates to us.

In discussing the inland waterway which he has labored so earnestly to interest congress in and cause to be established, Congressman Small used a large map that gave an intelligent idea of the project. It showed that between Cape Henry in Virginia, and Cape Lookout in North Carolina, a coast line of 234 miles, there is not a navigable inlet that will permit the passage of vessels of sufficient draft to carry our commerce, hence a great section of country is landlocked and shut in from the privileges of transportation which it should enjoy. If an inlet could be opened, it would yet leave the dangers of passing Hatteras which makes coast traffic impracticable. Hence the solution is the establishment of this inland waterway which will open to traffic one of the finest sections along the Atlantic coast, and through this benefit a large inland territory. The government has already made an appropriation for the construction of one

section of this waterway, and the whole of it will be completed in time. Then with direct through water transportation to these towns they will be in position to force freight rates to a proper level.

The people must move themselves if they are to get advantage of these conditions, and take such steps as will bring Greenville and Washington and the other towns in the same class of freight rates as Norfolk and Baltimore enjoy.

Congressman Small's address was listened to with great interest and should arouse our people to action in securing water transportation.

#### Report of State Tax Commission.

The report of the State tax commission for the year 1907 has been issued. It shows that the total assessed value of all property in the State for the year 1906 was \$488,662,568.18, against \$461,520,668.32 for the year 1905, an increase of \$27,141,899.86. The number of polls listed in 1906 was 287,171, as against 281,076 in 1905. The total tax levied on polls and property for municipal purposes for the year 1906, was \$814,078.92, of which amount \$108,069.12 was reported uncollected. The total amount of tax levied for State, county, school and municipal purposes was \$5,907,726.36. To show the increase in the listing and assessing of property which has been made in the past few years it is stated that the total assessment of all property for taxation in 1900 was \$300,709,300, as against a total assessment in 1906 of \$488,662,568.18, or an increase of \$187,953,268.18 since the establishment of the State tax commission.

### SEVEN SENATORS PASS.

#### Unusual Series of Deaths in the Greatest Body of Lawmakers in the World.

The death of Senator William J. Bryan of Florida, was the seventh to occur in the Senate of the United States during the past few months, all but one having occurred since the convening of Congress. The roll includes Senators Morgan and Pettus, of Alabama; Mallory, of Florida; Proctor, of Vermont; Lattimer, of South Carolina; Whyte, of Maryland and Bryan, of Florida. Mr. Bryan was appointed to the position he held to fill the vacancy occasioned by the death of Senator Mallory, whom he was not long in following to the "bourne from which no traveler returns."

In addition to this remarkable series of coincident deaths is the removal from the House by the Destroyer, of Representative Adolph Myer, of Louisiana, some time ago. The resignation yesterday of Representative Littlefield, of Maine, on account of legal business works another notable change in the personnel of that body. Mr. Littlefield was one of the most prominent members of the lower House, being chiefly known by his Littlefield liquor bill.—Charlotte Observer.

### HEAVY BLOW TO STATE'S RIGHTS.

#### Judge Harlan Predicts Disastrous Results.

Washington, D. C., March 23.—The principal of state's rights in the matter of the regulation of railway rates received a body blow from the Supreme Court of the United States today, which sustained the course pursued by Judge Pritchard in the Wood habeas corpus case from Asheville, asserting the complete jurisdiction of the United States circuit court. A case in most respects similar though based upon different procedure was decided adversely to the state of Minnesota. In all of these cases involving the right of the state to regulate rates, the court held that the penalty provisions of the acts are in violation of the fourteenth amendment to the constitution. The opinion of the court was concurred in by all the members of the court, save Justice Harlan who dissented. The dissent was a most vigorous virile document, defending in able manner the principle of states' rights. Justice Harlan declared that no case of so much importance has been decided by the Supreme Court since the foundation of the government. He dwelt at length and very eloquently upon the enormity of the offense that permits an inferior federal court judge to order the imprisonment of an official of a sovereign state while enforcing a state statute. He argued that a similar injunction could be put on a grand jury or a district attorney in any criminal proceeding. He said the decision today marked a new era in our form of government and predicted that the result would be disastrous.—T. J. Pence, in Raleigh News & Observer.

### CORN GROWERS' SPECIAL.

#### Now on Ten Days' Trip Through Eastern Counties.

The special train fitted up by the Norfolk & Southern railroad with an exhibit of corn and other grains, and called "The North Carolina Corn-Growers' Special" has started out on a ten days' trip through some of the eastern counties through which the Norfolk & Southern runs. The exhibit was fitted up by the State Agricultural Department, and the train stopped here a short while Sunday afternoon while enroute to Washington, the starting point of the trip.

The train consists of a baggage car in which are the exhibits and two passenger coaches to be used as audience cars for lectures that will be delivered by specialists along with the train. Mr. C. B. Williams, of the N. C. experiment station and Mr. Fred L. Merritt, industrial agent of the Norfolk & Southern railroad, have charge of the exhibit. This trip of the special will touch only points between Elizabeth City and New Bern and between Beaufort and Goldsboro. We hope a later trip, or another equally as interesting, can be arranged for this division of the road between Chocowinity and Raleigh.

A Maine congressman, Mr. Charles E. Littlefield, has found out that he can make more practicing law at home than in being a member of congress, and has sent in his resignation. There are plenty of others willing to give his place a trial.

Senator W. J. Bryan, of Florida, died in Washington City Sunday morning after a severe illness of typhoid fever. He was only three months ago elected to succeed the late Senator Mallory, and was the youngest member of the United States senate.

The address of Congressman John H. Small on water transportation delivered to the Chamber of Commerce of Greenville, ought to bring results, and one of them should be the determination of our people to take advantage of the opportunity Tar river affords for such transportation.

The recent attempt upon the life of Mr. Caesar Cone, of Greensboro, shows that the spirit of anarchism is extending to North Carolina. An infernal machine was sent to him through the mails which had he undertaken to open it would have exploded and caused his instant death. Fortunately he was warned by an anonymous letter and his life was saved. Suspicion pointed to a discharged employe as the perpetrator of this attempt to assassinate Mr. Cone, and he was arrested.

**RIGHT MAN IN RIGHT PLACE.**

The Wilmington Messenger calls on the Democrats of the First North Carolina District to see to it that Hon. John H. Small is continued as their Representative in Congress. To depose him and substitute another in his place the Messenger declares would be "suicidal and of incalculable injury to the State."

Though in a certain sense an outsider, this newspaper ventures to endorse all that its North Carolina contemporary has to say on this subject. Mr. Small is now serving his fifth term in Congress, and has proved himself an able and energetic Representative. To his energy and zeal more than to any other one cause is due the present bright prospect of an early consummation of the inland waterway project. In season and out, since he first entered Congress, Mr. Small has labored in behalf of this undertaking, in which his district is especially and vitally interested and which is of large concern not to his State alone, but to the entire Atlantic Seaboard. By constantly keeping before Congress and the public the great importance of this project and the enormous and widespread advantages sure to flow from its consummation, he has already succeeded in securing congressional authorization of the construction of one section of the Norfolk-Beaufort link; and to the campaign of education inaugurated and persistently pursued by him is no small mea-

sure due the concerted and vigorous action on the part of the Atlantic Coast States which argues so well for the success of the whole project. In the interest of this scheme, if for no other reason, Mr. Small should be continued in Congress. As the Messenger well says, this is no time for the First North Carolina District to be swapping Representatives. No new man could enter the next Congress and carry on this work as well as Mr. Small. By reason of long service Mr. Small has acquired influence and standing in standing in the House which no new Representative, no matter what his ability, would or could possess at the outstart. Besides he knows the subject, the arguments in favor of the inland waterway project, infinitely better than any other man in his district and as well as any man out of it, no matter from what State or section he comes. Mr. Small is the right man in the right place. If his constituents are wise and consult their own best interests, they will keep him in Congress as long as he is willing to remain and serve them. —Norfolk Virginian Pilot.

**A SHREWD LITTLE GIRL.**

Prompted a Question Which Saved an Old Woman's Life.

Elizabeth Janfield, afterward Lady Falkland, was called an "odd child." Sometimes her father, who was a judge, took her with him to court. On one of these occasions a woman was brought before him on a charge of witchcraft. It was said that she had bewitched two or three persons to death. The frightened creature when asked if this were so fell on her knees and, weeping, confessed that the accusations against her were true.

Co-operating with this cause is sleepiness and the shallow breathing which it entails. This factor as well as muscle quiescence is apt to attend the sense of boredom which one experiences in listening to a dull sermon; hence it is that the bored individual is apt to yawn. ## PAGANINI'S BURIALS.

Remarkable Wanderings of the Famous Musician's Remains.

Paganini died at Nice in 1840, and, although he made confession, he did not receive the sacrament for medical reasons, which the doctor stated in writing. The bishop refused Christian burial to the body, and the son appealed to the Nice tribunal, which upheld the bishop, but a further appeal was made to Rome. During this delay the body, incompletely embalmed, was deposited at the hospital. From thence the coffin was removed to a lazaretto at Villefranche.

After a month the authorities there determined to get rid of it and deposited it by the side of a stream formed by the refuse coming from an oil mill. After some days the Comte de Cessoles, a friend of Paganini, decided to remove the body, which he did by night, having it carried along the seashore in a storm to the Cape St. Hospice.

Here it was buried and remained for two years, when the great violinist's son determined to take his father's body to Genoa to be buried there. The ship, however, was refused admittance at this place, as it had come originally from Marseilles, where there was cholera, so the body was put into a hole in the rock of a tiny uninhabited island near Cannes.

Five years later the body was taken to Gajona, near Parma, and buried there on Paganini's own property. This was in 1845. In 1853 it was exhumed and re-embalmed. In 1876, thirty-six years after the musician's death, the papal court authorized burial in a church at Parma with Christian rites. Twice again was the body exhumed, apparently out of curiosity, and finally a pane of glass was put into the coffin to render visible the face, which had been preserved. —London Spectator.

### Leather Furniture.

A never failing method which may be resorted to for the cleaning of leather furniture is the following: Dip a soft woolen cloth in boiling milk and wipe the leather with this, rubbing gently until all the dirt is removed. Wipe dry with a soft flannel. When the leather is clean go over the surface with a piece of flannel on which is spread a tiny bit of prepared wax, about as large as a pea for the surface of a chair. The wax must be spread on the cloth as thin as possible. After the waxing go over the leather with a clean soft flannel, rubbing briskly, but not too hard. Here is the rule for preparing the wax: Put four ounces of beeswax, cut in small bits, in a bowl, place the bowl in a pan of hot water on the back of the stove. When the wax is quite soft take from the fire and beat into it half a cupful of turpentine and one tablespoonful of paraffin oil. If the wax gets cold before ready for use, place it in a pan of hot water for a few minutes.

### How Silver Mines Form.

The process by which nature forms her silver mines is very interesting. It must be remembered that the earth's crust is full of water, which percolates everywhere through the rocks, making solutions of elements obtained from them. These solutions take up small particles of precious metal which they find here and there. Sometimes the solutions in question are hot, the water having got so far down as to be set boiling by the internal heat of the globe. Then they rush upward, picking up the bits of metal as they go. Naturally heat assists the performance of this operation. Now and then the streams thus formed, perpetually flowing hither and thither below the ground, pass through cracks or cavities in the rocks, where they deposit their loads of silver.

## SPECULATION.

How It Acts as a Brake on the Fluctuation of Prices.

Speculation makes the change in prices gradual. There is not a sudden drop. It is impossible to secure absolute stability of prices, and speculation accomplishes the next best thing by putting a brake on fluctuations. It is the theory of those who denounce all forms of speculation that there is no relation between speculative prices and the law of supply and demand. But the main function of the exchanges is to make an absolute free market, with free competition between buyers and sellers. This compels minute regulation of prices. There is no speculation in potatoes, and the housewife will tell you that the expectation of a bad crop will put the price up so quickly that she will have suspicions of the honesty of her dealer. When a speculator on the cotton exchange sells July cotton at 10½ cents a pound he is registering his belief based on a close study of conditions at the present time that before July 1 next cotton will not be worth 10½ cents a pound. He and hundreds of others try to discount nature and anticipate events, and, as we have seen, the user of actual cotton utilizes this situation to his own advantage and security.

During the seventeenth century one Edward Lloyd kept a coffee-house in Tower street, London, where several of the big merchants used to meet. Many of them would have ships at sea with rich cargoes facing the many uncertainties of voyages to and from the east, involving great loss if they did not arrive safely. These merchants developed a plan of each assuming a part of the other's risk. Each would write his name under the names of the ships of the other merchants, and it is here we find the origin of the modern system of underwriting, which is nothing more than a division of risk. Lloyd's has become a familiar name in every corner of the earth, but in 1768 it was denounced as a gambling house that ought to be suppressed. —John Paul Ryan in Metropolitan Magazine.

### A Change of Name.

"Father," said Tommy Bardell of the William Henry Harrison grammar school, "you want to come next Saturday afternoon and see us play a game with the Oliver Wendell Holmes football team. We're going to do 'em up."

"Do you belong to a football team?" asked his father. "It is news to me."

"Do I?" exclaimed Tommy proudly. "Well, I reckon I'm the quarterback of the Tornadoes."

"The Tornadoes? Who are they?"

"That's the name of our school team."

"H'mph! And you are going to play a game next Saturday, are you? Well, I'll go and see it."

The game took place according to announcement, and the Tornadoes were beaten by a score of 26 to 0.

"Tommy," said his father, overtaking him while he was on his way home, "what did you tell me was the name of your team?"

"The Tornadoes," answered the boy, "but we're going to change it to something else. We ain't even a fog!" —Youth's Companion.

### Lightning and Thunder.

It is said that lightning may be recognized at a distance of 200 miles when clouds among which it plays are at a high altitude, but that thunder can seldom be heard at a greater distance than ten miles. The sound of thunder is also subject to refraction by layers of different density in the atmosphere as well as to the effects of "sound shadows," produced by hills and other interposed objects. These are among the reasons for the existence of the so called "sheet," or "summer," lightning, which seems to be unattended by thunder.

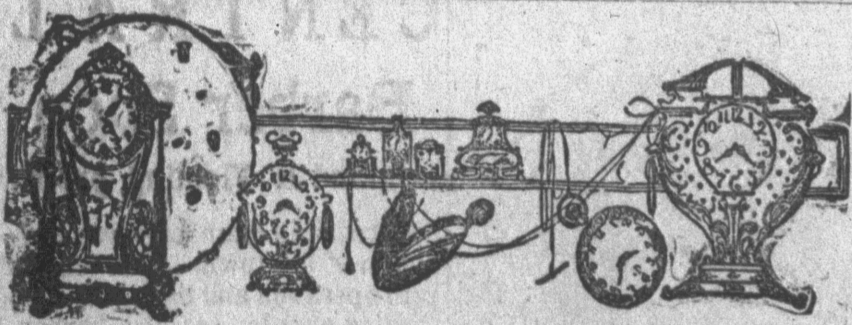

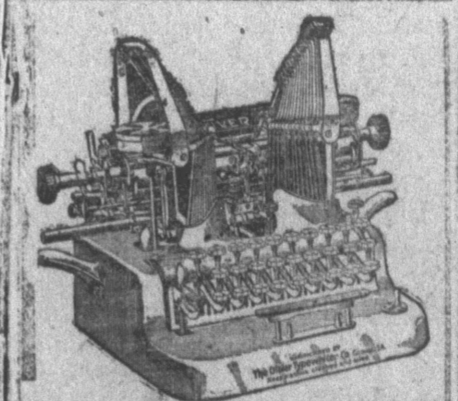
