AYCOCK EXPRESSES HIS VIEWS.

STRONG LETTER IN WHICH HE FAVORS CRAIG'S NOMINATION.

Knows Him in Public and Private Life. Is a Gentleman and Statesman of Rare Attainments.

Dear Sir:— It has been my habit ever since I became a voter to support somebody for nomination for various offices. I am always for somebody and never against any Democrat. This time I am for the nomination of Mr. Locke Craig. I am supporting him because I know him and have known him for thirty years. He and I were classmates, and I boarded for one year at his mother's table. I know the man in his personal and private life; I know his public career. He is a gentleman, a patriot, and a statesman. He has the courage of his convictions. He has the unselfishness of a genuine love for the people. No toil has ever been too arduous for him to undertake in behalf of Democracy. He made the first speech which was made in the year of our revolution, 1898. It was his speech which set the pace for that campaign. I made the second speech from the same platform with him, and followed his footsteps. His speech was along the line of appealing to the old Democracy and going to the people on the bad record made by the Republican party. He frankly and openly avowed the thought that a straight fight in behalf of Democracy would redeem the State. From the hour he made that speech until the election in November, 1898, I never ceased to believe for one moment that we would win the great victory which we achieved that year. While he was going to and fro through the State awakening all our people, his own people in Buncombe county nominated him for the Legislature and elected him, and he came to the Legislature in 1899 and rendered most valuable service in perfecting the Constitutional Amendment, which has already accomplished so much good for the State. But the adoption of the amendment by the Legislature was but the beginning of one of the greatest fights that this State has ever seen. The Amendment was greatly misunderstood by the people at first and the Republicans made a most adroit appeal to the unlettered white voters and sought to convince them that the adoption of the Amendment would disfranchise them and their children. No one contributed more to the removal of this difficulty than Locke Craig. As I recall it, he began his canvass in Buncombe county in January or February of 1900, and from then until the November election he worked without ceasing. When I reached the mountains in May of that year, on my canvass, I found that his splendid work had preceded me and the Democracy was fast uniting in support of the amendment. When the election came, the fruit of his work in that country was seen from the fact that the amendment came near carrying the mountain district, and I had carried it by a small majority; a thing which no one would have predicted in January, 1900. Mr. Craig is a true Democrat, believing in the right of the people to make nominations and platforms; but when the platform is made and he is elected upon it, no number of men, however great, could make him vary one iota

from the requirements of it. He is a liberal and broad-minded man. He loves his friends, and has no enemies to hate. In him as governor, I believe we shall have not only good government, but good government with a united party, carrying out every pledge in the platform and steadily growing in the confidence of the people.

I sincerely hope to see him nominated. That he would be elected follows as a matter of course.

If all they are telling on each other is true, the Democratic party is not entirely exempt from sorry material.

Governor Johnson says he will take the nomination if it is tendered him. There are others who would do likewise.

If the Democratic candidates keep on telling all they know on each other, there will be nothing left for their Republican opponents to tell.

Men are getting so hungry for office in these days that they say just as hard things against members of their own party as used to be said about each other by candidates of opposing parties.

Boston is going to ask the legislature of Massachusetts to allow the city to abolish poll tax on the ground that it costs the city \$10,000 more each year to assess and collect it than the taxes amount to.

The first Monday night in April is the time for the regular meeting of the Greenville Chamber of Commerce. The meeting should be marked by a large attendance as there are many things of interest to the community that might be discussed to advantage.

We are much of the opinion that the new order about railroad mileage books is going to give all manner of trouble to everybody concerned. It is going to be as big a nuisance to the agents as it is to the travelers, and is also going to cause delay of trains at stations.

A Wilmington negro saved up \$136 and had been keeping it in a savings bank. During the late panic he got scared and drew his money out of the bank, and was trying to take care of it himself. The result was that another negro stole the money. What happened to the first negro is liable to happen to anybody who undertakes to keep his money about his person or house. The moral is plain enough: Put your money in bank and let it stay there until you need it.

We hear some people expressing the fear that the present movement of street paving will stop for the time being when Evans street is paved from the court house corner to Five Points. It is to be hoped that such fear is groundless. It cannot now be said with any degree of accuracy how much money will be left for this purpose when the paving is completed to Five Points, but if such a thing is possible the work should be pushed on to the depots without great delay. As to the route from Five Points, that is in the hands of the board of aldermen.

A CURIOUS LAKE.

It Makes Four Distinct Changes in Color Every Year.

In Monterey county, Cal., at Sea side, there is a lake which changes its color four times each year. Apparently there is no outlet for the lake, although it is never stagnant. It is full of waterfowl and fish, and when its color is normal it is sweet to the taste.

The color changes are very pronounced and are in four distinct shades—yellow, green, red and dark gray that has the appearance of black at times. After each change the water regains its normal clear appearance. The color is in the water and is not the result of reflection from the sky. This has been proved beyond doubt by the fact that the color remains the same for days at a time, regardless of the condition of the clouds.

The four colors mentioned are the ones always seen, and they always occur in the order named, the disturbance, if such it may be called, covering a period of from six weeks to two months in July and August of each year. Old residents of Seaside assert that the phenomenon is a regular annual event and that it is always followed by the death of a large number of fish in the lake.

No explanation of the peculiar condition has ever been attempted by scientists, although several scientific men of note have studied the lake very carefully. The prevailing opinion among the inhabitants of the section surrounding the lake is that the lake is of volcanic origin and that the changes are due to subterranean disturbances, which produce chemical changes in the water of the lake.

This idea is supposed to have grown out of the belief that the lake is bottomless. Years ago, when the Southern Pacific railroad was being built across one end of the lake, the roadbed sank almost as fast as it was laid, and thousands of tons of gravel and stone were dumped into the lake before a stable foundation could be obtained. This led to the belief that the lake is bottomless. The lake is not more than three-quarters of a mile long by less than half a mile wide.—Los Angeles Times.

Playing School.

The Rush of the Amazon.

The tide has a great influence on the Amazon, extending many hundreds of miles from its mouth. At the northern part of the mouth occurs a curious phenomenon, called by the natives "pororoa." During the full and the dark of the moon the tide reaches its highest point for a few minutes only. As soon as this tide begins to come in a rumbling roar can be heard far away, a distance of five or six miles. It is the pororoa approaching. This roar increases with the coming of the wave, which is from thirteen to thirty feet in height and covers the entire width of the channel. Another wave follows immediately, then a third and sometimes a fourth. After these waves have passed, the impetuosity and force of which nothing can resist, the tide resumes its regular course.

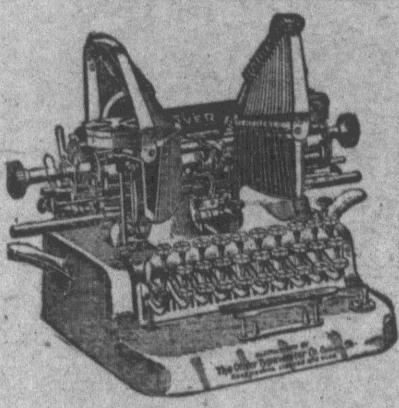

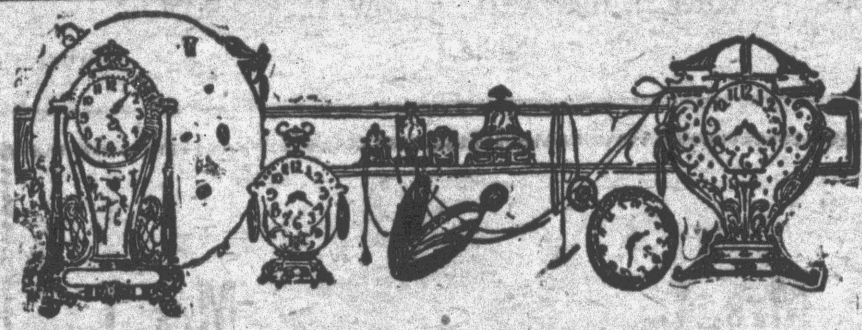

A BLACK EYE.

The Proper Way to Treat This Unpleasantly Disfigurement.

A black eye is simply a bruise, a black and blue spot, of the eyelids and the parts underneath the orbit. All these tissues being very loose and spongelike in texture, the blood which escapes beneath the skin in all cases of bruising and constitutes the black and blue mark spreads very widely and causes great disfigurement.

Sometimes, if the injury has been severe, there will be an escape of blood beneath the membrane covering the eyeball, but the eyeball itself usually escapes serious damage, owing to its elasticity and to the efficient protection afforded by the bony ring forming the edges of the orbit.

A short time after the injury has been received swelling of the part sets in, the skin is reddened and hot, and there is a feeling of tension, if not more or less actual pain. This is the time to treat the bruise in order to prevent as far as possible the formation of the "black eye."

If nothing is done, the discoloration soon appears, first of a dark reddish purple color and then almost black. Later it fades off with a play of colors, green, blue and yellow, until gradually all traces of the accident disappear.

The first thing to do, and that as soon as possible, is to apply cooling lotions to the part. A good way to do this is to keep two small handkerchiefs in a bowl of ice water and apply them alternately, squeezed dry and folded four ply. As soon as one handkerchief grows warm it should be replaced by the other.

By the end of the first day the cold applications will have done all the good they can, and then handkerchiefs wrung out of very hot water, in which borax or boric acid has been dissolved, should be applied and changed every minute or two. At the same time the discolored part may be stroked gently with the finger for ten or fifteen minutes at a time every two or three hours. This is a tedious process, but it will shorten the sufferer's period of embarrassment by three or four days if persevered in.—Youth's Companion.

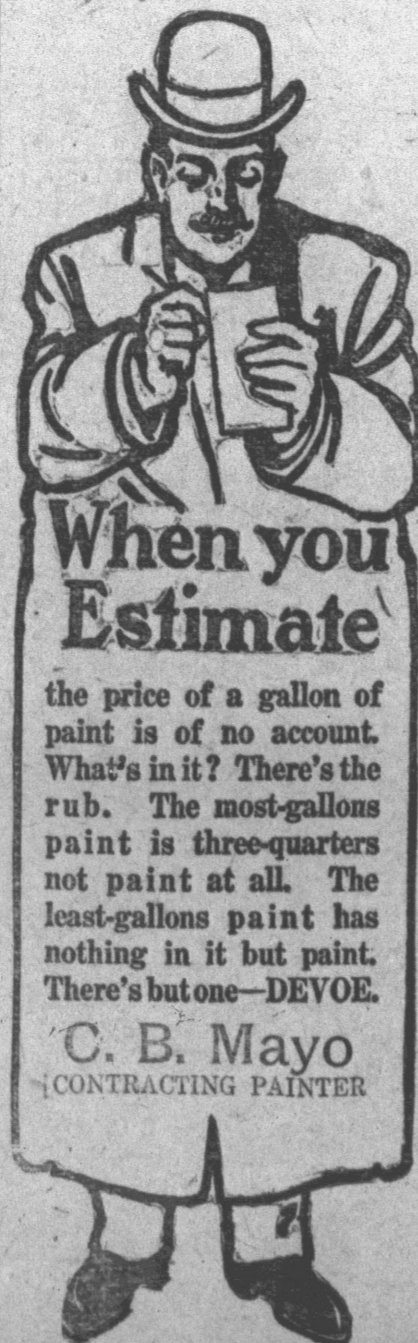
Writing of "Civilian Leaders of the Confederacy" in the Louisville Courier-Journal, John Goode says of Judah P. Benjamin:
