ANOTHER CASE FOR PITT.

State vs. H. A. Paramore and J. A. Ricks.

The Supreme court of the State has found as follows in the case against H. A. Paramore and J. A. Ricks for embezzlement, against whom a bill of indictment was found by the grand jury and a motion to quash the bill was made on the ground that one of the persons serving on the grand jury had not been drawn but was summoned by mistake in name:

1. While generally the provisions of the statute for drawing and summoning jurors are directory, the grand jury is illegally constituted when one whose name was not drawn from the boxes was summoned by mistake, and served.

2. A motion to quash a bill of indictment upon the ground that the grand jury was illegally constituted, is substantially a plea in abatement, and in such instances is proper and regular.

3. A motion to quash an indictment, made upon arraignment and before pleading, for that the grand jury was improperly constituted, is in apt time. Revisal 1970.

A Ghastly Find.

Tarboro, N. C., April 6.—The body of a white man was found in the Tar river, two miles from here today, by Capt. Parsons.

There were no marks of identification. From appearances the body had remained in the water three days and drowning was either accidental or suicidal. Rumors here are to the effect that a prominent farmer is missing. The body was brought to Tarboro on Parson's boat.

What Georgia Thinks of Ticket Arrangement.

The railroad commission of Georgia, in announcing revised passenger fares and mileage exchange ticket arrangements, in the Atlanta Georgian, March 28th, which arrangements in the southeast are effective April 1st, 1908, concludes the following statement relative to exchanging mileage at ticket windows:

"This is a new practice for the first time introduced in this territory, although it is one which has prevailed heretofore in many parts of the country and has proven very satisfactory both to the traveling public and to the railroads, the public having readily accommodated itself to the same and being glad thereby to get the benefit of such reduced rates. However, being new in this section, the purchasers of such mileage transportation should take notice and govern themselves accordingly. After all it means that the railway companies selling such mileage transportation are selling the purchaser an order for a certain amount of transportation which the passenger gets at reduced rates, and at rather lower than prescribed by law. This mileage order will be recognized, as the purchaser from time to time presents the same at the regular ticket office and receive in exchange therefor the regular form of passage ticket for use on the trains in the journey to be made. Just exactly as the individual purchaser of an individual or single straight trip ticket presents the cash at the ticket window and receives in return therefor a proper form of ticket for the journey to be made. There are many sound reasons which have caused the railway companies to adopt this plan for the handling and the use of this mileage transportation. Recognizing the difficulty of so framing the results on a subject that is to be perfect in the first instance it is to be presumed, and is so stated, that when by experience the justice of necessity for an amendment or improved in any particular shall from time to time appear, reasonable amendments of changes will be made to care for the particular case and consistent to the convenience and comfort of the traveling public, with due regard to the protection of the interest of the roads granting the reduced transportation."—Raleigh Evening Times, March 30th, 1908.

DR. W. H. BAGWELL DEAD.

Passed Away Suddenly This Morning.

It came like a shock to the community this morning when it was announced that Dr. William H. Bagwell had died suddenly, about 10.45 o'clock, at his home on Fifth street. While he had been sick since Thursday of last week, no one thought his condition was such that death was near.

Dr. Bagwell was about 50 years of age and a native of Wake county. He was educated at Wake Forest college and later graduated in medicine. In 1883 he moved to Pitt county and located at Pactolus for the practice of his profession. His skill as a physician and his genial manner brought him a large practice, and in 1893 he moved to Greenville so as to have his work more central. As a physician and as a citizen he made a host of friends and stood high in his profession and in the esteem of the people.

In 1887 he married Miss Nannie Spier, of Pactolus, and the wife and five children survive him. Much sympathy is expressed for these in the sudden bereavement that has befallen them. Dr. Bagwell also leaves several brothers and sisters living in this and other States. He was a member of the Baptist church and of the Pythians and Odd Fellows fraternities.

At this writing the time of the funeral cannot be stated, as the arrival of a son and some relatives will be awaited.

Tobacco Sales.

Secretary C. W. Harvey, of the Tobacco Board of Trade, reports the sales of leaf tobacco on the Greenville market for the month of March at 126,204 pounds, the average price being \$9.14 per hundred. The total sales for the season are 11,089,020 pounds at an average for the crop of \$10.45.

The season has now closed until the first of August when the sale of the new crop will begin.

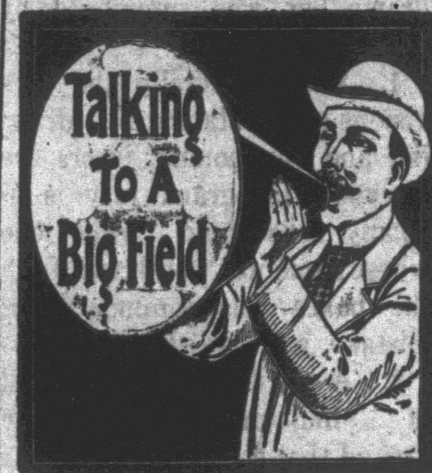
