FINE BIT OF DETECTIVE WORK.

P. O. Inspector Wilson Applies the Process of Elimination on a Robbery Case With Good Results.

A good bit of detective work came to light yesterday.

Some three or four months ago when Postoffice Inspector H. H. Wilson was assigned to this section, he fell heir to a case that had bothered and puzzled other inspectors, until it was old enough to find room in the pigeon hole marked "died of old age."

Always ready for work, and really wanting work to keep his wits in good condition, Inspector Wilson took up the case, studied it thoroughly, and at odd times drew his deductions.

The case was this:

About five years ago a registered letter containing \$70, or supposed to have contained that amount, came through the mail and was delivered to Mr. W. A. Wollihin, grand secretary of the Grand Lodge of Masons.

When the letter was opened there was only \$20 in it. There was no sign of the letter having been tampered with, but the \$50 was gone.

There was the usual question of who took the money, but the particular question was when was it taken. A great deal depended on this. The receipts all along the line to the place of starting were regular. The stay of the letter in the postoffice was a short one, and to the best of his knowledge and belief, it was not out of Mr. Wollihin's hands from the time it had been received to the time he opened it and counted the money.

The matter was at once reported to the postal authorities and placed in the hands of the inspectors. One after another worked on it, and each failing.

Inspector Wilson was somewhat chary of taking hold of the case for two reasons. One was that the trail was cold after the lapse of five years. The other reason was that it was not specially a government case. When Mr. Wollihin received for the letter, the government's responsibility ceased. But in the cause of justice, and to keep his hand in, the inspector took it up.

He applied the process of elimination to the case. He started with the sending office, thence along the line, then into Macon and then into the office of the grand secretary, forming himself into a combination of detective, judge and jury, and putting every man on the dock tried him to acquittal.

Following this up was tedious, but the inspector loves work. Every man down the line was acquitted by this elimination process except the porter in the grand secretary's office. The more the inspector worked to acquit him, the guiltier he seemed. Do what he would, in all these silent mental trials, he could never get a verdict of not guilty from his mythical jury.

Having thus convicted him, the inspector called on Jim Warren, the porter for any statement he might want to make before sentence was pronounced.

It was no surprise to the inspector when Jim confessed to the theft. By his process the man was guilty—guilty beyond the shadow of a doubt and what else could Jim do but make his statement!

In his confession, Jim said that just after the letter had been received in the office, Mr. Wollihin and his mother sat down to lunch. During the short time

And the Same Number for Sheriff and Register of Deeds.

There yet may be others to come out later for each of these offices.

NEGRO BOY PREVENTS WRECK.

Flags Down a Passenger Train and Saves It.

Kinston, N. C., April 13—An attempt was made to wreck the Norfolk and Southern shoo-fly train yesterday morning. A negro boy named Bill Williams flagged the train as it was approaching the place of its contemplated destruction running about forty miles an hour. As the train was approaching the 62 mile post, about four miles west of Kinston, Engineer Duncan, who was at the throttle, noticed a colored youth standing in the middle of the track, waving an improvised flag. Mr. Duncan stopped his engine within a few feet of the colored boy. Engineer, conductor and others ran to ascertain the reason for flagging the train. It is learned that some one had removed all the spikes and fish plates from one of the rails and had left it in such a manner that the oncoming train would have been derailed and wrecked.

The train was going at high speed down grade and nothing could have avoided a horrible catastrophe and loss of life had the engine not been stopped just where it was.

Williams, the youth who flagged the train, was walking along the track, going towards Falling Creek to attend Sunday school, when he noticed the condition of the rail and discovered the attempt at wrecking the train. He hardly discovered the deed when he noticed the shoo-fly approaching, immediately improvised a flag and signed the on-coming train. The crew of the shoo-fly spiked the rail sufficiently for the train to pass over and the train was brought to Kinston where the officials of the road were notified. The section boss of this division was sent out and repaired the track. There is no clue to the miscreant who attempted the crime, but officials are busily engaged making an investigation.

BIG FIRE SWEEPS BOSTON.

Originated From Spontaneous Combustion.

Boston, April 12.—Fire devastated more than one square mile of the manufacturing, business and tenement district of Chelsea today entailing a loss estimated at fully \$10,000,000. The fire started at 10:40 a. m. near the Boston Blacking Company's works on West Third street, near the Everett City line, and crossed the city, a distance of one mile and a quarter to Marginal, opposite the east Boston shore. So far as can be learned there was no fatality. Half a hundred persons were injured.

Among the buildings burned were 13 churches, Frost Hospital City Hall, Fitz Public Library five school houses, a dozen or more factories and about 300 tenements and dwellings.

The residential section of the city where the wealthier classes reside, escaped the flames.

In the retail section, through which the fire passed, were 20 business blocks which were destroyed. The United States Marine Buildings were not damaged.

SUPREME COURT SUSTAINS PLAIN.

B. M. Whitehurst vs. Atlantic Coast Line.

The Supreme court of the State recently handed down the following opinion in this case that went up on appeal from Pitt county:

1. When by agreement depositions were read upon the trial of an action, and it was testified that the deponent was at the time sick at home, for the purpose of showing she could not be present, the error, if any, was harmless.

2. In an action for damages for the burning of plaintiff's house, etc., by reason of hot cinders, negligently emitted from smoke stack of defendant's locomotive, it was not error in the court below, in identifying a certain engine which had passed immediately preceding the time of the fire, to permit plaintiff to testify that "the whistle he knew as Captain Taylor's" was the one on the engine; when, under the whole evidence the locomotive in question was clearly identified, and the jury could not have been misled.

3. Testimony of one who was on the premises of the plaintiff with another person immediately preceding the burning of his house, etc., wherein that the other person "said something like hot pebbles had fallen on his hands and burnt him," in the presence of the plaintiff, is corroborative evidence when such other person has testified to the fact.

4. When the damages are claimed to have been caused by the burning of plaintiff's house by reason of a defective smoke stack or a spark arrester on defendant's engine, it was competent to prove that the same train had set fire to property and joining that of plaintiff, or thereto, at or about the time in question.

5. It appears from the entire evidence that a witness was permitted to testify as to fires caused by the same engine on the day of the week immediately preceding the injury complained of, it was competent evidence, and within the rule. (Cheek vs. Lumber Co., 134 N. C., 225, cited and approved).

6. Taken in connection with other evidence, it was competent to identify the train, for a witness to testify that he saw smoke in his own woods immediately after seeing that arising from plaintiff's premises.

7. It was competent to contradict the evidence of defendant's expert witnesses as to the distance hot cinders could have been thrown from its engine, to show by witnesses how far they had been thus thrown to their own knowledge and observation.

8. In an action for damages arising from the alleged imperfect construction of the smoke stack of defendant's engine from which hot cinders were thrown upon plaintiff's property, causing it to take fire, a motion as of non suit, upon the evidence, will not be sustained, when there is evidence tending to show that the sparks or cinders from one of defendant's engines, caused the fire, and expert witnesses testified that, if this was the case, the engine was not properly equipped, or the spark arrester was not in good condition.

UP IN A BALLOON.

The Exhilaration That Comes With a Trip Through the Air.

Floating softly up into the blue ocean of air, watching the earth sink slowly away beneath us and fade and change quietly to an immense map spread before our wondering eyes—such are the first impressions of balloon voyagers. The noisy shouts of those who come to wish us "Bon voyage!" become fainter and fainter until absolute quiet reigns about us. It is so still that the ticking of the clock in the barograph is heard noisily counting the seconds as it traces the line of our upward flight across the sheet.

Meanwhile the earth map down below us stretches out larger and larger, but its details are fading and becoming blurred. High hills have changed to flat surfaces. A river winds and bends its way through the duller colors like a tangled ribbon of silver. A small lake sparkles in the sunshine, giving life and fire to the sober shades about it. A railway train creeps slowly along, its trail of smoke streaming back over it. But as we look it suddenly disappears from sight, apparently swallowed up before our eyes. Then we realize that it has plunged into the tunnel through a hill which to us seems only a flat surface. Now it appears again, coming out on the other side.

So the wonderful scenes come and go, ever changing, but ever grand and inspiring—scenes that come back to us real and vivid, that we may live them over again in later days. The cloud effects are at times the most beautiful of all. After having sailed up through these into the dazzling sunlight we see the snowy billows just below our car, the shadow of our balloon falling upon their white surface. This shadow is often surrounded by a halo of rainbow colors of rare beauty. At such times one has the feeling of having left the earth completely and to have reached some other planet. The white masses just below seem to be quite solid and look as though one might step out of the balloon and take a stroll over them if one only had snowshoes. The air is wonderfully clear and pure and gives one a feeling of exhilaration much greater than that enjoyed in mountain climbing.—Henry B. Hersey in Century.

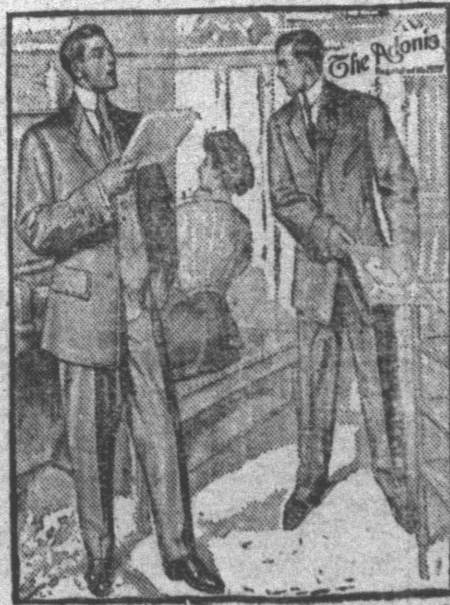
