HON. W. W. KITCHIN.

Candidate for Governor Addresses Large Audience Here Today.

Hon. W. W. Kitchin, of Roxboro, one of the Democratic candidates for governor, spoke to a very large audience in the court house here today. After an introduction by Representative J. J. Laughinghouse, Mr. Kitchin spoke for an hour and a half and was frequently greeted with applause.

Owing to the late hour at which the speaking closed we can not refer to it today only in a general way. He spoke of the attitude of certain newspapers in the State and also of the Southern Railway and the American Tobacco Company against his nomination, and explained that the railroad and trust had tested him and could not control him, hence were doing what they could to defeat him.

Mr. Kitchin explain the difference between natural and unnatural monopolies and the right of the people in regulating the latter. As to himself he was the servant of the people and not of the corporations. Because he stands by the people the corporations are opposed to him. He does not say that his competitors are with the corporations, but does say that the corporations are with his competitors, and if they can defeat him they will expect it to influence all public servants hereafter in taking a stand against them as he had done.

Mr. Kitchin also made a comparison of the claims of himself and Mr. Craig for the support of the people, but made no reference in his entire speech to Mr. Horne. He took up every claim made by friends of Mr. Craig for the nomination and answered it fully.

The audience was largely with Mr. Kitchin and his speech added to his number of friends in Pitt county.

Strong Plea for Prohibition.

Abstinence for the sake of others, and denying ourselves rather than lead others astray, was a strong point in his sermon, as was also his argument that prohibition cannot save the drunkard of today but is the hope of the rising generation in saving the boys from the evils of whiskey. His plea to the women to be active in the cause of prohibition was forceful. Any hearer of such a sermon should at once recognize his duty in the great issue now before the people.

Governor Glenn On Personal Liberty.

"You whiskey men assert that if you choose you could easily give up this privilege; then, if that is so, as you know thousands of weak men cannot break from this curse that is destroying their homes and their lives and dissipating every blessing, why won't you give us this thing that is called your liberty to save others from ruin, thus practicing your Master's commandment to love your neighbor as yourself and help those that are weaker than you? If you have gone so far that the habit has grown so strong on you that you cannot give it up, don't you think it high time that this liberty be taken away in order that you may be saved?"

"They say that prohibition will take away your liberty. Liberty to do what? Liberty to get drunk, to neglect and desert your families, to take provisions away from those dependent upon you. We are not trying to take your liberty away. The true rule of liberty is that nothing shall be taken away from an individual that is helpful to himself, his family and society. But if the business or the practice in which a person is engaged is evil instead of good, and injures others as well as himself, and that person has not force of character sufficient to desist from practicing it himself, then it becomes the duty of the State to take away from him that which is a curse to himself and to others. For this reason the State prohibits the carrying of concealed weapons; prohibits gambling; prohibits the buying of morphine and poisons, because in the doing of these things a man would not only injure himself but would injure others. The State has a right to grant the privilege to persons to sell liquor and the State has the same right to take away this privilege, when it sees that the sale of whiskey is cursing its citizens, and in so doing the State is protecting the liberty of its citizens, not taking their liberty away."

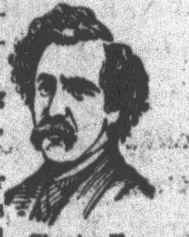

MORE ABOUT THE EDITORS AND CHARLOTTE.

The Reflector has only told part about the recent gathering of editors in Charlotte. The second day of the session proved of no less interest than the first. Maj. E. J. Hale spoke of the means of preventing freight discriminations against North Carolina and advocated the deepening of the Cape Fear river from Wilmington to Fayetteville. A resolution was adopted renewing the allegiance of the press of the State to the inland waterway project. Thus it will be seen that the editors in their meetings do not confine themselves to "shop talk," but discuss those matters that look to the upbuilding of the State.

The new officers elected for the association were J. A. Thomas, president; W. C. Dowd, J. Z. Green and Dr. J. O. Atkinson, vice presidents; J. B. Sherrill, secretary and treasurer; J. M. Julian, orator; J. F. Hurley, historian; R. M. Phillips, poet.

There were two pleasure features of the second day after business had been completed. One of these was an automobile ride over about fifteen miles of Mecklenburg's good roads. This ride was delightful, and also a revelation to those who had never seen such excellent country roads. The other feature was a reception and smoker at night in the parlors of the Manufacturers' Club where the editors and Charlotte's professional and business men spent a pleasant hour together.

The progress of Charlotte has been wonderful, yet it really looks to have but fairly begun, there are so many things under way. Buildings are now in course of erection that will call for an expenditure of three millions dollars. Thrift is in evidence on every hand.

Greenville has contributed some men to "help Charlotte grow" and The Reflector is glad to note their success. Mr. W. F. Harding is very prominent in the legal profession of the city, and Prof. H. P. Harding is superintendent of one of the city's best schools. Another young man originally from Greenville, Mr. Ronald Wilson, is editor of the Textile Excelsior. He left Greenville when only nine years of age, and after completing his education decided to cast his lot in the "best town in the State".

Charlotte is making much preparation for the Democratic State convention in June. Her auditorium is magnificent, large enough to seat four thousand people comfortably with room sufficient to crowd in another thousand. The city is looking for the largest crowd of visitors ever assembled there and will take care of them handsomely.

PHOTOGRAPHING ANIMALS.

Some Dangers the Man Behind the Camera Encounters.

Today the camera penetrates everywhere, and sometimes its use is attended with considerable danger and difficulty. Nowhere is this more pronounced than when the camera is brought into use in taking lifelike pictures of wild animals in captivity.

How hazardous this may be is shown by the following incident, which happened not long ago at a big zoological garden abroad: A fine white leopard had been added to the collection, and as soon as it appeared to have settled down the authorities decided to have it photographed. It seemed to be a fairly quiet creature—nervous and timid, to be sure, but without any sign of temper.

When the keeper entered its cage it had taken little notice of him beyond the usual spitting and hissing natural to its kind. The photographer therefore followed the keeper into its cage without apprehension of trouble.

He set up his apparatus, adjusted it, took several pictures of the leopard, and all seemed satisfactory. As he shut up his camera, however, the operator chanced to shuffle his feet once or twice on the floor of the cage.

Like a streak of lightning the leopard, with an ominous snarl, leaped at him, and before he could move the animal was gripping his ankle with his forepaws and furiously biting at his foot. Luckily the keeper and some assistants succeeded in beating off the beast in time to save the photographer's life, but it was a narrow squeak.

At the same zoo some time after when an attempt was made to photograph one of the llamas—an animal generally considered to be a fairly docile creature, with nothing particularly objectionable about it beyond its habit of spitting—the photographer's "subject" revealed its true nature by suddenly making a dash for camera and operator, and before the latter could be rescued he was the recipient of innumerable scratches, cuts and bruises which took some weeks to heal.

It is an open question whether seals and sea lions are vicious or not. They are certainly extremely curious and anxious to find out things for themselves, and a photographer who tried to take a picture of a troupe of performing sea lions had an experience worth remembering.

He erected his tripod and camera and was about to make the exposure when one of the sea lions wriggled off his pedestal and made straight for the camera. It was all done so quickly that before the photographer realized it the camera was upset and the sea lion was biting the man's legs and feet pretty sharply.

The trainer got him away, and no serious harm was done, but he explained to the camera man that sea lions often did a little biting just to find out what an object was made of.—Pearson's Weekly.

SHEFFIELD PLATE.

History of This Now Very Rare and Valuable Ware.

Sheffield plate differs from all other plated ware in that the plating was done on the sheet metal before the article was shaped. Before and since then plating of various sorts has been applied only to the finished piece, as in our electroplating process. Moreover, the plating was done on copper, while modern base metal is usually composed of an amalgam of copper, nickel and zinc.

Furthermore, it is possible for the collector to secure examples of early Georgian and so called Queen Anne work in Sheffield plate, while the rarity and high money value of silverware of that period make its acquisition extremely difficult. Sheffield plate historically and artistically is as worthy of a place beside old china and old mahogany as is old silverware.

In 1742 one Thomas Bolsover of Sheffield, England, described in the histories as an "ingenious mechanic," accidentally fused some silver and copper while repairing a knife. He began experimenting, seeking for a method of plating copper with silver for the manufacture of small articles. In 1743, together with Joseph Wilson, he set up a factory for the manufacture of buckles, snuffboxes and knife handles.

Joseph Hancock soon got hold of the secret and, perfecting it, demonstrated that it was possible to imitate the finest and most richly embossed silverware. Settling in Sheffield, he started the manufacture of all sorts of domestic pieces. Beginning modestly with horsepower, he later added water power for the rolling process. Other manufacturers followed his example, and Sheffield plate soon began to replace pewter on the tables of the English middle classes. Altogether we know of twenty-three important manufacturers of this ware.

The industry flourished until the middle of the nineteenth century, and so few pieces of copper rolled plate were made after that time that they need not concern the collector. Electroplating was discovered or invented by a medical student of Rotherham, near Sheffield, and the new process was patented on March 25, 1840. By 1850 the new ware was on the market everywhere, and the industry had been revolutionized.—Country Life in America.

BISMARCK'S ANGER.

The Incident That Made Certain the Franco-German War.

The Princess Bismarck, so the story goes, changed the political history of France unwittingly, and but for her the Franco-Prussian war might never have been waged.

Bismarck was unfriendly to France, but the Empress Eugenie hoped with her beauty to influence him so that the little trouble with France and Germany might be smoothed over. She therefore invited the German prince and his wife to visit the court of France, and the Prince and Princess Bismarck arrived in great state at the Tuilleries.

That evening there was a grand reception, and Eugenie received the guests in a gown which made her so ravishingly lovely that even Prince Bismarck, German, stolid and in love with his wife, stood and gazed upon her with admiration. And Eugenie was not slow to observe the effect of her beauty upon him. She called him to her side, and Bismarck came, with his wife upon his arm.

Now, the Princess Bismarck was tall and gaunt, and her feet were generous. As she walked she showed a great deal of sole.

While Bismarck stood talking with Eugenie an audible titter was heard along the line of ladies. Bismarck, who was quick as a flash, followed the glance of their eyes and saw them rest upon the feet of his wife.

That settled the matter. The political history of France was altered from that moment.

A year later, when Paris was besieged, Bismarck himself fired a cannon over the ramparts, and those who were near him heard him shout:

"Take that for the feet of the Princess Bismarck!"

The slight was avenged.

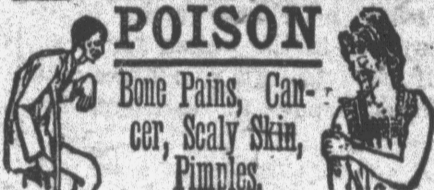
