## THE COMMENCEMENT AT GRIFTON

### ANOTHER OF PITT'S EXCELLENT SCHOOLS CLOSES TERM.

#### Pupils Give Interesting Concert—Ex-Gov. Aycock Delivers Eloquent Address.

The splendid graded school at Grifton, in charge of Supt. W. H. Cale and four assistants, held its closing exercises this week, and the people of the section and many visitors enjoyed an intellectual feast.

The exercises began Monday night with an interesting concert of music, recitations, declamations, etc. Tuesday night there was another concert that was historical in nature, that strikingly portrayed the progress of our country. This concert was so out of the ordinary as to afford unusual interest to the audience.

A medal which had been offered for best punctuality during the session was awarded to Miss Eliza Brooks and was appropriately presented by Prof. H. B. Smith.

Wednesday was the crowning day of the commencement. After an invocation by Rev. M. T. Plyler, the speaker of the day, ex-Gov. C. B. Aycock, was presented in a splendid introduction by Prof. H. B. Smith. Among other things Prof. Smith said in referring to him as our greatest educational governor, was that since retiring from the office he had not made any educational speeches, and he hoped the governor had not "fallen from grace." Gov. Aycock smilingly replied to this by saying he never made anything else but educational speeches, for whether he was addressing a jury, talking about prohibition or on any other subject, it was always educational.

What are we educating for? he asked. "Education is not what we put into a thing, but what we bring out of it. Everybody and everything should be educated." Then by forceful illustrations in both the vegetable and animal world he showed how the best is developed through education, and that it was equally true of the human mind. Education increases the value of whatever it is applied to. It also gives one power to hold on and wait for an opportunity, and then make the best of that opportunity as soon as it is presented.

Education costs something, is not worth much without sacrifice, but is not obtained by any other process. Books, teachers and school houses do not make education, but there must be hard work and sacrifice. Education for selfish ends is worthless. Educate everybody, as you get the best for yourself by giving the best to others. It takes competition to develop. The orator must have an audience who can appreciate his words or his speech is a failure. The skilled musician must have an audience of trained ears or the sweet music is lost. The eminent artist must place his work before eyes trained to appreciate it or the beauty of his picture is not seen. You must have an audience trained as you are trained or there is no incentive to development.

Happiness consists not in the gratification of the hour, but our greatest happiness comes through service to and thoughtfulness of others.

We give only a few of the strong points in Governor Aycock's speech. For more than an hour he dealt in truths and

thoughts equally as beautiful as those mentioned in the foregoing. Seeing the writer going to Grifton on the train to hear him, he remarked pleasantly "You might have stayed home in your office today and saved the trip by just saying 'ex Gov. Aycock made his same old commencement speech that everybody has heard before, and long ago grown tired of.'" But not so. It was a speech that more than repaid time and expense in going to hear, for no one could hear it without being benefitted.

Superintendent Cale announced that this school at Grifton having won the prize of \$25 by the Woman's Betterment Association of the county, the local association, in recognition of the worth of Miss Lillie Grant in leading the work, desired to present her a gold bracelet. County Superintendent W. H. Ragsdale was requested to perform this pleasant duty, which he did most gracefully and in beautiful language.

Miss Janie Roberson, teacher of the third and fourth grades, had so won the hearts of her pupils that they presented her with a silk umbrella and requested Prof. Ragsdale to also make this presentation for them.

After the exercises a bounteous dinner was spread on the school grounds to which every one present was invited. Grifton certainly has every reason to feel proud of her school.

## THE STREET PAVING.

### Editor Reflector Lays First Brick—Work Progressing Rapidly

The grading, rolling and other preliminary work necessary to the paving on Evans street having been completed, the actual laying of brick began a little before noon on Wednesday. Through the courtesy of Engineer F. J. McGuire, who is superintending the work, and Mr. J. F. Cole, foreman of construction, the editor of The Reflector was given the honor of laying the first brick, and after putting the initials of those two gentlemen and himself and the date on the underside of the brick, it was planted on the southeast corner of Evans and Third streets. And thus the paving started.

The paving is being done with vitrified brick, and after the laying of them started a considerable space was covered the first day. Where the paving is laid the street presents a fine appearance. The work will be pushed rapidly down Evans street to Five Points and then out Dickinson avenue to the depot.

## THE LATE COL. ISAAC A. SUGG.

### He Passed Away On the Eleventh Day of May, Mourned by Many Friends.

Col. Isaac A. Sugg has joined the great majority. That death "loves a shining mark" was conspicuously verified on this 11th day of May, 1908, in the falling to sleep of Col. I. A. Sugg, of Greenville, N. C., in the 60th year of his age. However familiar we may become with death, it never ceases to shock us, and the end of every life is a tragedy.

Forty years of unbroken friendship gives me the pleasure of knowing him as few could.

As a friend he was most lovable and loyal.

As an adversary, open and fearless.

In the presence of death we become retrospective. A friend having passed beyond the curtain that separates life from eternity, there is nothing left us but to follow backward along the pathway that brings to us memories of sweet companionship, and pick up here and there the fading flowers that have fallen by the wayside.

I remember well the first coming of Col. Sugg to the town of Greenville—where I then lived—nearly forty years ago. I was immediately impressed with his self reliance, manliness and candor, and was glad to welcome him as my friend and companion, a friendship that gained strength with increasing years, and knew no single cloud to dim its lustre.

In his robust manhood he seemed well fitted to fight the battle of life and the after results were a full fruition of this early promise. He surmounted obstacles that would have proven an impassable barrier to many, and seemed to gather strength from each struggle that wrung success from threatening defeat. While reading law, he was self supporting and after being licensed to practice he gave such promise of becoming a leader in his chosen profession that Gov. Jarvis was pleased to associate him with himself, and he immediately began to climb to those heights his ambition had pictured, even when his life was a monotone with no coloring to give it encouragement.

Later he was associated with Judge William Rodman and Mr. F. G. James, as Rodman, Sugg & James, and after the death of Judge Rodman, formed a co-partnership with Mr. James as Sugg & James.

For many years prior to his death, Col. Sugg had no partner in the practice of his profession. He was ready at all times to break a lance with any opponent in forensic death.

I love most to dwell upon the social aspect of his nature, as it was here I knew him best and was more capable of judging him.

He was decidedly an optimist and cheerful under the severest strokes falling from the lash of an adverse fate. He bore his long last illness with heroic cheerfulness, sustained by the loyalty of friends. His brother, Mr. B. F. Sugg, and nephew, Mr. Jarvis Sugg, showed a devotion that was beautiful in its constancy and unselfishness.

This was their especial privilege as Col. Sugg, at the time of his death, was an inmate of the Washington, N. C., Hospital, and they were residents of the town. Col. Sugg married Miss Mittie Rountree (the daughter of Charles Rountree, Esq., of

Pitt county, who preceded him to the unknown, ten years. As I knew Mrs. Sugg well as a girl, wife and mother it seems allowable that in performing this labor of love for the husband that I be permitted in loving remembrance, to give evidence of her worth in each phase of life she was called to fill.

Col. Sugg left four sons and two daughters. Three of the sons are successful men—C. R. of Washington, D. C.; I. A. Jr., of Waycross, Ga., and Benjamin Bruce, of Wilmington, N. C. The fourth, Julius, is a youth of fourteen years, living in Greenville, N. C. The daughters are Mrs. E. L. Brooks, of Elizabeth City, and Mrs. Alston Clark, of Kinston, N. C.

He is also survived by one sister, Mrs. Henry Harding, of Greenville, N. C., and one brother, Mr. B. E. Sugg, of Washington, N. C. James E. Clark.

In "The Shameless Diary of an Explorer" Robert Dunn tells of the journey on the roughly made rafts.

"Fred and I captained the Mary Ann II, the other three the Ethel May. We rasped and hauled them over the gravel shadows of our tributary, shot out between the main walls of the stream and seized upon that boiling current.

"We reached silently from cliff to cliff, jammed pike poles into the slate shelf overhead, twirled out of eddies. We bumped and grounded. We dashed overboard and on the run eased her across shallows. We tugged half an hour to make an inch at each shove through the gravel, suddenly plunged in to our necks, and she leaped free as we scrambled on.

"Boulders rose through white ruffs of water in midchannel. We might or might not hang on them for a perpendicular minute.

"You must be very handy with a pole. You must have a hair fine eye for moving angles, the strength of an eddy, the depth of foam ruffling over a stump. You must be surer of the length of your pole than a polo player of the reach of his mallet. You must be quicker than a St. Wash dog. You must know the different weight of each log down to ounces, the balance of the duffel piled high like a dais, covered with the tent and the bean pot, the mackinaws and the ax lashed to all the lashings. It's a pretty game."

### A STORY OF NELSON.

The Presence of Mind of the Great English Admiral.

Captain Mahan relates the following anecdote concerning Lord Nelson's letter proposing a truce to the crown prince of Denmark, dispatched in the midst of hostilities:

A large quantity of wax was used and extreme care taken that the impression of the seal should be perfect. Colonel Stewart asked:

"Why under so hot a fire and after so lamentable an accident have you attached so much importance to a circumstance apparently trifling?"

"Had I made use of a wafer," replied Nelson, "the wafer would have been still wet when the letter was presented to the crown prince. He would have inferred that the letter was sent off in a hurry and that we had some pressing reasons for being in a hurry." The wax told no tales.

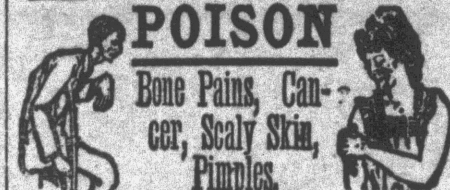

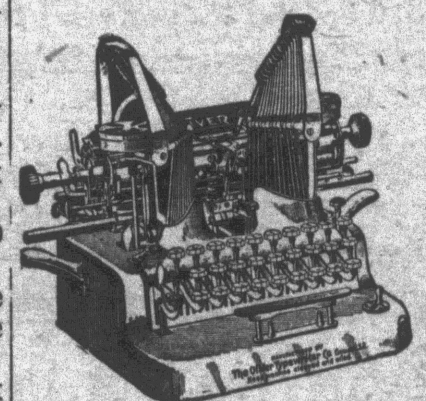
