## A NIGHT FOR GRADUATING CLASS. YOUNG LADIES READ THESES AND TWELVE GET DIPLOMAS

Dr. C. Alphonso Smith Delivers Admirable Address—Names of Honor and Scholarship Pupils Read—Medal for Mr. Brown

Thursday night be longed to the graduating class of Greenville graded school in connection with the commencement exercises, and the members of the class can congratulate themselves on the great number of people who were out in honor of the occasion. The opera house was crowded even to all available standing room, and scores of people turned back at the door when it was learned that the house was full.

There were twelve members of the graduating class this year, Misses Lillie Tucker, Margaret Blow, Jamie Bryan, Ethel Skinner, Lillian Burch, Lucile Cobb, and Essie Ellington and Conrad Lanier, Wiley J. Brown, Royce Tucker, Bruce Hooker and David Watson. Three of the theses written by the young ladies were selected to be read at the commencement as representing the class. These were "Imprisoned Genii" by Miss Lillie Tucker, "How to be Miserable" by Miss Margaret Blow, "On the Threshold" by Miss Jamie Bryan. Each of these papers gave strong evidence of careful study and thorough preparation and was read with grace and charm by the respective authors.

Between the reading of these theses there were splendid musical selections by Misses Brown, Bryan, Skinner, Gay, Critcher, Higgs, Warren and Spain.

Mr. F. C. Harding then in fitting words introduced Dr. C. Alphonso Smith, of the University of North Carolina, who delivered the literary address. Dr. Smith took for his subject "Stumbling-Blocks and Stepping-Stones," and from this delivered a short address that was a gem of beauty and logic. His thought was to take the stumbling-blocks that we encounter in life and turn them into stepping stones to success. Obstacles are opportunities for development, and the noblest part of man is developed along the line of greatest resistance. No true education is attained without difficulty, and the greatest reward follows the greatest sacrifice. The kind of life that tells is the one that possesses the unconquerable spirit, that knows no such thing as defeat. He gave several examples of persons Helen Keller, John James Audubon and others who had changed the stumbling-blocks of life into stepping-stones to success and had reached fame that was world wide. In closing Dr. Smith addressed a few words to the graduating class along the line of his speech that were most appropriate.

Ex-Gov. T. J. Jarvis, chairman of the board of trustees of the graded school, delivered the diplomas to the members of the graduating class. He said there was a time when it was his pleasant duty each year to present diplomas to the graduating class of our State University, and among those to whom he had delivered diplomas were Alderman, Melver, Aycock and Craig, but on no such occasion did it bring him more happiness than when he stood before such a class in his own home town, for in them he saw so much that pointed to our future progress

and pride. He was frequently interrupted with applause while making his presentation remarks.

Superintendent Smith stated that one year and two years ago he had read before the audience at commencement the names of pupils who had been neither tardy nor absent during the session, and he wished to do the same now. The record of such honor pupils the past session is as follows:

Seventh grade—Adrian Brown, Mary Brown, Alexander Harper, Nina Harris, Linda Smith, Mercer Tyson.

Eighth grade—Nannie Bowling. (She has not missed a day in five years.)

Tenth grade—Lillie Tucker.

An incident not on the program then came when Superintendent Smith called Frank Brown to the stage and said he had been requested by Dr. Laughinghouse, representing a large number of the people, of Greenville, to state that they wished to present Frank with a medal for the excellence he had shown in the debate Wednesday night. He would say that the decision of the committee in awarding the school medal for the debate was correct, and this entirely free from any reflection on that decision, but was only a popular desire to present Frank with a medal, a fund had been raised for that purpose and the medal ordered. The audience showed its appreciation in hearty applause.

Several colleges of the State had offered scholarships to this school, and the following pupils had won their choice of these in the following order: Boys—Conrad Lanier, Bruce Hooker, David Watson. Girls—Lillie Tucker, Margaret Blow, Lillian Burch.

## A STORY FROM WASHINGTON.

Secretary Root Aspiring to Supreme Court Bench.

Washington, D. C., May 21.—When the story appeared a couple of weeks ago that Ethu Root, secretary of state, aspired to a seat on the United States Supreme bench, there were few willing to believe it. But now, for some indefinite but pervading reason, it is coming to be accepted here at the capitol as true. A member of the cabinet, in private conversation, the other day made the prediction that should Taft be the next president, Root would be the next chief justice of the Supreme court.

The law provides that any Federal judge who has arrived at the age of seventy years and has been ten years on the bench is eligible to retirement on full pay. Chief Justice Fuller celebrated his seventy-first birthday last February and next October he will have been twenty years on the Supreme bench. While still in vigorous health, the chief justice has intimated to his friends that at no distant day he hopes to lay down the burden of his work.

## Unanimous Endorsement of Hon. C. L. Abernethy.

The Democratic convention of Greene county unanimously endorsed Hon. Chas. L. Abernethy for the nomination for solicitor of the third judicial district with ringing resolutions. The delegates appointed to the judicial convention, which convenes in New Bern on June 19th, were instructed to vote as a unit for Mr. Abernethy. There are six counties in this judicial district, viz: Carteret, Craven, Pamlico, Jones, Pitt and Greene. Greene was the first to hold convention. The other counties of the district will unquestionably follow the example set by Greene, because it is recognized that Mr. Abernethy has been a most faithful and efficient solicitor.—Snow Hill Special.

## HIS RIVER.

The Out of Doors Man Chafes Fondly Some Special Stream.

I believe that every out of doors man comes to have one stream that is more beloved than any of the others, says a writer in Forest and Stream. There is something about it which makes the days spent on that particular stream just a little nicer than on any other and which makes it linger in the memory until sooner or later one goes to all of the trouble of packing up and traveling over mountain roads to get back to it. It is the spirit of the water. When I say spirit I mean the appeal of the intellectual pose of one entity to another. The judge, who has lived on its bank all his life, is also possessed by it. This year he and his wife took a rather extensive water trip, embracing the great lakes, the St. Lawrence, the Hudson, the Atlantic and Chesapeake bay. The judge's wife told me that he would stand on the upper deck of one of the streams, look at the expanse of water and exclaim, "Give me the Black!" So, as I say, every man to his river, and here was mine.

Now, my companion had never run the rapids of a mountain stream or cast a fly. He and the river were total strangers, but it was interesting to see their advances toward each other. First came the exhilaration of "running down hill" over water and the fascinating study of how to run such places without having the boat hit the inevitable obstruction at the outside of the curve, the stump, or the log, or the rock, or the drift-wood with the current speeding beneath it. After a day or so he learned that he could not steer a boat in a rapid, but that he has to simply pick it up on his paddle and throw it. Then he quit hitting the stump in the curve, and I was able to fish without a paddle in one hand to fend the bow from the place. His closer intimacy with the water began by going in swimming, but that does not count for much. The real advance was when he stepped over the side of the boat and waded in the shallows with his shoes on. Finally, after swimming a place where the river darted through a narrow place, he deliberately put on his clothes and plunged in head first.

"I wanted to see if I could swim straight across with my clothes on," he said.

Then I knew that the dear had outwitted him even from the lures and perils that he could journey through with me again.

**MAN WITHOUT A SOUL**

The Uncanny Creation of Mary Godwin Shelley.

**MONSTER OF FRANKENSTEIN.**

The Interesting History of an Earlier Day Novel That is Frequently Alluded to in Literature and at Times Quoted Incorrectly.

Everybody, or nearly everybody, has heard of the novel of "Frankenstein," though it is not probable that many persons read it nowadays. There are so many allusions to it in our literature, however, that one absorbs some sort of notion of it so that he cannot help knowing that it is a weird and ghastly story about a monster, but whether or not Frankenstein is the monster even well informed people do not always know, showing that they never read the story.

Sometimes we hear allusions to "Frankenstein's monster," as in one of Charles Sumner's orations, where he speaks of the "soulless monster of Frankenstein, the wretched creation of mortal science without God," and sometimes the reference is to Frankenstein only, as if he were the monster. Of course Sumner, who was very particular in his use of figures of speech, was right. When Mrs. Deland in her novel of "Sidney" makes Major Lee say that "Christianity is a Frankenstein" she suffers the major to talk nonsense.

The story of this weird novel and the circumstances under which it came to be written are decidedly interesting and may be told in a few words. The facts are as follows:

In 1810 Mary Godwin, afterward Mrs. Shelley, eloped with Shelley, and they took up their residence near Geneva, in Switzerland. They had Lord Byron for a neighbor, and the three passed much time together. Their conversation frequently ran on the occult and the mysterious, and Byron one day proposed that each should write a ghost story. All agreed and went to work, but it was not long before the two poets gave it up as a hopeless task. They could write poetry, but they could not write stories.

Mary persevered and completed her tale in the spring of 1817. When Byron and Shelley heard it read they were surprised and delighted. It was bound to be the novel of the century! The name of it was "Frankenstein; or, The Modern Prometheus." It was immediately sent to London for publication and met with a great success.

Frankenstein is a Swiss youth, a student at the University of Ingolstadt, deeply interested in the study of chemistry and natural philosophy. He resolves to penetrate the mysteries of life and death and wrest from nature the secret of creation. After prolonged study he succeeds and discovers how to impart movement and animation to lifeless matter.

He then resolves to mold a colossal man, making him beautiful in form and feature and imbue him with life. He carries on his work in a studio far from the habitations of man, labors long and secretly, and at last the work is completed. There in the great room lies the form and semblance of a human being, perfect in all his proportions. Frankenstein relates the story: "It was on a dreary night in November that I beheld the accomplishment of my toils. With an anxiety that almost amounted to agony I collected the instruments of life around me that I might infuse a spark of being into the lifeless thing that lay at my feet. "It was already 1 o'clock in the morning. The rain pattered dismally against the window panes and my candle was nearly burned out when, by the glimmer of the half extinguished light, I saw the dull yellow eye of the creature open. It breathed hard, and a convulsive motion agitated its limbs."

Slowly the immense creature arose, and the artist, frightened at his own work, fled away. Then he returns to find his creation possessed of life and every attribute of humanity except a soul. Nowhere can it find human sympathy. It is out of harmony with all things about it, and after searching the world in pursuit of happiness it returns again to Frankenstein and demands that he make a companion with whom it can live in sympathy and love.

Frankenstein declines, and thenceforth the monster pursues him with hatred and revenge. It slays his brothers and sister, his friend and his bride. It follows him to Russia, to Siberia and into the Arctic ocean, and there creature and artist perish together. It is a most uncanny story to read of nights.

Sir Walter Scott reviewed the novel in the Quarterly, but, while admitting its power, confessed he did not like it. "Our taste and our judgment revolt at this kind of writing." All the critics agreed as to its daring originality.—Exchange.

**FINGER PRINTS.**

Using Them as Signatures is a Very Old Practice.

Finger print registration is in some respects a very ancient practice in Asia. In old Japan the mikado sealed documents of state by smearing his forefinger with vermilion ink and impressing it on the paper. To prevent passports being transferred the Chinese wrote the permission to travel on an oiled paper-bearing a print of the bearer's palm of the hand. Deeds disposing of land were similarly stamped by the vender's thumb. In India as long ago as 1860 Sir William Herschel instituted a system of finger prints at Hooghly as the directest and most certain means of identifying the parties in the transfer of land in Bengal and of preventing them from false personation or repudiation of the bargain by requiring them to affix their finger prints to the entries in the land register.

It was Sir William Herschel's use of this old oriental practice which led Francis Galton to take up the study of finger prints as a means of identification. By research and the examination of thousands of finger prints Mr. Galton raised the practice into a science and first drew public attention to its possibilities by an article in the Nineteenth Century in 1891. A few years later it was adopted by both the government and postoffice of India as a means of establishing identification beyond dispute, a matter of the utmost difficulty with natives, whose faces always appear as like as two peas to European eyes.

Military and civil pensioners must now finger print the receipts for their pensions, and the impression must correspond with that in the register before payment is made. Medical certificates are similarly rendered useless to bearer, and candidates sitting for civil service examinations must finger print each set of papers they hand in. Indians emigrating under the labor act also impress their thumb on their engagement contracts, and pilgrims setting out for Mecca are likewise given an identity they cannot deny.—London Chronicle.

**SENATE OF LILLIPUT.**

The Way Dr. Johnson Outwitted the House of Commons.

Parliamentary bodies were long a great stronghold of resistance to the press. Reporters were strictly barred from them, and reports of their proceedings were sternly punished. It was among the triumphs for the right and for common sense which Franklin achieved that he caused the chamber of the provincial assembly of Pennsylvania to be thrown open to publicity. Nevertheless no reports were allowed of either the Continental congress or the constitutional convention.

Dr. Johnson's violation of the cherished privacy of the British house of commons is a classic story. He reported its debates without entering its sacred precincts, and in order to escape the severe penalties of the law he reported them without mentioning the body or any of its members by name. Setting up an imaginary "senate of Lilliput" and giving fictitious names to the leading members of parliament, he edified for years the readers of the journal which then boasted the "largest circulation" in England.

Receiving a few scanty notes of what was going on at Westminster, he elaborated them into a brilliant spread. He was, indeed, the illustrious founder of the immortal craft of rewriters. His discerning readers came to know not only that the senate of Lilliput was the house of commons, but that "Blefsen" stood for France and "Mildendo" for London; that "sprugs" meant pounds, that "Nardac" was the Duke of Newcastle, and so on. What his notes lacked his imagination readily supplied.

Never was the eloquence of parliament more brilliant than in Johnson's reports of the debates, in which, he admitted, he took care that the Whig dogs got the worst of it, although Pitt himself must have felt mollified when he read the wonderful outburst attributed to him by Johnson on "the atrocious crime of being a young man." It is the best remembered of all Pitt's speeches, and it was written by Johnson "in a garret in Exeter street."—Boston Globe.
