CONVENTION STILL IN DEADLOCK.

FOURTH DAY SEEMS NO NEARER NOMINATION.

Kitchin Still Leads—Delegates Shifting Between Craig and Horne.

[Two Letters sent The Reflector on Thursday were delayed in mail but are given in regular order below.]

Charlotte, N. C., June 25. The delegates and visitors began reassembling in the auditorium at 4 o'clock Wednesday afternoon and no cessation of the interest manifested at the morning session. The delegates showed that they were ready and anxious for the contest. Many left coats behind at their hotels and others took them off upon getting to their seats. All had fans to raise a breeze.

The tumult of the afternoon began when two or three Craig banners passed through the aisles. The Craig men sprang to their feet, mounted chairs, waved hats and fans and opened their faces for a noise. The Kitchin men could not keep still amid this. The same large Edgecombe banner put in an appearance again for another tour of the hall. Pandemonium broke loose then sure enough and everybody was going at the same time. Both sides showed the best of feeling and turned loose their enthusiasm with a will.

It was 5:25 before the committees were ready to report and the racket continued until then, but grew quiet when Temporary Chairman Jarvis rapped for order.

The committee on credentials was first to report and all contests were settled.

The next uproar came when a delegate from Rockingham county undertook to read a resolution endorsing W. J. Bryan such a storm of noes and objections coming that the reading of the resolution could not proceed.

This was followed with a motion to proceed with nominations, and after adoption the chairman declared nominations for governor in order.

C. W. Tillett, of Charlotte, spoke first and presented the name of W. W. Kitchin. When he named his candidate the Kitchin men again sprang to their feet with cheers and waved hundreds of small North Carolina flags. He spoke 40 minutes and at the conclusion a large picture of Kitchin was unrolled and carried through the hall amid another prolonged outbreak of enthusiasm.

T. W. Bickett, of Louisburg, next spoke to present the name of Ashley Horne. Horns had been distributed among the Horne men, and Mr. Bickett's speech was applauded with much horn blowing and shouting. Mr. Bickett's speech was an exceptionally fine one and a great Horne demonstration followed it.

At the conclusion of the Horne demonstration at 8 o'clock the convention took a recess to 9:30 for the delegates, to get supper, and with the hotels so crowded the time was short enough for the multitude to feed and get back. But they came back perspiring and shouting, enthusiasm having lost none of its high tension. The galleries filled early and the throng enjoyed the hilarity of the incoming delegates and helped to swell the noise. At every session thousands of people are turned back from the doors who cannot gain admission.

It was a quarter of 10 when Chairman Parsons rapped for order, but at first the sound of his gavel fell on unheeding ears.

A megaphone was brought into use to announce that ex-Gov. C. B. Aycock would be the next to address the convention. At this the Craig men went wild in their turn and gave the speaker an ovation as he advanced to the front of the stage.

When Mr. Aycock got a hearing he presented the name of Locke Craig in a masterly speech. He rehearsed the history of the party during and since the trying days of fusion and pointed out the work and leadership of Craig in restoring the party to its supremacy and purity. His speech seemed to arouse the convention as it had not been stirred before, and at its conclusion the Craig demonstration was intense. Several new Craig banners came out and were cheered enthusiastically as carried around the hall.

At 11:15 V. S. Bryant, of Durham, began speaking to second the nomination of Kitchin, and that side of the house again warmed up to lung action.

J. T. Ellington, of Johnston county, gave the Horne contingent another inning in seconding the nomination of Horne.

Congressman W. T. Crawford seconded the nomination of Craig but before he had finished the crowd began showing that, it now being midnight, it was growing weary of speechmaking and wanted to vote.

The first ballot was started a little past midnight and was finished about 1 o'clock. There was so much noise constantly going on with moving about over the floor and frequent hurrahs for this or that man, made it difficult for the clerks to hear as the roll call of counties went on.

The convention continued in session all night, yet only three more ballots were taken, there being so much interruption that progress was slow.

About 5 o'clock after the fourth ballot had been taken there was a motion to adjourn so the delegates could get some rest. This was opposed by the Kitchin men, and a roll call vote was demanded. This consumed an hour with attendant wrangling, and while close seemed to show a small majority against adjournment. This brought the Kitchin enthusiasts into another demonstration in which their banners and picture again paraded the hall. This continued for some time when at 7 o'clock Chairman Parsons adjourned the convention until noon, leaving the demonstration still going on. The Kitchin men took exception at this adjournment, but it was impossible to transact business in such an uproar.

Charlotte, N. C., June 25.—This enthusiasm is something wonderful, and it was as much in evidence as ever when the delegates came back together at noon Thursday. Since the morning adjournment there had been all kinds of rumors on the streets that the contemplated deadlock was broken and a nomination for governor would not be long coming after reassembling.

The interest of the ladies in this convention has been remarkable. Many of them occupied seats in the galleries and on the stage, and several remained through the all night session. They joined in the demonstrations with waving fans, flags and handkerchiefs.

Chairman Parsons rapped for order at 12:45 and stated before starting business that the convention had been in session since noon Wednesday, and if it was

to complete its work in any reasonable time there must be better order. He thought there had been enough shouting and display of banners. The convention applauded this.

The roll of counties was called for the fifth ballot for governor which resulted as follows: Kitchin 377 535; Craig 327.645; Horne 151.77.

Tyrrell county's vote had been challenged on a previous ballot because the delegates changed the vote from 192 for Kitchin and 108 for Craig to 3 for Kitchin, and the chair sustained the challenge. In the fifth ballot the vote was again cast 3 for Kitchin and challenged. E. R. McNinch moved that the question be referred to the credential committee for decision. C. Morrison spoke in opposition of this motion and E. R. McNinch spoke in favor of it. After wasting much time trying to get a roll call on this motion it was withdrawn.

The sixth ballot showed Kitchin votes standing firm while some of Craig and Horne began to shift to each other, Craig pushing up to 340 and Horne dropping to 138. The seventh ballot reversed this, Craig getting 324 and Horne 154. Two more ballots were taken up to 4:30 o'clock when the convention adjourned to 8:30.

The delegates were not much in favor of adjourning Thursday afternoon until 8:30, even though they had missed dinner and were jaded from the experience of the previous all night session, but the statement was made by the offerer of the motion that it was upon agreement and at request of the three candidates for governor and their managers that adjournment be taken, so the delegates yielded. Out of this statement grew all manner of reports that some agreement was on between the candidates by which the contest could be brought to an end, and it was even said there would be some trading that meant the sacrifice of candidates for some of the other officers. This may have been mere rumor, but it put friends of these other candidates on the lookout and all were anxious to get back to the night session to see what developed.

The galleries filled early and as the delegates arrived and took their places it was evident that their enthusiasm had not slackened a particle. This not only goes on record as the largest convention the State has had, but it has also made a record for being the most demonstrative and noisy and the hardest to control. The chairman has had a most laborious task. Neither have the press men had an easy time, for they have been crowded and jammed almost to suffocation by people getting all over and around their tables at times when enthusiasm was highest. Those staying at home do not realize just what such a convention is, for nothing short of being right in it could give this idea.

When Chairman Parsons rapped for order at 8:40 tonight the Craig enthusiasts were in the midst of a demonstration and it took several rounds of the gavel to quiet them.

At the beginning of the roll call for the tenth ballot Alamance created a shout by announcing 12 votes for Kitchin and one for Craig. Her former vote on every ballot had been Kitchin 112, Craig 1, Horne 2. The one Craig man objected to a portion of his vote being given to Kitchin and there was an uproar. It was passed over for the present and

the roll call proceeded. No other county made any change from voting on former ballots until Cnslow changed half a vote from Horne to Craig. The ballot finished with Kitchin 380.500, Craig 329.435, Horne 127.56. So if there had been any trading during the recess it did not show on this ballot as Kitchin had only gained 3 votes in his lead. Yet his supporters went wild over the result.

The 11th ballot led off with Alamance giving all her 13 votes to Kitchin, and all went on as before until Gates gave her 5 votes to Kitchin, fractions having previously gone to Craig and Horne. Former figures prevailed down the column as before, with the exception of a little shifting between Craig and Horne, the ballot closing Kitchin 380.445, Craig 327.065 149.48.

Alamance started the 12th by giving half a vote back to Craig. Martin changed one vote from Horne to Kitchin. The ballot showed Kitchin 380.945, Craig 331.735, Horne 144.32. Before this time it had become evident the prediction that the nomination would come early after supper had failed, the galleries showed a marked thinning.

The superstitious thought something would surely happen on the 13th ballot. But it only slightly changed the vote which was as follows: Kitchin 381.145, Craig 335.235, Horne, 140.62. The Kitchin and Craig forces gave a lung contest with another display of banners, while the Horne horns tooted between them.

If this was intended to rally the respective forces to stick to their man it was successful to that extent, for the 14th ballot was as follows: Kitchin 382.325, Craig 321.615, Horne 153.600.

Here a motion was made to take a recess to 10 o'clock Friday morning on which a roll call vote was demanded. The roll call showed the Craig and Horne delegates voting almost together to adjourn, the Kitchin delegates voting solidly against it. The vote stood 483,80 ayes and 422 20 noes and at a quarter before 2 o'clock the convention took a recess to 10 a. m. Friday.

Charlotte, N. C., June 26.—The adjournment from 2 to 10 o'clock this morning gave the delegates chance to catch some sleep and they wore fresher looks and brighter faces upon reassembling. A Craig man was the first to try to start a noise, but he was so hoarse as to make poor success to that end. When the band struck "Dixie" at 10 o'clock there were two or three small rounds of cheering. The delegates were evidently now more anxious for work than for noise. A slight thinning of the ranks was also noticeable, several having gone to their homes by the night and early morning trains.

It was 10:30 when Chairman Parsons called the third day's session of the convention to order, and the secretary began calling the roll for the 15th ballot for governor, the counties answering rather slowly at first but soon got down to business. The line up showed no change of consequence.

The sixteenth ballot indicated a break up of the line when Alexander gave all her vote to Craig and Ashe gave all of hers to Kitchin. Nothing else occurred until Montgomery changed 4½ votes from Horne to Craig. The gain for Kitchin put his friends to shouting.

The seventeenth ballot Ashe gave Craig vote back to him and

all counties swung back near to their line up in each ballot.

On the eighteenth ballot things went about as usual with the exception of Northampton gave her 10 votes to T. W. Mason. This was the first man for a dark horse, but it carried no following from other counties.

In the nineteenth ballot Hertford changed a half vote each from Craig and Horne and gave it to Kitchin. Northampton came back to Kitchin and Craig as before.

By now the spokesmen of the counties stopped calling their vote, but just responded "no change" when the vote remained as before. In that way the balloting went faster and there was no change in the 21st and 22nd ballots.

On the 25th ballot the Horne vote reached high water mark, going to 157.39, and a great demonstration of the Hornites followed. The hall instantly filled with banners and shouting galore, the Craigites helping in the noise. This demonstration had hardly subsided when a Kitchinites appeared on the stage with a blackboard on which was written, "Kitchin Needs Only 47½ votes," and a Kitchin demonstration followed.

This rallying of the different forces seemed to have the effect of bringing them together and ballots from then on dropped back to their usual sameness. The convention was in continuous session all day and through the night until 3 o'clock this (Saturday) morning when recess was taken until 10 o'clock.

It was a test of physical endurance in which every side stuck to its man with a rigid determination.

There was a growing sentiment through the afternoon and night that a resolution be offered referring the nomination for governor to a State primary to be held the first Tuesday in August. This seems to be a practical solution of the deadlock, and if adopted will permit the convention to proceed to the nominations for other offices.

The following ballots have been taken today up to the time of going to press.

Forty sixth ballot taken at 5:30 a. m. resulted Kitchin 385, Craig 328 Horne 142.

Convention takes recess until ten o'clock.

Forty-seventh ballot—taken first thing after reassembling of convention. Kitchin 887, Craig 317, Horne 151.

Forty eighth ballot—Mecklenburg gives Craig vote to Horne. Kitchin 386, Craig 307, Horne 162.

Forty-ninth ballot—Kitchin 386, Craig 307, Horne 162.

Fiftieth ballot—Kitchin 386, Craig 297, Horne 172. Craig votes in Yancey and Mecklenburg given to Horne.

Fifty-first ballot—Kitchin 388 Craig 292, Horne 176

Fifty fourth ballot—Kitchin 389, Craig 304, Horne 162.

Fifty fifth ballot—Kitchin 389, Craig 306, Horne 162.

Last fall the ministers of the town visited the places of business of Greenville and ascertained the feeling concerning a uniform closing of stores Saturday nights. It was the opinion of the business men of Greenville that there would be nothing materially lost by closing at a reasonable early hour. The plan was to present a petition to the Chamber of Commerce asking that the business men agree upon some hour for closing all stores.

The gain of such a rule would be great. It would give the men a better chance to rest Saturday nights, and would this way better prepare them to spend Sunday in worship and recreation. It is hard for a man to be interested in Sunday school lessons and sermons, be they ever so good, when he has had only half enough sleep and rest.

Hon. Thomas J. Jarvis.

The Charlotte Observer of yesterday pays the following tribute to that grand old Democrat and Tar Heel, Thomas J. Jarvis:

"Nothing could have been finer or more befitting the occasion than the speech of the grand old man in taking the position of temporary chairman of the convention yesterday. It was marked by his accustomed expressions of party loyalty, of devotion to the State and by the wisdom which characterizes all of his public utterances. It is said by many, and it stands true, that Governor Jarvis is our wisest man. And it must be great gratification to him to know, as he must know, much he is honored, how much beloved by his people."

It is seldom, indeed, that a man retains his hold on the people so long after his retirement from political life as has ex-Governor Jarvis. Generally when a man retires from politics to private life the people are apt to consider his usefulness to his State gone and he passes out of the public mind. It is not so, however, with this man. As he grows older and gets further away from active politics he is still looked up to as a safe adviser in matters pertaining to the good of his party and of his State. In years to come his name will stand high in the honor roll of North Carolina.---Wilmington Star.

Preaching and Practice.

The president writes message after message urging the protection of the forest and declaring his convention that only by such protection can the farmers make good crops or thousands of people along the river valleys be safe in person and property. But when the forests can only be protected by making a breach in the tariff wall and a deficit in campaign contributions the forests may take care of themselves. We hear the president declare that if congress will not provide for one of his favorite commissions he will "do so himself," might we ask why he does not care for his forestry commission all by his lonesome? The tariff is to remain sacred till it

has won yet another national election—by its contributions. Publicity is a good thing, but it is not to unveil the secrets of the tariff. Fair play is a fine theory, but it does not help the man who is taxed for the benefit of another. The square deal points a period and adorns a tale, but the tariff is exempted from its rule. Inordinate wealth is a danger, but in the hands of those who divide with the party it is very useful and Mr. Carnegie may sit among the governors and debate with their chairman.---Florida Times-Union.

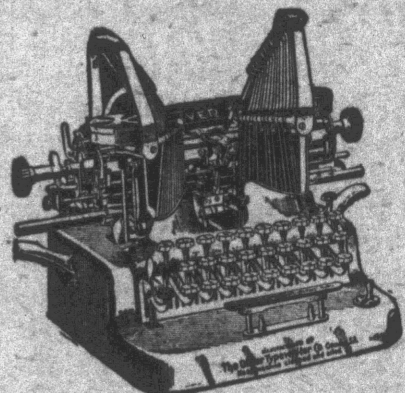

MRS. VIXENHEAD.

The Story of a Berlin Shrew and Her Likeness in Stone.

This quaint equivalent of the German term neidkopf is applied by travelers to an effigy carved in stone and fixed in a niche in the second story of a house in the Helligengelstrasse in Berlin not far from the emperor's palace. The neidkopf represents a hideous, bumpy faced woman with snake-like curls and tongue protruding in mocking derision.

One day some 200 years ago, the legend runs, Frederick William of Prussia, more familiarly known as Old Fritz, was walking about the streets of the city in the unconventional way he affected when he chanced to look through a window and observed a hunchbacked goldsmith hard at work. The king entered the little shop for a chat.

The result of his interview was an order for a gold table service for the royal household, an order that made the fortune of the hunchback. Later his majesty made other visits to the shop to see how the work was advancing, and on one of these occasions he observed a woman in the window of the opposite house contorting her face in the most hideous grimaces and pointing with derisive finger at the crippled workman.

To the king's query as to what ailed the old woman the goldsmith replied: "It is envy, sire. She is the wife of a rival goldsmith, and ever since your majesty so graciously gave me this order she and her daughter have reviled me."

Frederick William, paternal in punishment as well as in reward, at once investigated as to the ownership of the house in which the shrew lived. He found that it belonged to her husband and therefore reasoned that there was little likelihood of the family moving, an idea that seemed greatly to please his majesty. His next move was to consult a sculptor, whom he commanded to make the bust of a woman with the most shrewish, Kn-tippe-like face he could imagine. The king then bought and renovated the house in which the hunchback had his workshop, presented it to him and caused the bust to be placed conspicuously above his workshop window. Thus whenever the envious woman across the street looked forth from her casement the first object on which her eyes fell was this intended portrait of her amiable self.

For more than a hundred years the neidkopf—spiteful vixen head, as one would say in English—stood in proud prominence, a reproach to the envious woman and her descendants. It afterward mysteriously disappeared, but in 1840 or thereabouts it was found in a forgotten collection of bric-a-brac. Frederick William IV. bought the bust for a large price and had it replaced in its original niche, where it stands today.—New York Tribune.

The Senate Band.

The press gallery of the senate does not look unlike a band stand, with its elaborately decorated front, and it is never occupied by the scribblers prior to the opening of the proceedings. A young lady seated in the gallery opposite the press gallery had been looking intently at the empty seats for quite awhile. Her curiosity got the better of her, and, going to the doorkeeper, she said, "Mister, will you please tell me when the band begins to play?" The doorkeeper was amazed. "No band will play, miss," said the gentleman. "There is no band. Why do you ask?" The young lady looked disappointed and embarrassed when she said, with hesitation, "Isn't that the band stand?" pointing to the press gallery.—Washington Herald.

RESOLUTIONS BY PHYSICIANS

Relating to the Prescribing of Intoxicating Liquors in North Carolina.

The following resolutions were unanimously passed at the recent session of the State medical society in Winston-Salem, June 16, 17, and 18 1908:

Dr. Way vacated the president's chair and on behalf of himself and Dr. Laughinghouse introduced them and moved their adoption:

Whereas, the people of the State of North Carolina have by a large majority vote recently ratified an act which after January 1st, 1909, makes illegal the sale of intoxicating liquors in North Carolina except upon physician's prescriptions:

Whereas, the legislature of North Carolina, in framing the prohibition law, did evidence great confidence in the medical profession of said state by placing in the hands of such profession to an extent the success or failure of the law, in that the members of the said medical profession are given the right to prescribe spirituous liquors at their discretion. Therefore be it resolved: 1st. That the Medical Society of the State of North Carolina in fifty fifth regular annual session assembled do hereby condemn as unprofessional and grossly immoral any lax or unfaithful conduct in its members in the exercise of the privileges conferred in this law.

2nd. That the Medical Society of the State of North Carolina respectfully urges upon all the physicians of this state, whether members of this society or not, to join us in demonstrating to the people that the members of the medical profession can be relied upon implicitly to perform their full duty in aiding in the enforcement of the prohibition law and in building up a public sentiment that will insure protection against an illegal traffic in intoxicating liquors.

3d. That the Medical Society of the State of North Carolina respectfully urges upon the Board of Medical Examiners of the State of North Carolina the manifest duty of revoking the license to practice of any physician who may be proven guilty of abusing the privilege accorded him in the prescribing of intoxicants.

Signed, J. Howell Way, Chas. J. O'H. Laughinghouse. Unanimously adopted by vote of the Society and ordered given to the press of the state for publication.
