PLAN FOR PRIMARY ELECTIONS.

Plan for holding primary elections for the nomination of democratic candidates for county and township offices and members of the legislature and township executive committee, in pursuance of resolution adopted by the state democratic executive committee at its meeting held in Raleigh on the 26th day of July, 1904.

Section 1. At the meeting held for the purpose of calling a county convention to nominate candidates for county offices and members of the legislature, the county democratic executive committee may, upon motion, determine the question of nominating such candidates by primary election as provided for in the following resolution of the state executive committee:

"Resolved, That this committee will provide an optional primary, to be adopted by the executive committee of any county desiring to nominate county candidates and members of the legislature by a primary. That the chairman is authorized to appoint a sub-committee to formulate such a plan, and when approved by the chairman the said plan shall become a part of the plan of organization. Where any county executive committee has already called a primary, such county executive committee may formulate and promulgate its own rules for such election already ordered. The plan provided for in this resolution will not supersede the present plan except in those counties adopting this plan."

Sec. 2. If before such meeting is held there shall be presented to the chairman of the county executive committee a petition in writing, signed by one-fourth of the members of such executive committee, or a petition in writing signed by at least one hundred known democratic voters of such county, asking that a meeting of the county executive committee be held for the purpose of considering the advisability of nominating such candidates by primary election, then it shall be the duty of said chairman forthwith to call a meeting of his county executive committee within ten days to act upon the said petition. In any county where it has been decided by the majority of the executive committee to nominate candidates by primary election, shall be held under the following rules and regulations:

Sec. 3. The time of holding the primary election shall be not less than thirty days before the general election, and not less than fifteen days' notice shall be given of the time and places when and where such primary is to be held. When a primary election under this plan shall be ordered, notice thereof, giving the date and the various balloting places and the names of the persons appointed to hold the same, shall be published in the democratic press of said county, and copies posted at every balloting place in said county, and such other notice given as the county executive committee may think proper. In such primary election the county executive committee shall designate the places where voting shall be had, and they shall select, as far as practicable, the places provided by law for holding the general state elections. They may, however, select other places if the convenience of democratic voters justifies such change, but there shall be at least one voting place in each township.

Sec. 4. For the purpose of holding such election, the said committee shall appoint two well known democrats for each precinct, or other voting district in the county, who shall conduct such election, receive the ballots, count them, declare the result and make a written statement thereof. If any person appointed to hold a primary election shall decline to serve, become incapacitated, or become a candidate before said primary, the chairman of the executive committee of that township or precinct shall have power to designate some qualified democrat to fill such place; and if the chairman of the committee shall not be present, then the remaining poll-holder or person authorized may designate some person to assist him in holding the same, and such substitute person shall have the same right and authority therein as if he had been originally appointed by the county executive committee.

Sec. 5. The said persons shall provide such boxes for the reception of ballots as may be necessary, but there shall be separate boxes for the following classes of candidates, to-wit: Candidates for the general assembly shall be voted for in one box, all county officers shall be voted for in one box, all township officers in one box. The hours for holding such primary election shall be as follows: From ten o'clock a. m. to five o'clock p. m. Provided, that the county executive committee may designate other hours within which said primary election may be held; but in no case shall the time for holding said election be less than six hours.

Sec. 6. Any democratic candidate who is voted for in said primary election may attend the same, in person or by representatives, and be present during the conduct of said election and counting the vote. Every white democratic elector shall have the right to vote at his proper polling place, and in case the vote of a man claiming to be a democratic elector is challenged on the ground that he is not qualified as an elector, or is not a democrat, he shall not be denied the privilege of voting except by the judgment of both poll-holders. Every challenge shall be recorded, and any candidate or his representative dissatisfied with the result shall have the right to appeal to the county executive committee, and the county executive committee shall hear the same and allow or disallow the returns from that precinct in accordance with its judgment upon said appeal.

Sec. 7. At the close of the voting it shall be the duty of the poll-holders, in the presence of such candidates or their representatives and any democrat who wishes to attend, to proceed at once to count the ballots and make a list of all persons voted for and the offices for which they were voted, and the number of votes received by each, and they shall sign such list and send the same immediately to the chairman of the county executive committee. They shall give any candidate or his representative, upon his request, a copy of the said list and they shall also give to the county executive committee a statement of the number of challenges allowed or disallowed, and how said challenged voter voted or how he offered to vote when challenged.

Sec. 8. Within five days of the holding of such primary election, it shall be the duty of the democratic executive committee of such county to meet and ascertain and declare the result of the same, and if any person has received a majority of all votes cast for an office, they shall so declare, and he shall be the nominee of the party for such office. And if no person has received a majority of all the votes cast for an office, but has received a plurality thereof, the said committee shall declare him to be the nominee of the party for such office, unless the person receiving the next highest vote for such office demands of said committee in writing that a second primary be held, in which case a second primary shall be ordered and held under the rules and regulations herein provided, as near as may be, and such second primary shall be held within seven days from the time of said call, provided that in the second primary election no votes shall be cast except for the two persons receiving respectively the highest and next highest vote in the first primary. In the event each person voted for in the second primary receives the same number of votes, the county executive committee shall decide which of them shall be the candidate of the party for that office.

Sec. 9. At the meeting in which said primary is ordered under this plan, it shall be the duty of the executive committee to fix the date upon which said committee will meet to ascertain and declare the result of such primary, and notice thereof shall be given in the call for such primary. In case a second primary is necessary, the date for the meeting of the executive committee to canvass and ascertain the result thereof shall be fixed and announced in the call of the second primary.

Sec. 10. The county executive committee shall have the right to make any rules with regard to holding the primary elections which it may deem proper, not inconsistent with the rules prescribed in this plan. It shall have power to provide for raising the funds necessary to pay the expenses thereof.

Sec. 11. No primary election shall be held under this plan unless the same shall be ordered by the executive committee of the county, and in case the executive committee of the county shall not order a primary election under this plan, nominations for county offices and candidates for the legislature shall be made under the plan of organization in force prior to the adoption of the resolution hereinbefore set forth.

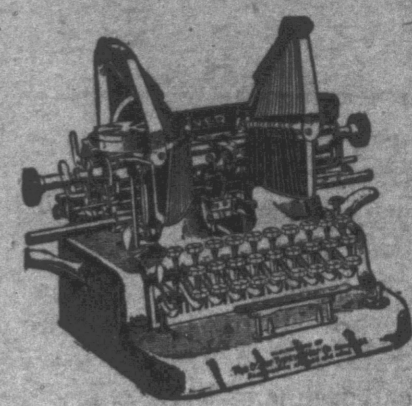

PLAYING A TROMBONE

A Rather Easy Matter, the Musician Seemed to Think.

SUCH A SIMPLE INSTRUMENT

But Somehow or Another the Explanation Only Muddled the Man Who Wanted to Learn and Who Decided to Tackle an Accordion.

The band was playing loudly in the Trinkfestbergarten and the little bald-headed man had his eyes fastened interestedly on the trombone player. When the players stopped to recuperate he beckoned the man who works the loose horn over to his table and ordered two glasses of schoonesbraue.

"My name is Biggs," said the man whose hair was absent. "One of my lungs is trying to quit work, and the doctor advises me to break up its shiftless habits by blowing a brass. The careless way you yank that pump horn looks good, and I want you to put me on."

"What do you want to know?" asked the musician.

"Just a hint about how you handle that wind machine so nonchalantly."

"The trombone is very simple," replied the musician, wiping his lips, which curled in thick, red volutes. "The slide is divided into seven shifts, or positions, about three inches apart."

"Starting with the lowest note in the first position—the slide closed—you get B flat. Push out the tubes and you hit successively A, A flat, G, F sharp, F and E."

"That's only seven notes," objected Biggs.

"Yes. Getting the rest depends on how you pucker your lips. In the first position you can make, figuring upward, B flat, F, B flat, D, F, B flat and C. In the second you obtain A, E, A, C sharp, E, G and A. The third gives you A flat, B flat, A flat, C, E flat and A flat. It works out the same all the way down."

"There are higher notes that I didn't mention, but you won't want to monkey with them. But a good player has a compass of more than three octaves." Biggs looked troubled.

"Let me see," he said. "You start in the first position with B flat."

"Yes," replied the other—"that is, provided you are playing in the bass clef. In the treble clef the first position is C."

"What?" exclaimed Biggs. "It's one note one time and another another?"

"In the treble clef," explained the musician, "the trombone is a B flat horn. In the bass clef it is a C horn."

Biggs mopped his brow.

"Say that again, will you?" he appealed.

"Don't you see?" came the answer. "When the first position is C it's a B flat horn. When the same shift is B flat it's a C horn."

Biggs unbuttoned his coat.

"You may call this thing simple," he said, "but if it is I'll give myself up at the nearest asylum. You are talking antonyms."

The musician grinned.

"We'll take one thing at a time," he said. "In getting at what a B flat horn is let's consider a cornet."

"Let's, if it's simpler," said Biggs hopefully.

"It's because it's always a B flat horn," replied the other. Then he added, "Except when it's an A horn."

Biggs gave a sickly smile.

"The lowest note on a cornet when open—when no keys are pressed down—is really B flat," said the bandman.

"But it is called C."

"That doesn't make it C," said Biggs. "For all practical purposes it does."

was the reply. "There is a reason for doing this, but it's complicated and at present I'm keeping to simple facts."

"Yes, indeed," murmured Biggs.

"In an orchestra, for instance, when the first violins are playing in C natural the cornetist's score is two semitones higher and is thus written in D or two sharps. When the violins are playing in D the cornet player is tooting in B or four sharps. But if things kept on this way the cornetist would soon be lost in a confusion of sharps and double sharps, so he slips an A crook on his instrument. That raises the signature three semitones. When the fiddles play in A or three sharps the cornetist is blowing along the easy path of C natural."

"Look here," said Biggs. "If my wife is playing 'Under the Pink Lilac Bush' on the piano, couldn't I play with her from the song score?"

"Not unless you can mentally transpose as you go along," said the musician. "The system looks queer at first, but it's logical. Its purpose is to bring the same music within the natural compass of all the instruments of a band or an orchestra. But if you are going to play the trombone you won't have to bother your head about any of this, as trombone music is nowadays always written in the bass clef."

"Then what have you been talking about it for and mixing me up?" shouted Biggs, jumping up.

"What are you getting mad about?" asked the trombonist.

"I'm not mad," replied Biggs. "I'm only going to make my will and buy an accordion."—Washington Post.

At the head of the table was the tea and coffee equipage, where she seated herself and sent the tea and coffee to the company."

The point of interest is that breakfast menu—five kinds of meat decked with sprigs of parsley and accompanied with divers vegetables. Isn't there an appetizing array and doesn't the heart long for just such a scene? Of course the mere feeders, the fellows that hanker for hot things, may not think so, but the very mention of cold ham, cold chicken, cold mutton and cold corned beef all in the same breath is an appeal to a conscientious appetite that is unresisting. ON A MAN-OF-WAR.
Hints to Landlubbers Who Want to Do the Proper Thing.

As you pass over the ship's side and step aboard, if you see a man touch your hat in salute to the flag. The officer of the deck, who represents the majesty of the nation while he is on watch, will return this salute.

Don't say "downstairs" or "upstairs." There are no stairs on board ship—only ladders. Say "below" or "on deck."

Looking forward—that is, toward the bow—the right hand is "starboard," the left hand "port." Everything on board ship is starboard or port, except with reference to a gun, where "right" and "left" are used as on shore, the gun being movable.

Keep clear of the starboard side of the quarter deck. The quarter deck is the after—or rear—end of the upper deck. Its starboard side is sacred territory, to be used by the admiral, the captain, the officer of the deck, other officers and men when there on duty and official visitors.

Never peep into the officers' private quarters. They are no more to be entered into than any private citizen's bedroom. They can be entered only upon invitation.

Keep your hands off the bright brass work, the polished guns and the clean paint work. Remember that jack tar has to be put in hard labor every day keeping these clean. Do not increase his work.

Do not expectorate on the decks. This warning is unnecessary to gentlemen, who do not expectorate in public anywhere.

Never dream of tipping a man who shows you about the ship. He is sufficiently rewarded by the entertainment he gives you. Men-of-war's men are not servants, and they resent a tip. The navy has pride.

Never take a lady up or down an "undressed" ladder. It is immodest for the lady. "Dressed" ladders have flags or canvas spread beneath them. "Undressed" ladders have no such screens.

Upon leaving the ship salute the flag as you come aboard.—San Francisco News Letter.
