## THE TOBACCO MARKET OPENS.

### BEGINS NEW SEASON UNDER FAVORABLE CONDITIONS.

First Day's Sales are Light, But Prices Very Satisfactory—Record of Warehouses and Buyers.

The Greenville tobacco market today began sales for the season of 1908-09 under most favorable conditions. Following the heavy storm of last week that put extra work on the farmers in taking care of their crop and made it too busy a time for them to get to market, large sales were not expected today, yet each of the five warehouses had very fair breaks and the opening prices were entirely satisfactory.

There were quite a number of people out at the warehouses to see how the market started off and to get an idea of opening prices, and several remarks were heard that if prices kept on as they started today the farmers will all be satisfied this season.

The first sale was at Parham's warehouse, then following in order at the Gum, the Liberty, the Star and the Centre Brick. The warehouses all had good forces, and the buyers came up with their bids like they are ready for business and anxious for tobacco. ## THE STATE PROHIBITION

### Law Must be Enforced—Elect Right Man for Legislator.

Wilson, N. C., August 1, 1908. To the Friends of Prohibition: The forces of righteousness have prevailed against the advocates of the saloon; and hereafter our fair State is to be free from the legal sale of liquor. This, however, does not mean complete victory. Only a portion of the liquor forces will quietly and freely submit to the law; others must be made to. On the part of some there will be a ready disposition to manufacture, sell and buy liquor in spite of the prohibition law.

Therefore it is incumbent upon us to see to the enforcement of the law we have championed. Duty demands that all good citizens defend the law, and oppose law breakers. It is better to protect the law than the lawless. It is wiser to shield the people from criminals than to shield the "blind tigers" from law. Let us, therefore, use our evidence and influence to convict any person who disobeys the prohibition law of our State. Then the liquor traffic will stop.

I desire further to put you on your guard with reference to representatives in our next general assembly. I am sure that the advocates of license will leave no stone unturned to carry their points and nominate men who favor license to represent your county. Already they are laying plans to this end. Be wise and cautious; and see that only temperance men who favor no-license are nominated and elected. Find the man who will properly fill the position and press him into the race. Only thus can we get the best possible men. By this measure we often get excellent men who would not otherwise become candidates. This is an all-important matter. See that your county does the safe and sane thing.

If the friends of prohibition fail to use their privileges and sit idly by, while the advocates of license work for and nominate through the primaries and county conventions, men of their choice, we can blame only ourselves when we meet reverses in the legislature. Work while it is day. It will be too late after the primaries are over; and this matter is entirely too important to be overlooked. We must give it thought and attention. Some men become candidates for representatives to the legislature in behalf of civic righteousness, even though it may mean personal and financial sacrifice. Help me to preach this doctrine.

## HYDROPHOBIA.

### Preventive Treatment—Announcement by the State Board of Health.

The general assembly, at its last regular session, enacted the following:

An act authorizing the State board of health to provide for the preventive treatment of hydrophobia.

Section 1. That the State board of health is hereby authorized and empowered to provide for and have conducted under its direction the preventive treatment of hydrophobia or rabies, whenever in its judgment circumstances, financial and other, will justify it. To meet the expenses of this treatment the said board is hereby given authority to supplement the revenue derived from fees for the treatment by such sums from the treasury of the State laboratory of hygiene as may be necessary: Provided, that the usefulness and efficiency of the said laboratory is not thereby impaired.

Sec. 3. That the benefits of said treatment shall be given free of charge to all residents of the State who shall present to the secretary of the State board of health, or its representative having in charge the management of this special work, an affidavit of inability to pay, duly sworn to and subscribed before a justice of the peace, or, if the case be a minor, such an affidavit by the parent or guardian. To meet as far as may be the expenses of this special work, the said State board of health is hereby authorized and directed to demand from those able to do so the payment in advance of a reasonable fee, not to exceed in any case the usual charge made by the reputable Pasteur institutes of this country.

The board of health, at its recent annual meeting, decided that circumstances would now justify the treatment.

The following extract from the circular of information issued by the laboratory of hygiene gives the necessary details:

Rabies—in no other disease is an early diagnosis of more vital importance. Fortunately, a diagnosis can in most cases be made from a microscopic examination of the brain of the rabid animal. The suspected animal, or its head and neck, should be sent at the earliest possible moment to the laboratory for examination. The head should be packed in ice to prevent putrefaction, and should be sent by express, prepaid. A careful account of the animal, with a full history of cause of suspicion, should be sent in every case.

The treatment will require the presence of the patient in Raleigh for about three weeks, but residence in a hospital is not necessary. The cost of the entire treatment will be \$50, or will be furnished free to persons unable to pay, upon submission of an affidavit of inability to pay, duly sworn to and subscribed before a justice of the peace, or, if the case be a minor, such an affidavit by the parent or guardian.

Attention is called to the fact that the law requires the fee to be paid in advance. It should be said also that, if after trial it should be found necessary for the support of this special work, the fee will be increased. This work will be in charge of Dr. C. A. Shore, director State laboratory of hygiene, and all communications on the subject should be addressed to him at Raleigh.

## WATERLOO.

The Immutability of the Famous Old Battlefield.

One of the most striking features of a visit to the battlefield of Waterloo today is the immutability of the entire scene in which one of the greatest battles of history took place. Notwithstanding the many years that have passed since the memorable day of June 18, 1815, the entire scene of the battle remains practically unchanged and untouched, and the very buildings around which the tide of battle surged the fiercest, save for the necessary restorations of the damage they sustained in the conflict, remain exactly as they were, nor has any encroachment of building or progress marred the historic field.

The battlefield of Waterloo is an open, undulating stretch of good farming land. On the day of the battle the greater part of it was covered with crops of rye, wheat, barley and oats, and the same crops are still grown there each season. The field is intersected by two highroads branching at Mont St. Jean, the one on the right leading to Nivelles, while that on the left, which lay in the center of both armies, led south to Genappe, Charleroi and Namur. Upon the crest of the ridge which formed the first of the allied positions a crossroad runs east and west. This road, on approaching the spot where the "Lion of Waterloo" now stands, ran through a cut in the crest some twelve to fourteen feet deep, and it was this point that was known after the battle as the Hollow Road. Some 500 yards to the southeast of the "Lion" is the farm of La Haye Sainte, while about 900 yards to the southwest stands Hougomont, the old chateau, farmhouse, outbuildings, walled garden and orchard, which played such an important part in the fate of the day. These buildings are nearly 300 years old and were built with a view to their defense, as many old stone loopholes still to be found testify. — Robert Howard Russell in Metropolitan Magazine.

# LUDWIG THE LUNATIC

Patti Once Threw Him Into a Frenzy of Madness.

## A FREAK OF THE CRAZY KING.

He Frightened and Enraged the Great Diva by His Strange Whims, and When She Finally Sang For Him in Munich It Drove Him Wild.

When Patti was in the first heyday of her fame Ludwig II, the mad king of Bavaria, set his heart on having her sing for him at his private auditorium in Munich. He wrote letter after letter, begging, imploring, offering extravagant sums of money, but Patti resolutely refused to go. 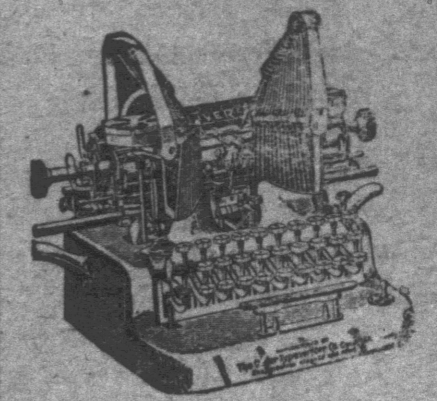

## SHOE BUCKLES.

Picturesque and Costly Craze of the Eighteenth Century.

Once on a time your shoe was nothing without the buckle. Indeed, it was a case of the "tail wagging the dog," for the buckle was the attraction and the shoe but the accompaniment. Be it observed that at first, however, it was not the size, but the costliness of the buckle, which was conspicuous. Thus among royalties, people of high rank and those who were the glass of fashion and the mold of form at court wore diamonds. Needless to say that then, as now, those who desired to imitate them wore paste buckles, happily perhaps in that self complacency which imagines nobody else shrewd enough to estimate possibilities.

In 1720 a leader of fashion would wear a full flowing curled wig reaching in ringlets halfway down the back and arms, a laced coat cut straight, with buttons put on in every possible place—thereby, by the way, affording a remarkable similarity to the "pearlies" of the popular and up to date costermonger—and square toed black shoes, with an enormous flap on the instep, high heels and on the flap a small but brilliant buckle. Next to the buckle of brilliants came that of gold. Rich landowners and equally rich merchants, men whose reputation for being "warm"—or, in the then recent Alsatian fashionable slang, "rhinocerial," a quite obsolete synonym for money—was universal, wore gold buckles larger than the diamond ones, but still small in proportion to the flaps.

Your thriving shopkeepers wore buckles of silver and your opulent farmers those of shining steel, and the poorer classes had buckles of brass or iron, but of some material every one wore buckles on the shoes. Indeed, so wide reaching was the depreciation in buckle makers' work when, at the epoch of the French revolution, people in general followed "Roland the Just's" example and took to shoe ribbons that the buckle makers actually, in their desperation, petitioned George III. and parliament that shoe ribbons should be forbidden under penalties, clamoring for a renewal of the sumptuary laws of Plantagenet and Tudor, with an apparent inability to read the signs of the time. A spasmodic attempt was made by the princes and their entourage to benefit the buckle makers by wearing buckles as ostentatiously as possible, but ribbons, decidedly far more unpicturesque, though much more practical, carried the day.—St. James' Gazette.
