## THE GREENVILLE TOBACCO MARKET LARGE GAINS MADE IN PAST FISCAL YEAR.

Report of President Jeffress to Tobacco Board of Trade Makes Gratifying Showing.

To the officers and members of Greenville Tobacco Board of Trade:

Your president begs leave, in accordance with the usual custom, to submit for your consideration, this his annual report as follows:

First. That during the fiscal year just closed, that is from August 1st, 1907, to August 1st, 1908, there was sold upon the various warehouse floors of this market, 11,089,000, pounds of tobacco, at an average price of \$10.45 per hundred pounds, including scrap tobacco. During the year beginning August 1, 1906, and ending August 1, 1907, there was 8,855,795 pounds of tobacco sold upon the various warehouse floors at an average price of \$9.90 per hundred pounds; showing, as you will see, a gain of almost 3,000,000 pounds over the previous year, and also a gain of \$0.55 per hundred pounds in price, even including scrap tobacco.

Second. During the past year the Greenville tobacco market was in better condition than it has ever been before in my knowledge. There was no friction in our board—everything was harmonious and there was no friction between the warehousemen, the buyer, and the farmer; and lest I might forget it, I desire to thank the members of this board, both warehousemen and buyers, for their uniform courtesy and kindness to me, and for their aid in assisting me in enforcing the rules and regulations of this association.

Third. This market made a larger increase in the number of pounds sold than any other market in Eastern North Carolina. Greenville is now the third largest loose-leaf tobacco market in North Carolina; Greenville has buyers representing all the largest purchasers of loose-leaf tobacco in the world, such as the American Tobacco Company, the Imperial Tobacco Company, the Japanese Government, and also the large and strong corps of buyers representing independent buyers and speculators.

Fourth. From the viewpoint of the farmer the tobacco warehousemen of this market are the equal, if not the superior to any in the State, oftentimes spending a large per cent of their legitimate commissions and profits in their zealous endeavors to see that each pile of tobacco sold brings its full value, and oftentimes they make it bring more than its market value, by buying the same and disposing of it at a loss.

Fifth. This market is fully equipped with all modern conveniences, buildings and machinery, and can easily handle from fifteen to twenty millions pounds of tobacco annually without any inconvenience to buyers or warehousemen and without detriment to the interest of the producers; and in these particulars the Greenville tobacco market has a decided advantage over most all the other loose leaf tobacco markets of the South.

Sixth. The only criticism that I desire to make in respect to this tobacco market is the apparent lack of interest of the business men, doctors, lawyers, ministers, bankers, and all other classes of citizens of the town not

directly engaged in the tobacco business; but it gives me great pleasure to state that despite this lack of co-operation of the people of Greenville this market has made larger gain in almost every particular for the past three years than any of her sister markets. And this is due, in my opinion, in part to the splendid equipment for taking care of the tobacco crop and the high prices paid for the tobacco upon the warehouse floors.

Seventh. Some of the members of this association do not recognize that a great majority of the citizens of the town have no conception of the immense tobacco business we are carrying on here; and if you will but take the report of your secretary and multiply the numbers of pounds sold by the average price per pound for which it was sold, and add to this the expense of the purchasers, of hauling, reordering, stripping, and packing, and the total account paid out in the town during the past fiscal year on account of the tobacco sold and purchased upon this market, the sum so expanded will approximate \$2,000,000, which is many times larger than any other class of business in the entire county.

Eighth. I desire to urge upon every buyer to be as courteous, polite, and attentive to the farmers marketing tobacco upon this market, as his duties will permit—I know of no discourtesy by any buyer to any producer; but I suggest that more attention be shown them by the buyer.

Ninth. It becomes my sad duty in concluding this my annual report to call your attention to the death of a former member of this board, Mr. George S. Prichard, at Panacea Springs on the 31st day of May 1908. In the death of Mr. Prichard this board has sustained a very great loss is deprived of the advice and services of a highly esteemed and valued member; and I would suggest that a committee be appointed to draft suitable resolutions in respect to his death, and that the same be spread upon our minutes, a copy mailed to the deceased's family, and the same published in the local newspaper.

Mr. Wade, as he dragged his great chair up to it, said a bit sharply:

"Herrick is taking a long look ahead perhaps,—” A silence fell; then I distinctly heard the three slow taps of his forefinger on the bare table, as he finished with emphasis, "That man—will go far—watch!"

The clock struck, my mother's toe touched me warningly. I arose, fairly trembling with excited interest in the man who was going to be very wealthy, who lived right across the street, and who was "going far." Even in the first confusion of thought, I almost prayed he might not start before I could see him. ## COMMITTED SUICIDE.

Mr. Frank Harris Ends His Life by Jumping in a Well.

On Monday about noon Mr. Frank Harris, who lived at the home of his son-in-law, Mr. Jesse Hardee, in Swift Creek township, committed suicide by jumping in a well. Mr. Harris had been in feeble health for some time and had on one or two previous occasions threatened to take his life. To prevent him doing harm to himself one of his grandsons was kept close by to watch him. Monday he was out in the yard under the shade of the trees with the little boy. Mrs. Hardee called her son to get something for her, and when the boy returned to the yard a few minutes later Mr. Harris was missing. After a short search his body was found in the well.

Mr. Harris had gone to the well, and being to feeble to climb over the top of the curb he had pulled off some of the planks to make the curb low enough for him to step in. He fell in the well feet first, and when found was in an upright position with the water reaching to his eyes, and his hat had not been displaced from his head by the fall in the well.

### Forest Service Appointments.

The Forest Service of the Department of Agriculture announces that thirty nine young graduates of nine American forest schools have lately received appointments as assistants in the forest service and have been assigned to positions for the present field season. The new appointees are drawn from the various forest schools as follows: Yale 18; Biltmore, 5; University of Minnesota, 4; University of Michigan, 4; Michigan Agricultural College 3; Harvard, 2; Cornell, 1; University of Iowa, 1; and University of Nebraska, 1. They have secured their appointments as a result of passing the regular civil service examination, which is the only avenue to employment as a forester under the government.

**OLD CLOTHES IN AFRICA.**

The Natives Often Make Dreadful Mistakes With European Attire.

The "ol' clo' man" is a familiar figure in American streets and one by no means without picturesque quality, but no American dealer in old clothes has established a business of such extent of interest as that of John Hyman of London, whose specialty is to purchase showy costumes and discarded military and official uniforms for disposal in the orient and Africa.

Even the retiring lord mayors of London have become almost by official tradition his customers, and the cocked hat, gold laced coat and knee breeches at which during one season London has gazed with awe in the famous pageant of the lord mayor's procession are likely the next season to delight the eyes of darkest Africa upon the proud person of a darkest African.

"I have visited most of the great oriental bazars and watched our goods being purchased," says Mr. Hyman. "I have seen blacks solemnly walking around with waistcoats buttoned behind instead of before and even men wearing ladies' costumes. I have seen enormously big fellows in clothes so small I could not imagine for the life of me how they got into them or how they could get out again unless the stitching gave way."

The Prince de Joinville when off the Gabon coast once received on his ship an official visit from two chiefs, father and son, who must, one would think, have been Mr. Hyman's customers. They were known as Big Denis and Little Denis, and each owned for ceremonial occasions a military uniform.

That of Big Denis was a French general's, which his wives managed to get him into. That of Little Denis was a Hussar's, and its intricate cut, numerous buttons, straps and buckles and painfully small size proved quite too much for him. He sent the prince a despairing message begging help, and a relief party of delighted midshipmen was sent to dress him and bring him aboard.

They fulfilled their errand; but, with the mischievousness of their kind, they so tightened every fastening of his overtight attire that the poor youth was nearly bursting with combined pride and suffocation when he arrived, and it was evident he could never be got out of his unwonted finery by any method less drastic than cutting him out.

Still, no manner of wearing a complete costume ever equals in comic effect some of the savages' combinations of unrelated items. One venerable African chieftain received his European guests with an antiquated evening shoulder cape of pink flowered satin and spangles worn about his waist as an apron, while his white wool was martially crowned by a military helmet.

Still another conducted important negotiations with an exploring party clad simply and impressively in a lady's large Gainsborough hat, a pair of cavalry boots and a necklace of glistening tin ornaments used to decorate Christmas trees.—Youth's Companion.

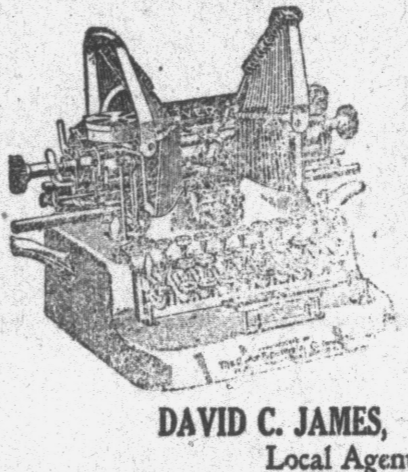

**THE VATICAN.**

Home of the Popes is the World's Richest Depository.

The Vatican covers a space of 1,200 feet in length and 1,000 feet in breadth and is the largest palace in the world. It is in Rome, on the right bank of the river Tiber, and on the Vatican hill, from which it derives its name. It is said to have been founded by Pope Symmachus, who erected a small house on its site about 300 A. D. On this site, too, a building was inhabited by Charlemagne in 800.

Several times it has fallen into decay and been restored. Pope Eugenius rebuilt it on a magnificent scale in 1160. In 1305 Clement V. removed the papal see from Rome to Avignon, and the Vatican was in a neglected and obscure state for many years.

Nicholas V. in 1450 commenced the great work of making it the noble palace that it now is. After the return of the pontifical court to Rome it became the actual residence of the pope. One after another a long line of popes have added splendid buildings to it, and at present the lowest estimate gives the number of rooms at 4,423.

Gradually it has been enriched with great paintings, statues, books, curious medals, gems, frescoes and antiquities of every description until it is now the world's richest depository. The museum of statuary is about a mile in length and contains more than 70,000 statues that have been exhumed from the ruined temples and palaces of Rome.

The Vatican contains the Sistine chapel, built by Sixtus IV., 1473, and adorned by the wonderful genius of Michelangelo; the Pauline chapel, built by Paul III. in 1540; the Loggia and Stanze of Raphael and the court of the Belvedere.

The library of the Vatican is truly a great one. It is exceedingly rich in manuscripts, containing as many as 40,000, some of which are by Pliny, St. Thomas and St. Charles Borromeo and many Hebrew, Arabian, Syrian and Armenian Bibles. It has about 50,000 printed volumes and several rich museums of ancient and modern articles of vertu.—Exchange.
