DAMAGE FROM FLOOD.

Streams Overflowing and Crops are Suffering.

Raleigh, N. C., Aug. 25.—There is much apprehension here as to the effect of continued heavy rains on the crops. Low lands corn and other crops are already badly damaged by overflow on the streams throughout this section and the rain continues with no indication of any change for fair weather at least for forty-eight hours. Streams throughout the county are overflowing the low lands and if the rains are to continue for many days the upland crops of cotton, corn and other crops will be very badly damaged. The rain fall for 24 hours up to 8 this morning was 2.72 inches. The rains are heavy throughout the inland sections of the State and are stretching from Texas, through Georgia to this State. Advices from Fayetteville today indicated that the Cape Fear river was rising steadily, being now at 26 feet with indications that flood gage would be reached Wednesday morning, that being 30 feet. Tar river at Greenville is rising steadily, being already up eight feet or more, and Roanoke river at Weldon was 13 feet above normal and steadily rising. There is no indication of clearing weather for 48 hours at least according to the weather bureau authorities.

Lumber Road Discontinues.

The Kinston Lumber Company today discontinued operation of the Kinston-Carolina Railroad and all passenger and freight service has been abolished. Notice of the discontinuation of the road was made public last week, and was pursuant to an order of Mr. George L. Roper receiver of the road. The reporter has been unable to obtain any information at the offices of the company in this city. There is a rumor current on the streets today, that the company has notified the Norfolk and Southern Railroad of the discontinuance of the road and instructed them to take the rails—which were leased to the Kinston Carolina by the Norfolk and Southern some time ago. It is also stated semi-officially that the right-of-way of the railroad is the property of the A. and N. C. Company. It has been suggested that there is a strong probability of the Norfolk and Southern taking over and operating the road.

Officials of both companies seem very reticent when approached for information. In fact, to one's inquiries the inevitable reply is, "we don't know anything about it." There is a wall of protest going up from the people living along the line and a petition is in circulation requesting that the federal judge order the continuance of operation, for the present at least. The heaviest sufferer along the road is the Rutledge Lumber Company, which is practically bottled up, without any practical means of getting its lumber to market. It is said that the Rutledge mill has already 1,000,000 feet of lumber sawed and ready for market.—Kinston Free Press.

Wife of Baptist Missionary Dies in China.

Durham, N. C., Aug. 24.—A telegram has been received by Capt. J. F. Freeland, chief of police, telling of the death in China of his daughter, Mrs. Lula Bryan, wife of Dr. R. T. Bryan, a well-known missionary of the Baptist denomination. Mrs. Bryan had been afflicted for several months and her death was expected. She was 45 years of age and has four children, three in China and one in Mississippi, where she is being educated. She left in addition to her husband and four children, father, four half-brothers and four half-sisters. Mrs. Bryan went to China in 1884, immediately after her marriage to Rev. Mr. Bryan, and has paid two visits to this country since then. The cablegram telling of her death came to the daughter in Mississippi and a telegram sent here told the father of the death. She died several days ago. The interment takes place in China.

CHANGE ON N. & S.

All Trains to be Dispatched from New Bern.

Orders have been issued from the Norfolk and Southern in Norfolk, that completely changes the present system of train dispatching on this road. Under the new order, beginning September 1st, all trains will receive orders from the New Bern office. The new order means the abolishing of the dispatchers' offices now existing on the several divisions of the road—at Belhaven Mackey's Ferry, Raleigh and other points.

As a result of this change of dispatching all trains from this office, extra help has been sent here ahead of time to get familiar with the condition, and some of the dispatchers here have been sent out over the road to learn the routes and familiarize themselves with these divisions.—New Bern Sun.

Humane to Your Horse.

The late Judge Dossey Battle, while he was editor of a Tarboro paper, set on foot the influence that gave us our statute against cruelty to animals. This paper has many times insisted that the law should be enforced. The Wilmington Star recently said: "Because your horse when left standing in the broiling sunshine for several hours these hot days makes no complaint, as would a man under similar conditions, is no reason why you should think that your horse does not suffer from the heat under such circumstances. 'Love me, love my dog' in such weather as this is to 'Love yourself, love your horse.' We have seen instances during this hot spell where owners or drivers of horses have seemed to take it for granted that those animals are not sensitive to heat, that they do not suffer when required to stand in the heat of the sun for such a time that were the man who forced them to do so required to do the same by some one who had the power to do so he would complain bitterly of the inhuman cruelty, were he left vocal power enough to do so after the fearful experience. In this awful weather have regard for the comfort of those dumb beasts, you who have control of them. Remember that they, as well as human beings, suffer from the heat and try to make life for them as comfortable as you do for yourself. The humane man will in this fearful weather look out for the comfort of his horse; the human brute will seek the shade for himself while he will leave his faithful brute companion to suffer in the sun without one thought of his comfort."—Scotland Neck Commonwealth.

HEAVY RAINS CAUSE DAMAGE.

River Overflows Lowlands—Washouts on N. & S. Road Annuls Trains.

Mr. C. V. York, the weather observer here, says that for the twenty-four hours ending at 8 o'clock this morning the rainfall was 1.10 inches, and for three days it was 4.78 inches. The river rose 3 feet in the preceding twenty-four hours, and 6½ feet since Sunday, the water reaching the 11.1 foot gauge this morning and continues rising.

The water in the river is so high that the ferry cannot be operated and passage suspended for the time being.

The railroads are troubled much by washouts and trains on this division of the Norfolk & Southern were annulled today. No trains from the west passed here Tuesday, and those from the east had to stop at Wilson. The Atlantic Coast Line trains are fairly regular so far.

Crops have suffered materially from the excessive rains and the flooding of lowlands.

LEPER FROM THIS STATE.

In Lonely Tent on Banks of Potomac—Awaits His Fate.

Washington Aug 25—With his religious faith his only solace, Jno. Early, a leper, is isolated in a lonely tent on the Potomac river, where, guarded day and night, he awaits his fate. At Lynn, N. C., his wife and child face the horror of becoming victims of the disease. The health authorities are taking steps to get him out of the country. They have appealed to the North Carolina health authorities to have him removed to his home. He may possibly be sent to the leper colony in Louisiana. It is supposed that Early caught the disease in the Philippines. He is an ex-captain in the Salvation Army, and conducted services at Oswego, N. Y. He recently worked at Lynn, N. C., where his family now resides.

The discovery of the case was made Friday, but the facts were not made public by the health department until yesterday. Early has been placed in a tent especially erected for his isolation in the rear of the small pox quarantine station near the district jail on the bank of eastern branch of the Potomac. He will be kept there under guard, until cold weather comes when if necessary a house will be built to make him more comfortable. He has been supplied with bed clothes and clothing and utensils necessary for living. His food is carried to him and poured into the vessels supplied for his personal use.

Early asked the health department to keep from his wife information as to the character of his illness. This being impossible he expressed a desire to return to his wife and child and to be permitted to die near them. "If this is not possible then I am perfectly willing to remain right here or anywhere else the authorities may say until the end comes," said he.

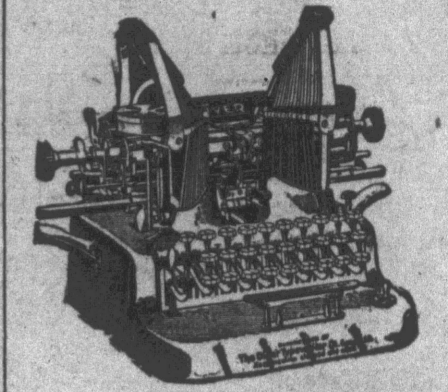

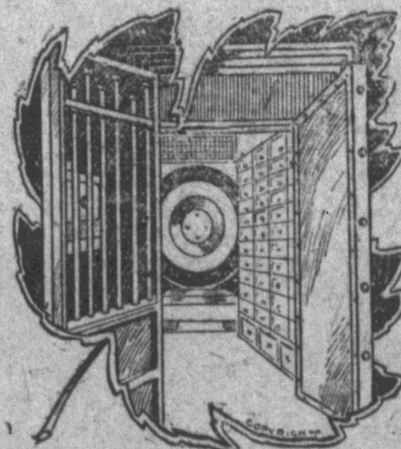
