TOBACCO CO. QUILTS KENTUCKY.

Night Riders Win Trust Fight, But it May Cost State Millions.

Victory which may cost Kentucky millions of dollars in trade is now conceded to the night riders who for many months have waged war with fire and rifle against the American Tobacco Company. It is now said the tobacco company has decided to give up the fight and withdraw from the State.

This means that the company will start a price war with the growers in Kentucky, and the far reaching effect of such a battle has caused consternation among the local tobacco men.

According to reports given out this afternoon the American Tobacco Company has withdrawn its twenty-two country buying agents from Kentucky. Further more, it is known that the company intends to open up headquarters in Cincinnati. Officials of the American Tobacco Company decline to discuss the outcome of the move.

Louisville has been the largest tobacco market in the world, thousands of more hogheads of tobacco being handled on the local "breaks" annually than at any other point. It is generally believed that the numerous night rider troubles and the intense feeling which exists against the American Tobacco Company at many places has caused the officials of the company to withdraw their country agents from the State.—Louisville, Ky., Dispatch.

All this time spent in college and in making money with which to pay his debts cuts into his life considerably; and to settle upon the wisest course is no trifling question. But there are two sides to it. Asheville, N. C., Aug. 26.—It is learned here that Mrs. Moore and Miss Moore, mother and sister of the late Judge Frederick Moore, are desperately ill of typhoid fever at Brass-town. It is said that they have been so ill that they have not yet been acquainted with the death of Judge Moore.

Wilmington, N. C., Aug. 26.—This morning shortly after ten o'clock Mr. Charles N. Hudson, a well-known and prominent young citizen of Raleigh, was drowned at Wrightsville Beach just to the north of the Atlantic Yacht Club, and this terrible tragedy has cast a pall of sadness over the resort.

A remarkable phenomenon happened in New Hope township Saturday, when the 15 months old daughter of Mr. and Mrs. L. B. Hines went to sleep with her hair of light, flaxen color, and by her awakening within a half hour the hair had changed to auburn. No one is able to account for this extreme change.—Goldsboro Headlight.

Asheville, N. C., Aug. 26.—Another serious accident occurred at the government building works this afternoon about 5 o'clock, when a scaffold on which a man named Sprouse and another brickmason were standing, was struck by a heavy falling stone and sent crashing to the ground, a distance of probably forty feet. Only Sprouse was injured and his injuries will not prove fatal.

Georgia Dam Breaks

Atlanta, Ga., Aug. 26.—The floods in the Carolinas and Georgia culminated today in the breaking of the big dam six miles from Augusta which diverts the water from the Savannah river into the canal at that point. The great flood of water let loose soon found its way into the city, and tonight from Fifteenth street to Eastern Boundary, Augusta is under from 6 to 12 feet of water, which is gradually rising.

Looks Like End of the Storm.

There was a steady rain through nearly all of Wednesday night, but not so heavy as the previous fall. It ceased raining early in the morning and none has fallen since up to this writing at one o'clock. At eleven o'clock this morning the water in the river had reached 134 feet and was still rising. Indications now look like the storm is over and there will soon be better weather.

Trade Report.

Bradstreet's Saturday will say for Richmond and vicinity:

Unseasonable weather has to some extent had a deterring effect on trade generally this week. Wholesale dealers in dry goods, notions and kindred lines report orders increasing in number and of fair volume. Stock in hands of dealers in rural districts are reported much depleted. Produce is dull. Retail trade has been retarded by continued rain absence of many from the cities. Cannery are reported operating at full capacity, fruit and vegetables for this purpose being plentiful in most localities.

CROP REPORT.

In Virginia, tobacco has been somewhat injured by wet weather and the corn crop damaged by wind and flooded river lands. In North Carolina, tobacco is being marketed in moderate quantities at fair prices, but the offerings have been principally of the cheaper grades. Peanuts are reported in good condition. Collections continue slow.

ELECTION CAMPAIGNS.

Modern Methods Started With the Advent of Jackson.

Jackson left his mark on all that he touched. With his advent a new regime was inaugurated. Its coming was accompanied by new methods. The presidents who preceded him were educated, polished statesmen. They were of the aristocracy. When their aspirations for the presidency were voiced in stately fashion by friends a measure of dignified decorum was observed in the spoken or printed expression of hopes and claims.

Campaigning in the modern sense was unknown. Conventions had no existence. Platforms declaring the principles and policies to which the candidate pledged himself had not yet been formulated. Political cartoons, caricatures, great mass meetings, flamboyant flaunting of flags, taunting transparencies, parades, campaign songs, brass bands and buttons—these played no part in the election of Washington, Adams, Jefferson, Madison and Monroe.

They were lacking in even the campaign of 1824, when Jackson was first a candidate, though the house of representatives defeated the popular will, which had named him as its choice, by selecting John Quincy Adams to fill the presidential office.

But in the campaign of 1828 the general, who had done things differently at the battle of New Orleans, seems to have stimulated in men who advocated or opposed him a desire to follow new methods.

Jackson's first successful campaign in 1828 was opened by a celebration of his famous battle in the city of New Orleans. Hero of the battle and presidential candidate, he attended as the guest of the state. On his way from his home he was entertained at Natchez. A procession, a banquet and a ball kept him busy. A fleet of steamers was sent from New Orleans to meet him. A throng greeted him when he landed. Four days of festivity, news of which stirred the people throughout the land, followed.

This was the beginning. With his campaign for re-election modern methods were fairly established.—St. Louis Republic.

Tennyson's Humility.

The poet Tennyson was gifted with the grace of humility. His letters disclose his dissatisfaction with himself and his achievements. He pitched his ideals high, and he knew, none more clearly, when he failed to grasp what he had reached after. An anecdote contributed by the Duke of Argyll and quoted by Miss Cary in her volume, "Tennyson," exhibits the poet's humility.

"The first words I heard him utter," says the duke, "remain indelibly impressed upon my memory. On being introduced to him at an evening party in the house of Lord John Russell I said, perhaps with some emotion:

"I am so glad to know you!"
"Not in the tone or voice of a mere conventional reply, but in the accents of sincere humility, he answered:
"You won't find much in me, after all."

FISH SUPERSTITIONS.

Over Old Time Notions, Some of Which Still Survive.

The one fish medicine of which modern science thoroughly approves is cod liver oil, and this, though in far less nauseous form than formerly, is swallowed in tons every year.

In old days a much wider use was made of fish as cures for various evils, and some of these practices have survived to the present day. Some little time ago a boy died of epilepsy in a north Wales parish. The doctor, called in too late, inquired if the deceased had been given any medicine. "Oh, yes," was the answer. "We caught a trout, drowned it in new milk and gave it to the boy."

Eels are supposed to possess all kinds of virtues. In the dark ages of medicine a powder made of eels' livers was considered an absolute specific for deafness and was also employed in cases of ague or fever. A decoction of eels' fat is still used by Dutch peasants as a remedy for falling hair.

But the most valuable part of the eel, according to popular superstition, is its skin. Many an old farmer wears a belt of eel-skin as a preventive against rheumatism, and some believe that a garter made of the skin of this snake-like fish worn next to the human skin as a preventive not only against rheumatism, but also against sprains or similar injuries.

Another cure for rheumatism, which finds favor with salt water fishermen, is a red herring. The herring being the most plentiful of all the sea fish, a number of superstitions have attached themselves to it. For luck through the ensuing year one must be sure to eat a herring on New Year's day.

Fishermen believe that each shoal is headed by a king herring, which is more than double as large as any of its followers. They believe that when one of the "kings" comes up in the net it should be thrown overboard; otherwise the next day's fishing will be a failure.—Pittsburg Gazette-Times.

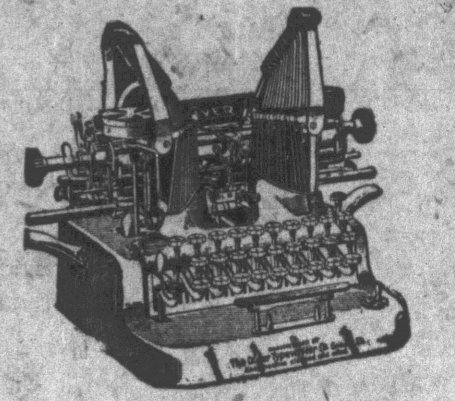

THE IDEAL HEIGHT.

For a Man It is an Inch and a Half Under Six Feet.

Recruits who are much over six feet tall are not desired for the United States army. There are exceptions, of course; but, as a rule, men who run much over six feet lack depth of chest and by reason of inadequate lung capacity fall below the average in power of endurance.

The ideal height for a man, according to observations from a military point of view, is an inch and a half under six feet. It does not seem to be intended by nature that the male human animal shall exceed this stature if due regard is to be had for development at all points. On the other hand, it is an obvious disadvantage for physical effectiveness to be under the average number of inches. At five feet ten and a half a man attains his best development of muscle and bone, with highest vital efficiency.

Just what is the average height for a man seems to be not satisfactorily settled. Obviously it differs largely with race, we and the Japanese representing among civilized peoples the two extremes. On the other hand, the American Indians are taller than we are, and the aborigines of Patagonia are the loftiest folk in the world, inasmuch as the men commonly run over six feet in height. When the early Spanish explorers described them as a race of giants they were not far from the fact.

Even in the United States the stature seems to vary considerably with locality. During the civil war, from the beginning to the end of which our government put into the field and on board of fighting ships more than 2,500,000 men, the tallest recruits came from Kentucky, averaging over five feet eight and a half inches. Kansas, Minnesota, Missouri, California and Nevada came next in the order given, all of them over five feet eight. Maine, Illinois and Michigan averaged five feet seven and four-fifths inches and Ohio and Pennsylvania a trifle less. Recruits from Massachusetts and Connecticut stood at the foot of the list, measuring five feet six and a half inches.

After fifty years of age the human body begins to undergo a progressive shrinkage. Not only do the muscular tissues lose bulk, but even the bones become smaller. Meanwhile there is a contraction of the cartilaginous tissue between the vertebrae of the backbone, which causes a loss of height, a man originally six feet tall frequently losing as much as an inch and a half of his stature by the time he is seventy years old.—Saturday Evening Post.

New York the American Venice.

It is a surprising thing to know that New York city, although not known as the American Venice, contains more islands than any city but Venice, for within its boundaries are thirty-one separate and distinct islands, most of which, encircled by deep water, will afford unlimited shipping accommodations and dockage for the commerce of future years to reach undreamed of proportions, judging from past and present growth.—National Magazine.

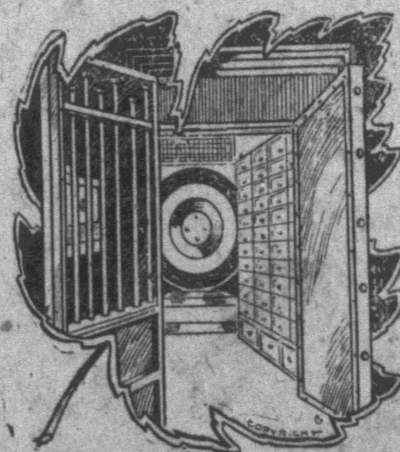
