RIVAL TO MUNCHAUSEN.

Col. Dockery Explains Peculiar Disappearance of Milk.

Col. H. C. Dockery, of Rockingham, who is here attending the Farmers' convention, broke up the meeting yesterday afternoon with one of the Munchausen narratives.

Col. Dockery started off by asking how many of the farmers present had ever had black snakes to relieve their cows of the milk. On receiving several answers to his question, he related his peculiar experience. He had noticed his cows coming in every afternoon without any milk. This mysterious disappearance of the milk continued for several days and no explanation could be given by the boy attending the cows. The boy was given a shotgun and told to shoot the first man or beast that even looked cross-eyed at his cattle. But that afternoon the cows came in dry as on previous afternoons.

Mr. Dockery became alarmed by the State of affairs and determined to find out for himself the cause of the lack of milk. In accordance with his determination, he himself went down to the pasture and stayed with the cows all day and nothing happened to arouse his suspicion until the cows went into the river to take their afternoon draught. When they went into the water their bags were full, and when they came out the milk had disappeared. He remembered seeing quite a rattle in the water when the cows waded so he had an idea what was happening.

Next day he hung some fish hooks to each of the cow's bags and sat down by the river to await results. The cows waded in the usual rattle accompanying their entrance, and when they had finished drinking it was with great difficulty that they came out of the water. To the surprise of everybody around, about a dozen huge eels were hanging to each cow. The convention stamped and a motion to adjourn was passed by acclamation. —Raleigh Times.

Trade Report.

Richmond, Va., Sept. 4, 1908. Bradstreet's Saturday will say for Richmond and vicinity: Trade generally has been retarded by unfavorable weather conditions and crippled transportation facilities in this territory for the past week. Fair orders for dry goods are being received, though a falling off since last week is noted in the lumber industry. Dealers in building material have had a satisfactory season; however, building operations are less active than at any previous time this summer. The produce market shows slightly more activity, dealers are anticipating an active fall trade. Increased sales of tobacco are noted in North Carolina and price compare favorably with the same season of last year. Retail trade is dull. Collections continue slow.

CROP REPORT.

Heavy rains and flooded lands have greatly damaged crops throughout Virginia and North Carolina, though not to the extent that was first reported. In some sections of North Carolina the damage to cotton is reported twenty per cent. The damage to the tobacco crop in Virginia will average about ten per cent. The hay and corn crops on flat lands have been greatly damaged.

STATE NEWS

Items of Happenings Over the State Gathered from Our Exchanges

Williamston, N. C., Sept. 3.—The marriage of Mrs. Dennis Simmons Biggs to Mr. James Grist Staton took place on Wednesday morning in the church of the Advent, Bishop Robert Strange, celebrant, assisted by the Rev. William J. Gordon, rector of the church.

Asheville, N. C., Sept. 2.—In the county primaries held here today to nominate a successor to the late Judge Fred Moore, of the Fifteenth Judicial District, Judge J. D. Murphy, of Asheville, defeated the Hon. J. S. Adams by a conventional vote of 13. Mr. Adams' managers say they will contest some of the precinct returns. Adams carried the city of Asheville, but Judge Murphy led in the county.

Kinston, N. C., Sept. 2.—Mr. O. W. Patterson, a bookkeeper for the National Bank of Kinston, was drowned in Neuse river this afternoon about 5 o'clock. Mr. Patterson was out on the river in a small gasoline boat with Messrs. C. E. Spear, C. W. Pridgen and Asa Hawkins. When nearing the county bridge the swift current swept the boat irresistibly onward toward the bridge, the floor of which was only about three feet above the surface of the water. Striking the sustaining rods of the bridge the boat was capsized. The other gentlemen saved themselves by grasping the structure of the bridge, but Mr. Patterson is supposed to have sustained a stunning blow on the head, which rendered him unconscious. He was seen to rise to the surface feet foremost one time since, but his body has not been found.

The Cost of The Flood.

Although it is now near a week since the cessation of rains, yet we read that the floods are just about reaching Kinston, in this State; Georgetown, in South Carolina, and some other places similarly situated. Who could now doubt the impending danger to a vast area of fertile and populous country by the continued destruction of the forests in the mountains and in the upland country? In the States of North Carolina, South Carolina and Georgia, the production of cotton approximates from three to three and one-half million bales. None could doubt that out of the three and one-half million bales, more than one hundred thousand bales have been lost by the flood. Here is at once five million dollars value gone on one commodity. Adding to this the value of other crops, of railroad and county bridges lost, of damage done in such cities as Augusta, the aggregate cost of the flood cannot be less than \$25,000,000. Yet Congress stubbornly neglects an appropriation of \$5,000,000 to make a beginning on a forestry system. It is not alone that this beginning might save further destruction in the Appalachian and White Mountains, but it would be a beginning on plans that would extend all over the United States. Every constituent in this whole section should insist that Congressmen representing them should not only vote for, but work for an appropriation of a sum of money to make a beginning on an American forestry system. —Charlotte Chronicle.

Debs Says Cannon Belongs to Trusts.

St. Joseph, Mo., Sept. 3.—Eugene V. Debs, candidate for president on the Socialist ticket, was in St. Joseph this afternoon and spoke to 1,000 people from his red special. He later left for Omaha.

Debs arraigned Speaker Cannon of the House of Representatives in severe terms. He said: "Uncle Joe is worth \$2,000,000 today and he didn't have a dollar when he entered Congress."

"Uncle Joe is the property of the trust," said Debs. "The two great parties are wings of the same fowl—a bird of prey," continued Debs. "Lincoln would not belong to the Republican party if he were alive today, and the Democratic party has degenerated sadly from Thomas Jefferson and Andrew Jackson to Rogers Sullivan, Bath House John and Hinky Dink."

The press dispatches say that Foraker and Taft are at outs. It is not worth while to lay much store by that, as the "fire eater" will likely be in the line-up with other pie eater when election day comes.

Even in the face of the certainty that the cotton crop is cut short several million bales by the recent storms, there is no improvement in the price. Which goes to show that the cotton exchange gamblers are in control of the situation and make the price to suit themselves.

And so Mr. Cox proposes to conduct his campaign by writing letters—and checks—Durham Herald.

But according to that letter written by the editor of the Greensboro Industrial News, the check writing part is not easy to get Mr. Cox to do, even after he has promised to sign his name for so much.

At noon on Thursday the people of Wilmington held a mass meeting for the purpose of rendering public thanks to God for His blessing in sparing the city when so many other sections are suffering from the effects of the recent flood. They are a wise people who recognize the providence of God, and render Him the praise that is due. It is what we all should more often do.

THE PRIMARY.

The Christian Sun, of Greensboro, remarks thus upon this modern institution:

"To date we have found little virtue in the modern political primary. If it is working any particular salvation to the State we have failed to comprehend. Our conviction is that it has started a popular current, and the politicians haven't the courage to stem it."

North Carolina is infinitely worse for it, but once start the cry that all power resides in "the pee-pul" and there you go. Of course it does, but it is sometimes better for them to exercise it indirectly. But the referendum being established, the man who proposes a return to the old system of representative government is held to be a public enemy.

"What has the primary produced? What improved conditions has it brought about? We fail to see. We find no better office-holders than existed under the regime of the county convention. Surely there is as much play for the wily politician, and for the use of bribe-money, as in the convention of delegates. If the primary has chosen candidates and officials with keener scrutiny than the conventions-used to choose we, have failed to make the discovery."

In this The Christian Sun is not alone—no one has made the

discovery. It has brought about no improved conditions. The better office-holders resulting from the county convention are not in evidence. The primary is the opportunity of the demagogue and in it money which would be valueless in a convention can be made most effective.

"There are certainly two serious objections to the modern political primary. First, there is more canvassing, and more political agitation, than under the old regime. Now every candidate must canvass his constituents twice; once for the nomination, again for the office. Politics used to 'warm up' in August or September. Now the politicians begin in early spring and hold forth all the year. Second the primary engenders strife and stirs bad blood within the ranks. This is necessarily so; for in the primary only persons are discussed; only when standing for the office against a party are principles and issues debated. Men resort to personalities and often engender bitter and lasting feuds in preparation for the primary, which bitterness and which feuds do more damage in a community than forty primaries will ever cure. For the life of us we fail to grasp the glory, greatness or virtue of the modern political primary.

The Christian Sun has spoken a parable. The primary engenders all the bitterness here mentioned, a degree of heat impossible to a convention, for men discuss personalities because there is nothing else to talk about. Yet it has been engrained upon our system and will stay. It is of a piece with that type of politics which demands the election of United States Senators by the people, yea, some even demanding the popular election of Federal judges. The whole innovation is a departure from first principles. Men are forgetful of, or indifferent to, the fact that this was established as a representative government, not a pure democracy. We never had a better State judges than when they were appointed by the Governor or elected by the Legislature, or a better Senators than when the Legislature elected them without instruction from the people. Legislatures are of picked men and these are better qualified to pick Senators and judges than are the masses who pick the legislators. The fathers who framed our constitutions. Federal and State, knew better about these things than we of this generation. If they were living to-day it is doubtful if Graham, or Badger or Mangum could be elected to the Senate or Nash or Ruffin to the Supreme Court bench.

If this be heresy make the most of it.—Charlotte Observer.

The Republican papers had a good deal to say after our last Democratic State convention about the ungrateful treatment of the Confederate veterans in the nominations made. While it is true that only two Confederate veterans were nominated by the Democratic State convention (Hon. B. F. Dixon and Major W. A. Graham), pray tell us how many did the Republican State convention nominate?—Pittsboro Record.

There are seven different candidates for president this year, nominated by seven different parties. They are William J. Bryan, Democrat; William J. Taft, Republican; Eugene V. Debs, Socialist; Thomas E. Watson, Populist; E. W. Clavin, Prohibitionist; T. S. Higgen, Independent League; and Moorie B. Preston, Socialist Labor, who is in the penitentiary for murder and has as his proxy August Gillhaus.

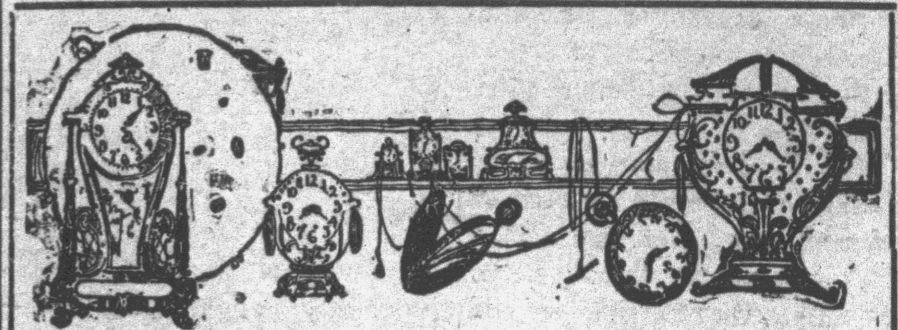

OUR BIG COUNTRY.

A Season When the Sun Never Sets on the Stars and Stripes.

There is only one flag that the sun never sets on—the British. But the American flag is a close second, for the sun during half the year never sets on it either. That is to say, these two are the only flags that the sun is continuously shining over, no matter what his position in the heavens—the one all the year round and the other during exactly half the year, from March 23 to Sept. 22.

Of course it is true that on no day at all during the year can the sun be seen from any two points of continental United States at all times during a period of twenty-four hours. But the United States naval observatory has made careful calculations which by including Alaska, Porto Rico and the Philippines show that between the spring and fall equinoxes the sun never ceases to shine in the eyes of the American eagle.

Perhaps nothing could make us realize how great a nation our expanded country is better than this simple astronomical fact. Moreover, within these two dates there are also several other pairs of eastern and western extreme points where the same condition obtains, though for much shorter times.

It is not generally known, but the easternmost point in the United States and its island possessions is in the island of Porto Rico—longitude 65 degrees 12 minutes west, latitude 18 degrees 20 minutes north. The westernmost point is in Balobe island, in the Philippines—longitude 116 degrees 40 minutes east, latitude 8 degrees 0 minutes north. When the sun is at what the calendar makers call "north declination" of 0 degrees 19 minutes—that is to say, on March 22 and on Sept. 22—it rises in Porto Rico at exactly the same time that it sets in the island of Balobe. Between these two dates during the winter months the sun does set on the United States, and during the remainder of the year, the summer months, it does not.—Scrap Book.

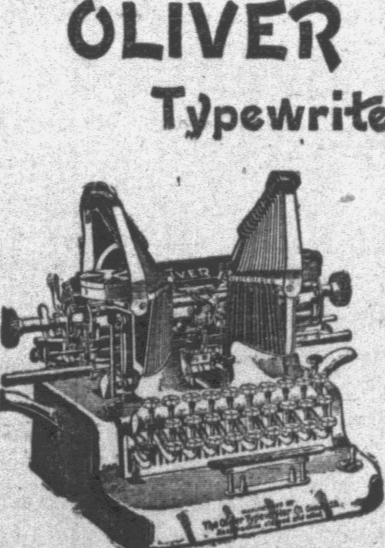
