AFFAIRS WITH THE ALDERMEN.

THEY HAD A BUSY SESSION THURSDAY NIGHT.

Give Privilege of Town to a Carnival—Taxes Ready for Collection—Other Matters.

The board of aldermen had seven members present at the regular monthly meeting, Thursday night, and the session was a lengthy one owing to much discussion of the carnival and other matters.

The tax lister made his return of the completed tax list for the year of all taxable property within the town, which was accepted and the collector was instructed to proceed to collect the same.

A representative of the Jones carnival was given a hearing and requested permission to hold a week here in connection with one of the fire companies. Aldermen Higgs moved that no permission be given for a carnival to operate here at night. This brought forth much discussion and when the question was called for the motion was lost by a vote of four to three.

Aldermen Flanagan then offered a motion that the carnival be allowed to come here the week beginning September 21st on conditions which were stated in the motion, and this motion carried by a vote of five to two. The conditions are that the fire company shall receive 15 per cent of the carnival receipts, and the carnival shall guarantee under satisfactory bond that the fire company's part of the receipts for the week shall not be less than \$250.

The street committee reported that sidewalk lines had been established in front of property of J. R. Moye, F. J. Forbes and R. L. Smith. The committee also reported that the streets were in bad condition, and that the street sweeper had been received.

The special committee appointed to make contract for paving the sidewalks of Evans street and Dickinson avenue reported that contract had been made. The work is in progress.

The committee to negotiate sale of the town horses reported that an offer of \$300 had been made for the pair. No action on the report.

The matter of having the fire engine repaired was referred to the property committee and the chief of fire department with authority to act. They were also authorized to make some provision for having the fire hose drained after use.

J. V. Harper was granted license to conduct a restaurant at his place of business in the White building.

The clerk was instructed to prepare the financial statement for the last fiscal year and have the same published in The Reflector.

The board then held a brief executive session to consider a communication from B. M. Torbett, special accountant, who had been employed to investigate and straighten the books of the water and light commission. The board upon return to open session decided to spread the communication on the minutes and to advise the water and light commission to make such recommendation as is deemed best.

The mayor was instructed to communicate with the superintendent of health and the water and light commission relative to the advisability from a sanitary standpoint of requiring all surface privies in the business portion of the town removed and require that buildings have connection made with the sewerage system.

BLIND TIGER ON WHEELS.

Three Men in the Lock-up For Dispensing Blind Tiger Booze on Train.

Yesterday an excursion train came to New Bern from Farmville, N. C. for a day's outing. Among the passengers one Louis Green was arrested for drunkenness. On being questioned very closely he coughed up the evidence where he bought the booze. On the information received Officers Lupton, Parker, and Rowe and Deputy Sheriff White made a search of the excursion train. From the evidence they had gained and conditions found in one of the cars was sufficient for the arrest of three men for the sale of blind tiger booze. They were Andrew Moore, John R. Wainwright, and Wm. Horner. They were taken before Justice Barrington, who after hearing the evidence bound them over to the next criminal court under \$300 bond each. Being unable to furnish the required bonds, they were taken to jail. Besides the witness Green, the officers confiscated a barrel of booze, half beer and half whiskey, which will be used as evidence against the defendants.—New Bern Sun, 5th.

This is Labor Day, and we are laboring right on.

Five hundred citizens of Durham county were presented by the grand jury for failure to list taxes.

Greensboro must be expecting to house the whole 42,000 in the auditorium she is building. The Record says it will be sufficiently large for a game of base ball to be played in it.

The State Democratic Hand Book has been issued and we are in receipt of a copy. It is a useful campaign document and worth a careful reading. It is one of the best that has been sent out.

Editor Hilderbrand, of the Greensboro Industrial News, is standing up and eating his crow like a tin soldier. He says it was only a little personal trouble between him and Candidate Cox and has been adjusted. Little trouble or what not, Mr. Hilderbrand thought it was enough to cause him to write a scathing letter to Mr. Cox, and to intimate that he had lied to boot.

Favors Mr. Dowd Speaker.

We note with pleasure that W. C. Dowd will be a candidate for speaker of the house. A better and more conservative man can not be found in the Old North State, and we think the members of the house realize this from his past record.—Polk County News.

Public sentiment throughout the state is undoubtedly in favor of W. C. Dowd and was in favor of him two years ago, and if his advice and counsel had been heeded then there would have been no need of an extra session to settle the mistakes of the first session. He is the best and most capable man in North Carolina for the speakership, and we hope to see him elected.—Raleigh Times.

Worth Preaching from the House Tops.

As long as a state or a community sends away the bulk of its money it can not expect to become prosperous. The habit of buying abroad and failing to make at home what can be made at home, and to raise there all that can be raised is causing the communities that have a surplus to sell to grow richer and richer, while the spend-thrift section wears the shabby clothes.

That this is true no one will gainsay, and there will be a general endorsement given to the advice in a letter of Mr. H. H. Williams, published in this week's Chapel Hill News, in which in referring to various impressions he received while on a visit to New York he has this to say:

"I got another clear impression. New York is interested in the South. They wish to know what we are doing. Talking in the office of the Wall Street Journal about conditions here, I was surprised to find myself quoted next morning in the two big New York dailies. I sought the explanation and found it

when I counted ninety cars of melons being rushed into New York from Georgia. I looked for something from Orange county. They told me that Orange county did not sell to New York, but bought many things. Coming home I passed through Virginia and stopped a day. Wherever I found rich lands, big crops and a bank account, the explanation in every case was cattle. Feed cattle and make rich the land. That is the story. One man put it this way: 'I never sell anything that can't walk to market.' Carry this message to Orange county: 'Raise cattle, make rich the land, quit sending to Chicago for meat.' And I told him I would go home and preach it from the housetops."

The message that Mr. Williams has taken to Orange county can well be read and heeded in every section of North Carolina, not alone with regard to cattle, but changing the wording a little with reference to everything that will bring back money to the place from which it is sent. In the South we pay too little attention to this. We have grown accustomed to sending on our money to buy in other sections, in place of having the money of other sections hunt us out to buy from us.

"Orange county did not sell to New York, but bought many things" is true not alone of Orange county, but of a great majority of counties in the South, which do not raise or make at home many of the things which they could easily do for their own use, and never send off products of factories, farms or fields to other sections. It is time to change this, and Mr. Williams is doing a service to Orange county and to all who hear his message as he preaches the gospel of raising and making things at home to sell abroad in place of always buying, to become a producer in place of always being a consumer.—Raleigh News and Observer.

Loyal and Subtle.

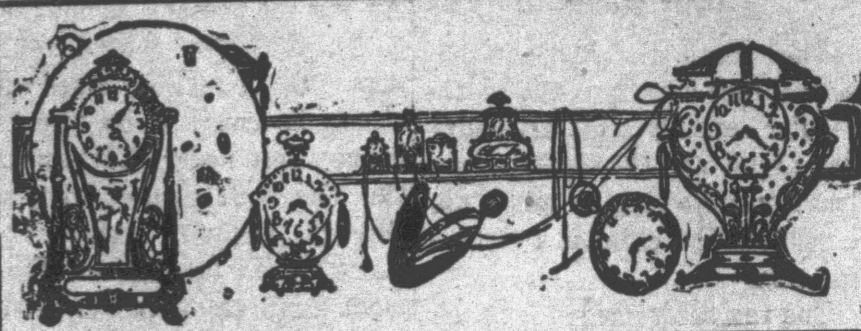

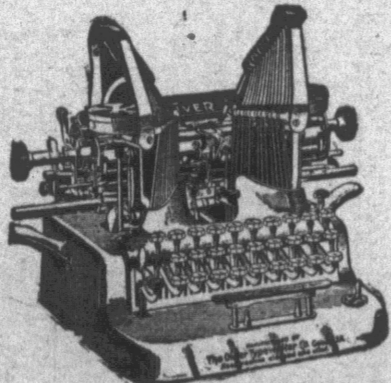

THE PHOTOGRAPHER.

He is One of the Cleverest Diplomats in the World.

In the kingdom of vanity fair and vanity that is not fair, but would be, there is the interpreter, the man who makes free translations of foibles, conceits, caprices. He deals with human nature in the raw and is an individual without illusions.

He humbly calls his profession that of photographer. His associates know that he is more than a simple maker of pictures. They will tell you he is an artist, a psychologist, a diplomat, a strategist, a person of magnetism and affability—indeed, a combination of those virtues which make him "all things to all men."

"I want a picture like that," says a stout dame, holding up the likeness of a symmetrical member of her sex, who stands erect with a bunch of roses in her hand.

SOLDIERS IN BATTLE

How Men Feel and Act With Death All About Them.

THE STORY OF A PRIVATE.

With the Beginning of the Fight Comes Fear, but That Soon Passes Away in the Eagerness For Killing. Varying Effects of Wounds.

A narrative of the battle of Solferino as told by a veteran survivor to Robert Shackleton appears in Harper's. It is, word for word, a chapter of history as seen by a man in the ranks. Incidents which impressed him are curious:

"We halted, and a Tyrolese lying on the ground cried out: 'I am dying. Give me to drink.' Whereat my companion stooped to offer him a flask, and as he stooped the Tyrolese struck savagely at him with his bayonet, but my companion jumped back, and it missed him, and he said, 'You Tyrolese, you said you wanted a drink before you died, and now you shall die without the drink.' And he stuck his bayonet through him as a boy would stick a pin through a fly.

"The fighting soon began again, and it was very fierce. It was soon that we came to know that we were to capture a little village and the hills about the village. The village was named San Martino, and there were walled barns and gardens, and the Austrians were very strong there.

"The bursting of the shells was very bad. Sometimes all of us close by would be thrown down and be covered with mud and earth, but most of us would jump up again, not wounded, but always there were some who would not jump up again, because they were wounded or dead.

"At the beginning of a battle a soldier feels afraid. At the beginning of this battle I felt afraid, and I know that other men felt afraid, though it was not our first battle, and we knew what it was to be under fire.

"So it was that at the beginning we commended ourselves; we felt like death, but soon that passed away, and we thought no more of death, but only of the killing of the Austrians.

"All around me men were killed. There were heads and arms blown off, and men flew into pieces like the smashing of a jug. But we did not care. We thought nothing of it. I do not know that we even knew we saw such things, but some of them come to me as I sit with you and talk of that long day. We did not notice, and we did not think that at any moment we too might have our heads blown off or be smashed into little pieces like the breaking of a jug.

"Once, when we rushed over the big guns and killed the men who still fought with us, we turned the guns to fire on the Austrians as they flew away, but they had driven bits of steel into the touchholes, and so we could not fire them. They were of a courage, those Austrians.

"Only once in all that battle did I think much of what I saw or heard, and that was when there was the terrible screaming of a captain who had his foot shot off. He twisted and turned as he cried out, and it was a very bad sound. But it is just as it chances. I saw many men who were hurt worse than that captain and many who were blown into little bits, but I did not trouble about them. It is just if it chances so.

"It is very often that a man does not know that he is hurt. I remember that once there was a man near me with a great hole in his forehead, but he ran right on with us with his bayonet, and I thought, 'He will fall dead.' But after that I saw him no more, for there was always the fighting.

"The storm and the blackness, they made of us a great mixing. Yes; it was a very great tangling, for all lines were lost, and I know that sometimes Austrians struck at Austrians and sometimes Italians struck at Italians, for we were in a very great mixing and very fierce in the blackness of that storm.

"We were told to lie down and sleep, so we lay down where we were, among the dead and the wounded, among the Italians and the Austrians.

"And we slept. Yes; we were tired, for we had fought hard for all that long, long day, and on that hill that at last we had gained we slept, and we gave no heed to the dead men or the wounded.

"The wounded they made very great piles, and there were men sent to go among them with lights. Some were surgeons, and some were men to carry them to the field hospitals. But the most of us we lay there and slept, and we were very tired, and we knew that with the morning there might be an other fight."
