THE BRIDGE QUESTION AGAIN. OPENING NOT YET DEFINITELY SETTLED.

Chamber of Commerce and Tobacco Board of Trade Again Discuss the Matter.

The Chamber of Commerce and Tobacco Board of Trade were in joint session again Friday night to hear the report of the committee appointed at the previous meeting to investigate when the bridge now being built across the river here will be completed and open for public travel.

F. M. Wooten, chairman of the committee, read the following report:

Greenville, N. C. Sept. 18, 1908. Mr. Presidents and Gentlemen:

We your bridge committee beg to submit the following report. That we have submitted the attached letter of inquiry to the chairman of the Board of County Commissioners. That we have visited the bridge from time to time. We find that some lumber for flooring has been delivered since our last meeting. That today about 300 running feet of flooring has been laid. That about all the flooring which has been delivered has been laid and there remains now about 300 running feet yet to be laid, which will be laid tomorrow if the flooring is delivered by the contractor.

That the abutment on the North side of the river is built. That there is a temporary crossing over the space for the abutment on the south side, which to complete will take a few hours only.

And after diligent inquiry of the chairman of the Board of County Commissioners and others, we are of the opinion that if the lumber is delivered tomorrow, as we understand is so promised, that the bridge can be crossed next Monday.

We, a committee acting for the Chamber of Commerce and the tobacco Board of Trade, and by authority of these organizations do respectfully tender the Board of County Commissioners, through their chairman, R. W. King, the services of both the Tobacco Board of Trade and the Greenville Chamber of Commerce, both collectively and its members individually, to the end that the bridge across Tar river now under construction at Greenville may be completed and opened to the public at the very earliest possible hour, and ask what, if any, service they may render in this matter.

2 We suggest that it is the sense of these organizations that the best interest of the public will be served if your honorable board find it necessary to do so and will offer a reasonable money inducement for the immediate delivery of lumber and other material necessary to the completion of this work and deduct the same from the original contract price of said bridge.

3 That through their committee these organizations respectfully petition your honorable body to make known to them through their committee the difficulties which are causing the delay in the completion of this work.

4 That you make known to this committee, as accurately as possible the date on which this bridge will be opened to the public.

5 That both the Chamber of Commerce and the Tobacco Board of Trade petition and urge through their committee that if the contractors for the building of this bridge have broken their contract, or any of the conditions imposed on them, that your honorable board take immediate and direct control of said work and rush it with all possible and consistent haste that it may be open to the public at the earliest possible hour.

Committee.

After reading this report and letters, R. W. King, chairman of the Board of County Commissioners, being present, was asked for information relative to the time the bridge could be opened for public use. He stated that he could not say definitely when the bridge can be completed, but thought it would be only a few days. A contract had been made with parties for the delivery, this week of sufficient lumber to complete the flooring; all the lumber that had been delivered was laid as fast as received, but the contractors were yet some 10,000 feet short of the quantity needed. If the lumber yet short is delivered today (Saturday) it will be laid at once, but if it is not delivered until some day next week it cannot be laid until it is delivered. He was informed that one car load of lumber had broken down in transit, and he could not learn just when the railroad can get it here.

Mr. King also stated that the action of the Chamber of Commerce and Tobacco Board of Trade in appointing the investigating committee had not hurried matters any; that the Board of County Commissioners a few days previous to the appointment of the committee had the representative of the bridge builders before them; that the contract was then made by this representative for delivery of additional lumber as quickly as possible, and that the commissioners were in no way responsible for the delay. They felt as much interested as any other citizens in getting the bridge completed quickly, and he thought the criticisms some persons had made against the commissioners were unjust.

R. O. Jeffress stated that he considered the appointment of the committee and the work the committee had done was timely. Results were wanted so that the public might know what to expect. The town, the tobacco market and the people living north of the river were all heavy losers by the bridge being incomplete, and it was important that the work be finished as quickly as possible.

On motion of F. D. Foxhall the report of the committee was received and the committee continued to make such further investigation as might be deemed practicable.

A general discussion followed in which several ways were suggested for getting the needed lumber at once and completing the bridge.

On motion of R. O. Jeffress the Board of County Commissioners through its chairman was requested to telegraph the bridge building company to give the Chamber of Commerce and Tobacco Board of Trade permission to procure immediately enough lumber to complete the work.

A motion was offered by S. T. Hooker and adopted that a committee of one be appointed to

investigate as to the location of the car of lumber said to be broken down in transit, and to take such steps necessary to getting it reloaded and brought on at once. Mr. Hooker was appointed as this committee.

E. G. Flanagan stated that another matter the two organizations might consider with profit was good roads. He introduced A. P. Gilbert, of Durham, who made a talk on this subject. He said that from what he had just heard it was evident a big discussion could be raised over a few hundred feet of bridge being incomplete, yet hundreds of miles of public roads are allowed to be practicably impassable and there is little or no agitation about this which is far more important. He spoke of the need of good roads, called attention to the good roads convention, to be held in Greensboro Oct. 13th, and urged that this section send delegates to this convention.

Dr. Laughinghouse offered the motion, which was adopted, that the Board of County Commissioners be requested to send delegates to this convention.

On motion the joint meeting then adjourned until Monday night when the two bodies will meet again to hear further from the committee in regard to the probable opening of the bridge.

Trade Report.

Richmond, Va., Sept. 17, 1908. Bradstreet's Saturday will say for Richmond, Va., and vicinity:

In the wholesale dry goods market the between sale dullness prevails. They have had a fair season, though in amount sales have been far behind those of last year; some sales are still being made to dealers in nearby districts. Stocks of goods in rural districts have been much depleted and dealers anticipate active business from filling in orders. Fruits and produce are plentiful and satisfactory prices are being obtained. Jobbers of shoes report fair orders, they are now preparing for the spring trade and some dealers have their salesmen out. Retail trade shows some improvement. Collections continue slow.

CROP REPORT.

In Virginia the tobacco crop is being cut. In North Carolina increased sales of tobacco are noted, and prices, which have been good, are maintained. Corn is being harvested in Virginia and although this has been considerably damaged by storms and high water, a fair yield is expected. Farmers are preparing to seed winter wheat. Favorable weather conditions existed for the past week.

ICE PLANT DESTROYED.

Building and Machinery Wrecked by Fire.

Fire which started about midnight last night almost completely destroyed the plant of the Greenville Ice Factory, owned by Hill & Johnson and located on the corner of Fifth and Reade streets. The alarm could scarcely be heard, hence not as many people as usual were out at the fire, and when those who did go reached the scene the entire upper section of the plant was burning from end to end. The fire department did good work, but the fire was too far advanced for the building to be saved.

No explanation can be given as to how the fire originated. The fireman and engineer were on duty for the night, and the fireman says that after renewing his fire about midnight he was dozing, and when he roused up the entire top of the house was burning.

The plant was valued at between \$7,000 and \$8,000 and there was insurance on it with Moseley Bros' agency for \$4,000.

REPUBLICAN CONVENTION.

Nominates County Ticket—Speeches by Whitener and Settle.

The Republican county convention met in the court house at noon today and was called to order by R. C. Flanagan, chairman of the Republican county executive committee. W. R. Dixon was made chairman of the convention and H. T. King secretary.

The old Republican custom of naming a committee to retire and select the candidates was followed, and while the committee was out for this purpose the chairman introduced Hon. A. A. Whitener, of Hickory, one of the Republican candidates for elector-at-large, who spoke for some over an hour. As to real argument or presentation of facts there was not much of either in his speech, but he said a number of things to amuse the audience and produce applause.

At the conclusion of his speech the committee made its report recommending the following as their county ticket:

After the adoption of this report S. V. Laughinghouse introduced Hon. Thomas Settle, of Asheville, the other Republican candidate for elector-at-large, who addressed the convention.

Trial Postponed.

The preliminary hearing of the Hardee case on the charge of waylaid and robbing Gus Mills, which was to have taken place today, was postponed until Tuesday. There were many people here to attend the trial.

Prices Advancing.

During the past week the Star warehouse branch of the Farmers Consolidated Tobacco Co. sold 300,000 pounds of tobacco at an average of \$10.53. Prices are looking up right along and this is selling tobacco.

MR. CHARLES SKINNER DEAD.

Passes Away This Morning—Funeral Sunday Afternoon.

Mr. Charles Skinner died at 7.10 o'clock this morning at his home on Cotanch street, after an illness of only a few days.

Mr. Skinner was born in Perquimans county Feb. 6th, 1851, making him in his 58th year at time of his death. He married Miss Hattie Cotten, of Bertie county, daughter of the late Louis Cotten, in October, 1877. He moved to Greenville in 1880 and engaged in the mercantile business with J. S. Congleton under the style of J. S. Congleton & Co.

In 1891 he quit the mercantile business and took charge of Hotel Macon which he conducted successfully. Later in connection with his hotel he engaged as a traveling salesman which he continued through the past several years.

Mr. Skinner was a member of the Episcopal church, a Mason, a good citizen, one who took interest in the welfare and advancement of his community. He was held in high esteem and his death brings sorrow to many hearts. He leaves surviving him his wife, Mrs. Hattie Skinner, and children, Mrs. Myra Ficklen, wife of E. B. Ficklen; Mrs. Pattie S. Carr, wife of C. S. Carr; Dr. L. C. Skinner and Misses Margaret and Ethel Skinner, of Greenville; Charles C. Skinner and Frank Skinner, of New York. He also leaves one sister, Mrs. J. M. Whedbee, and one brother, Col. Harry Skinner. His elder brother, ex Congressman T. G. Skinner, died in December last.

The remains of Mr. Skinner will be interred in the Episcopal cemetery Sunday afternoon, following service in the Episcopal church conducted by Rev. Harry Harding, of Tarboro.

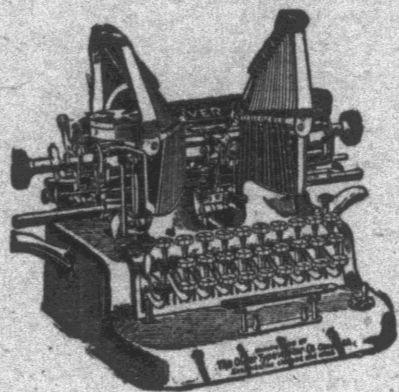

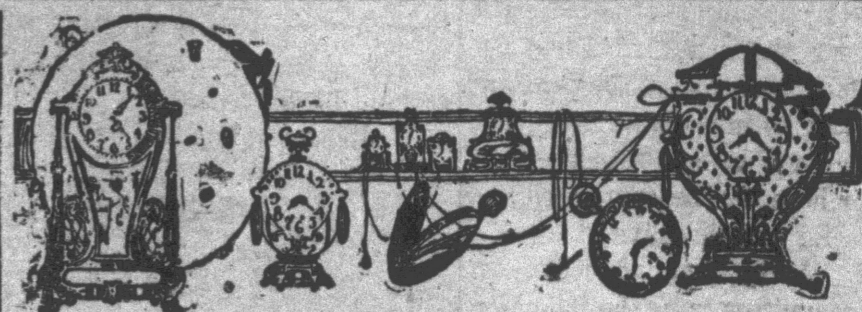

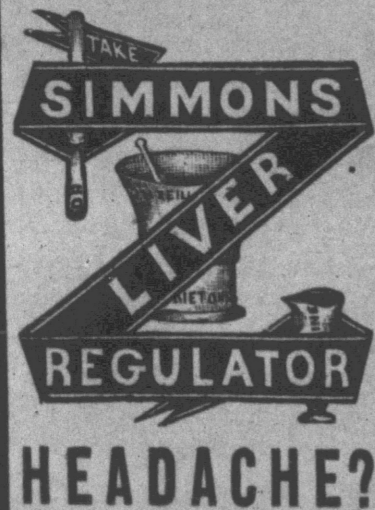

A TURBULENT GHOST.

Noisy Nocturnal Rounds of an Invisible Visitor.

QUEER DEATH OF OLD JABEZ.

The Uncanny Incident That Disturbed the Quiet of an Old Virginia Home. A Nightly Tramp That Never Ceased Until the House Was Demolished.

"I am not exactly prepared to say that I believe in ghosts," said the old gentleman from Virginia, "but at the same time, in view of certain things that have been told me, by persons whose reputations for veracity do not admit of a doubt, I cannot allow myself to ridicule the ideas of others who do believe in an occasional return to earth of the dead.

"There is one case in particular that I know of personally and that can be vouched for by a number of citizens in the upper counties of my state, and that is the case of old Uncle Jabez Martin, who knew a number of well to do farmers in Fauquier as well as in Spottsylvania, Rappahannock and other counties in the northern part of the state. 'Uncle Jabe,' as most every one who knew the old fellow called him, had considerable of the nomad in his disposition and led a wandering, pastoral life. He was always willing to work when any one needed his services and did a good deal of rough carpentering in return for a 'meal o' wittles and a shakedown,' as he expressed it, and as he was pretty well known in the land of his pilgrimages it was a rare occurrence when he was not given a welcome.

"If old Uncle Jabe thought more of one family in the state than he did of another it was the Greens. Virginia, as all know, is full of Greens. An estimable crowd they are, and nearly all of them consider themselves as related in some degree of consanguinity to the others of that name. 'The Greens of Virginia is the finest tribe of that name in seven states,' was the constant boast of Uncle Jabe, and above and beyond any other Green anywhere he placed Marse Dickie Green of Fauquier, and that is where my ghost story, if you will please to consider it as such, begins.

"One wild night in the month of October not very long before the war the old wanderer made his appearance at Squire Green's. Mr. Green was called squire by virtue of being a justice of the peace. Jabe wanted his usual 'meal o' wittles and shakedown,' and it was at his service, as usual, and after a good supper he sat on the back steps of the house, smoked his old pipe for awhile and then went to bed.

"Squire Green was engaged in some work that kept him up until midnight, and as the clock struck 12 he heard a heavy sound on the stairway. It seemed as if some one was coming down the steps with heavy irons on the legs. The sound was carried to the door, which was opened noisily and then closed with a terrific crash.

"Thinking it strange that old Jabez Martin would be guilty of making such unnecessary noise, the squire rushed to the door and opened it. The moon was shining in all its beauty, and everything was perfectly calm and nobody in sight. Back again went the surprised squire and up into the attic chamber, where Martin always slept when he made his calls. He found everything calm and quiet there. It was the quiet of death, for old Uncle Jabe was lying supine on his back, with his glassy eyes staring right up to the ceiling, where the squire left him until the morning.

"When he related the circumstances in the morning it seemed that every other one of the house had been disturbed by the uncanny noises. The strange part of it is that next night the same sounds were heard again, even to the slamming of the door, and an investigation proved that there was no person to make them. There were no cowards in Squire Green's family, but the noises disturbed them, and when they were heard, as they were, frequently at midnight they became so used to them they would simply remark that 'Uncle Jabe was tramping again' and go to sleep again.

"Friends and neighbors who knew of the ghostly exercises were averse to staying all night in the house, and the darkies couldn't be bribed to come near the place after nightfall. The sounds never ceased until after the house was torn down, and even its demolition, which it was hoped might reveal the source of its strange and gruesome sound, failed to present any explanation. There are folks living today in Fauquier county," said the relater of the ghost story, "who can, and I have no doubt readily will, testify to the truth of what I have made mention of."—Washington Post.

(MUNICIPAL)

NEW SCHEDULE WATER AND LIGHT RATES

Effective October 1st, 1908.

WATER RATES TO CONSUMERS.

The minimum monthly rate to any consumer shall be \$1.00 for three thousand gallons (or less) of water.

For any amount over three thousand gallons, up to and including ten thousand gallons, a charge of 31 1-4c per thousand will be made.

Charges for an amount exceeding ten thousand gallons are as follows:

Second	10,000	gallons	25c per 1000.
Third	10,000	gallons	18c per 1000.
Fourth	10,000	gallons	16c per 1000.
Fifth	10,000	gallons	15c per 1000.
Second	50,000	gallons	14c per 1000.
Second	100,000	gallons	13c per 1000.

Price for a greater quantity than 200,000 gallons will be quoted upon application to the Superintendent.

ELECTRIC LIGHT RATES TO CONSUMERS.

10c per K. W.

Discount.

All of the above rates are subject to a 10per cent. discount if paid on or before the 5th of the month succeeding the month in which service was rendered.

BILLS.

Bills are payable at the office of the Water and Light Commission in the Masonic Temple. Notice of accounts due will be given by postal card or other means, but all bills must be paid by the consumer at the office of the Water and Light Commission, as making collections outside of the office is strictly forbidden.

Failure to receive notice by the consumer will not be accepted as an excuse for failure to pay bill when due.

Discounts will not be allowed after the 5th.

Both electric and water service will be shut off from delinquent premises without notice, after the 15th. of each month.

REINSTATEMENT.

A charge of \$1.00 will be made to reinstate electric service and also water service when same has been cut off on account of failure to pay bills.

All of the above rates and rules will be strictly enforced.
