TEACHERS' ASSOCIATION.

Held First Meeting of New School Year Saturday—Large Attendance.

The Pitt County Teachers' Association met in the graded school building at eleven o'clock with something near a hundred present. The devotional services were conducted by Rev. M. T. Plyler, after which the association was called to order by the president, H. B. Smith. The committee to nominate officers for the coming year, consisting of Prof. J. A. McArthur, Misses Lillie Grant and Hulda Cox retired at once and after several minutes of deliberation recommended the following officers for the coming year.

F. C. Nye, Winterville, president; E. M. Rollins, Farmville, vice president; Miss Ada Tyson, Farmville, secretary, Miss Bettie Wright, Greenville, reporter.

The programme was then taken up. The first discussion was made by Supt. Smith on the work in our schools for the coming year. His talk was pointed and most practical recommending thoroughness and proper grading in our schools.

The next talk was made by Prof. G. E. Lineberry on the duties of the teacher to the community. He laid special stress on attending religious services in the community and visiting the homes. By so doing the teacher has the opportunity of getting hold of the affections of the people and also leaving their influences in those homes.

Prof. J. B. Martin, of Bethel, then read a most interesting paper on suggestions in regard to the duties of the community to the teacher, among which were courtesy on the part of the trustees and committeemen to the teacher, sympathy for the teacher, co-operation responsiveness.

There were discussions on these topics by several others. The discussions were of a high order and would that every teacher and patron in the county could have heard these. Surely the teacher that misses these meetings will never know his full loss.

A rising vote of thanks by the association was extended to the retiring officers for the excellent manner in which they presided over the association last year.

The association was delighted to have ex Gov. Jarvis present, who extended an invitation to the teachers to visit the Eastern Training school grounds at 2:30.

We look forward for the best year's work yet, to be done by the association though she looks back into the past with pride at her great achievements. The good to Pitt through the influence of this association will never fully be recorded this side of eternity.

Information on Registration.

Raleigh, Oct. 10.—Attorney General Gilman has given an opinion on registration. He says that the new registration is required for the coming election. All persons registered in the last election can vote without registering again. Once on the permanent roll, they are always on it. He says further that there is no reason why any county cannot order a new registration if its board of election so desires, but does not think the latter can eliminate names on the permanent registration roll because the persons do not re-register.

However, minors coming of age must register. This is the last election in which those who cannot read and write can register under the grand-father clause as the Constitution of this limits the time to December 31st next.

A Ten-Year-Old Boy Locked up in a Dark Closet.

Boston, Mass., Oct. 10.—Manuel Silva, of Peabody, ten years old, a prisoner in a dark closet on the top floor of a school house overnight and till the next morning, cried and screamed in vain for release as volunteer parties searched the town for him. He had been placed in the closet by his teacher in the afternoon, it is charged, as a corrective measure, and had been forgotten. It was only by accident that he was discovered twenty-four hours later.

While the boy suffered all the tortures that a child can experience left alone in the dark in a deserted building, the teacher was acting as bridesmaid at a wedding. The affair has caused the school board to take special action, while the parents of the child are determined to have satisfaction. Miss Catherine Reynolds, the teacher of the Silva boy, is a graduate of the state normal school and this is her first year as a teacher. She is prostrated over the situation.

For the last few days the editorial column of the Durham Herald has looked like Editor King was off fishing.

There are more good things yet ahead for Greenville. Go to the meeting of the Chamber of Commerce and Tobacco Board of Trade in the court house, Tuesday night, and talk about some of them.

The State department of agriculture gives Greenville second place in the sales of leaf tobacco for the month of September. Wilson was the only market that went ahead of Greenville in the number of pounds sold.

UP TO MR. ROOSEVELT.

Four years ago Judge Parker, then the Democratic presidential candidate, charged that the money for the Republican campaign was being furnished by the trusts and corporations and the big insurance companies. Thereupon President Roosevelt denounced Judge Parker as a liar.

Subsequent events, such as the insurance investigation; the letter of President Roosevelt to Mr. Harriman asking the railroad magnate to call on him in Washington and Mr. Harriman's action after the call in raising a big sum of money for the campaign—these and other events fully sustained Judge Parker's charge and vindicated him, and at the same time showed that the president was either ignorant of the facts, which nobody believes, or that he wilfully falsified.

Monday night Judge Parker spoke before a great audience in Baltimore. Referring to the president's denunciation of Haskell for his alleged Standard Oil connections, Judge Parker made another charge, the incident being thus reported by the Baltimore Sun:

Judge Parker said he expected that the charge he now made would bring forth another letter from the president, but that the facts were as he stated them, and this was not all. He reiterated the charges he made in October, 1904, and reviewed the Harriman-Roosevelt correspondence as evidence that what he said then was true and had been substantiated since.

He charged that Mr. Cortelyou had gone to the Standard Oil building in New York soliciting a contribution and had been given \$100,000. This was not near as much as had been expected, Judge Parker said, and Cortelyou and the committee were greatly dissatisfied. Mr. Roosevelt was communicated with and wrote a letter to Mr. Cortelyou denouncing the Standard Oil and telling him to take the money back.

"But," said Judge Parker, "they did not take it back. They kept it. They not only kept it, but they spent it. And after that letter of the President they went back again and asked for \$250,000, but they did not get it. This will bring forth another letter from the President, I have no doubt, but these are the facts."

It is inferred from this statement that the President's

nunciation of the Standard Oil Company and his order to return the money, was because the contribution was not big enough. Up to the present the President has not denied Judge Parker's charge. A statement from the White House is to the effect that there is nothing new in the charge and that it has already been dealt with. Cortelyou makes no statement for himself but a Washington dispatch to the Baltimore Sun, Taft supporter, denies the charge on Cortelyou's behalf. But so far the charge stands and Judge Parker talks like a man sure of his ground.

There is already abundant evidence that the President does not respect the truth, and evidence is accumulating that he is the arch hypocrite of the age.—Statesville Landmark.

The Republican Plan of Regulating the Trusts.

In a speech in the west Mr. Taft told the people that if Mr. Bryan succeeded he would put trust-controlled articles on the free list, but that the Republicans would not do anything of the sort, but "the Republican plan of regulation is the proper remedy." The "Republican plan of regulation" has been in operation twelve years, with the result that under McKinley 127 new trusts were organized and under Roosevelt 107 new ones began business. If "the Republican plan of regulating" is proper, why do trusts multiply and why do they continue to practice extortion?—Ex.

Modern Republican Politics.

Former Governor James E. Campbell's address at the Democratic campaign opening at Marshfield, O., was devoted chiefly to a defense of the financial record of his administration as governor. He also ridiculed Taft's speech of acceptance and declared the workingmen who marched in the parade at Youngstown, at the opening meeting of the Republican campaign, marched under orders of their foremen, because they were afraid to do otherwise.

Again, he deplored the fact that at that meeting "the only soldier whom the grand old party has sent to the Senate from Ohio during the 47 years that has elapsed since the outbreak of the civil war was not there." He declared Sherman, Republican candidate for vice-president, to be the tool of the trusts.—Columbus, O., State Journal.

PROVED HIS SPELLING.

An Incident in the Career of Stephen A. Douglas.

An amusing incident occurred in McLean county, Ill., at the first court which Stephen A. Douglas, the famous politician, attended after his election as prosecuting attorney. There were many indictments to be drawn, writes Professor Allen Johnson in his life of Douglas, and the new prosecuting attorney in his haste wrote the name of the county McLean instead of McLean. His professional brethren were greatly amused at this evidence of inexperience and made merry over the blunder. Finally John T. Stuart, subsequently Douglas' political rival, moved that all the indictments be quashed. Judge Logan looked at the discomfited youth and asked what he had to say to support the indictments.

Smarting under the gibes of Stuart, Douglas replied obstinately that he had nothing to say, as he supposed the court would not quash the indictments until the point had been proved. This answer caused more merriment, but the judge decided that the court could not rule upon the matter until the precise spelling in the statute creating the county had been ascertained.

No one doubted what the result would be, but at least Douglas had the satisfaction of causing his critics some delay, for the statutes had to be procured from an adjoining county.

To the astonishment of court and bar and of Douglas himself it appeared that he had spelled the name correctly. To the indescribable chagrin of the learned Stuart the court promptly sustained all the indictments. The young attorney was in high feather and made the most of his triumph. The incident taught him a useful lesson—henceforth he would admit nothing and require his opponents to prove everything that bore upon the case in hand.

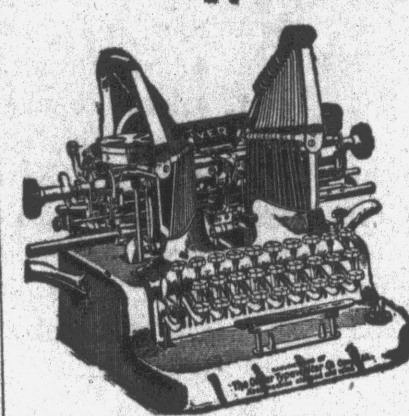

GRANT AND A. T. STEWART.

Nomination of the Merchant For Secretary of the Treasury.

It was not unnatural that in the absolute absence of political experience President Grant should not only have had much to learn concerning the nature and conduct of civil government, but that he should also have had much to unlearn of the mental habits and the ways of thinking he had acquired in the exercise of large—indeed, almost unlimited—military command. This was strikingly illustrated by some remarkable incidents.

As usual, the nominations made by the president for cabinet offices were promptly ratified by the senate without being referred to any committee. But after this had been done it was remembered and reported to President Grant that one of the nominees so confirmed, A. T. Stewart of New York, whom President Grant had selected for the secretaryship of the treasury, as a person engaged in commerce was disqualified by one of the oldest laws on the statute book—in fact, the act of Sept. 2, 1789, establishing the treasury department. That this law, which provided that the treasury department, having the administration of the custom houses under its control, should not have at its head a merchant or importer in active business, was entirely proper—indeed, a necessary one—had never been questioned. The next morning, March 6, I had occasion to call upon President Grant for the purpose of presenting to him a congratulatory message from certain citizens of St. Louis. I found him alone engaged in writing something on a half sheet of note paper. "Mr. President," I said, "I see you are busy, and I do not wish to interrupt you. My business can wait." "Never mind," he answered, "I am only writing a message to the senate." My business was quickly disposed of, and I withdrew.

In the course of that day's session of the senate a message from the president was brought in in which, after quoting the statute of Sept. 2, 1789, the president asked that Mr. Stewart be exempted by joint resolution of the two houses of congress from the operation of the law which stood in Mr. Stewart's way. There were some signs of surprise among senators when the message was read, and Mr. Sherman at once asked unanimous consent to introduce a bill in accordance with the president's wish. But Mr. Sumner objected to the immediate consideration thereof because of its great importance. This stopped further proceedings, and the bill was laid on the table, never to be heard of again.—Carl Schurz's Reminiscences in McClure's.

A Maharahjah's Revenge.

A maharahjah of Nepal committed suicide in horror at the disfigurement which an attack of smallpox had caused in her features. The maharahjah, who was passionately attached to her, first wreaked his vengeance on the physicians who had attended her in her illness. Then he flew at higher game. Out of the great temple he brought the idols, placed loaded cannon before them and bade gunners fire. In terror at the proposed blasphemy, they refused. Thereupon the maharahjah hanged several of them. The survivors then submitted, and the guns were fired and the idols blown to pieces.—Leipste Missionsblatt.

Blue Drinks.

"Champagne is golden," said a bartender, "beer is amber, claret is red, cream of mint is green, whisky is brown, punches are white, but you will never, never find a drink that is blue. Doesn't the thought of a blue drink seem unpleasant to you?"

"Blue drinks could be easily made, but the public would have none of them. Nothing blue would go down with the public. Why is this aversion to blue so general? Many reasons have been advanced, but none of them is good. One is that blue, being the color of poison bottles, incites distaste and horror."—New York Press.

"Would you advise me to go into politics?"

"Young man," answered Senator Sarghram, "the mere fact that you are so modest as to ask advice about it proves that you are unfit for the profession."

CANADIAN HARE SKINS.

Made into Warm, Soft, Light Blankets by the Indians.

From the fur of the Canadian hare, which comes south into the United States and in winter turns snow white, the Indians make one of the warmest and softest of blankets.

After the skin has been cured and made supple it is cut with a sharp knife into a single narrow strip many feet in length. The strip is carefully curled into a tube seven feet long, with an inner diameter of rather more than a quarter of an inch and an outer diameter of about half an inch.

The skin is thin, but tough, so that the tube is light, but strong. The edges are sewed together with great care and firmness. Enough of these tubes are made to form a blanket seven feet square.

When all are made they are sewed together with animal sinews, so that the blanket is almost as strongly made as if it were woven. All this is done by the Indian women, the men merely trapping the hares, which are so numerous in the far north of Canada that the trapper may catch dozens in a single night.

When finished the blanket is a beautiful thing of dazzling whiteness, extremely light and very warm. Its warmth is secured not only by the fur, but also by the air in the many slender tubes. In time the blankets lose their beautiful whiteness, but they retain their essential qualities and last for years.

They are highly prized by the Indians, and they fetch good prices. As a matter of fact, they are seldom seen outside of Canada, and like an eiderdown quilt, they are ever warm for heated houses in this latitude.

It is probable that fully 200 rabbits go to the making of such a blanket, since one skin makes but a single narrow strip of the whole seven feet. An old Indian chief was asked one night as he sat before his campfire in the north how many skins were required for a blanket. He looked at the questioner and said, with a smile:

"I'll tell you how many skins make a rabbit blanket.

"You go out into a clear spot in the woods when the snow is very deep in early winter and give a whole day to felling trees and gathering light, dry wood for a fire. Then at night you make your fire, a very big fire, of all the wood you have gathered.

"It will light up all the clearing and will melt the surface snow for many yards around. The hares will come out of the woods in whole families, attracted by the light of your fire, and will crouch on the surface of the melting snow to watch it. There they will sit for hours until the fire has gradually died down.

"Meanwhile the cold night will have again frozen the surface of the snow, and the rabbits, which have covered it so thick you cannot see anything but their fur and their eyes, will freeze tight to the freezing snow. You can go out with a stick then and knock them all on the head, but it will be a big job. When it is done, however, you'll have enough rabbit skins to make a blanket like mine."—Washington Post.

Woman.

What constitutes society? Woman. She is its sovereign arbitress. It exists for her and for her exclusively. But woman forms the great educational influence for man. She it is trains him in the gifts that charm—courtesy, discretion and the pride that shudders to be self assertive. She it is teaches a few the art of pleasing and all the useful art of not displeasing. From her we learn the lesson that human society is more complex and more delicately adjusted than is generally suspected by the politicians of the cafes. Last, but not least, it is she brings home to us the great truth that the ideals of sentiment and the visions of faith are invincible forces and that it is by no means reason that governs humankind.—Anatole France in "Garden of Epicurus."

Shakespeare.

Pretty nearly everything about Shakespeare is uncertain, and most statements concerning him need to be made in a provisional way. It is generally understood that his dramatic career began about 1589 or 1590, when he was between twenty-five and twenty-six years old. He died in 1616, and if, as is generally assumed to be the case, his birth year was 1564, he died at the comparatively early age of fifty-two.—New York American.
