SMALL FIRE TUESDAY NIGHT.

W. B. Wilson's Stables Burned—Horses and Vehicles Saved.

About 8:30 o'clock Tuesday night the stables on the lot of Mr. W. B. Wilson, in South Greenville, were practically destroyed by fire. Mr. and Mrs. Wilson were entertaining friends and had just finished supper when a servant about to leave the kitchen saw flames burst through the roof of the stables in the yard. This timely discovery possibly saved a serious fire, for residences are thick in that vicinity.

Firemen quickly responded to the alarm and soon had on two streams from the hydrant on the corner of Ninth street. Though the stables burned furiously the flames were confined to this building and part of it was left standing.

Three horses and a cow in the stables were gotten out in safety, as were also the vehicles and harness. A quantity of feed stuff was destroyed.

From the place the fire was burning worst it is supposed to have started in the trash in the loft, but how it caught is not known. There was no insurance on the stables.

HEIRESS IS KIDNAPPED.

Eight Year-Old Girl Carried Off From Home.

Chicago, Oct. 13.—While she was walking beside her grandmother yesterday afternoon, Margaret Frances Mitchell, an eight-year-old heiress to \$200,000, was seized by kidnapers. They threw her into an automobile and drove through the streets of the city and the surrounding country towns for four hours before they finally disappeared, taking the child with them.

In the car, besides the chauffeur, were two women and three men. Robert C. Mitchell, father of the child, an employee of the city law department, believes that one of the women was his wife from whom he separated three months ago. The other persons are believed to be friends of hers.

The three male passengers alone were visible to persons on the sidewalk at the time the seizure was made and it is thought that the women hid themselves in the bottom of the tonneau when they feared they might be recognized.

The entire police force of the city has been called into the case.

Chicago, Oct. 13.—Margaret Frances Mitchell, eight years of age, said to be an heiress to a fortune of \$250,000, was kidnaped while on the street with her grandmother. The little girl was snatched by one of three men in an automobile and taken away after the grandmother, Mrs. Caroline F. Mitchell, had been knocked down. The police are working on a clue that the child was taken out of the city, probably to Sparta, N. C.

CRIMINAL ASSAULT.

16-Year-Old Girl Criminally Assaulted Near Concord.

Concord, N. C., Oct.—After being carried fifty yards in the arms of her assailant, Miss Pearl Tucker, a girl only sixteen years of age, was outraged by a negro near this city this afternoon. The negro told the girl who was picking cotton in a field near her home, that he had been sent to tell her to go to the other end of the field to look for a hammer. When the girl had gone some distance she was picked bodily up by the brute and carried into the woods, where he accomplished his purpose, after firing a pistol and telling the girl to remember his name, that it was Henry Faggart.

Officers from Salisbury were notified, and were quickly on the scene. They arrested Will Graham, a negro, whose clothes were covered with weeds. The girl was too nervous to say whether or not Graham was the man who assaulted her. The negro was spirited away by the officers in an automobile in the direction of Salisbury. It is believed that Graham is the negro.

Found Man's Body.

Lenoir, N. C., Oct. 12.—Saturday night, while out possum hunting near King, Creek, this county, a party of men found the body of a man named Bunk Sanders, who had been missing several days. The deceased had had a slight stroke of paralysis and partially recovered and it is supposed he had another attack, while out walking alone in the woods. He was about 45 years old and a well-to-do farmer and a good citizen. The coroner's jury returned a verdict to the effect that deceased came to his death by natural causes.

Lucille, a carefully brought up little girl of five years, returned from her first party in great glee. "I was a good girl, mama," she announced, and talked nice all the time.

Robbed by Negro Youth.

Charlotte, N. C., Oct. 13.—D. M. Beattie, living twelve miles west of the city, was knocked down by a fifteen-year-old colored boy, Jim Boulware, near the Beattie home, this afternoon and robbed of about twenty-five dollars. The negro was later arrested in Charlotte. He is absolutely indifferent about his apprehension and admits taking the money.

Died.

Mr. L. G. Whichard died at 5 o'clock this morning at the home of his brother, Mr. D. L. Whichard, in Pactolus township. He suffered a stroke of paralysis a few weeks ago from which his death resulted. He was some over fifty years of age, unmarried, and the eldest son of the late Mr. James Whichard.

THE SAME OLD REPUBLICAN PARTY.

That little band of Federal officeholders, known as the Republican party of Pitt county, were called together a few days ago and made some appointments for their county candidates to go before this intelligent people and misrepresent the affairs of the government, both county and State.

The Democratic party will see that their position on public questions cannot be misrepresented without those who are guilty of such misrepresentation being held up before the eyes of a people who know the depths to which the Republican party has stooped in the past. It is the same old party, only after long practice and hard training has learned how to stoop lower.

Daniels Predicts Certain Victory for Bryan.

Josephus Daniels, head of the press department of the national Democratic headquarters, declares that it is the belief amounting to conviction, with Blair Mack and others associated with him in the work of national headquarters, that Bryan's election is already assured. They do not believe any conditions could arise to change the outcome. Going into detail, Mr. Daniels declares that a month ago there was a strong belief that Maryland and Ohio were doubtful States with a probability both would go for Taft. Today they are assured that both will be in the Bryan column. Every Western State shows big gains for the Democracy, with the party united and confident of New York. Mr. Daniels says the conditions are most reassuring for the Democracy, and if the Empire State is carried, then Bryan's majority will be simply tremendous. But if New York is lost there will still be a safe margin for Bryan's election. He says he will not come South this campaign, because his advisors insisted that he devote all his energies to the doubtful States. He expects to come through the South some time in November or December.

Shot in Saloon Riot.

Wheeling, W. Va., Oct. 13.—In a saloon riot at Bellaire, across the Ohio river from here, this morning Silas Bledit was shot by Samuel Kavin and four coal miners are in the Bellaire jail charged with rioting. The four miners entered the saloon and attempted to run the place. Samuel Kavin, the bartender, opened fire, but one shot would not strike Silas Bledit, bystander. The wounded man is now in a dying condition at Haskins Hospital. Kavin has been placed in jail.

VAGARIES OF SOUND.

Acoustic Phenomena That Are Puzzling to Scientists.

At twilight some time ago at a life saving station of the English coast noises were heard that sounded like signal shots from some distance at sea. A boat was launched and sped with all possible energy to the place from which the sounds seemed to have come, but it returned without having heard or seen anything further. Yet the seaman who had been left behind on guard declared solemnly that in the meantime he had heard near shore unmistakable cries for help from drowning persons. The bluejackets themselves are most inclined to regard the whole matter as supernatural and the voices as spectral. Scientists say that it is possible, however, that such sounds may be audible in remarkable distinctness where there is a high coast, though they may come from a great distance, especially when persons there are placed accidentally so that behind them rises a wall which receives the sound and throws it back.

On some coasts that are often visited by fogs a legend of so called "fog shots" has acquired vogue. These are said to have their origin, for some reason not yet fathomed, within the masses of fog. Acoustic phenomena are found of such a strange kind that the investigation of them may be said to be still very far from conclusive. The most inexplicable secret lies perhaps not in the occurrence of sounds, the origin of which may be reached only with great difficulty, but in their disappearance and in absolute silence when audible noises should be expected. Many a ship has been wrecked because its signals of distress, loud and uninterrupted, have remained inaudible, although only a very short distance from the coast.

But, again, it happens that in such an instance the very same signals become audible at a far greater distance, where they provoke great excitement. A remarkable example of this was produced by the firing of guns by the English fleet in the roadstead at Spithead on Feb. 1, 1901, as a token of mourning for Queen Victoria. This was not heard at all by many persons close at hand who were listening for it, while at places much farther away it was heard plainly. The direction of the wind failed to explain this aberration of the waves of sound.—Chicago News.

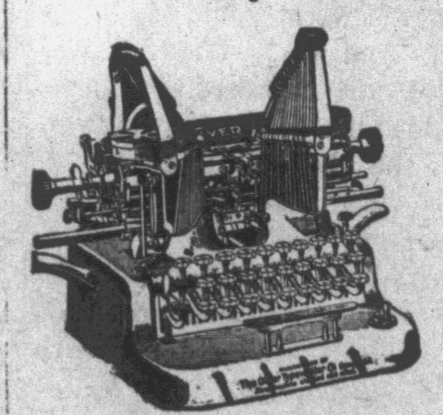

HUCKLEBERRY FARMING.

Agriculture With a Match in the Timber Regions.

"It may seem incredible to those who have never lived in or traveled much through timber districts where the huckleberry is indigenous," said a native of such district, "but it is a fact that there is a tribe of shiftless persons in all such regions who systematically and without regard to law, property or life set fire to woods or cut over land adjacent to woods simply to increase the area of huckleberry bushes. There is only one way in which huckleberries can be cultivated, and the huckleberry farmer does not need to own an inch of land. If he has the title to one simple lucifer match he can put thousands of acres under cultivation in a very short time.

"He has only to light the match and touch it to the dry leaves and branches on the ground, either in early spring or late fall, and his cultivation is soon under way. No matter what grew on the ground before fire swept it bare, huckleberry bushes will never fail to spring up luxuriantly from the ashes and scorched soil. They will be in abundant bearing the next season. What the result may have been in loss of life or property does not concern the persons who reap the benefit.

"Many of the fires that devastate our forests every year may be traced to this reckless and deliberate making or improving of huckleberry patches. I remember one instance particularly where the setting fire to the brush on a huckleberry barren in northern Pennsylvania resulted in a forest fire that swept over a 10,000 acre timber tract, doing incalculable damage to the standing timber and reducing to ashes 50,000 feet of logs and lumber and 30,000 cords of tanbark, representing a money value of nearly \$750,000. Twenty persons were burned to death and thirty so badly burned that seven of them died from their injuries. The huckleberry crop gathered from this cultivation of that barren waste perhaps realized \$200 to the cultivators.—Washington Post.

Herbert Spencer's Courage.

WORK OF THE BEAVER

Feats Performed by This Industrious Little Worker.

A CLEVER HOUSE BUILDER.

He is Capable of Constructing a Dwelling as Large, Though Not So High, as a Small Haystack, and He Can Cut Down Big Trees With His Teeth.

Almost every one knows something about the beaver and that it builds dams and houses to dwell in, but very few people have seen beavers in their wild state. It is also a fact that the race of industrious little workers is rapidly disappearing. In the older districts beavers generally live in the banks of the streams they inhabit, and the sight of a beaver house is uncommon.

Where beavers do build houses, says Forest and Stream, the structures differ greatly in size, shape and location. Some are as large, though of course less high, than a small haystack; others are hardly more than six feet through at the base. They may stand either wholly on land or partly in the water and partly on the bank or wholly in the water.

They are never placed in very deep water, for a base must be built for the house to stand on reaching up to the surface, since the chamber inhabited by the occupants must be dry.

The shape of those houses on the shore approaches the conical. Those in the water are more irregular, sometimes only rounded, at others long and rather flat on top.

Within each house and connected with the water by a concealed passage through which the beavers pass to and fro is the chamber which is the animals' dwelling place.

It is large enough to contain seven or eight of them and high enough so that a beaver can conveniently sit up on his haunches. It is warm, dry and clean, for the beaver is extremely neat in all his habits.

The food of the beaver consists chiefly of the green bark of twigs and young limbs of various trees. Cottonwood bark is preferred; then comes willow, then alder, but the bark of almost any tree may be eaten.

I have known them to eat pine and white cedar. The beaver often cuts down trees of very considerable size to get at the smaller limbs, which they eat.

I have seen cottonwoods twenty inches in diameter so cut, and once on Vancouver island I found a cedar two and one-half feet through which they had gnawed down.

The work of cutting down a large tree is done by a single animal. I have seen the beaver engaged in the operation, which is as follows: The beaver sits up on his haunches facing the tree and with its fore paws resting against it. With its head turned on one side he cuts a groove above and then one below and bites out the chin, taking it off in almost the same way an axman would.

He thus saves himself the trouble of gnawing all the wood up into fine cuttings. When the tree is felled the whole community attack and cut up the tender limbs, carrying them away to the cache.

Unlike many of our gnawing animals, the beaver does not sleep through the winter. He remains active, often venturing abroad during the whole of the cold weather. He must, therefore, have food, and a large part of the summer and autumn is devoted to securing this food and depositing it in caches. This food consists of the limbs and twigs of the trees most preferred by the beaver.

They are cut from one and a half to three feet long, stripped of their leaves and smaller twigs, carried to the water and floated to the cache, where they are sunk. And here comes a very curious point.

These sticks are floated to the cache and are sunk by the beaver to the bottom of the water, where they remain without any apparent anchorage. They are not stuck in the mud of the bottom or held down by weights. If you lift one to the surface it will float, but you may move it about on the bottom without its rising.

I have myself tried this with sticks from which the bark has been eaten, but have never done so with the green, unpeeled limbs before the beavers had taken them into their houses. This matter to me is a very mysterious one, and I have never been able to get any hint as to how these sticks were sunk.

All through the winter the beavers visit these caches, carry the sticks to their houses, where they eat off the bark, returning the bare sticks to the water.

Sometimes it may happen that for some reason or other the cache may not contain enough to last the whole winter. In this case the beavers, if possible, get on land through some air hole or piece of open water and then forage among the timber. Occasionally a combination of severity and severe weather may oblige the colony to emigrate during the winter to some more favorable spot.

A SCISSORS ARTIST.
The Wonderful Feats Performed by Joanne Koetren.

More than 200 years ago a little girl was born at Amsterdam, Holland, whose name was Joanne Koetren. She was a peculiar child in that she cared nothing whatever for play and sport, but found her greatest delight in making copies of things about her, imitating in wax every kind of fruit and making on silk with colored floss exact copies of paintings which were thought wonderful.

But after she had become very accomplished in music, spinning and embroidery she abandoned all these for a still more extraordinary art—that of cutting. She executed landscapes, marine views, flowers, animals and portraits of people of such striking resemblance that she was for a time quite the wonder of Europe. She used white papers for her cuttings, placing them over a black surface, so that the minute openings made by her scissors formed the "light and shade."

The czar, Peter the Great, and others of high rank paid her honor. One man high in office vainly offered her 1,000 florins for three small cuttings. The empress of Germany paid her 4,000 florins for a trophy she had cut, bearing the arms of Emperor Leopold, crowned with eagles and surrounded by a garland of flowers. She also cut the emperor's portrait, which can now be seen in the Royal Art gallery in Vienna. A great many people went to see her, and she kept a book in which princes and princesses wrote their names.

After she died, which was when she had lived sixty-five years, her husband, Adrian Block, erected a monument to her memory and had designed upon it the portraits of these titled visitors. Her cuttings were so correct in effect and so tasteful as to give both dignity and value to her work and constitute her an artist whose exquisite skill with the scissors has never before or since been equaled.
