## WO MEN SHOT WITH SAME PISTOL

### F. WHITE AND A. B. KITTRELL DANGEROUSLY WOUNDED.

#### Lamentable Tragedy Sunday Night That Shocked the Entire Community—Whisky the Cause.

A most distressing tragedy occurred here Sunday night from which two of our citizens are dangerously wounded, and the chances of recovery very much against them.

The tragedy occurred a little past 10 o'clock. Messrs. J. H. Tarkey and A. B. Kittrell were sitting at the counter in Harper's alm garden partaking of a drink.

Mr. C. F. White was on the outside and someone on the inside called to him to come in and he walked up to the counter and said something to Mr. Kittrell about calling him, which Mr. Kittrell replied that he had not done. Mr. White drew a pocket knife and Mr. Kittrell picked up a chair and held it out between them to ward off the attack. Mr. White then drew a pistol and fired three shots, the first going wild, one entering Mr. Kittrell's breast above the heart and the third striking him in the side. Mr. Kittrell then grabbed the pistol from Mr. White's hand and shot the latter once in the abdomen with the same weapon, felling him to the floor.

Mr. Kittrell then handed the pistol to Policeman McGowan, who had entered the room.

Both men are dangerously wounded. At this writing Mr. Kittrell is said to be sinking and it is not thought he can live many hours. Mr. White was taken on the morning Norfolk Southern train to the hospital in Washington.

It is a most lamentable tragedy and is deeply regretted by all people of the community. No reason can be assigned for the difficulty except that Mr. White was drinking and supposed he had been insulted.

## BIG DAY AT FARMVILLE.

### Fine Speeches by Craig and Small—Large Numbers Hear Them.

Farmville, N. C., Oct. 17, 1908.—Today was a Democratic day for Farmville. There has seldom been such a throng of people here on any occasion as this little city saw today. They came from every direction, and by two o'clock the Lady Turnage opera house was packed to overflowing.

When the county candidates had finished speaking, Mr. J. B. James introduced Hon. Locke Craig, that able, eloquent and matchless orator from the mountains. Mr. Craig began his great speech by saying that one among the fundamental principles of Democracy is that every man has the right to vote for whoever he pleases, and that he is no less a Democrat today than he was before he was defeated for the gubernatorial nomination. Mr. Craig reviewed in a masterly way the history of the Democratic party, and its wonderful achievements. He refrained from criticising, in his own language, the Republican party, but called for his witnesses the "high-up" Republicans. He repeated what they had said about each other. He said they ought to know more about each other than he did. Mr. Craig was frequently interrupted with applause. The greatest applause of the day came when he sublimely pictured the history of W. J. Bryan from the Chicago convention of 1896 to the White House in 1909. Our people have never heard a greater speech.

At the conclusion of Mr. Craig's speech Hon. Jno. H. Small, our well known congressman, spoke for one hour. Most of his speech was devoted to State issues.

The old time Democrats, who had traveled for miles to hear these eloquent men, went away rejoicing.

The Ayden band furnished music for the occasion. It was a Democratic day and Farmville will give the same old majority.

## MONTGOMERY SUES DIXON

### Sequel to Denunciation in Recent Exchange of Compliments at Raleigh.

Raleigh, N. C., Oct. 17.—Ex-Associate Justice W. A. Montgomery, of the North Carolina Supreme Court, instituted today in the United State District Court here, a suit for \$50,000 damages against Thomas Dixon, Jr., for an alleged libelous attack on him through the newspaper here Friday, in which Dixon characterized Montgomery as a "Southern scalawag or traitor, a sneak of which type the more he sees the better he likes dogs," declaring this man has stood forth always unique and shameless in degradation.

"He was made to consume such leper trash, but if I were the devil I would not give him hell room. I'd make a brush heap on the outside."

Two weeks ago Judge Montgomery in introducing J. Elwood Cox, Republican nominee for governor to a Raleigh audience, incidentally bemoaned the revival of reconstruction and Ku Klux memories and in treating Dixon's part in this revival by recent books and plays, referred to him as having "a face from which any child would turn with fear and repugnance" and characterized Dixon as "a hyena yelping around a church yard." The case was docketed in the Federal Court here today but service has not yet been made on Mr. Dixon by the marshal.

## AN EVENING OF MUSIC.

### Delightful Service in Memorial Baptist Church.

On Sunday evening in Memorial Baptist church there was a special musical service under the direction of the choir that was truly delightful, and it was enjoyed by a very large congregation. One thing clearly demonstrated by this service is that people love music, and nothing is more sure to draw large numbers of people to the services in the churches than the assurance that they will hear good singing. In this respect such services as the one Sunday night are exceedingly helpful and uplifting to the community, for it not only gives the choirs more interest in their part of the church services, but also awakens in the people a greater desire to attend services. The Gospel in song is hardly less powerful in drawing persons nearer to God than the preached Word. Governor Jarvis well said in his remarks that he was glad to be present at such a service and wished all the churches of the town would hold them more frequently.

The program previously published for this service was splendidly rendered. The selections by the full choir were in good volume and harmony, the instrumental selection with organ and violin was entrancing, and the vocal solos by Mrs. B. E. Parham, Miss Olive Gaston and Mrs. W. L. Hall were superb. Each of these ladies sang charmingly and our people have at no time heard sweeter or more inspiring solos. The singers had excellent support in the faultless organ accompaniments by Mrs. G. J. Woodward and Miss Lillian Carr, and the violin obligatos of Mrs. L. M. Savage. It was inspiring.

The addresses by ex-Governor T. J. Jarvis and Prof. H. B. Smith were indeed timely. Governor Jarvis spoke on "Man's Duty to Man" with an emphasis and earnestness that deeply impressed his hearers. This "grand old man" whose own life has been such a blessing to his town, his county and his State, and even as our representative at home and abroad, always says the right words at the right time, and he never seems happier than when he is giving wise counsel, or saying or doing something to help and uplift those who are coming after him. No wonder the people love him as they do.

Prof. Smith spoke on the value of music to the community, and the benefit of such services as the one the people had enjoyed on this occasion. He said there was much musical talent in Greenville, and seeing the advantage of its development he had a little more than a year ago prevailed upon the trustees of the graded school to establish a music department in the school. The result of this has been most gratifying, and ultimately the churches and the community will be greatly benefited.

The choir of the Baptist church has planned to have special music services on the third Sunday night in each month, and we hope the other church choirs will also regularly hold such services.

Big Price For a Bechtler Coin.  
At sale of old and rare coin in New York last week, a Bechtler \$5 gold piece was bid off at \$785. The Bechtler coins were minted in Kutherford county, North Carolina, and this particular one was dated 1834. It was purchased in 1832 for \$6.25 by the man for whom it was sold.—Statesville Lankmark

## \$40,000,000 GRAFT.

### Taft and Roosevelt's Brother-in-Law in Big Skin Game.

The biggest sensation sprung in the political world in some time was produced by the publication of the story in the following special cable despatch to the New York World from Paris:

Paris, Oct. 15.—In an effort to solve the mystery of the identity of those who got the \$40,000,000 paid by the United States government for the Panama canal, the world retained one of the foremost English corporation lawyers to come here from London and conduct an investigation. He is a member of Parliament, a distinguished member of the liberal party and thoroughly versed in the procedure of the French courts, with which he has had long experience. He came here armed with exceptional credentials.

He has just rendered a statement of his findings, which is doubly interesting because of the report that very little of the \$40,000,000 went to the Frenchmen, but most of it to a syndicate of Americans, including, it is said, Douglas Robinson, brother-in-law of President Roosevelt, and Charles P. Taft, brother of William H. Taft, the candidate for president of the Republican party and who was secretary of war in 1904, at the time of the sale of the canal to the United States.

According to this report the American syndicate, confident that William Nelson Cromwell, the New York lawyer and friend of President Roosevelt, and Mr. Taft would be successful in selling the Panama canal to the United States, bought up the securities of the canal company at a ridiculously low price compared with the price paid by the United States government. Though the form was gone through of sending the \$40,000,000 here through J. P. Morgan & Co., instead of French stockholders getting the money most of it was distributed to representatives of the American members.

The report made by the World's lawyer makes the fact clear that full information of the identity of those who got the \$40,000,000 is in possession of the Roosevelt administration in Washington, and records of the payment having been turned over to the United States government.

You are going to hear something like Pitt county giving a big Democratic majority on the 3rd of November.

Chairman Mack says the fight is won, but we hope the boys will not put up their guns until the night of Nov. 3rd.

There would not be so much hard times if people would just make an effort to pay their debts, instead of seeing how long they can put off doing so.

There is no question of electing the entire Democratic ticket in Pitt county by a handsome majority, but the thing to do is to make the majority a record breaker for the county.

Instead of Roosevelt succeeding Taft after eight years of the latter, as suggested by Son-in-law Longworth, there is more likelihood of Parker succeeding Bryan along about that time.

The Raleigh Times says ex-Judge Montgomery has brought suit against Mr. Thomas Dixon because of that letter. According to the way we look at it, Judge Montgomery started the matter and got only what might have been expected when he stirred Mr. Dixon. But it is not entirely a new thing for a man to get the worst end of a controversy and then try to even up by bringing suit for slander.

spicuously; "By royal command that excellent gentleman and trustworthy custodian. Mr. George R. Sheldon, the treasurer of the Republican national committee, has visited the White House to sit as Saul at the feet of Gamaliel and learn from an eminently 'practical' man how best to raise the sinews of war. The White House bulletin which narrates the important meeting gives the assurance that the President having put some ginger in the campaign - most chemists would call it dynamite - will now impart vigor to a delicate patient by a hypodermic injection of greenbacks. The Washington correspondent of our neighbor, The Herald thus speaks of the immediate effects of the active intervention of Mr. Roosevelt in the matter of a comparatively empty campaign treasury:

"There will be something doing in the region in which Mr. Sheldon circulates in the very near future. Balance sheets of the campaign fund, totals from which are reported to the President, indicate that it has increased heavily since he took up the matter of adding to the assets. Several large contributions which have been hanging back have been shaken down by the President's vigorous methods and have rattled into the treasury."

"Mr. Roosevelt's qualifications for this work are beyond dispute. The past has shown that in raising campaign funds he is unembarrassed by ordinary conditions of official propriety or common decency.

"Who but Theodore Roosevelt would have sent for 'My dear Harriman' to raise money on the eve of an election, coupling with the invitation the stimulating assurance that 'a few weeks hence, before I write my message, I shall get you to come down to discuss certain government matters not connected with the campaign'? A Tammany grafter taking his toll of suffering and shame could not have been more direct.

"Who but Theodore Roosevelt would have directed two years later an investigation by the Interstate Commerce Commission of the Union Pacific Railway system, upon the receipt of information conveyed by Mr. James Schoolfield Sherman that Mr. Harriman declined to be mulcted further for campaign contributions?"

"Who but Theodore Roosevelt could have detached from his cabinet the Secretary, who was officially most intimately connected with commerce and industry, and therefore with great corporations, and make him the chairman of the Republican national committee?"

"Who but Theodore Roosevelt would have sought, through his personal selection of such chairman a contribution of \$100,000 from the Standard Oil Company, to help re-elect himself?"

"Who but Theodore Roosevelt would for his own protection have written simultaneously a letter which directed Mr. Cortelyou to return the Standard Oil contribution and then tacitly permit its retention and actual use in the campaign?"



LIGHTNING AND SHIPS.

Vessels Are Struck More Frequently  
Than Is Supposed.

In spite of the popular impression to  
the contrary, ships remote from the  
land are seldom damaged by lightning,  
although some of the most awe in-  
spiring displays of atmospheric elec-  
tricity are frequently witnessed by  
those on board of them.

Standing rigging and even parts of  
the running gear are now made of  
steel wire, and this substitute for the  
old fashioned hemp serves the purpose  
of lightning conductor when the ship  
is not fitted with such an aid to safe-  
ty. The electric current is conveyed  
down the wire rigging and reaches the  
sea through the vessel's metal hull.  
Damage occurs only if the current be  
interrupted on its way down. In a  
comparatively large proportion of in-  
stances the fore royal truck is struck  
by lightning, that of the main less fre-  
quently and the mizzen least of the  
three.

Very serious casualties under this  
head occurred to warships and mer-  
chant vessels in the days of wooden  
hulls and hempen rigging. In July,  
1802, as thirteen sailing vessels of the  
East India company were trying to  
round the cape in the vicinity of Algoa  
bay, homeward bound, two of them,  
the Britannia and the Bombay Castle,  
were struck by lightning. The fore-  
mast of each was soon enveloped in  
flames, and the masts had to be cut  
away in order to save the ships and  
their combustible cargoes. A heavy  
gale was blowing, the night was dark,  
and the other ships of the fleet, which  
were hoisted to at the time, were wit-  
nesses of this thrilling incident.

Many vessels are now fitted with  
lightning conductors of approved types  
lest the wire rigging should fail to  
carry off the electric current. In May,  
1896, shortly after a severe thunder-  
storm, accompanied by lightning and  
rain, in 3 degrees south, 87 degrees  
east, the P. and O. steamship Victoria  
had a sudden increase of deviation  
amounting to 6 degrees in both the  
standard and the wheelhouse com-  
passes, and later it was discovered that  
the lightning conductor on the fore had  
fused. The ship must have been  
struck by lightning during the storm.—  
Knowledge Magazine.

WALL STREET "TIPS."

Best Place to Plant Them if They  
Come Your Way.

A seasoned Wall street campaigner  
condenses a life of practical observa-  
tion in the remark: "Stock market  
'tips' are, as a rule, founded on noth-  
ing better than guesswork or pure in-  
vention. Although usually without  
valve, openly peddled out to the pub-  
lic and not possible to trace to any  
reliable source, they come clothed in  
such a garb of mystery and apparent  
importance that there are always a lot  
of ill informed persons who will ac-  
cept them and act on them as on gospel  
truth.

"Often these so called 'tips' are but  
the whispered suggestions of some ma-  
nipulator who was confident that his  
mysterious, semi-confidential hint would  
travel and be made the basis of large  
buying of some stock he was especial-  
ly anxious should be largely sold.

"It is told of one great speculative  
magnate of the past generation that  
when he was approached by the pastor  
of a rich and fashionable Fifth avenue  
church in search of means by which  
he could become suddenly rich he put  
his lips close to the clerical ear and  
whispered: 'Buy Pacific Mail. It's a  
sure thing. If you lose on it I'll make  
good your losses.'

"The pastor departed gleefully. Some  
two weeks later he called at the office  
of the manipulator and deplored the  
great financial losses he had incurred  
in following the confidential 'tip.'  
'How much were they?' asked Mr. G.,  
and on being told he drew his personal  
check for the amount.

"The minister took it and after ex-  
pressing his thanks hesitated a mo-  
ment and then said: 'But how about  
my parishioners? You placed no ban  
of secrecy on me, and their losses have  
been enormous.'

"The financier smiled grimly as he  
remarked, 'You see, doctor, those were  
the fellows I was after.'

"This story may be true or may not,  
but it points a moral. If you get a  
'tip' on Wall street bury it in the back  
yard and forget it."—Cleveland Leader.

THE BOTTLE TREE.

A Life Saver For Cattle During the  
Australian Droughts.

"It was like a real bottle, thirty feet  
high, covered with the bark of a box  
tree and with a gum tree growing out  
where the cork ought to be."

Such was the way in which an Eng-  
lishman described the first bottle tree  
which came under his notice, and truly  
one who does not know the tree its  
sudden appearance in his pathway,  
often in the midst of dense scrub, must  
make a vivid impression.

The lower part of the trunk is thick  
and cylindrical, decreasing in size to-  
ward the top, its shape being that of a  
gigantic living bottle, from the neck of  
which spring the only branches and  
leaves that the tree possesses. In this  
respect it carries to an excess the pec-  
uliarity of most Australian trees—  
namely, their lack of branches for a  
considerable distance up the stem.  
The bark is of grayish color and is  
very hard, says the Philadelphia In-  
quirer, but the wood inside is soft and  
moist. The latter can be chewed in  
the same way as sugar cane, but as it  
lacks its sweet, pleasant taste it is  
rarely used in this way. This peculiar  
characteristic of the tree, however,  
makes it a valuable food for cattle.

Indeed, during the long droughts  
which occasionally visit Australia hun-  
dreds of settlers have to thank the  
bottle tree for saving them from ruin.  
Sometimes for more than a year and  
in the inland districts for still longer  
periods scarcely a drop of rain falls.

Every blade of grass is dried, tanks  
become empty, creeks no longer run  
and in many cases dry up altogether,  
as do nearly all water holes and lag-  
oons; cultivation is impossible, and  
fodder for cattle and horses is extreme-  
ly difficult to procure. Then the bottle  
tree comes to the rescue. Every scrub  
is searched for these living bottles,  
and everywhere is heard the ringing of  
axes as the strange, attractive trees  
are laid low.

As soon as the trunk has been strip-  
ped of its bark the cattle are brought  
to it if within easy distance, and there  
they remain till neither leaves nor  
wood is left. In places where the  
settlers have no scrubs of their own  
they will drive many miles in order to  
obtain a wagon load of this great treas-  
ure.

Sometimes instead of allowing the  
animals free access to the tree the set-  
tlers cut the trunk into strips, put the  
strips through the cutter and thus  
make a substitute for proper chaff.

In many instances during a drought,  
except for prickly pears and the fol-  
lage of trees, cattle are fed on these  
living bottles alone, and they have  
been the means of saving large quan-  
tities of stock.

It seems strange that in the absence  
of rain these trees should retain their  
moist interior, as the majority of oth-  
ers look dry and drought stricken.

But throughout all the bottle tree  
flourishes, lifting its dark green leaves  
toward the sky, whither the farmers  
and squatters turn longing eyes in  
hopes of the wished for rain.

When the dry season ends and the  
land in a very few weeks is covered  
with fresh green grass, the work of  
the bottle tree is done. But, mindful  
of its past usefulness, no farmer un-  
less under absolute necessity fells this  
tree, and it may often be seen stand-  
ing in solitary grandeur, its strange  
shape outlined against the blue sky,  
while the land at its base has been  
put under cultivation or has been con-  
verted into grazing grounds for the  
cattle.

The Persians.

Every traveler from Morier on-  
ward has descanted on the physical  
cowardice of the Persians. But  
there are mysteries about the valor  
of Asiatics which no European his-  
torian has yet set himself to solve.  
It was currently said in the early  
eighties among Englishmen that the  
Egyptians were cowards, yet under  
Mehemet Ali they defeated Turkish  
armies and Wahabi fanatics and  
would have overthrown the Turk-  
ish empire if Europe had not inter-  
vened. There are similar passages  
in Persian history.—London Nation.
