GOV. GLENN AT WINTERVILLE.

A Big Day for Democracy in That Town and Section.

Gov. R. B. Glenn was with the Democratic county candidates at Winterville on Thursday and spoke to a large and enthusiastic audience. It was first planned that speaking should take place from a platform in open air, but the weather was not favorable for this and the large auditorium of the high school was used, the audience filling this.

Mayor H. W. Whedbee, of Greenville, presided over the meeting and first introduced the county candidates present whom he said would be allowed just one minute each to make their announcements.

Following these Mr. Whedbee, before introducing Governor Glenn, said he wanted a few minutes to refer to some county matters that should be mentioned. He named some falsehoods Republican speakers in this county are telling, and the way he lambasted the Republicans for it was a caution. He said men should be just as honest in politics as they are in business dealings or around their firesides, but honesty seems to be an unknown principle to Republicans.

Mr. Whedbee then eloquently introduced Governor Glenn who made a speech that aroused great enthusiasm and brought frequent interruption of applause. He captivated his audience at the very start by saying "Like the preacher, I want to begin by making a few announcements. First—An election is going to be held on the 3rd day November, 1908, and in that election North Carolina is going to give 40,000 to 50,000 Democratic majority. Second—On the 9th of January, 1909, a man is going to take the chair as governor of North Carolina who spells his name W. W. Kitchin. Third—

Soon after the 4th of March, 1909, some of you folks will be receiving commissions signed by W. J. Bryan, president of the United States.

Governor Glenn then went into a discussion of national issues that was strong and convincing. His comparison of the two candidates for president, Bryan and Taft, and of the platforms of the two parties made it clear that it is the duty of every one to vote for Bryan. Taft, he said, was not the choice of the Republican party as its candidate, but the Republican convention at Chicago was dominated by Roosevelt who forced the naming of Taft as a means of furthering his policies. Upon the tariff and the iniquitous indirect tax it imposes upon the people he made the best argument we have heard from any speaker, his illustrations of this being simply unanswerable.

In the discussion of State issues Governor Glenn was equally effective. The records of the two parties in North Carolina were brought vividly before his hearers who were asked if there would be any reason in overthrowing the Democratic administration which had placed this State in the foremost rank of progress and prosperity, and turn it back into the hands of the Republicans whose record of plunder and extravagance was so pronounced.

All through Governor Glenn's speech was emphasized with sound argument, now and then some striking story being used to impress a point. It was a great speech and made the principles of Democracy stronger in

BENEFITS OF BUILDING AND LOAN

[Extract from the address, of Hon. O. B. Eaton at the State Convention of the North Carolina Building and Loan League at Winston-Salem.]

"The first impression of what one is, what he ought to do, what he ought to be and what he ought to have is not derived from teaching or preaching, but from the home. Any intelligent plan, honestly and wisely managed which offers a poor man an opportunity to save a part of his earnings with which to pay for a home is a blessing and a benediction. The Building and Loan Association is undoubtedly a poor man's friend, and helps him when he could get help from no other source. It teaches him the great lesson of economy; it teaches him that some measure of self-denial is an invariable condition and blessedness in human life; it teaches him to sacrifice today that he may possess tomorrow; it teaches him that he can never build himself up as a citizen and a man of influence unless he owns a home, or in some way is tied in a business direction to the community in which he lives."

Advertising.

This is a live topic with the merchant. A merchant who does not advertise cannot stay in business long at a time.

For advertising is a broad term. It includes window displays, talking up one's wares, courtesy to customers, satisfaction to customers (for haven't we all been told that a satisfied customer is the best advertisement?)—circular letters, bill-board and program advertising, newspaper advertising and what not.

So it is that every merchant must advertise. And the main question is how best to advertise.

Newspaper advertising should be given the preference for several reasons. The newspaper is an institution which is constantly laboring for the up-building of a town. Not only so, but newspaper advertising, it is generally conceded, brings the best results.

But with all this true, merchants spend a lot of money on other ways of advertising than newspaper advertising and some of this so-called advertising is scarcely worthy of the name. They are approached with all sorts of schemes. Shrewd solicitors drop into town, stay about two days and go out with seventy-five or a hundred dollars of the town's good money; while the merchants in most cases get nothing or what amounts to nothing.

We urge our merchants, as we have done before, look closely into these advertising schemes. Think the obscurity and uncertainty out of them and see if in nine cases out of ten you are not getting humbugged. Think, too, about whom you are helping by extending patronage. In nearly every case it is not somebody who will spend the money you pay him miles and miles away from here where not one cent of it will ever drift back into your money till? On the other hand, remember that the money you pay the newspaper is turned loose right here where it helps to swell the volume of business and does its part towards enabling us to have a live, progressive, hustling town. Remember, too, that in extending patronage to a newspaper you are helping an institution which is constantly working for the advancement of your town.

Cut out the gew gaws of advertising and put more time and money into real advertising.—Greensboro Telegram.

The more Roosevelt and Taft display themselves in this campaign, the more votes are made for Bryan.

There seems now only one possibility for Taft to defeat Bryan, and that is for the Republican national committee through the aid of the trusts to buy the State of New York in the election. The cry the Republican committee is making for more funds is good evidence that such a move as this is in contemplation. They hope in the few days preceding the election to sweep down on New York with a big corruption fund that will buy the State for Taft. The election of Roosevelt was corruptly bought four years ago, and they hope to do the same thing for Taft this year.

Another evidence of the interest the Norfolk & Southern Railway takes in helping to develop the section through which it travels, is the system of low rate excursions from the West the road has inaugurated. Round trip excursion tickets from points in Ohio, Indiana, Illinois and Kentucky to points on the Norfolk & Southern are sold at about 80 per cent. of the regular fare one way and limited to twenty-one days. The purpose of these special rates is to induce Western farmers, stockmen and investors who contemplate a change of location an opportunity of visiting this Eastern section and investigating its advantages. If any one who reads this has friends or relations in the West it might be well to write them and call attention to these excursions with a view of getting them to take advantage of them.

TAFT'S SOUTHERN TOUR.

The tour of the Republican candidate for president in Kentucky, Tennessee, North Carolina and Virginia ended on Sunday in the White House. This way around for reaching Robin Hood's bath was probably the real object of the trip rather than any hope of making political propaganda in the South. If any such hope had lodgement in the breast of the candidate, what he witnessed in the South ought to convince a more sanguine man of its illustrious character.

Instead of propitiating the people of the South, Taft appears to have gone there to insult them and stir up a spirit of sectionalism in the North in his despair of their support. What could be more insulting than his gratuitous assertion that a class of the Southern people will vote against him while hoping that he will be elected, or his assumption that they do not know what is for their own good? Whether in the South or the North, no citizens can be more contemptible than such as are wanting in the courage to vote in accordance with their convictions of political duty. When have the Southern people de-

served Taft's reproach of cowardice? His utterances betray for yet another time how little he is in sympathy with genuine popular sentiment. But what could be more natural in a bureaucrat who has never been in touch with the people than his assumption that the people are incapable of managing their public affairs or so frivolous as to vote against their own judgment?

Mr. Taft is quite as much mistaken when he attributes the aversion of the Southern people from the Republican party to outworn traditions and to the question of race and color. A sufficient ground for this aversion is that the acts of the Republican party leaders afford no reason for confiding in their promises and professions in this campaign. What degree of confidence could the people of the South have in the presidential candidate of a party whose leaders in the last session of congress passed the Crumpacker bill to deprive them of their rights of national representation? Why should they hope for the election of this candidate while voting against him?

But, wholly apart from this menace of sectionalism, the same party that impoverished the South, under its carpet-bag regime is pursuing a like policy of spoliation toward the entire American people. Is not that a sufficiently solid ground of aversion? The systematic exploitation of the people for the shameful aggrandizement of trust interests constitutes the fundamental policy of the party of which Taft is the standard-bearer in this campaign, in spite of all subterfuges and pretenses for cloaking the naked hideousness of the policy. In the South and the North, in the East as well as the West, the national Democratic party, with full ranks, is marching to extinguish this system of robbery and restore the principle of "equal rights for all, special privileges for none." In this generous movement the Democratic party rejoices in the support of thousands of independent Republicans and workingmen who have become convinced of the necessity for a change of government. —Philadelphia Record.

A QUIANT SWISS CUSTOM.

Picturesque Ceremonies Accompanying the "Passing of Winter."

The land of the Switzers is rich indeed in folklore. Who has not heard of the ringing deeds of William Tell? And so thoroughly do these hardy mountain folk enter into the spirit of these old stories and quaint customs that the traveler finds monuments erected to the memory of this traditional hero, while even in such up to date cities as Zurich, that so impresses the American tourists on account of its imposing buildings and busy stir, the entire population abandons its industry in order to take part in a symbolic festival every spring. It is the "passing winter," or, to use the picturesque native expression, "sechselauten"—8 o'clock ringing feast—the beginning of which is announced by the cathedral chiming the hour of 6. The real celebrations begin at 8 o'clock, when the national and cantonal flags are hoisted on the staff of the cathedral. A pretty sight is that of the procession of more than 1,000 children, in appropriate costumes, escorting the triumphal car bearing the Goddess of Spring, attended by her maidens, while behind her is drawn amid dancing clowns the captive Boegg, representing winter, being a huge figure made of wood and covered with cotton wool stuffed with crackers and gunpowder.

Winding through the streets on either side of the river Limmat, the procession makes its way to the lakes. Here the Boegg is raised on high poles and a bonfire built up around it. During the afternoon the city guilds parade in quaint costumes, and many merry jokes are played, until at the first stroke of 6 the torch is applied to our friend Boegg, and winter's reign is a thing of the past. The flames leap up and are reflected in the lake, while from surrounding boats fireworks add to the liveliness of the scene. The guild houses, of which Zurich has many handsome examples, are thrown open to visitors, and the evening is devoted entirely to pleasure and entertainment. — Springfield Republican.

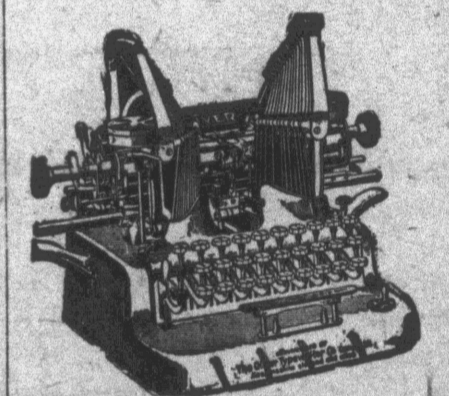
