ADDRESS OF O. L. JOYNER.

At the 8th Convention of Tobacco Association of the United States.

In this issue will be found the address of Mr. O. L. Joyner, delivered before the annual meeting of the Tobacco Association recently held at Richmond.

Mr. T. M. Carrington, president of the Association, writes that he considers the address the best he ever heard on the question discussed by Mr. Joyner.—Southern Tobacco Journal, Winston, N. C.

MR. JOYNER'S ADDRESS.

When solicited by the President of your Association some weeks ago to come and participate with you in the celebration of your 8th annual convention, making a few remarks, I was somewhat at a loss to know what I could talk about that would be of interest to the members of your Association, and I therefore wrote him that I was a public speaker, but possibly might be able to say something at a meeting of tobacco dealers the relation of the tobacco grower to the tobacco dealer would be of interest. Repeating he told me my suggestion the subject would be entirely satisfactory, as "the tobacco dealers should be thought a good deal of by the tobacco growers."

In reply in the above language, gentlemen, confirmed my suspicion that the subject suggested is one with which your Association was not very familiar, and I decided to be with you and endeavor to present to you some phases of this subject that might throw some light and do good. Although my identity with the tobacco trade covers a period of eighteen years, yet during this time I have occupied what may be very properly termed a light zone, that indistinct and most indefinable position connecting the two great factors of the tobacco world, to-wit: The tobacco grower and tobacco dealer.

I have said indistinct and indefinable position by which I mean, and the thought that I intend to convey is not that the warehouse business is not as definite and as pronounced as any other branch of the tobacco business but as the connecting link between the two great factors is not at all clearly and distinctly understood as either, since I have employed Mr. Bryn's newly coined phrase of a twilight zone as nearly expressing the sphere of the tobacco warehouseman than any other word of phrase at my command. From the vantage point, if such may be called, of this position accustomed by the very force of its circumstances to look at questions affecting the interest of both the seller and buyer, from a wholly disinterested personal point of view, the conscientious warehouseman has opportunities of forming a more correct idea and estimating more accurately the true relation of the tobacco grower to the tobacco dealer than any other factor engaged in the trade.

At first thought it may seem to some of you that this is a subject of not much concern to members of this Association, but upon reflection I am sure that you will agree that there are many matters affecting the interest of both alike, which if they were properly understood and adjusted, would result in the solution of many problems with which the trade stands confronted. No one of us has the legal or moral right to say "I am not my brother's keeper," therefore,

with the view of presenting some phases of this question for your consideration in the hope that they may lead to a better understanding of the true relation of the tobacco grower to the tobacco dealer, I have left a very busy business to be with you this evening.

In the first place, gentlemen, how many of you ever seriously thought about your relation as dealers to the growers, and if so, have you located your responsibility in that relation? It is perfectly frank in me to assume that not many of you have felt any greater obligation to the grower than your contribution to the price of his raw product, which price is established, not by any voluntary act on your part, but by the force of natural law, found in its expression of supply and demand.

If my assumption is correct, then it follows that the discharge of the obligation is not a voluntary act on your part, but the result of trade conditions which on account of the lack of intelligent concert of action on the part of the growers a state of affairs has been brought about that in many places is not at all satisfactory to the growers and certainly not profitable to the dealers. Confronted then with such a situation is there a practical remedy which the dealers can assist in employing that will result profitably alike to both dealer and grower? I contend that there is, and to this question I wish to address my remarks.

In a very large majority of the homes of the tobacco growers of my section, eastern North Carolina, many of them humble homes, it is true, there are glad hearts and smiling faces, not over fortunes made out of the growth of bright tobacco, for not many of them have made money, but because there is a clearer and more intelligent understanding of the true relation of the grower to the dealer. If all is not realized by the grower for his crop that he feels he should have, he knows from an understanding of conditions that there is a cause, and instead of resorting to the torch or seeking his gun to right his real or supposed wrongs, he goes about to ascertain that cause and remove it or improve it in a legal and orderly way.

This condition is the result of the honest efforts of both dealers and growers to better understand each other's positions. A free and easy intercourse between growers and dealers and the removal of the stone wall of restraint that once obtained and hedged about the dealer and caused him to be looked upon by the grower as some different and superior being altogether above and beyond his reach has contributed materially to this condition. A simple remedy this, yet it has accomplished wonders and no one will say such a condition is not more desirable and profitable to both grower and dealer. Prevailing prices for our inferior tobacco may be said to be the cause of this condition. Granted that to some extent this is true, but even with such prices it is the exception and not the rule that much money has been made for the past few years by our tobacco farmers. The real cause is the fact that our farmers are sufficiently intelligent to comprehend conditions and honest enough to assign just motives to the acts of others, attributes of character, always admirable wherever found, and found just as often among farmers as in other professions, and to become marked characteristics need only

the proper cultivation. This cultivation to be effective must be done by tobacco dealers, that is by men engaged in other branches of the tobacco business than that of growing it. For eighteen years I have engaged in the tobacco warehouse business, and as I have tried to become master of my art have found it very necessary to study closely the nature and characteristics of the farmer. As a result of my experience I give it now as my deliberate opinion that the farmer, considering his opportunities and advantages, his environments and his training, is the equal of any other profession of men I have ever mingled with, and the superior of many of them. He is possessed of the same human nature, susceptible to all its varying moods and impulses, and endowed with its hopes and ambitions, but on account of the limited opportunities of a broader training in the pursuit of his vocation, he is more easily influenced in his conclusions, especially along the line of his natural inclinations, than others of superior opportunities and advantages, but in my experience I have found that with few exceptions the tobacco farmers have willingly embraced such opportunities as have been offered them of tracing cause and effect. When men endeavor honestly and conscientiously to find what is right in order that they may do right, no legitimate business will suffer at the hands of such men. On the other hand when men, bent only on carrying out their own wishes employ and justify any means to accomplish their ends, every legitimate business will suffer in consequence. Therefore a relation of good will and harmony for the best interest of both should obtain between the grower and the dealer. To bring about such a condition is the duty, and should be the desire, of both dealer and grower, but the greater burden and responsibility of bringing about this condition lies with the dealer, because of his greater opportunities and advantages. The permanency of any business structure will depend largely on the justice of its foundation. You cannot build up success and prosperity among tobacco dealers upon the ruined homes and shattered hopes of the tobacco farmers. You cannot foster very long a smiling land of tobacco growers at the expense of the legitimate earnings of the tobacco dealers.

The interests of both are too closely allied and interwoven for disaster to either not to effect seriously the welfare of the other, and the sooner this principle is recognized by both the sooner and surer will a congenial and harmonious relation be established that will insure respectful consideration for the rights of both.

SENSATION OF THE CAMPAIGN.]

James S. Sherman Exposed in Big Land Fraud.

W. E. Gonzales, editor of the Columbia State, wired his paper from New York last night as follows:

"New York, Oct. 26.—The World sprung the sensation of the campaign this morning when it devoted two and a half pages to exposing the connection of James S. Sherman, Republican vice-presidential candidate, with a land company that proposed to secure a great block of public land from New Mexico at 3 to 5 per cent. of its value. The company first planned to buy 150,000 acres by means of 'dummy' applications for 160 acres each. Workers in a Milwaukee brewery were the dummies.

"But the promoters became alarmed and decided to get Congress to permit New Mexico Territory to sell in 25,000-acre blocks. Sherman, general attorney for the land company, drew and introduced the bill. It passed the house and was only held up in the Senate by one objector, Patterson of Colorado.

LEGAL WORD SPECIALISTS.

Have to Know Exact Shade of Meaning in Words and Phrases.

"Some people seem to think that an important legal document can be drawn up by a lawyer in the time it takes his client to smoke a cigar," remarked a gray-haired law clerk the other day. "It takes time and the most scrupulous care to get things just right. If lawyers were not careful the Lord only knows where the clients would land."

"Why, I know a man in one of the great law offices who is a specialist in the exact shade of meaning of each word or phrase used in a legal document. Nothing goes out of that office without being submitted first to him to pass upon. Sometimes he will give a week to the study of but one short but very important paper, theorizing as to the possibilities of its meaning being construed this way and that. When he gets through with a document, however, and has submitted every word of it to the acid test there is practically no chance of its not being exactly right, as to its verbiage at least. In some cases, too, it is deemed desirable by clients to becloud the meaning of a contract so that there is a loophole for its being construed in another way in the event of certain contingencies occurring. That is where the services of an expert word juggler are indispensable."

"The biggest case that I ever heard of in this line was when one of the great corporations wished to issue some mortgage bonds against its property. A long contract had to be drawn, and the wording on the back of the bond had to be decided upon. The matter was so important that, after the attorneys themselves had decided on the forms to be used, it was turned over to two of these experts in verbiage."

"They looked up the dictionary meaning of practically every word used in the two documents and made innumerable changes and suggestions. Before the papers were finished thirty different drafts of each of the two documents had been made, and there was not a word used in the final form of the papers that had not been considered carefully, not only as to its individual meaning, but also as to its individual relation to the other words of the phrase or sentence containing it. It is safe to say that these two documents are never likely to be assailed successfully in a court of law and that they mean exactly what the corporation and its counsel wished them to mean."—New York Press.

ABOVE THE LAW.

Courts Have No Jurisdiction Over Foreign Ambassadors.

The chief of an embassy is an august being and one who boasts some remarkable privileges. It may be mentioned to begin with that in the land

in which he is officiating an ambassador ranks immediately after the princes of the blood-royal.

The ground on which an embassy stands is in theory as well as in practice the territory of the nation to which its principal occupant belongs. Even if a criminal were harbored in an embassy the police could not enter the premises without permission.

An ambassador is above the law of the country to which he is accredited. The courts have no jurisdiction over him, and, strangely enough, his subordinates and even his domestic servants are also inviolate. The humblest employee in the embassy if he committed a punishable offense could not be arrested without the consent of his master, nor can an embassy official be imprisoned for debt.

Ambassadors are to be envied most of all perhaps for their freedom from the burden of taxation. They disburse not one penny in taxes, either directly or indirectly, and, as for the custom house, it is nonexistent so far as they are concerned. No duty whatever is charged in respect of wines, cigars, cigarettes, etc., that are consigned to them.

Again, their excellencies need not bother about taxes unless they please. That they do so is purely an act of grace on their part. They are not legally exempt from these tantalizing demands on the purse, but if they decline to meet them there would be no means of enforcing payment.—Cassell's Journal.

If All Candidates Were White.

The word "candidate" is from the Latin "candidatus." Literally it means white robed, and it was thus called because in Rome those who sought office wore a glittering white toga. Fancy, if you can, all our modern Americans dressed in accordance with their political ambitions. In some sections there would be no such thing as a dark suit of clothes. Washington would simply be one shining center of universal whiteness.—Saturday Evening Post.

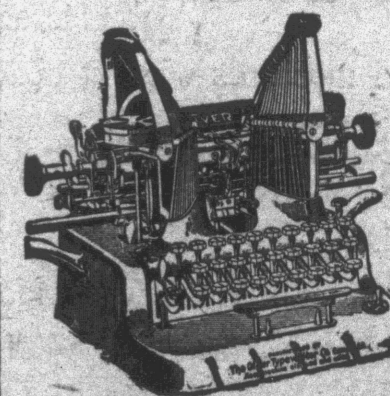
