THE ELECTORAL VOTE.

Taft Will get 309 and Bryan Will get 174

New York, Nov. 4.—The following votes will be cast in the electoral college for Bryan:

Practically complete returns received up to a late hour tonight indicate that William H. Taft, of Ohio, as President-elect, will have a vote of 309 in the electoral college. This is within sixteen votes of the forecast made by National Chairman Frank H. Hitchcock, and sixtyseven more than a majority out of the total electoral vote of 433.

The most important news of the late returns indicate that Maryland, after vacillating during the day and apparently being safe for the Democracy, has been swung into the Taft column. The unofficial figures give Mr. Taft the State by 136 votes.

Maryland was the last of the doubtful States to be heard from, Indiana and West Virginia, as well as Montana, turned out to be safely Republican. Colorado went for Bryan.

Mr. Bryan has a total of 174 votes, two less than he received in 1895. In 1904 Mr. Parker received only 140 votes, in 1900 Mr. Bryan received 155 votes and in 1896, the Nebraskan received 176 votes.

Mr. Taft's 307 electoral votes compare with 336 received by Roosevelt in 1904, 292 received by McKinley in 1900 and 271 received by McKinley in 1896.

TENTH DISTRICT IN DOUBT.

Though it Appears That Crawford is Elected.

Asheville, N. C., Nov. 4.—The result of the election yesterday in the Tenth Congressional district is still in doubt tonight. Although incomplete returns indicate that William T. Crawford has a small majority over John G. Grant, the Republicans are confident, claiming Grant's election by 119 majority. Although some of them privately admit at the figures may be wrong and that Grant did not have more than 50. The Democrats, on the other hand, claim Crawford will have 257 majority, conservative estimates place this claim in the exaggerated column. According to the most reliable Republican Crawford will have a majority of about one hundred or a little less. The Republicans are basing their claims on the information that tonight Swain will give 200 majority for Grant instead of the original claim of 175, that Cherokee will give three hundred instead of two hundred and four. And they have carried Macon by about seventy-five. The Democrats claim Macon, and the vote is probably close. It will take the official count to determine the result in the district.

When the news of the death of Ola Forbes was announced it sent a shock of surprise to his many friends and acquaintances throughout the country. In perfect health a few weeks ago he was stricken with fever, but no one dreamed it was to be his fatal illness. After battling five weeks he was finally overcome and in exhaustion fell peacefully to sleep to wake no more.

I stood at the bedside of this dying man, who only yesterday was so strong in the prime of vigorous manhood and watched the lifelight gradually fade, and as I realized that his vision was becoming obscure and saw the gathering of the cold damp death dew on his brow, many tender recollections of happy bygone days crowded to memory.

He was a big, noble hearted man, who loved his friends and in turn was loved by them, but the most beautiful affection I have ever known was the simple intense devotion that lived and has eternal existence among the parents and children of this family, who until this death had known no such bereavement.

To them the grief and sadness over his death is unutterable anguish. To his wife and children, the especial objects of his affection and devotion, his death brings grief and sorrow that knows no comforting.

SHALL FIND JOY OUT OF OFFICE.

William J. Bryan Expresses Pleasure at Result in His Own State.

Lincoln, Neb., Nov. 4.—While not caring to discuss at this time the political effect of the Democratic victory in his home State, or analyze the causes, William J. Bryan this afternoon in an informal talk to a number of friends who called on him expressed his pleasure at the result in Nebraska and the satisfaction it afforded him to learn of the election of so many of his political and personal friends.

A delegation numbering nearly a hundred from Lincoln, visited Mr. Bryan at Fairview to express to him their confidence and devotion and to assure him that such was the sentiment of a majority of the people of his city and State.

Mr. Bryan in responding, said: "I am highly gratified over the results in this State. The national defeat has not been such a disappointment when we have had so many things to console us. I hope I have convinced my friends that running for office has only been an incident to my work. My heart has never been set on holding office, but I wanted to do certain works and it looked as though the Presidency might offer the opportunity to do that work. I am sure in private life I can have the chance to do something. One is not required to hold office to do big things; one is simply required to do some thing within his reach, and that much is within the reach of each of us.

"Personally I shall find as much joy being out of office, if the returns show I must be, as I would be in office. I hope still to be of influence to bring about needed reforms. I appreciate very much the confidence and loyalty of the people near us. It has been the greatest comfort that the election has given us. The fact that those among whom we live have shown this confidence we appreciate more than I can tell you. It has been very kind in you to come out here and visit us on this day."

The Advantage of Discounts.

The discount of 10 per cent on bills paid by the 5th of the month, inaugurated by the Water and Light Commission, is working well both ways. It makes collections easier and more prompt at the clerk's office, and the discount is worth saving by consumers of water and lights. The service ought to have more patrons, as we hardly see how the people can get along comfortably without water and electric lights in their homes. If you consider the expense and inconvenience of keeping up a well and having to carry in water, the advantage of having a spigot at hand is apparent. And the same thing is true as to lights—keeping lamps filled and cleaned calls for labor that amounts to more than the monthly cost of electric current.

Bridge Order.

The Board of County Commissioners here ordered that no person drive or ride across the river bridge here faster than a walk. The order will go in effect on the 10th, and any person who violates it may expect to pay the penalty prescribed.

Accepts a Call to Holy Communion Episcopal Church of Charleston

Rev. F. H. Harding, for five years rector of Calvary Episcopal church of Tarboro has accepted the call to the Holy Communion, of Charleston, S. C. This decision was rendered to the vestry today, when Rev. Harding tendered his resignation to take effect November 30th.

Rev. Harding is a son of Rev. Nathaniel Harding, of Washington and came to Tarboro in 1903 from Grace church, Baltimore, of which he had been rector for two years. During his rectorship in Tarboro, Rev. Harding has made many friends, who will regret to learn of his decision, but who will wish him abundant success in his new and much broader field.

The Holy Communion, to which Rev. Harding has been called, has 350 communicant members, is the parish of the students of the Porter military school, and of an orphanage. It is a much larger field than the local parish. —Tarboro Southerner.

Mr. Bryan in Defeat.

The case of Hon. William Jennings Bryan is one full of pathos. From whatever motive, whether selfish ambition as his enemies assert, or an unselfish desire as he claims, to be in a position to serve the interests of the people, there is no doubt that he was keenly anxious to be elected president—never so anxious as this year, nor so confident as in the campaign just ended. His disappointment, therefore, in the result of yesterday's election must approach anguish of mind, and be the keener by reason of the fact which must be perfectly apparent to him that his last opportunity to be president has passed. Men have run for this office three times but none four, and Mr. Bryan's name will now be dropped, no doubt at his own instance, from the list of the available candidates of the future. Clearly in the last moments of the campaign he realized that his star was about to set; one reading his speech at Marysville, Kan., Monday night, could detect between the lines that he had seen the finger of fate. Every man with a heart in him must feel very sorry for this man, whose hope of twelve years has been dashed.

A STRANGE DANCE.

Curious Religious Rites at Whitesun-tide in Luxemburg.

A singular ceremony takes place at Whitesun-tide in the Luxemburg town of Echternach. It consists of a procession to the tomb of Willibrod, one of the patron saints of the city. The Rev. T. H. Passmore describes this curious and picturesque proceeding in his book "Further Ardenne."

In this old corner of Europe the idea of dancing to God's glory lives still. Religious dancing is as old as history and was once common in the church. The spring procession of Echternach refreshes the philosopher because it trips right up from old times and certifies him that nothing is absurd which is done sincerely. A man may smile at such things; no gentleman can laugh at it.

It is Whitsun Tuesday at 8 in the morning, a late day in spring. The town is gay with wreaths, flags and streamers, the windows aflame with flowers. Twenty thousand people fill the streets and stretch in a double row across the bridge. A sense of serious waiting fills the air.

The procession starts, with its banners, tapers and 300 singers and its clergy. All chant the litany of St. Willibrod.

Suddenly an electric tremor thrills along the whole cortege of pilgrims, instruments all along the line take up the tune, and 40,000 feet, not all light, but all fantastic, are vibrant in the dance.

It is a sort of sobered polka, three steps forward and two back. Youth and the old man rejoice together, the sick and the hale, the bent dotard side by side with the saucy schoolboy. They dance for health, for the state of their parents and friends and for the ills of their beasts.

Some very old and infirm dance by deputy, and many an urchin dances lustily for several invalids. Here a young mother dances with her young child in her arms; here an old man, whistling like a saw, forces to the measure his rheumatic bones. The pageant takes five hours to travel three-quarters of a mile.

When all is done the tired throng goes home.

Peculiar Views of Life Entertained by Eskimo Men and Women.

These people in the white world, these children of the snow and ice, give themselves little concern regarding what is going on in worlds beyond their own. The climate in which they live and the limitations of their whole environment make it impossible that there should be much change in their own manner of life, and they do not care for the changes that soap and water might make in their domestic life, while the women of the family are not anxious to adopt changes in methods of cooking that might make some of the dishes they prepare much cleaner and far less deadly than they appear to be. But the best filled larder in the homes of the most affluent of the Eskimos offers but little in the way of variety in food, and the question so vexing to the American housewife, "What shall we have for breakfast?" or for dinner or supper never troubles the Eskimo housewife, since these meals may not vary for months at a time and are prepared in the primitive way in which they were prepared by the Eskimos of generations and generations ago.

The dress of the women and the men is so much alike that if an Eskimo lady's husband's clothes happened to be better than her own she might borrow them to wear to some Eskimo society function without exciting any comment as to her dress.

As in some other lands, the man is regarded as a being vastly superior to the woman, and the birth of a girl is never regarded as a blessing. Indeed, it often happens that both the father and mother resort to the unavailing folly of tears and lamentations when it is announced that a newcomer is a girl. A boy can become a great fisherman or a great hunter, while a girl—of what use is she? A mere lumberer of the earth, regardless of the fact that she works as many hours a day as and even more than a man when she reaches the goal of her ambition and marries. Not to marry is as sad a misfortune as may befall her, and if she is married and widowed she makes all possible haste in securing a second partner.—J. L. Harbour in Leslie's.

A LESSON IN SPANISH

How Tourists in Mexico Wrestle With the Language.

A QUEER RESTAURANT ORDER.

The Way an American Woman Shocked a Waiter With a Demand For a Dish That the Cook Would Not Prepare.

"It's no wonder that men who go from the States down to Mexico on business do not get along better," said a returned New Yorker. "They don't study Spanish as they should. In the clubs half of the stock stories are about these half educated Americans."

"It was in a restaurant where only Spanish is spoken that a party of American tourists assembled. There were a woman and her two daughters and, of course, the attendant and patient papa with the wad."

"Let me order," said the mater. "I want to use my Spanish." And she proceeded to pull out a handy book of conversation. "Let me see," scanning the menu; "we want oysters, I'm sure. A small fry for each would be just the thing."

"Running her fingers through the leaves, she found that 'chiquita' means 'small' and 'frita' means 'fry.' Perfectly simple. 'Chiquita fritas' would mean 'small fries.' She held up her fingers to indicate four and said complacently to the expectant and polite waiter:

"'Chiquitas fritas.' The waiter's eyes bulged out, and his Latin politeness got a shock. 'Oh, no, senora,' he cried as he backed away; 'no chiquitas fritas!'"

"Why not?" returned the patron. "Don't you have 'em?" for in her surprise she had fallen back on her vernacular. Then she remembered her role and consulted her book.

"Nothing doing. No end of gesticulations on the part of the waiter.

"'Nice country where one can't get fried oysters,' piped the woman, and she added, 'I wonder why?'"

"You can get 'em, ma'am," said a man's rattle voice at an adjoining table. He continued: "You ordered fried babies, and they don't serve 'em in this part of the republic. The word 'chiquitas' means babies, a term of endearment, but you're all O. K. as to the fritas. If you had asked for 'ostras fritas' the order would have gone through all right."

"And she ordered 'em, though she looked daggers at the stranger, who was a New Yorker and had lived in Mexico for twenty years.

"It was the same sort of woman," continued the traveler, "who tried to ask her Spanish by asking the amount of her bill after she had taken her dinner in a restaurant in the City of Mexico. With a bland smile she addressed the head waiter with 'Como mucho?' intending to ask how much.

"Now, the word 'como' not only means 'how,' but also 'I eat,' so that the woman had remarked to the waiter, 'I eat a good deal.' This was as much as to say that the dinner was so good that she had eaten all or more than she ought. In fact, it was a compliment and such a compliment as is highly appreciated in any Latin country.

"With a deep bow the servitor expressed his delight that his humble vindex should have found approbation in the sight of the most excellent senora. It was expressed in the choice phrases that so readily lend themselves on such occasions through the Castilian tongue.

"But my lady didn't understand a word of the lingo. She meant business, and she repeated in a louder tone: 'Como mucho? Como mucho?' She was sure of her correct Spanish, but somehow she couldn't get the waiter to do anything but bow and scrape and smile.

"The puzzle was solved when the proprietor, hearing the excited voices, entered and learned that the lady merely wanted to pay her bill. Had she known that not 'Como mucho?' but 'Que es la cuenta?' ('What is the account?') is the correct expression she would have been saved trouble and mortification.

"Time and again United States consuls have set forth in federal publications the advantages of a real knowledge of Spanish to the business man. The need is growing more emphatic with every day, as our relations in trade are growing with Mexico daily. But I guess that federal publications don't hit the people at large as a general rule.

"One of the easiest ways to learn a foreign language is to read good novels in that tongue. You get so interested in the story that you just have to go on to the end to learn whether the hero and heroine come out all right.

"Students of Spanish don't adopt that method in New York. I guess, for you can't find any Spanish novels on the second-hand bookstore tables up or down or across the city. The only specimens I have found have been Spanish novels translated from the French novels. It is strange, too, for there are many excellent novels nowadays by Spanish writers.

"Of course an instructor is needed to obtain the correct pronunciation, but on visiting Mexico with a good, ready knowledge of the language you can soon acquire the needed pronunciation. In fact, you have to do it in order to get along."—New York Sun.
