Salaries of the State Officers.

The general assembly will convene on Wednesday, January 6, and after canvassing the vote will appoint a day for the inauguration of Hon. W. W. Kitchin. Eight years ago Gov. C. B. Aycock was inducted into office on Wednesday, January 15; four years ago the inauguration was on Wednesday, the 11th of January, the legislature commencing on the 4th, and it is probable that Mr. Kitchin will be inducted into office on Wednesday, the 13th of January.

The legislature of 1907 passed an act abolishing the fee system in the state offices and placing the State officers and employes on a salary basis. The law does not affect the governor's salary, which is \$4,000, but a separate act allows the chief executive \$600 annually for traveling expenses.

The act of 1907 fixed the salaries of state officers after January 1, 1909, as follows:

Secretary of State	\$3,500
State treasurer	3,500
State auditor	3,000
Supt. pub. Instruction	3,000
Attorney general	3,000
Insurance commissioner	3,500
Members cor. com'n., each	3,000
State bank examiner	2,400

The other elective officers are commissioner of agriculture, whose salary, fixed by the State board of agriculture is \$3,250, and commissioner of labor and printing, who receives 1,500 annually.—News and Observer.

ASSAULT ON HIS OWN COLOR.

Charge Against Nat Laws, Under Arrest in Durham.

Durham, N. C., Nov. 10.—Nat Laws, a negro, was arrested this morning about eight o'clock on the charge of criminal assault on a colored girl, Vella Williams, last night out near the George Lyon Park, where the carnival is on. The story told in the court this morning was such that Mayor Graham excluded every one from the room with the exception of the defendant, witnesses, officers and newspaper men. That tells the story. It was such that it has not and will not be printed.

At the last minute the prisoner asked that he be allowed a witness who was not present and the mayor continued the case until tomorrow. The negro prisoner was committed under bond of \$1,000 and two of the important State's witness were committed in default of justified bonds of \$500 each. All three are in jail and the case will be resumed tomorrow morning. There is not much doubt but that the negro will be sent over and that he will have to face a jury on the life and death issue.

The first airship will have a capacity of seven passengers. We are told it will be equipped with double motors capable of attaining a speed of 30 to 40 miles an hour. It will be similar to the United States government dirigible for 1909, which will be built along the same lines and capacity.

Secretary Cortelyou in a statement announced that he concurred in the recent decision of Attorney General Bonaparte against the deportation of John R. Early, the North Carolina leper who is kept in Washington under guard. Mr. Cortelyou holds that while he has authority to make regulations to prevent the introduction of contagious or infectious diseases into a State or Territory or the District of Columbia from any State, he has no authority to make any rule by which Early can be legally deported from this city or the State of North Carolina required to receive him.

Of the first twelve months after he retires from the office of governor of North Carolina next January, Governor R. B. Glenn says February, March, April, May, October and November will be devoted to work under the direction of the Presbyterian Home Mission Board of the Southern States in its promotion of education and evangelistic work. The months of July, August and a part of September will be devoted to the lyceum platform, under the direction of Dr. W. L. Davidson, of Washington, D. C., in connection with Chautauqua work.

ANTIQUITY OF THE COFFIN.

Probably a Survival of the Mummy Case or the Dolmen.

The shapes of familiar objects of human manufacture do not as a rule excite our curiosity. The box-like form of a coffin, for instance, suggests nothing. Even an undertaker has no views on the raison d'être of coffins save that they conduce to decency. Yet on grounds of propriety many nations, such as the ancient Romans and the Hindus, have preferred cremation to interment, since the latter involves the disfigurement and gradual decay of the dead.

Coffins indeed are not explainable on grounds of hygiene or seamliness, for which primitive men cared very little. Rather must we see in the modern wooden coffin a copy of the prehistoric stone or chalk receptacle which was a conventional reproduction of one of two things—the mummy cases familiar to students of Egyptology or the dolmen (or stone house) in which prehistoric non-Aryan races, especially around the Mediterranean from Egypt westward, were in the habit of burying their dead.

Coffins were, as Lord Avebury points out in his "Prehistoric Times," apparently unknown to very ancient man. The dead were buried in a sitting posture or in the attitude of sleep in what were regarded as a kind of ghost houses. The most elaborate and fully differentiated of these houses of the dead are, as Professor Sergi maintains, the pyramids, with their mummies and various precautions against the decay of the body.

A less elaborate differentiation of the house idea is to be found in the dolmens still remaining all over the world from India to Great Britain. A dolmen, built of five slabs of stone, covered by a tumulus, crowned by a menhir, surrounded by a stone circle, as at Stonehenge and Avebury, and led up to by an avenue of standing stones, is, in fact, a rude adumbration of the pyramid. Inside the dolmen the dead sat crouched among cooking utensils, arms, etc., put there for their use in the spirit world. Is it too much to suppose that the earliest stone coffins were imitations of the dolmens—in fact, dolmens in miniature?

Whether this be so or not, it is very probable that our old fashioned standing tombstones, and especially our table tombs (which are five sided), as well as the family vaults of great families, with their traditions of embalment and their leaden shell coffins, which conventionally outline the shapes of the dead within, are so many relics of the remote epoch when a tomb was conceived of as a house in which the dead continue to live their former lives.

The leaden shell coffins just mentioned may indeed have originated the modern coffin. The latter was still, for no apparently sufficient reason, to be constructed in accordance with careful measurements and in conventional imitation of the human shape. The leaden shell in the family vault sometimes goes so far as conventionally to preserve the outline of the fingers of the corpse, and this fact would seem to point back to a time when corpses were not confined. Thus the shell, and afterward the coffin or elaborated shell, might be regarded as interpolations in the dolmen scheme of burial.—London Lancet.

Real Self Possession.

Not long ago a young couple entered a railway carriage at Sheffield and were immediately put down as a bridal pair. But they were remarkably self possessed and behaved with such sang froid that the other passengers began to doubt if their first surmise was correct after all.

As the train moved out, however, the young man rose to remove his overcoat, and a shower of rice fell out, while the passengers smiled broadly.

But even that did not affect the youth, who also smiled, and, turning to his partner, remarked audibly:

"By Jove, May, I've stolen the bridegroom's overcoat!"—London Tatler.

Malacca Belles.

Eastern standards of beauty differ, like the customs, from those of the west. In Malacca, we are told, the small waist and velvet eyes do not count, but instead the length of the neck is the criterion of beauty. The longer it is the more perfect the beauty. The girl of Malacca at a very early age is fitted with a metal collar which compels her to keep her head erect, and as she grows the collar is increased in size, and by this means the neck is gradually elongated. A Paris contemporary, with the present style of corset in view, suggests that, given time, figures equally grotesque will be seen in European cities.—London Globe.

CONSULTED HIS RIVAL.

The Direct Methods of Work of John D. Rockefeller.

Let us give a story to show John D. Rockefeller's fundamentally direct mode of working:

In the early nineties he found himself in possession of a great deal of land in the iron ore country in the Lake Superior region. To make the land, which was purchased as an investment, yield any interest it was necessary to get this ore to market. His competitors controlled the means of transportation, and he was practically shut out of the best and most effective facilities. This was the way he went at the task of overcoming these disadvantages:

He sent, first, a representative to find out who knew most about ore transportation and the building of ore vessels. The identity of the man was easily discovered, and it was, of course, a man who was himself a large factor in the control of the trade into which Mr. Rockefeller purposed to enter.

Most people would have concealed their plans from the one person who was to be the chief rival in the new business. This is exactly the opposite of what Mr. Rockefeller did. He asked the gentleman to call upon him and then explained to this expert that he was going into the ore business and that he wanted him to build the boats. When the ore man recovered from his amazement he declined and explained that he had no idea of working to aid a new rival to go into his business. In ten minutes Mr. Rockefeller explained to him that he was obliged to market his iron ore from his lands to get an income from the investment, that he was willing to pay the builder a good profit for the best boats that could be built, that he was also willing to give an order then and there for \$3,000,000 worth of ships, but that if he did not care to take this order he would have to go to the next best man, which would deprive the ore man of the profit to be gained from building the boats, but that the work would surely be done by some one. He had logic and common sense on his side, and the ten minutes' talk was sufficient. The details were worked out at the office. The ore man accepted the order at a price profitable to him, and the result was a good bargain for both. You may be sure that the satisfaction to Mr. Rockefeller was the personal touch with the man—the making of the trade. Even in his most active times he was not interested in details.—F. N. Doubleday in World's Work.

Earthquake Carpenters.

The term "earthquake carpenter" at first glance might give the impression of a person capable of doing a job in fast time, regularly shaking the work together. To some persons it might convey the idea of a man whose work was so poor that it was likely to drop to pieces at any moment. Actually it is a Jamaican term and really means a man whose work is in wrecking, a man who takes apart the fallen houses and sorts out the timbers.—New York Sun.
