AN INTERESTING SUNDAY.

At Three of the Town's Churches—Prospective Preacher Preached.

Summrell preached. He is to serve this church one Sunday night in each month. He has served the church before and is esteemed highly by Greenville people.

At Memorial Baptist church Rev. Leland W. Smith, of Louisville, Ky., preached both morning and evening. This church recently invited Mr. Smith to become its pastor, and while having the matter under consideration he decided to make the church a visit. His sermon made a deep impression on our people and many expressed the opinion that the church and the community will be fortunate to secure such an able preacher. It is earnestly hoped that his decision will be to accept the call. The choir gave splendid music at both services.

At the Christian church Rev. D. W. Arnold preached as usual at the morning hour for service. Neither this church nor the Methodist church had service at night, both the pastors attending the service in the Baptist church. The spirit of Christian fellowship between the churches of Greenville is very strong.

Four Coming Eclipses.

The almanacs of 1909 foretell four eclipses to transpire during the coming year, three of them being total, and the number being equally divided between the sun and the moon. Three will be visible here, while the fourth will not favor the citizens of this land.

A total eclipse of the sun, which will occur on June 17th, will be visible to the United States, with the exception of a small part of the Pacific coast States.

A total eclipse of the moon will appear, or rather disappear, June 3rd, which will also be visible in this part of the country.

A total eclipse of the moon is scheduled for November 26th and 27th, which will be in the nature of a Thanksgiving offering. This eclipse will be in plain view in Charlotte.

A partial eclipse of the sun, December 12th, 13th, will not be visible to the people of the United States.—Charlotte Observer.

INAUGURATION OF KITCHIN.

Outgoing and Incoming Governors Arranged for Jan. 12 as the Date.

It is agreed that the inauguration of Hon. W. W. Kitchin as governor of North Carolina will be on January 12. Mr. Glenn and Mr. Kitchin have just reached this agreement. Mr. Kitchin wanted the inauguration January 13 or 14, but Governor Glenn has important business engagements in Washington on these dates and Mr. Kitchin yielded to the wishes of Governor Glenn for the inauguration to be January 12. The legislature meets January 6 and will, on the 8th, in compliance with the requirements of the constitution, canvass the vote and declare Mr. Kitchin's election as preliminaries to the inauguration four days later.

Cotton Gin Burned.

Wilson, N. C., Nov. 28.—The large up-to-date gin of the Walstonburg Ginning Company went up in flames last night and its contents were entirely consumed. Besides the structure there were destroyed five bales of cotton, about fifteen hundred pounds of seed cotton, a large quantity of cotton seed meal and a wagon—entailing a loss of four thousand five hundred dollars. Mr. E. Dannenberg, of Wilson, was a large stockholder in the company.

Several gins have been burned in this section within the past few weeks which represents a loss of many thousand dollars.

When the flames were first discovered horsemen were heard riding from the scene at a break neck speed, and just at daylight this morning they were tracked for a mile or more, when the trail was lost sight of in a dense swamp.

Next week congress will begin another one-sided game.

Wonder why Hitchcock denied it when the plum was already to be put in the pot for him.

If the government would wipe out the unmerited part of her enormous pension graft, there would not be such a big deficit in running expenses.

As long as the government pays millions of dollars in undeserved pensions just to get G. A. R. votes, deficits in running expenses may not be unexpected.

A government that nearly half a century after a war has closed has more names on a pension roll than it had soldiers in the war, may expect to have deficits in running expenses.

The State canvassing board in tabulating the returns from the counties find that Bryan's majority in North Carolina was 22,848. This was about 15,000 less than Kitchin and the other State officers received.

In Tennessee they resort to "night rider" treatment on almost any kind of pretext. Two boys were taken out in the woods at night by masked men and whipped because they would not work, and another was whipped for the reason that he had been talking too much.

Not to be Deterred.

The fate of either of the two chief political parties in North Carolina is a minor matter. As to that, either the one or the other or both are doomed in justice to crushing defeat, and to destruction if need be, according to the necessities of the case called for of divine right in the work of widening and strengthening the laws already enacted in the matter of prohibition. We write earnestly and emphatically. Our words are not overbold. We only voice the stalwart and unflinching resolve of the irresistible element who stand for righteousness, godliness and sobriety, in the State. It is a growing force. Within its ranks are gathered already out of every social following adherents who will stand to their guns. No allurements can entice them, no obstacles can deter them, no assaults can move them, they are unutterably resolved that the people shall have the protection and the blessings provided for them in the existing prohibition statutes of the State. The cry of agitation, the menace to party interests, and the slogans of local government and of let us alone, is a waste of breath. In every fact, whatever else may be said about the aspiring politician nothing is more true of him than that he is doomed to defeat if he is in favor of a return to whiskey in North Carolina.—Presbyterian Standard.

Bryan and Taft in This State.

It is of peculiar interest and significance that Mr. Bryan's majority over Mr. Taft in North Carolina in the recent election, according to the findings of the State board of elections, is only 22,848, a falling off of nearly fifty per cent. from the Democratic majority of four years ago. In 1904 Judge Parker's majority in the State over Roosevelt was 41,679. What is even more significant is the fact that the total vote for President cast in the State in 1904 was 206,563, while this year the total vote was 251,011, an increase of nearly fifty thousand votes, all of which and more, were cast for the Republican candidate. In 1900 the total vote cast for President in the State was 292,669 and Mr. Bryan's majority was 24,671. In the recent election Mr. Kitchin ran 14,499 votes ahead of Bryan. The figures, taken in connection with the loss of three Congressmen, are full of instruction for the Democratic party. Whether or not the lesson will be taken to heart is another matter.—Charlotte Observer.

SHAKESPEAREAN PARTS.

That of Hamlet is the Longest of Them All.

The longest part in any Shakespearean play is Hamlet, who is before the audience almost constantly. Hamlet is a constant talker, and it is surprising that in the circumstances he says so many wise things. He has to his share 1,569 lines. Richard III. is another long part, as the character speaks 1,161 lines, next comes Iago, with 1,117 lines. Henry V. has 1,063 lines.

One would suppose from seeing the representation or from looking over the play that Othello had more lines than Iago, but it is not the case, for the valiant Moor has only 888 lines. Coriolanus has 886, the duke in "Measure For Measure" 880 and Timon 883. Antony in "Antony and Cleopatra" does not seem a very long part, judging by the appearance of the prompt book, but in reality he has 830 lines.

Brutus in "Julius Caesar" has 727, Falstaff in "Henry V." 719. Macbeth appears a long part, judging from how much he is on the stage in the representation, but in fact he has only 705 lines. Romeo has 618, which is only a few more than the king in "Hamlet," who has 551. Cassius in "Julius Caesar," although a first class part, has but 507 lines.

The female parts in Shakespeare's plays are not very long. The actress who plays Portia has 589 lines to study. Rosalind has 749. Cleopatra has 670 and Juliet 541. Desdemona has only 389. Beatrice has 309. Only twenty of Shakespeare's women have more than 300 lines each, and some of the most famous of the great bard's feminine creations have comparatively little to say. Cordelia in "King Lear" has only 115 lines. Kate in "Taming of the Shrew," although so conspicuous and voluble, has but 229, while Lady Macbeth has but 211.

Why He Thought So.

"Auntie," inquired the little nephew as the unbecoming spinster stood gazing in the long mirror, "what are you thinking of?"
"I was thinking how my figure looks in the glass, Willie."
"I thought that was it!" quickly exclaimed the youth.
"What made you think so?" asked the aunt, her curiosity getting the better of her.
"Because you made such a wry face."—Bohemian Magazine.

Insane Sense.

Among the inmates of a certain insane asylum were two who were considered perfectly harmless and not without a certain modicum of common sense. These two were generally employed in the garden and were frequently left without supervision.

An opportunity offering, they planned between themselves an attempt to escape.
"Now, bend down, Tom," said Jack as the two conspirators came to the wall surrounding the grounds; "then I'll climb up your shoulder to the top, and when I'm up I'll be able to give you a hand."

Tom accordingly bent down, and Jack, with a little difficulty, managed to gain the top of the wall, where, instead of assisting his friend, he disappeared on the other side and as he was making off shouted:
"Well, I think, Jack, you'll be better to stay on another fortnight yet. You're not nearly cured."

Queensland's Upas Tree.

Queensland, Australia, has a curious tree which ensnares and kills insect life and sometimes birds also. A traveler says of it: "The seed vessels of the Queensland upas tree, 'ahmoo' of the blacks (Pisonia brunoniana), which are produced on spreading leafless panicles, exude a remarkably viscid substance approaching birdlime in consistency and evil effect. Sad is the fate of any bird which, blundering in its flight, happens to strike against any of the many traps which the tree in unconscious malignity hangs out on every side. In such event the seed clings to the feathers, the wings become fixed to the sides, the hapless bird falls to the ground and as it struggles heedlessly gathers more of the seeds, to which leaves and twigs adhere, until by aggregation it is inclosed in a mass of vegetable debris as firmly as a mummy in its clothes."

The Town to Be Born In.

In the German town of Klingenberg, near Aschaffenburg, Bavaria, in addition to having no rates to pay for the upkeep of the town, those actually born in the parish receive from the municipality a sum of £12 15s. a year. This sum, if invested regularly at, say, 3 per cent, would entitle the owner to receive about £1,500 at the age of sixty—a very handsome old age pension. Were it not necessary that the inhabitants should prove birth in the parish before becoming entitled to this payment the popularity of Klingenberg as a place of residence would doubtless be enormous.—Westminster Gazette.

TRADING FOR A WIFE.

Indian Believed He Had Made a Deal and Had to Be Bought Off.

"He says he would like to trade with you for your wife!" It came out at last. It was a startling proposition indeed. For a moment we were both too breathless to comment. Finally my husband yielded to his impulse for amusement, and, smiling at me, he replied:

Pepys' Sparrow.

AUSTRALIAN TALES.

The Native Blacks and the Sharks and Crocodiles.

Australian aborigines fear crocodiles, but have no fear of sharks. The author of "Confessions of a Beach Comber" says: "They take every care to avoid crocodiles, exercising great caution and circumspection when crossing inlets and tidal creeks. Their indifference to sharks is founded on the belief that those which inhabit shallow water among the islands never attack a living man. And so they continue to think, notwithstanding a tragic incident like the following, which, indeed, they attributed to a 'debil-debil' and not a shark at all: The captain of a beche de mer cutter was paddling in a dingy along the edge of a detached reef not many miles from Dunk island, while several of his boys were swimming and diving. Suddenly one of them was seized and so terribly mutilated that he died in a few minutes. Although the captain was within eight or ten feet of the boy and three of his mates were not more than a few yards off, no one saw a shark or any other fish capable of inflicting such injuries as have caused the death of Jimmy, nor was there any disturbance on the surface of the water."

It has been said that the Australian blacks never commit suicide, that self destruction does not come within their philosophy. The same author mentions a case of recent date which he thinks might be regarded as in conflict with that view: "A member of the Clump Point tribe, painfully afflicted with a vexatious skin disease, was fishing at the mouth of a creek when his hook fouled. To a companion he said he would dive to get it clear. His friend endeavored to dissuade him, reminding him of the crocodile which they had seen but a short time before. But the boy, worn with pain and weary with never ending irritation, said if he was taken: 'No matter. Good job. Me finished then.' He dived, and there was a commotion in the water. The boy appeared on the surface, making frantic appeals for help, while the crocodile worried him. He escaped for a moment, and his friend clutched his hand and drew him to the bank, only to have him torn from his grasp."

A tale of a native "boy" from the same volume: "A boy accustomed to see his master, the owner of a station, jump his horse over the gate, instead of stopping to open it tried to follow. The horse cantered up grandly, seemed to gather himself for the jump and balked. The boy shot out of the saddle and over the gate. As he picked himself up and shook the dust from his clothes he glared back at the horse, saying, 'You blurry liar!'"

PRIVATE STAMPS.

Principal Cities Had Their Own Special Issues Years Ago.

The private carrier stamps of the United States in use in the forties and early fifties are among the most interesting memorials of progress from the quaint customs of a century ago to the highly advanced methods of today's civilization. Every section of the country got its private mail carriers just as every section of the country today has its moving picture arcade.

One of the private concerns that did an extensive business and issued one of the neatest stamps was the American Letter Mail company. Its postal service embraced the states of Massachusetts, Rhode Island, Connecticut, New York and Pennsylvania, with connections in the principal cities of each state.

W. Wyman of New York was one of the big competitors of the American company for New York to Boston mail. His stamp bore a picture of a locomotive of those days, drawing what was presumably a mail coach.

Ovcrton & Co.'s letter express was also in competition for the same business, but was rather more ambitious than Wyman, for they extended their service as far south as Philadelphia and had well organized connections at that city for distributing mail over a wide territory in Pennsylvania and adjacent states.

Still another rival of these mailmen was in the field in the person of the Hartford mail, a famous old private mail carrier that operated between the cities of Hartford, Boston and New York. There were several smaller enterprises covering portions of the same ground, and the fact that they all thrived shows that even at that time the advantages of reliable mail communicating methods were appreciated.

Boston had a "city dispatch" in New York, as did Boyd, the latter's headquarters being at 1 Park place, and the long series of stamps he used covered the period from 1844 to 1878.—Boston Herald.

BOUNDING THE INFINITE.

Are the Number of Stars in Space Without Limit?

How many stars are there? It is not known, but most astronomers believe the number is not unlimited. The argument is that with an infinite universe of stars the heavens would be one uniform blaze of light. The more distant stars are, of course, dimmer; some are too far away to affect the naked eye at all, but no matter how slight the units an infinite number of them would produce the effect described.

As there is no uniformly blazing sky, the number of stars, though possibly immensely great, must be limited. This argument is supplemented in a recent astronomical paper by a similar one drawn from gravitation. Every star, no matter how distant, exercises its own power of attraction on every other heavenly body, including our earth.

However, as the earth's center is farther away from the attracting body than its surface is, particles on the earth's surface are attracted with greater force than those at the center, and the practical result is to lessen the force with which the earth's mass is held together.

Now, if the number of stars is infinite, this decrease would be so great that weight on the earth would practically cease to exist. Moreover, the same conditions would prevail everywhere throughout a boundless universe and probably all masses would be disrupted. That this result does not occur is a proof, we are told, that the number of heavenly bodies in existence is not infinite.

These arguments make certain assumptions that may or may not be granted; they can neither be proved nor disproved. The argument from light assumes that light waves are transmitted through space without loss; that from gravitation assumes that the same thing is true for gravitational attraction.

If light or gravitation is absorbed or lost in some way when passing from star to star, the number of stars may be infinite after all. At its best the speculation is more curious than conclusive.—Chicago Record-Herald.

STRENGTH OF AN EAGLE.

Wonderful Power in the Bird's Claws and Legs.

While I cannot give any positive proof of how much a bald eagle can carry, I should suppose, declares a writer in Forest and Stream, that he could carry at least as much in proportion to his weight as a hawk or a horned owl. I have the recorded weight of a male bald eagle weighing nine and a quarter pounds and a female weighing twelve pounds.

A horned owl will weigh from four to five pounds, and I have several times known one to carry off a large house cat. One cat was very large, and the owner told me he could hear the cat cry as he was being carried off. Now, any one who will weigh a large house cat will find it to weigh at least ten pounds.

I have seen a goshawk carry off a hen fully twice its own weight, and I have taken from a marsh hawk a very large chicken which would weigh more than twice what the hawk would. The marsh hawk is one of our weakest hawks, but he had carried this chicken over a quarter of a mile. My belief is that if a hawk or horned owl can carry more than twice its weight (and I know positively that they can) then an eagle could, if occasion required, do as much in proportion to his weight, which would be to carry eighteen or twenty pounds.

Once when an eagle, shot through the body with a rifle ball, lay on his back I up ended a long road skid and dropped it on him. Before it reached him he stretched up and caught it in his claws and held it the length of his legs above him. I walked up on the skid and stood above him, and he easily held me and the skid, which I should judge would weigh more than twenty pounds. I took pains to be weighed the same day and weighed 119 pounds. Put a stick in the claw of a wounded eagle and let him grasp a small tree with the other, and a man must be stronger than I ever was to take the stick from him.

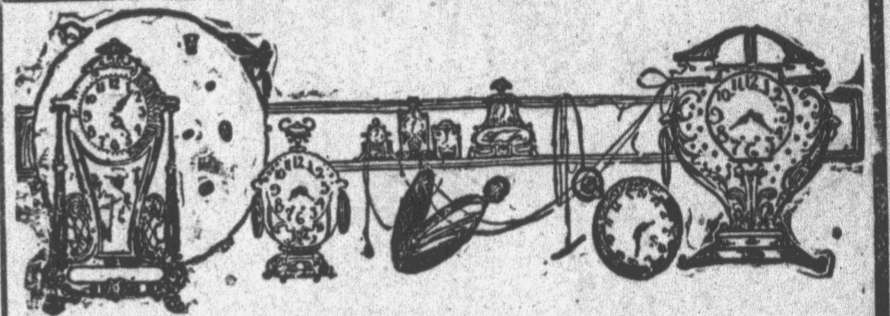
