## TWO BOARDS AT ONCE.

And Both Transacting Business for a Few Moments.

For a few moments on Monday there were two boards of commissioners in Pitt county transacting business at the same time, a thing very unusual. When the hour arrived for the new board to qualify, the old board lacked just a few matters of having their business completed, some signatures of the chairman and minor details yet to be done. The two members of the old board who had been re-elected withdrew, leaving the other three to complete this minor work, and with the other members of the new board went before the Superior court clerk to qualify. After taking the official oath the new board retired to a room where they organized and elected a chairman in readiness for business, the three members of the old board being at the same time getting to the end of their work. So just for the time there were two boards of commissioners at work.

## Apple is Crowned King.

Spokane, Wash. Dec. 7.—Other crops may wither and fail, but the luscious rosy-hued apple will continue to hold its kingly sway throughout the length and breadth of the land. It had its day of glory with the formal opening in this city of the National Apple show, for which preparations have been going forward for months past. The exhibition was opened by a telegraphic signal from President Roosevelt. The spacious state armory was at first thought large enough to house the exhibition, but the exhibits were so numerous that several temporary structures were erected to accommodate the overflow display. Altogether some eighty thousand square feet of floor space has been used. The exhibits include fruit from many parts of the United States and Canada, and from England, Germany, France, Norway and Japan. The show will continue through the entire week. During this time there will be lectures by heads of agricultural departments and meetings under the auspices of various horticultural societies.

The primary purpose of the exhibition, which is the first of its kind, are to show the value of the apple as a wholesome food and healthful fruit, to demonstrate its manifold uses, together with the value of its by-products, and to stimulate an industry which already means millions of dollars annually to commercial orchardists in America.

Premiums to the value of \$35,000 are to be awarded and there are also twelve prizes consisting of tracts of irrigated fruit lands with perpetual water rights. The largest apple, of regular shape, with perfect stem and calyx and without blemish, is to be produced in bronze, which will be heavily plated with gold. The reproduction will be given to the grower of the perfect apple. Special prizes also will be awarded to those devising improved methods in the packing of the fruit for shipment.

## Ginners' Report.

The ginners' report issued this morning places the cotton of this season's crop ginned up to Dec. 1st at 11,010,864 bales. Tomorrow the government will give out an estimate of the crop for the entire season.

## MULE LOOKING FOR DOCTOR.

And Failing to Find One Lay Down and Died.

Monday night a mule belonging to Mr. B. P. Cobb, about 8 miles from Greenville, was taken with colic. The animal broke out of the stable and took the road for Greenville. Upon reaching town he turned up Dickinson avenue and stopped in front of the office of Dr. Laughinghouse. Seeing nobody around the office, the mule laid down right there and died. Now the question is, was that mule looking for the doctor? Several persons on the street saw the mule stop in front of the doctor's office.

## Identifying Himself

## In Interest of Tobacco Growers.

The work in Pitt county is also undertaken in connection with the recent broad development of the bright tobacco industry throughout the tidewater region of the State. Within the last half dozen years the production of the cigarette tobacco, of peanuts and of various truck crops has made great headway throughout the entire eastern portion of the State, and Pitt county is now one of the leading bright tobacco counties in North Carolina, with an excellent prospect that still greater acreage and better yields of this class of tobacco will be attained in the near future.

A considerable interest in this work has already been shown by the tobacco growers and the farmers in general in Pitt county, and on two separate occasions the bureau of soils has furnished soil experts to address the educational meetings held by Congressman Small in Pitt and the adjoining counties in the first North Carolina district.—Washington City cor. of Charlotte Observer.

## In Memory of Cleveland.

New York, Dec. 7.—Notable exercises in memory of the late Grover Cleveland, former president of the United States, constituted the feature at the opening session in this city Saturday of the association of life insurance presidents, of which he had been chairman during the year and a half between the time of its organization and his death. The program included addresses by President Paul Morton, of the Equitable Life Assurance Society and Dr. John H. Finley, president of the college of the city of New York and the reading of letters which had been received from former vice-President Adlai E. Stevenson and Governor Hoke Smith and Hilary A. Herbert, members of Mr. Cleveland's cabinet.

## Sensation May Follow Attack.

Washington, Dec. 7.—Sensational developments may follow President Roosevelt's denunciation of Delavan Smith, of The Indianapolis News, for an editorial on the alleged scandal in connection with the purchase of the Panama canal. The article brought in the names of Douglas Robinson, brother-in-law of President Roosevelt, and Charles Taft, brother of President-elect Taft, as having been members of a syndicate that is alleged to have secured possession of the Panama canal property upon a low figure and upon its sale to the United States for \$40,000,000 pocketed the difference.

## For New Agricultural Building.

Raleigh, N. C., Dec. 7.—Now that the state board of agriculture has set about to invest \$80,000 in a new state agricultural building here numbers of the state officials and others are deeply interested in bringing about a combination of legislative appropriation with this agricultural fund for the erection of a mammoth seven or eight story fire-proof concrete building on the sites of the present agricultural building and the supreme court building adjacent, both of which are really unsafe and inadequate.

The idea is to have the proposed new building extend across the square at Edenton street from Salisbury to Halifax street. Such a building, it is urged, would accommodate the whole of the agricultural department work, the Supreme court and its library, state library and afford ample officers and storage for all the other state officers who are not already adequately accommodated in the state house.

The new building would be equipped with elevator service to make the top stories easily and quickly accessible. It is estimated that such a building would cost about \$15,000. The present old agricultural building and the state library floor of the supreme court building, four years ago fell through on the weight of a crowd gathered for a legislative committee hearing. Both buildings, it is urged, should be torn down.

## Only Six-Year Term.

Mr. J. M. Blow, manager of The Reflector's Ayden department, was among the visitors to Greenville Monday. He came along, as did many other justices of the peace, to qualify on that day as the law requires. The difference in his case, however, was that he qualified for a six-year term, he being the only one in Pitt county whom the last legislature appointed for that length of time. This is quite an honor to Judge Blow, and he wears it gracefully.

**A WHOLESOME DECISION.**

The supreme court of the United States has handed down a decision reversing that of the United States circuit court for the eastern district of Virginia, which had held to be unconstitutional the order of the state railroad commission fixing a two cents passenger rate on state business.

The effect of the United States supreme court decision is to uphold the order of the state railroad commission.

The essence of the decision seems to be that the state courts have proper jurisdiction over such cases in question and must be upheld in their jurisdiction. It is only in the event that they abuse their power—in other words, it is only in the event that they uphold rates which are clearly confiscatory and therefore in violation of a fundamental constitutional right that the federal courts have the right to interfere.

as one of the most wholesome doctrines yet propounded by the supreme court. It goes a long way towards simplifying the situation.

The fourteenth amendment to the constitution has many sins to answer for, but never has it been more flagrantly abused than in stretching the provision which declares that a citizen shall not be deprived of his property "without due process of law," until it had almost placed the legislative, judicial executive functions of a state under the jurisdiction of a federal court, on the sophistical plea that the property of the railroads was about to be "confiscated."

This recent decision of the supreme court clearly recognizes the rights of the state courts to pass upon the merits of such regulations as may be made by the railroad commissions of the several states, and the federal courts are only empowered to assume jurisdiction when the state courts abuse their powers and uphold real "confiscation."

This latest doctrine of the courts—or more properly this latest expression of an established doctrine—will go far towards upholding the rights of the states which have been seriously threatened of late and will place a wholesome curb on the abuse of interlocking decrees.—Atlanta Journal.

Immigration produces some queer situations. In a single block in New York there are 1,400 people of twenty distinct nationalities. There are more than two-thirds as many native-born Irish in Boston as in the capital city, Dublin. With their children, mainly of pure Irish blood, they make Boston indubitably the leading Irish city in the world. New York is a larger Italian colony today than Rome, having 500,000 Italian colonists. It contains no less than 800,000 Jews, mainly from Russia. Thus it is also the foremost Jewish city in the world. Pittsburg, the center of our iron and steel industry, is another tower of Babel. It is said to contain more of that out-of-the-way people, the Servians, than the capital of Servia itself.—Greensboro Record.

### SEEING LONG DISTANCES.

Mont Blanc Visible From Mountain  
133 Miles Away.

One of the fast trains between Paris and Marseilles was just leaving the station at Dijon in October last when a passenger in great excitement called out:

"There is Mont Blanc!"

The other passengers looked out of the windows, and sure enough they saw away to the southeast the snowy upper part of Mont Blanc rising above the summits of the intervening Jura mountains. It looked like a cloud floating in the air.

It was a sunless day, but the air was extraordinarily limpid, for all the dust in it had been washed out by the rain that had fallen every day in the month.

It is most unusual for Mont Blanc to be seen from the railroad track at Dijon, 136 miles distant, in a plain less than 800 feet above the sea. It is visible at times from the heights around the city.

It is of interest to travelers in France to know that Mont Blanc is normally always visible from Lyons, 99 miles distant; Macon, 102 miles, and Chalon-sur-Saone, 114 miles. Whether or not the mountain can be seen from many points in southeastern France from day to day is popularly regarded as a weather indication.

Of course if you are standing on a considerable elevation and there are no obstacles in the way you may see Mont Blanc from greater distances. The mountain is in view, for example, from the heights that dominate Marseilles.

Puy de Dome, in France, 4,790 feet high, is 188 miles west of Mont Blanc, but the great snow mountain is visible from the top of the lower summit. The mountains of Forez bar the way between them, but it happens, curiously enough, that there is a deep depression in these mountains just along the line of sight between the tops of Puy de Dome and Mont Blanc, and through this abrupt lowering of the range the snow mountain may be seen.

This is believed to be the greatest distance that can be seen with the naked eye in the climate of southern Europe. Here are a number of mountains and the distances at which they may be seen out at sea:

Vesuvius, before the last eruption, 87 miles; Ventoux, 105; Canigou, 128; Etna, 138; Tenerife, 157; Fujiyama, 160; Kamerun, 165; Chimborazo, 191; Aconcagua, 201.

Most of the giants of the Andean cordillera, even those that are a considerable distance inland, can be seen from out at sea. The first view shows them only as little elevations above the horizon, and the lower mountains around them are not in sight. But as the land is approached the great summits are gradually revealed in all their splendid proportions.—New York Sun.

### Memory, Not Mystery.

"Memory can play the strangest of tricks," says a specialist, "and it is responsible for not a few superstitious fears in sensitive people."

"A lady once told me that she found herself at times in places where her surroundings seemed to have been known to her before, though she knew that she had never been there previously. Probably you will recognize this experience, which is common enough. How many people, when reading or listening to a conversation, become vaguely conscious that they have read the passage or heard the identical words in 'the dim, long past'?"

"It is not a haunting mystery, but just a way that memory has. Innumerable impressions of the most trivial things are stored in the brain and will come out when called upon. In the lady's case she had probably seen a picture of the scene at some time, and a view of the actual place produced memory's feeble effort to recall it."

### A Valuable Stuffed Giraffe.

Few tourists who visit the Smithsonian institution at Washington and gaze on the mounted giraffe therein exhibited, which at the time of his death was known to be the second largest sized beast of its kind in captivity, would ever guess that the specimen contains the most costly "insides" that could be imagined.

This is owing to the fact that the papier mache used in the construction of the mounted specimen is simply the ground up pulp of thousands of one dollar, two dollar, five dollar, ten dollar and twenty dollar bills furnished the institution by the bureau of engraving and printing, where the worn bills redeemed by the treasury department are macerated. It is estimated that old money to the amount of \$200,000 was employed to make the pulp which went to fill the dead giraffe.—Harper's.

### NAUTICAL SLANG.

Many Phrases Imbedded In English Popular Speech.

Talking of slang, has any one ever made a list of the nautical slang imbedded in English popular speech? Most people who speak of a person "carrying on" would be surprised to learn that they are using a nautical metaphor. To carry on is literally to carry a great deal of sail, generally too much for the weather conditions—that is, to behave in a more or less sensational and foolish manner. To say that one is "taken aback" is a metaphor from the management of a square rigged ship, which is "taken aback" when, through carelessness or ill luck, the wind gets round to the wrong side of the sails—an awkward and perhaps dangerous accident. To give anything "a wide berth" is sailor's slang. It means literally to give a thing—probably a rock or other danger—a wide bed to lie in. We speak of "sounding" a person with reference to some proposal. The metaphor is that of a navigator finding his way cautiously by trying the depths, say, in approaching an unfamiliar shore. "Landmark" is not at all a nautical looking word, but it is strictly a mark on land—a tower, building or other prominent object—which serves to guide the mariner clear of rocks and shoals into a port.

More obviously nautical, but probably equally vaguely understood, are such phrases as "sailing close to the wind," "look out for squalls," "keep one's weather eye open," "take the wind out of one's sails," "see whether the coast is clear." To sail close to the wind is to try to keep directly on one's course when tacking is almost necessary and so to run a risk of being taken aback. To keep one's weather eye open is to keep a sharp lookout on the weather side of the ship (that is, to windward, where the weather comes from) for the signs which mark the approach of squalls. To take the wind out of another boat's sails is to overhaul her (presumably in racing) and pass to windward, thus cutting off her wind for the time being. To see whether the coast is clear is to find out whether it is free from outlying dangers, such as rocks and shoals or from enemies in naval war or smuggling. Finally we have one or two shipbuilding metaphors. We speak of having a piece of work "on the stocks," stocks being the frame of timbers which supports a ship while she is building. If she is well built of the best materials, she is "A1"—the highest grade in Lloyd's classification.—Dundee Advertiser.

### A FLOATING ISLAND.

It Was Found Roaming About In the South Atlantic.

A United States cruiser out destroying derelicts found its water supply running low. The water tanks are usually filled at Corn Island, but the ship was too far from it to sail there without losing precious time, which it could not afford to do then, as it was hot on the track of a particularly dangerous derelict, and the chase had led pretty well down toward the coast of Honduras. So when a low bank of purple that might be a cloud or might be land was seen low down on the eastern horizon it was decided to make for it in the hope that it might turn out to be a small coral island yet uncharted.

It proved to be a little island about three-quarters of a mile around and a quarter mile wide. In shape it was long and narrow, with a thick growth of vines and bushes reaching down to the water's very edge. Three tall cocoanut palms grew in the middle of it. No life of any kind was on the island, nor was there any water, though instead of being sandy or rocky, as such islands usually are, the soil was rich, dark and very moist. After gathering the cocoanuts the sailors returned to the cruiser, which, oddly enough, seemed much farther off and considerably more to the southwest than when they left her. Then it just dawned on them that they had been visiting one of the floating islands so often heard about, but seldom seen, in the south Atlantic. Further observation soon confirmed the suspicion, as the cruiser remained near it long enough to see the island change its position.

These floating islands are parts of other islands torn away by hurricanes or some great seismic upheaval. They drift about for months, moving slowly with the winds and currents, held together by the matted roots of trees and plants until they either attach themselves again to solid land or are disintegrated and eaten away by the action of the waves. In some rare instances they gather other flotsam of the sea to themselves and, stranding on a reef, become in time a new island.—New York Press.
