## PRESENTED WITH WATCH FOB

R. W. KING, EX-CHAIRMAN BOARD COUNTY COMMISSIONERS

Praised on Going Out of Office Monday—J. L. Fleming Makes Presentation Speech.

After the old Board of County Commissioners had turned over their offices to the newly elected board, and while ex-Chairman R. W. King, was assisting the new chairman in swearing in the officers and routine business, J. L. Fleming, county attorney, appeared before the board and requested a few moments suspension of business.

Mr. Fleming said in part "Mr. Chairman, and gentlemen, I crave your indulgence for a few moments while I, with great pleasure, and at the request of the retiring commissioners and the old members of the new board, and at the request of Mr. Joseph McLawhorn, the very excellent manager of the Pitt county convict camp and road force, present to the outgoing chairman, Mr. R. W. King, this beautiful token of acknowledgment of service well and faithfully performed, and of their esteem and appreciation of his kind, courteous, just and efficient rulings.

"They desire to point with pride, Mr. King, to your ability and promptness as the presiding officer of the board for the last two years; to the readiness with which you have grasped the procedure and questions which have been presented to the board; to the manner in which you have so readily and correctly caused the dispatch of the business of the board, and to the great personal sacrifice of your own time in the management of the convict force and in the construction of the iron bridges and other bridges entrusted to you by the board, and in attending to the business and interest of the county generally, with pay or remuneration. They desire to give some unusual and public expression of their appreciation of your great and faithful service to the people of Pitt county during the last two years.

"And, Mr. King, while I know your service has been largely without pay or compensation, and I am sorry to say, without popular approval in all respects, I hope this beautiful pure gold watch fob and token of esteem from your associates and Mr. McLawhorn, who has worked largely under your direction, will be a partial reward to you and serve ever hereafter to inspire public officers to strive for the public good. I now, with pleasure, present to you this beautiful token.

"Not before in the history of Pitt county has there probably been such marked progress as during the administration of the outgoing board, and as time passes on and the people fully understand and realize the motives that have prompted you all and the faithfulness with which you have executed every trust, and they see the great good that will evidently result to the county from the acts of your board, they will then begin to realize and appreciate the great public service that has been rendered this county and started it on the road of progress that will place it in the front ranks of the counties of this State."

Mr. King was taken entirely by surprise, and arose and very feelingly said:

"Mr. Fleming, I assure you that no one was ever more surprised than I at what is now oc-

curing. Nevertheless, I would be insensible of every prompting of my nature if I did not feel the appreciation which I now do. I frankly say to you that, surprised as I am, words are inadequate for me to express to you, and through you to my associates, the great pleasure and gratification this testimonial of their appreciation gives me. To my mind there is nothing so valuable as the appreciation and good will of those with whom we are associated in a business capacity, especially when this association is public and official.

"I desire to say first, that in all of our association and in all of our work, as trying as it has often been and as much perplexed as we have sometimes found ourselves, there has never been the slightest disagreement or friction in reference to any matter that has come before us. At all times they have shown a disposition to consider well and frankly all matters before us, and when the matters have been thoroughly gone into we have always arrived at a unanimous decision. For me to say that there has been disagreement of opinion would be far from the facts in the case.

"To manage the finances of a great county like this, varied as they are, with the upward look and progress this county has had, and our desire to foster and encourage progress along all lines, and yet at the same time to look to financial interest of the county, has been no small problem, and but for the kind consideration shown by every member of this board, I believe I state a truth when I say that there would necessarily have arisen differences of opinion in reference to the great matters that have come before us during the past two years, but this has not been the truth and stands as a monument to those who have been associated with me.

"As an evidence of the management of the finances of this county, I would say to you gentlemen of the new board, that today we turn over to you in the hands of our treasurer the sum of \$6,600 in cash of 1907 tax levy, and in addition thereto \$4,000 paid into his hands by the sheriff of 1908 taxes, making a total of over \$10,000.

"I know full well that at all times we have not had the approval of every one of our constituents. I know also that we need not have expected to have had this, for whenever the occasion arises in the history of any board to go forward it its work we may expect some, who probably do not look at matters as the progressive element does, to criticize the action of those who inaugurate and carry out these movements.

We have, however, the approval of our consciences that we have at all times had but one purpose in view and that was that we should faithfully and conscientiously discharge the duties of this office, having regard to the interest of the county and every citizen thereof. And we believe that when the people come to see the results that are to come to this county from some of the things that have been done by this board, there will be a universal approval of its action.

"We have no regret that as our term closes we leave to this county a steel bridge spanning Tar river at Greenville, another at Grifton, a great institution located in our center with the prospects it has for the future, both for the material and educational progress of the county,

the court house and grounds remodeled, as you can see, and last but not least, an experimental road in progress, which acting as the model of an inspiration to men in the future to make other conditions better by improving the means of travel.

"I desire here to mention the facts that in the prosecution of this work there has been under our supervision Mr. Joseph McLawhorn in charge of the convict forces of the county, and I would be unfaithful as a man who observed him at all times, not to say that in my judgment no man could have ever filled the position he has held better than he. He has been firm, kind and active in whatever he has undertaken, and in my judgment no man in this county is better fitted to prosecute the work that he has been and is now doing than Mr. McLawhorn, and the county would be poorer to lose the services of such a faithful and progressive citizen. I am sure I voice your desire when I bear testimony to the work and efficiency of this public official.

"As your chairman I have at all times tried to be considerate and just in all my rulings, and in the appointment of all committees, whatever was to be committed to their charge. If I have erred it has been a matter of judgment and not of heart. I desire here and now to express my appreciation of the courtesy and kindness that has been shown me by every member of this board at all times, and to say to you that no man's association with any body of men has ever been more pleasant than mine with you.

"And to those who go out today and those who remain of this board, I have the kindest of feelings and express but the wish of my heart when I say that wherever they may be or whatever they may do, as they have done, for the progress and betterment of this county, they will always carry with them the best wishes of a man who has been so intimately associated with them.

"To you, Mr. Fleming, and through you to the members of this board and McLawhorn, who are the donors of this beautiful fob, I desire to express my sincere appreciation and thanks. In the future this testimonial will always remind me pleasantly of my association on this board, and it will be carried through life cherished and regarded as the expression of kindness and appreciation upon the part of these faithful officials who have served with me for the past two years, and will act as an inspiration to me in the faithful discharge of every duty that may come to me as a private citizen, in the support of those who have in charge the interest of the county that is dear to all of us. Again I thank you."

## THE CHRISTMAS BAZAAR.

Great Attraction in Progress in Perkins Hall.

Perkins' hall has sheltered many attractions in its day and time, but none more interesting than the Christmas bazaar now being held by the Ladies' Aid society of Jarvis Memorial Methodist church. Mr. F. G. James is president of this society, and how well she and her co-laborers have wrought and executed their plans is shown in the attractive booths and the many beautiful articles they contain.

The bazaar was opened to the public Tuesday evening and a great crowd assembled to take in the pretty scenes and purchase suitable articles for Christmas. Buying was quite liberal, for it was found that articles sold at very reasonable prices.

The designing of the booths about the hall is in excellent taste and pleasing effect.

The fancy booth, in charge of Mrs. H. L. Carr, is decorated in light blue and white and contains an elaborate display of articles in fancy work, that are the especial admiration of the ladies.

Miss Alice Smith presides over the young ladies' booth. This is decorated in pink and white and has on sale handkerchiefs and candies in fancy Christmas boxes.

The Japanese booth, with Mrs. L. C. Arthur in charge, has a real oriental appearance in its emblematic decorations, and, as the name implies, is devoted to the sale of Japanese ware.

The smokers' den catches the men. Here Mrs. J. W. Ferrell presides, and for the price of a cigar will let you sit in a cozy corner and enjoy a smoke, with no extra charge for the music going on within the den. National colors characterize this booth.

Out in the centre of the hall is the doll booth, the delight of the little folks. This is a rustic design in circular shape with a canopy of holly. Dolls are all around and about it, and in the midst is a pretty Christmas tree from which the little folks can draw for prizes. Mrs. C. V. York is in charge of this.

The country store is an attraction out of the ordinary and contains everything from a long stalk collard to a bale of hay, from a needle to a plow, with country hams, chickens and turkey gobblers around the door. It has the average cross roads store "skinned a block." Mrs. C. T. Munford conducts the store and knows how to make a trade.

If the president don't watch out he will get his liars' club overcrowded.

Raleigh is pushing along trying to keep in the procession with Durham. A big highway robbery has been pulled off near that city.

If the president's trip to Africa could have preceded that long message to congress, it would have saved the country the need of delving through it.

The speeches of the North Carolinians at the banquet of the North Carolina Society in New York, Tuesday night, were as good as any of them.

If congress had to sit up and listen to many more volumes of Roosevelt messages, the members would almost be justifiable in demanding a raise of salary.

In his speech before the North Carolina Society in New York, President-elect Taft still showed his anxiety to get the South to come around to his way of thinking politically, but he will hardly succeed in this.

**What Politics Costs New York.**

The public debt of New York City materially exceeds that of the United States and the difference in interest rates makes the burden decidedly greater. Including interest installments and sinking fund payments, the debt costs five dollars a month for every family. Figures in the published budget of 1909 show \$156,545,148 as the estimated expense of running the city. This represents an increase of \$13,000,000 over the total for 1908. At this rate of increase the tax-payer ten years from now will have to face a budget calling for \$370,000,000; and former Deputy Comptroller Levey recently pointed out, with general assent, that if prevailing methods continue such a result is almost certain. It is further pointed out that the completion of the Hudson river tunnels will open up for settlement enormous tracts in New Jersey, rendering the city's taxes no longer recoverable through excessive rents. There was much talk of seeking an injunction against a recent loan of \$12,500,000 on the ground that the city was exceeding its constitutional debt limit.

If the tax-payers of New York were getting anything like their money's worth, this constantly mounting burden might be borne without much murmuring for a long time yet, but they are not. Unless all calculations have gone wrong, the city does not get more than forty cents of value in the dollar expended. Frequently there are jobs which cause one dollar's value to cost many dollars—mostly petty jobs for taking care of political hangers-on. Government of this sort is becoming excessively burdensome even for New York. And as the worst of the situation the tax-payers are so hopelessly outvoted that government on a business basis appears to be the most distant prospect imaginable.—Charlotte Observer.

**THE DRUG FIEND.**

Hasheesh Makes Its Slave Utterly Useless For Any Service.  
 One of the drugs that are most striking in their effects is hasheesh, or Cannabis indica, largely taken in Asiatic countries, where I used myself to meet its votaries. Its chief peculiarity is to make one believe with all his might whatever is suggested to him.

If he is an Arab, tell him that he is a sultan, and straightaway he orders heads to be cut off. Tell him he is a rooster, and he will crow. I knew of two Americans who experimented on themselves, and when the first was told that he was like a locomotive he snorted and whistled and kept going round the table puffing and blowing until he dropped from sheer fatigue.

The other, somehow conceived the idea that he was dead and forthwith gave elaborate directions for his own funeral till he waxed wroth at the unseemly mirth of his companions when they should have wept.

Hasheesh makes its slave utterly useless for any service, and so with the other drugs. Their victims one and all end in becoming do-nothings. Self made do-nothings, or those who are so by drug taking, are much worse than useless.

As they usually do not begin till as adults they reach the working period of life, they become wretched burdens on the real workers, since our social system lacks any constitutional enactment whereby, as occurs in a community of bees, the workers systematically put their drones to death.

#### HEIGHT OF WAVES.

When the Billows of the Ocean Run "Mountain High."

That ocean waves run "mountain high" no one ever believed unless he was very credulous indeed. The phrase is a highly exaggerated figure of speech. But the observations of keepers of lighthouses in exposed situations have proved that waves run high enough in great storms to make very respectable hills. Some years ago the steamer that carried supplies to the lighthouse on Tillamook rock, on the coast of Oregon, was able to make a landing and establish commercial communication with the light keepers after a series of storms only by strenuous endeavors covering a period of six weeks.

The waves of the Pacific had torn away the wharfs and other constructions on the rock, even carrying off timbers which were riveted to the rock. As yet, however, the lantern had remained untouched.

Put the storm increased, the waves rose in height and soon dashed against the lantern, which was 150 feet above the level of the sea. Finally the water washed over the top of the lighthouse, going in through the ventilators overhead.

The keepers were compelled to work desperately all night long to keep the lamp lighted. They were continually in fear that the lights in the glasses looking seaward would be broken in by the force of the waves and that they themselves should be washed out into the sea to certain death. But the iron lattice-work outside the windows saved the panes from destruction.

The light keepers, who were old sailors, affirmed that no experience on shipboard could be as horrible as this long struggle with the storm at the summit of the lighthouse. They would have been glad to take refuge even in a frail ship.

The Tillamook light had on previous occasions been washed over completely by waves. The same thing happened to the Eddystone light, off the coast of England, and to the light at Fleaux-de-Brechot, off the coast of France, both of which are about 150 feet in height.

It seems well established, therefore, that waves may mount to a height 150 feet above the general level.—New York World.

#### Threescore and Ten.

The old tradition was that threescore and ten was the average span of life, and we are becoming convinced that it is true. Nine old people out of ten probably die within three years of seventy—that is, old people who meet with no bad accidents and who inherit no fatal disease from their parents. Look at the death list in any paper. A man who passes sixty is pretty apt to die within three years of seventy. Old traditions are entitled to a great deal of respect. After all the talk about health rules, the fact remains that the average life is wound up to run about seventy years. If he does not take care of himself nature will remind him of his duty in a way that must be heeded.—Atchison Globe.

#### Will Not Down.

"After all, my friends," said the campaign spellbinder, "vital principles never change. Questions of expediency may arise to cloud the real and living issues from time to time, but the issues themselves are the same from generation to generation. Political parties, in the main, agree as to aims. It is a difference of opinion as to methods that divide them. For example, what one thing do we all, without regard to political affiliations, regard as one of the essentials of our civilization?"

#### Speaking For the Chickens.

#### The Word "Salary."

The way languages are built up is very interesting, and the derivation of the word "salary" is curious as well. In ancient times Roman soldiers received a daily portion of salt as part of their pay. "Sal" is the Latin for salt, and when the salt was in course of time commuted for money the amount was called salarium or salt money, hence our word "salary" and hence, doubtless, the expression "not worth his salt"—that is, not worth his "salt money" or salary.

#### NAUTICAL SLANG.

Many Phrases Imbedded in English Popular Speech.

Talking of slang, has any one ever made a list of the nautical slang imbedded in English popular speech? Most people who speak of a person "carrying on" would be surprised to learn that they are using a nautical metaphor. To carry on is literally to carry a great deal of sail, generally too much for the weather conditions—that is, to behave in a more or less sensational and foolish manner. To say that one is "taken aback" is a metaphor from the management of a square rigged ship, which is "taken aback" when, through carelessness or ill luck, the wind gets round to the wrong side of the sails—an awkward and perhaps dangerous accident. To give anything "a wide berth" is sailor's slang. It means literally to give a thing—probably a rock or other danger—a wide bed to lie in. We speak of "sounding" a person with reference to some proposal. The metaphor is that of a navigator finding his way cautiously by trying the depths, say, in approaching an unfamiliar shore. "Landmark" is not at all a nautical looking word, but it is strictly a mark on land—a tower, building or other prominent object—which serves to guide the mariner clear of rocks and shoals into a port.

More obviously nautical, but probably equally vaguely understood, are such phrases as "sailing close to the wind," "look out for squalls," "keep one's weather eye open," "take the wind out of one's sails," "see whether the coast is clear." To sail close to the wind is to try to keep directly on one's course when tacking is almost necessary and so to run a risk of being taken aback. To keep one's weather eye open is to keep a sharp lookout on the weather side of the ship (that is, to windward, where the weather comes from) for the signs which mark the approach of squalls. To take the wind out of another boat's sails is to overhulher (presumably in racing) and pass to windward, thus cutting off her wind for the time being. To see whether the coast is clear is to find out whether it is free from outlying dangers, such as rocks and shoals or from enemies in naval war or smuggling. Finally we have one or two shipbuilding metaphors. We speak of having a piece of work "on the stocks," stocks being the frame of timbers which supports a ship while she is building. If she is well built of the best materials, she is "A1"—the highest grade in Lloyd's classification.—Dundee Advertiser.

#### A FLOATING ISLAND.

It Was Found Roaming About in the South Atlantic.

A United States cruiser out destroying derelicts found its water supply running low. The water tanks are usually filled at Corn island, but the ship was too far from it to sail there without losing precious time, which it could not afford to do then, as it was hot on the track of a particularly dangerous derelict, and the chase had led pretty well down toward the coast of Honduras. So when a low bank of purple that might be a cloud or might be land was seen low down on the eastern horizon it was decided to make for it in the hope that it might turn out to be a small coral island yet uncharted.

It proved to be a little island about three-quarters of a mile around and a quarter mile wide. In shape it was long and narrow, with a thick growth of vines and bushes reaching down to the water's very edge. Three tall cocoanut palms grew in the middle of it. No life of any kind was on the island, nor was there any water, though instead of being sandy or rocky, as such islands usually are, the soil was rich, dark and very moist. After gathering the cocoanuts the sailors returned to the cruiser, which, oddly enough, seemed much farther off and considerably more to the southwest than when they left her. Then it just dawned on them that they had been visiting one of the floating islands so often heard about, but seldom seen, in the south Atlantic. Further observation soon confirmed the suspicion, as the cruiser remained near it long enough to see the island change its position.

These floating islands are parts of other islands torn away by hurricanes or some great seismic upheaval. They drift about for months, moving slowly with the winds and currents, held together by the matted roots of trees and plants until they either attach themselves again to solid land or are disintegrated and eaten away by the action of the waves. In some rare instances they gather other flotsam of the sea to themselves and, stranding on a reef, become in time a new island.—New York Press.

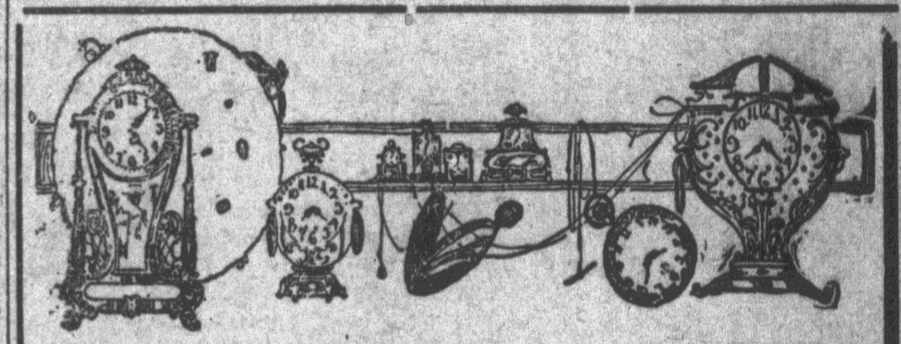

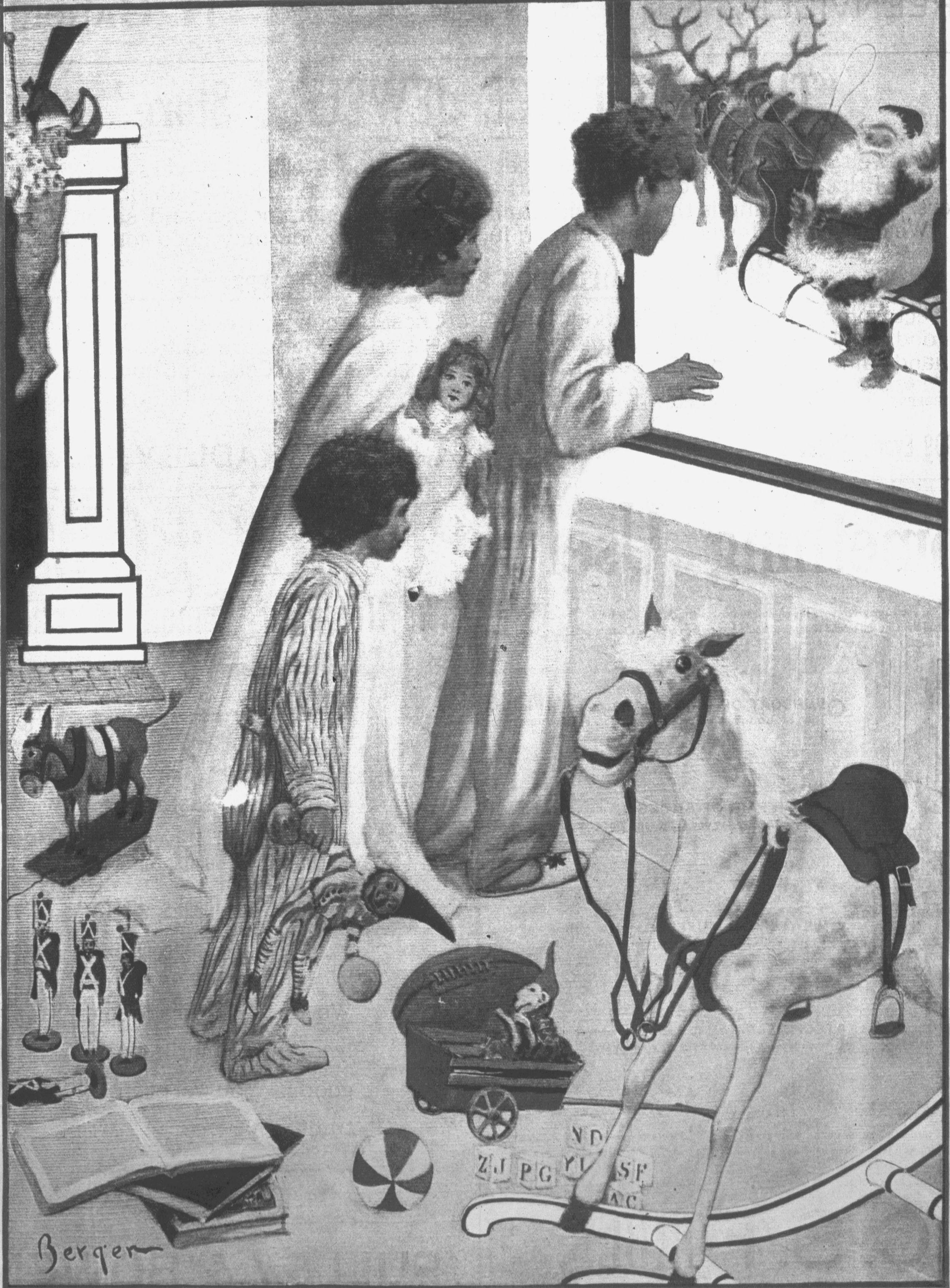
