MARION BUTLER INDICTED.

Four Bills for Libel Found Against Him in Guilford County.

Greensboro, N. C., Dec. 14.—The grand jury of Guilford Superior Court this afternoon returned four true bills against Ex-United State Senator Marion Butler and his brother, Lester Butler, charging criminal libel against ex-Judge Spencer B. Adams, chairman of the Republican party of North Carolina.
The charges are based upon articles published in the Raleigh Caucasian, owned by the Butlers, several months ago. The ex-Senator and his brother were arrested November 4th, and bound over to the present term of court in bonds of \$1,000 each to await action by the grand jury. On motion of Butler's attorneys the trial is continued until January term of court, notwithstanding Adams' attorneys pressed for trial. Neither of the Butlers was in court today.

Suffolk Goes Dry.

Suffolk, Va., Dec. 15.—This place went dry yesterday with a majority of 257. Considerable excitement has been occasioned for some time by the contest, and the majority was larger than was generally conceded by either side.

FIGHTING TURKISH TOBACCO.

Virginia Tobacco Men Will Ask For a Higher Duty on Turkish Tobacco.

Danville, Va., Dec. 14.—The Danville tobacco board of trade at a special meeting to-day appropriated funds to send a large committee to Washington Wednesday to appear before the ways and means committee of Congress to urge the passage of laws which will impose a higher duty on Turkish tobacco, which is coming more and more in competition with the tobacco grown in the bright district, which is mainly in Virginia and North Carolina. The Danville tobacco-growers contended that as the United States government protects the New England tobacco growers in imposing a high duty on Sumatra tobacco, the bright tobacco growers should in a spirit of fairness be afforded the same protection. Among those who will go to Washington are President Carrington, of the Commercial Association, and President Adams, of the Tobacco Growers' Protective Association of Virginia and North Carolina. Concerted action on the part of the tobacco associations in both of the two States has been asked for.

THE GRAND OLD MAN.

The Raleigh News and Observer in speaking of "three grand old men" at the recent North Carolina Conference in Durham, had this to say about one of them:

The most distinguished layman in attendance upon the conference is Hon. Thomas J. Jarvis. He has held the highest positions in the gift of the people—State legislator, speaker of the house, Lieutenant Governor, Governor, Ambassador and U. S. Senator. No man of his generation has been more signally honored by the people of the State. He filled each position with dignity and ability, but he never seemed so great a man in high official positions as now, in the sunset of a long life, he busies himself with the work of teaching the children in the Sunday school, leading in building a new church in his home town, working to secure the location of a State Normal College in Greenville and acting as chairman of the board of trustees, securing for his town a model graded school, and taking first place in ridding the State of the saloon and still. These are the public duties to which he devotes as much time as he can spare from the active practice of the law. For a man beyond three score and ten, who lost the use of an arm by reason of a wound he received while leading his company in battle in the Confederate army, he is doing work that would tax the powers of a young man, and is earning the title that has been given him of "North Carolina's Grand Old Man." It is mainly due to him that the special session of the legislature this year submitted State-wide prohibition to the people that was ratified by the voters in May by a majority of 44,000. Three fourths of the State has put the saloon and the still out of business and there was a disposition to postpone the fight for State prohibition until next year when Governor Jarvis sounded the trumpet-call for immediate action. The State was ripe for it and when so distinguished a leader sounded the tocsin there was a general response and the world knows that North Carolina is the first State in the South to end the liquor traffic by a vote of the people as it was first by popular vote to purify the suffrage. The father of Governor Jarvis was a Methodist preacher and if it be given to the dead to look down upon what transpires in this life, that heroic old circuit rider in glory must have added joy to see his son walking in his footsteps after treading the courts of public honor. It is a sad fact that public life in many cases leads away from the sort of Christian work in which Governor Jarvis now takes delight, and his abundant labors in his church, for education and for temperance is an inspiring example to the young men of the Commonwealth.

Snakes Changed into Rods.

Army Relics of the Miserly King and Lavish Author.

A TYPEWRITING POINT.

Why in Some Work Periods and Commas Show Black and Deep.

"When in anything typewritten you see the periods and commas punched black and deep," said an experienced typewriter, "you may know that the work was done by a beginner or by one who had not yet done sufficient work to have acquired a perfect touch."

"The reason for the deep punching of the punctuation points is very simple. Naturally enough the beginner at typewriting plays upon all the keys with equal force, but as the types attached to the keys present unequal amounts of printing surface it follows that equal force applied to all the keys results in more or less unequal printing on the paper."

"For instance, a certain amount of force applied to the 'B' key might produce of that type a fair impression on the paper, but the same force applied to a period might drive that, a mere point, clean through the paper. In fact, it is not unusual for beginners on the typewriter to punch holes in the paper with their periods."

"But as the learner progresses in her art she comes to realize that some types must be touched more lightly than others, and gradually her periods become less black and deep, and with further practice she comes instinctively, automatically, to grade her touch on all the letters and signs until at last she is able to produce typewriting that is nothing less than artistic in effect, true and uniform and beautiful."

"It is something fine to see the good work of the intelligent, sensitive and truly competent typewriter."—New York Sun.

An Indian Trick.

In the snake bag trick of the Memomni Indians the performer holds before him a red flannel bag about thirty inches in depth by twenty inches in width, with fluffy white feathers along the top of the opening. Then he rolls the bag up into a ball to show the audience that there is nothing in it. Then he takes the bag by the two upper corners and holds it up before him once more and begins to dance around the circle, his confederate preceding him dancing backward, chanting with the performer and making various gestures toward the bag.

The good, old fashioned morals of former days are relaxed in order to obtain it, and defalcations constantly grow because of the modern creed that reads, "Get money—honestly if possible, but get it in any event."

Luxury increases and extravagance grows. The idea of slow accumulation of money saved during the productive against the declining years, when the earning power decreases, no longer obtains. We would all be rich, and we would be rich quick. Speculation arises, and a long train of evils marches constantly before us, because our age has become an age of money irrespective of all other considerations.

It is exceedingly pleasant to have wealth. When we see the beautiful palaces at Newport and their gardens and the countless luxuries that money spells anywhere and everywhere only the anchorite turns aside and will have none of it. Horses, steam yachts, European travel, entertaining, various art products and a thousand and one things beckon to the rich man and lure him and tend toward making him forget that the conquest of the world is not worth the loss of a soul.

We of this age of money need to remember that there are certain cardinal virtues that will linger when stock and other exchanges are no more, and in ages yet to come money will be replaced by something higher and better than a commodity that can upon occasion take on a taint.—W. Making of Veneer.

The best veneer is sawed, but a great deal is sliced and still more is "rotary cut." By the last named process logs of the desired wood are steamed until they are soft and then fixed in a lathe-like machine, in which they are turned against a wood knife. As the log rotates against the knife veneer of the desired thickness is peeled off in a continuous slice, as if you should pare an apple, going deeper and deeper at each complete turn, until nothing is left but the core. The center of the log left after the veneer is cut is also called a "core." A good deal of waste occurs in the manufacture of veneer. It is always a problem, for instance, what use to make of the cores left by the rotary process. In many cases these are used for pulp wood, pillars or panel headings, and they are largely used also for fuel, excelsior, crates, boxes and baskets.

Who Was Jack Robinson?

Jack Robinson has long been a favorite synonym for rapidity of speech or action, but possibly few people who use the phrase are aware that Jack Robinson was a real live person.

"As a politician," says Lady Dorothy Nevill in her "Reminiscences," "John Robinson was a great favorite with George III. His political career was long, for he was a member for Harwich during twenty-six years, being on one occasion bitterly attacked by Sheridan, who, denouncing bribery and its instigators, replied to the cries of 'Name! Name!' by pointing to Robinson on the treasury bench, exclaiming at the same time, 'Yes, I could name him as soon as I could say Jack Robinson,' and thus originated the saying still current at the present day."

A CYCLONE OF FLAME

Fires in Bamboo Forests Are the Fiercest Known.

SWEEP ON A MILE A MINUTE.

Like the Roar, the Roll and the Rattle of a Great Battle Is the Noise of the Exploding Stalks That Sometimes Shoot High into the Air.

When the forests are afire, when the smoke makes dusk at noon and reddens the harvest moon, a thousand miles away, there is the measure of a conflagration. When the prairies burn, as they used to before farms had crept in upon the endless miles of grass, there was a fire which ran like mad and left behind it a blackened trail of death. If one could combine the speed of the prairie fire with the tumult of the blazing forest, that would be a fire indeed.

Such a combination is effected when the bamboo groves catch fire. The bamboo is but a grass, a grass with the height of a tree, swaying stems reaching 100, even 150, feet in air.

In Cambodia, where the bamboo groves along the rivers cover the space of forests, it is no unusual thing for fires to break out and sweep all before them for many miles. If the summer has been dry the bamboo turns sear and inflammable as any grass.

All that is needed is a spark; then ruin runs red. It is not necessary to rely upon the carelessness of the woodsman to start the blaze. The bamboo can kindle itself.

Let two swaying stalks of dry bamboo be set in motion by the breeze, let one rub across the other long enough, and the friction will set the spark, and the long dry leaves will feed the flame. It is known that many fires of the bamboo forests thus originate. Perhaps it was from observing such a sight that primitive man learned the Promethean secret. That theory has been advanced.

As soon as a flame in the bamboos has crept to the level of the tossing tips it spreads like wildfire. The wind carries a sheet of flame along the grove at tremendous speed. Some observers say that such fires have been seen to move forward at the rate of more than a mile a minute. Seen from below, it looks as if the sky had burst into an instant flash of flame.

From such a burst of fire there could be no escape. Fortunately it passes high overhead at the tops of the bamboos. It serves as a warning to the traveler who may be making his way along some one of the water courses by which the forest is intersected. The bamboo itself is almost an obstacle to travel of any sort. It is well high impossible to force a way through it except by the slow and toilsome labor of hewing out a path.

The fire in the great trunks moves more slowly, and if warning be taken it may be possible to sink one's boat and throw up wet herbage and clay against the bank of the stream to provide shelter until the furnace blast has blown by. Such a fire in the bamboo has not only the speed of the prairie fire on its sweep overhead, but it has the same volume of fuel as is found in any forest fire. It combines the two types.

Bamboo forest fires have another quality which is all their own. They bang and rattle with thunderous crashes, as of artillery fire, without cessation.

The stalks of these tree bamboos are frequently more than a foot in diameter. Near the ground the joints are close together; in the younger growth the nodes may be several feet apart. But, long or short as they may be, each joint of the sun dried bamboo is a tightly sealed chamber filled with air. The partitions between the cavities are singularly tough; the outside rind of the stalks is almost pure flint.

When the blast of the flame sweeps onward the air in the stalks upon which it is driven is suddenly heated to a very high temperature. The residue of moisture which may be in the stems is immediately transformed into steam and at once subjected to superheating, thus becoming a violent explosive. As the hot breath of the flame becomes hotter these joints burst with loud cannon discharges.

Sometimes the force of the explosion near the roots is so great as to shoot the stalk like a javelin high into the air, where it flashes into torchlike flame and is carried by the wind to spread wider disaster. The bursting of the smaller joints is like the roll and rattle of rifles and machine guns. The effect is that of a battle hotly contested.—Washington Post.

An Aquatic Outfielder.

One day a ship was lying at anchor at Boca Grande when the crew observed a dolphin chasing a flying fish. Both coming directly toward the ship. On nearing the vessel the flier arose in the air and passed over the bow just abaft the foremast. As it did so the dolphin went under the ship and, coming up on the other side, sprang from the water and caught the flying fish on "the fly" just as it was curving gracefully down in its descent to the water.—Punta Gorda Herald.

PAINTERS' BLUNDERS

Reckless Pranks Played With Heavenly Bodies.

IMPOSSIBILITIES IN NATURE.

A Rainbow Depicted Wrong Side Out and Moons in Positions and Forms That Could Not Occur—Amusing Anachronisms by Old Time Artists.

That artists, like authors, should commit many errors of fact is hardly a cause for wonder. Rather, it is astonishing that they are not found oftener at fault in view of the great variety of knowledge required in their work. Despite this, however, there is no manner of excuse for certain absurdities.

For example, there is the case of an English painter who depicted an elaborate rainbow. Unfortunately he painted it wrong side out. But we forget amazement at such stupidity in admiration for the artist's magnificent audacity when we learn that he charged £20 additional for repainting the rainbow colored in accordance with nature's arrangement.

Painters are very prone to distress the astronomers by their reckless pranks with the heavenly bodies, particularly with the moon. One artist presented a scene in which was a crescent moon low in the eastern sky directly opposite a setting sun. Moreover, this genius disdained the criticisms of the learned. He insisted that this arrangement was necessary for the composition, inasmuch as the rest of the picture would be destroyed by a full moon—the only one possible in such a situation.

Other artists have trifled with the moon by turning its convexity away from the sun, which is, of course, impossible in nature. In one picture the moon was placed near the constellation of the Great Bear, though as a matter of fact the satellite never ventures into this part of the heavens. There are, too, oft recurring errors made in the bulk of the orb. An American astronomer amused himself by measuring the moons in a number of paintings. He established the fact that by reckoning from the satellite's size the average height of the hills in these landscapes was forty-three miles. One of the mountains, indeed, had the stupendous altitude of a hundred miles.

Artists of old time were often outrageously wrong, sometimes necessarily by reason of the limitations imposed by the ignorance of the period. A Dutch artist painted the garden of Eden with well clipped borders and yew trees trimmed into fantastic shapes. He wrought in all innocence, for of such sort were the only gardens of his experience. But the excuse does not apply to a Dutch painting of 1794. This showed Abraham about to slaughter Isaac by means of a blunderbuss—the product of an age 3,000 years after the time of the patriarchs!

Yet this mistake occurs again and again. There have been elaborate paintings of the children of Israel crossing the Red sea with muskets on their shoulders. A beautiful ivory tankard, an Augsburg carving of the early seventeenth century, was sold for a high price in London not long ago. The design, which is exquisite in workmanship, shows the good Samaritan, with his attendants, in the Jericho road. One of the servants carries a gun!

Many a child as well as some older persons has puzzled over that "beam" in the eye of which the New Testament speaks. It is not always understood that this means a beam of light. But it was left to Solomon Bernard, in his woodcuts illustrating the Bible, published at Lyons in 1553, to picture this beam as one of wood, rectangular in section and several feet in length!

The matter of costumes offers vast opportunity for flaws, which the painters have not failed to seize. In the national gallery at Edinburgh Pharoah's daughter and her accompanying women are exhibited garbed in the long waisted bodices and hooped skirts of Europe in the sixteenth century. The national collection in London has a picture of Joseph and his kindred in Egypt, where the buildings shown are not at all Egyptian in their style of architecture, but distinctly Italian. In the same gallery Paolo Veronese's "The Family of Darius at the Feet of Alexander After the Battle of Issus" displays the women of the group in the pointed waists and inflated skirts that made the familiar dress of Venetian women in the painter's time.

Errors that have to do with armor may be more readily pardoned, though the artists fail lamentably in knowledge as to the earlier forms of metal protection. Thus in some paintings showing the time of Christ the warriors are seen clad in beautifully damasked mail, yet this form of armor did not come into actual use until half a thousand years later.

Similarly, in other pictures of Christ's time, monks are portrayed in their robes, with tonsures. In fact, however, they did not exist in the church prior to the fourth century A. D.

A curious illustration of the limitations set on genius by circumstance is exhibited in one of the world's most famous paintings, "The Last Supper." Leonardo da Vinci simply did not know that the table, the cloth, the plates, the knives and forks and salt cellars were impossibilities in the scene he designed to portray. The eastern people of that age who were his subjects used no table, no chairs, no forks, but squatted about a common dish and ate from it with their fingers.—Pittsburg Post.

A NIGHT OF TORTURE

It Brought a Fortune to Its Hall Strangled Victim.

AN INNOCENT MAN'S ORDEAL.

Twice Strung Up by Lynchers, He Confessed to Murder and Was Afterward Vindicated and Recovered \$25,000 From His Assailants.

Late in the fifties of the last century George W. King was the proprietor of a hotel in Oxford, twenty-six miles from Lafayette, Ind. In 1850 a stranger arrived at the hotel and gave his name as Dr. Rowe. He told King that he had no money and asked to be trusted for his board till he could get practice in the place, promising to pay him as promptly as possible. King consented to the arrangement, and Rowe soon became a favorite with the people on account of his companionable disposition and superior intelligence. The doctor, however, fell deeper and deeper in debt. He had been at the hotel for nearly a year when King reminded him one morning that he had not paid anything on his board bill for three months. The conversation, it afterward appeared, was overheard by some one in the hotel, though nothing was thought of it at the time.

A week after the conversation Rowe was called out late at night to see a patient and failed to return. Days passed without any word from him, and his disappearance soon was connected with the conversation that had passed between him and the landlord about the unpaid board. One night three months later a party of disguised men entered the hotel and, overpowering King, took him to a woodland adjoining the town.

He recognized the voices of several of his captors and especially of the leader, who told him that he was suspected of murdering Rowe and demanded that he confess. King stoutly maintained his innocence, and the leader of the mob ordered his companions "to string him up." A rope was placed around his neck, a dozen men pulled down a stout limb, over which the other end of the rope was thrown, and when the limb was released it carried King off his feet and left him hanging by the neck. He was nearly unconscious when let down and again ordered to confess.

After much delay he was restored sufficiently to understand what was said to him, and he again refused, declaring his innocence and saying he did not know what had become of Rowe. A second time he was strung up and a second time let down, but life was nearly extinct, and he was much longer in being restored than before.

The luckless landlord knew he could not pass through another such ordeal and live, so he consented to confess. He purposely lengthened the confession in order to gain time, and said that he and two men, named Rogers and Haggard, had poisoned some whiskey and induced Rowe to drink it, and after his death they had buried him in a hollow some distance away. It was nearly daylight when the confession was made, and the lynchers determined to take King to jail in Lafayette and then arrest Rogers and Haggard.

Before the jail was reached day had dawned, and King recognized his captors as members of the Horse Thief Detective company of Benton, Warren and Tippecanoe counties, nearly all of whom were known to him. Confident of his guilt, the men made no attempt to conceal their identity. So great was the excitement and so intense the feeling against King that he waived examination and went to jail, hoping that something would turn up to establish his innocence.

From the jail at Lafayette King addressed letters to editors of papers in Cincinnati, Chicago, St. Louis, Louisville and other cities, setting out the circumstances of his confinement and asking them to keep his letter in the papers in hopes that it might fall under Rowe's notice. The appeal was a pathetic one and was copied into many papers throughout the north-west.

Two weeks after its first appearance Dr. Rowe rode into Oxford and, attended by a number of citizens, proceeded to Lafayette, where his appearance caused the immediate release of the accused landlord. In explanation of his disappearance Rowe said he had left his home in the east on account of domestic troubles, that he had learned that his wife was on her way to Oxford, and he had determined to leave the place secretly in order to prevent her from learning where he had gone. He had gone to a little town in southern Illinois, and it was there that he learned that the man who had befriended him was suspected of his murder and was in jail in Lafayette.

As soon as King was released he brought suit against thirty-two members of the Horse Thief Detective company for \$5,000 each and also against the company as a corporation. Thomas A. Hendricks, afterward vice president, was his counsel, but the case was not allowed to come to trial, the lynchers compromising by paying King \$25,000. With this money he purchased a farm and other property near Lafayette, where he lived till his death at the age of seventy-eight years.

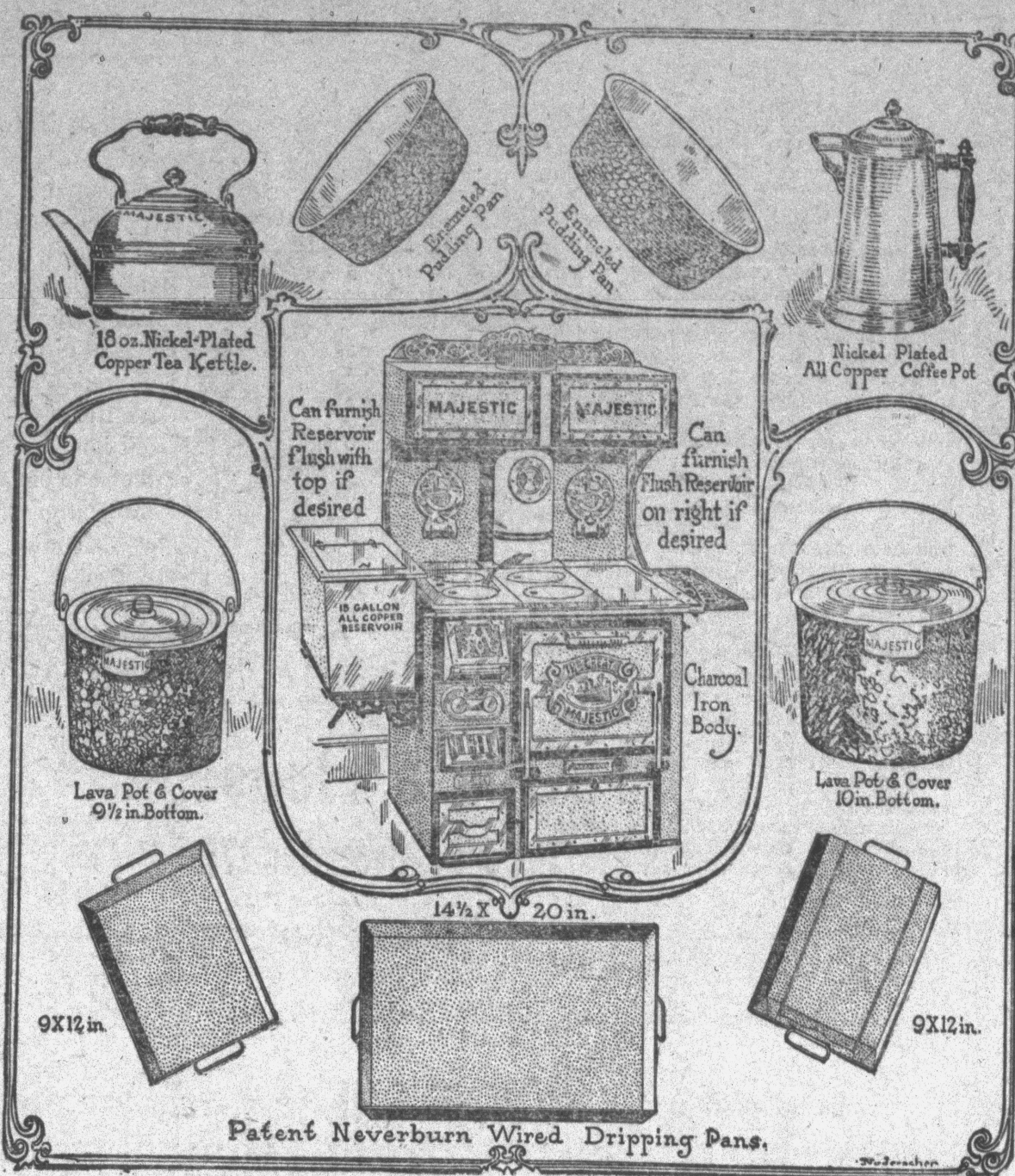

THE TURTLE'S DEFENSE.

Coyote Helpless Against Snapper, Whose Eggs It Devoured.

In 1850 a war party of Cheyennes had started out on foot to take horses and had got as far south as Black Butte creek—perhaps Big creek of the whites—which runs into the Smoky Hill river from the north, near where Fort Larned afterward stood.

They had come to the banks of this stream and were sitting there resting, some of them drinking water, others lying down in the grass and sleeping. As they sat there, says Forest and Stream, one of the men saw coming over the prairie a coyote, slowly trotting toward the stream. It acted as if it smelled something.

Now, it is the law that when people are on the warpath they must not kill or injure either wolf or coyote. So no one thought of harming the animal, and the men sat there and looked at it, and one said to the other: "Sit still, now. Do not frighten it. Let us see what it will do."

The coyote trotted along slowly until it had come to a sand bank at the edge of the water, and there, after smelling about a little, it began to dig and presently had partly uncovered the eggs of a snapping turtle and was beginning to eat them. But close by, lying on the

sand, was a big snapping turtle, the mother that had laid these eggs. She saw the coyote and commenced slowly to walk toward him. The coyote had his head down in the hole, busily devouring the eggs and saw and heard nothing, and in a moment or two the turtle was close to it and, darting out its long neck, seized him by the cheek and the ear, closing her jaws on him with a grip that nothing could loosen. The coyote yelled dismally and tried to pull away, but could not. The turtle was big and strong, and she began to back slowly toward the stream. The coyote, howling with pain, pulled back as hard as he could and struggled desperately, trying to shake himself free. But the turtle held on and marched steadily backward until she got into the water and dragged the miserable coyote after her. Gradually the water got deeper and deeper, until it had reached the coyote's body, and then presently its head disappeared, and the last the Indians saw of him was his tail and his hind legs waving in the air.

For some time the Indians sat there looking at the water and talking over what had happened, and at length they saw the body of the coyote rise to the surface and float away down the stream.

So the old turtle protected her young ones.
