I could not decide at once, but in a little wagon, bare-headed, with tangled and unkempt locks, there sat Rollin Jacob, a startling figure surely, and with the assistance of the jailer who was in the act of placing him out on the ground or grass, I noticed his legs were entirely useless and so badly deformed he could only move when ready for propulsion and a start by bracing himself with his hands and shoulders behind him like an inverted crab, (poor man) and as he turned to survey the urchins who faced him he at once said "Hello, Dickey," for my friend knew all the prisoners, ex-prisoners, or prospective prisoners, (his father was high sheriff) and Dickey of course had seen them and had been in the dungeon frequently and shaken hands with old Ben Soon (senior) in his chains.

Richard Evans Selby, has now been dead many years, peace to his ashes, but he was a born leader in his day among the boys, and I can imagine that he said something like this when we had gathered about him, first, he assured us that his friend was perfectly harmless and could crawl any where when not interfered with, and as the champion of the gall-berry country he had numerous fights and scrimmages and was compelled to knock a fellow over with a club who needed it. But Richard said he was curiously misjudged and sent to jail for lack of appreciation on the part of his friends.

Then overwhelmed with admiration and pity for the almost legless hero, the young gentlemen with long drawn inflations quietly departed without discovering that Jacob was a tough.

## THE LEGISLATURE.

What Our Law Makers Are Doing at Raleigh.

### TWENTY FOURTH DAY. SENATE.

The only new bill introduced of more than local importance was for the relief of prisoners in jail awaiting trial.

A resolution was offered providing that the finance committee be required to make its report by February 12th, and that no bill be introduced after February 15th.

A bill allowing 8 per cent to be made the legal rate of interest by private contract between the parties, was taken up and discussed by senators. It failed to pass second reading on roll call by a vote of 29 to 3.

### HOUSE.

In the house were many new bills, but the only ones that did not apply alone to some particular town or county were: To protect employes; to prevent black listing; to make it unlawful to list claims for collection outside the state; to provide a free employment bureau for labor.

A large number of previous bills were up on second and third readings.

## STATE NEWS.

Happenings of Interest in North Carolina.

A young man named Ed Wright was found dead in a launch near Washington Tuesday morning. His skull was fractured and it is supposed that he fell against the engine in the boat.

A well dressed white man apparently 45 years of age, giving his name as R. E. Varne, shot himself in the head with a revolver last night about 10 o'clock at his room in Hotel Clegg, inflicting a wound from which he died a few hours later.—Greensboro Telegram.

Elizabethtown, N. C., Feb. 1.—The beautiful residence of Judge C. C. Lyon was totally destroyed by fire here yesterday afternoon between 4 and 5 o'clock. Fire originated in the stove room adjoining the house. Most of the furniture was saved but badly damaged by the excited crowd.

Clinton, N. C., Feb. 2.—The jury returned a verdict of "guilty" in the case of State against Will Ward for rape after having been out fifteen minutes. Judge Allen sentenced Ward to be hanged March 3.

Salisbury, N. C., Feb. 2.—By the use of dynamite the grocery store of D. M. Miller, in Salisbury, was blown open shortly after midnight this morning and the premises robbed by unknown parties.

Winston Salem, N. C., Feb. 2.—John Adkins, a prominent farmer of Stokes county, was thrown from his mule today and sustained what is regarded by attending physicians as fatal injuries. His skull is fractured.

### Saving Time on the Phone

According to a district manager of one of the local telephone companies, the stereotyped "Hello" as a method of opening a conversation over the wire is doomed to go. "It is really a waste of time to bawl out 'Hello' over the wire," said the manager, and I think people are beginning to realize it. The line of least resistance is a very good one to follow in telephone talk and so may encumber your conversation with unnecessary words? You will find that those in the telephone business have cut out 'Hello' entirely. Take for instance the operator. See how they've cut out the unnecessary talk. It is simply 'Number please,' with them and that's all there is to it. Now the proper way to talk over the telephone is to establish your identity at once and then get right down to business so I always answer the telephone with a 'yes' as I think that is the most direct means to the end of finding out what's what. Some people answer the phone by giving their name. In speaking you can use a certain inflection, which answers the purpose of a half dozen words. For instance, let us say a Mr. Smith is called. He answers the telephone by saying, 'Smith,' Then the other fellow can plunge right into his business without wasting time by asking who is on the phone or other needless questions. It is a great time-saver, and a great many business firms have issued rules to their employes never to say 'Hello' but to give the firm name upon answering the telephone, so you can readily see that 'Hello' is doomed to leave us. It is already old-fashioned.—Philadelphia Record.

**Governor Glenn Explains.**

Former Governor Glenn has made reply to the charges that have been made over the fact that he was allowed \$30 per month for servants' hire while he occupied the governor's mansion. The reply sounds reasonable and comes from his home city, Winston-Salem. It follows:

"Just before he left today for Baltimore, where he lectures tomorrow, ex-Gov. R. B. Glenn, gave out a statement, saying that some newspapers were commenting on the report made by the legislative committee, condemning the act allowing the governors to draw \$30 a month for servants' hire at the governor's mansion. The ex-governor says after his induction into office, he made inquiry about the matter, and was told that he was entitled to it, that other governors had been paid this sum regularly.

"The right of the governor being paid the \$30 was never questioned until last December. Governor Glenn then referred the matter to the attorney general, who held that the payment was just and right, and it was under these circumstances that the ex-governor accepted the money.

"You can say, too, that I lost \$2,000 a year during my entire term as the State's chief executive," said the governor."

The gay old prince was delighted. He came himself of a race famous for its dancing. He still pos-

sessed a good eye, a quick ear and a light foot. That same evening in the great hall of the castle, to the whistling of his host's son, he endeavored to emulate some of the feats he had seen.

The duke's solemn English butler was present, and his horror at such unroyal antics was reflected in his eyes. The prince perceived it, and, shooting a sudden forefinger at him, demanded imperiously: "Eh! Tell me, then, what you think of my dancing!"

Discreet and dignified, but flurried inwardly, the butler's manner was perfect, but his tongue betrayed him. He answered:

## SOME QUEER PRAYERS

Curious Mistakes That Have Been Made by Preachers.

### A CAUTIOUS SCOTCH ELDER.

The Way He Qualified in His Petition His Praise of the Pastor's Wife. The Blunt Appeal of Father Taylor, the Boston Preacher.

The most frequent cause of inappropriate petitions is no doubt the persistence of habit. Certain phrases are used again and again until they come to be repeated without any thought of their immediate application, says the Christian World. We may similarly explain the stories of the workhouse chaplain who prayed that those present might not trust in uncertain riches and the prison chaplain who besought the Lord that he conduct the worshippers in safety to their respective places of abode.

The sense of humor must surely have been lacking in the old man of eighty, supported by crutches, who regularly included among his petitions at the weekly prayer meeting the request that he might be kept from running with the giddy multitude to do evil. Familiarity with conventional phraseology was the undoing of the minister who, after the sermon on the Pharisee and the publican, asked that there might be poured out upon his hearers a double portion of the publican's spirit. Not very complimentary was the use of a well known Scripture passage made by a minister at a wedding:

"May these persons live together in such harmony in this life that they may finally attain unto that state of felicity where they neither marry nor are given in marriage." As a concluding example of the thoughtless use of familiar language one may quote this remarkable amalgam: "O Lord, we praise thee that we are thine; we feel that we are thine; we know that we are thine; Lord, make us thine."

As in a sermon, so in a prayer, the attempt to correct a hasty utterance sometimes leads to surprising results. A cautious Scotch elder, it is said, had taken supper at his pastor's house and in returning thanks after the meal entered upon a detailed exposition of various causes of gratitude. He concluded by invoking the divine blessing upon the pastor's wife as his godly helpmeet, who had always upheld his hands in every good work—"at least," he added in a saving clause, "as far as we know." It is related of a patriot that in a moment of forgetfulness he once thanked God for "the salvation of all men," but immediately redeemed himself from heterodoxy by the qualification, "which, O Lord, as thou knowest, is true in one sense, but not in another."

There are some men who seem to think that an indirect manner of expression is especially suited to sacred things, as the Scotchman quoted by Dr. Boyd as saying, "For, as thou knowest, men do not gather grapes of thorns nor figs of the national emblem," and the Englishman who thus pledged himself, "And, O Lord, if thou wilt move the heart of any young man to enter thy service, we will show our approval in a way which thou wilt appreciate."

Father Taylor, the Boston sailor-preacher, was one of the most direct of men and on the one recorded occasion when he essayed a roundabout style nature triumphed over artifice. It was the Sunday before the state elections, and he was praying fervently that a man might be chosen for governor who would rule in the fear of God, who would never be afraid of the face of clay, who would defeat the ringleaders of corruption, who would defy his own party if it yielded to wire pullers, who—suddenly Father Taylor paused and then exclaimed: "O Lord, what's the use of boxing the compass in this way? Give us George N. Briggs for governor. Amen!"

The temptation to use public prayer as a vehicle for the conveying of information has sometimes been too strong to resist. In his lively reminiscences published some years ago in the Wesleyan Methodist Magazine the late Dr. Benjamin Gregory recalled how a certain Methodist minister of an earlier generation was accustomed to convey all necessary directions to his younger colleagues through the medium of the throne of grace. Here is an example: "O Lord, bless thy dear young servant. Thou knowest his appointment for tomorrow is at —, and he will have to stop at Brother —'s, who keeps a little shop opposite the church. Oh, grant that thy dear young servant may not

forget to let the people have the magazines and to bring home the moneys."

The famous Dr. McCosh of Princeton was accustomed to meet the students in the college chapel every morning, when he would make any necessary announcements as well as conduct devotions. One morning in the prayer with which the service concluded he prayed for the president of the United States, the cabinet, the members of both houses of congress, the governor of New Jersey, the mayor and other officials of Princeton, and he then came to the professors and instructors in the college. At this point there flashed into his mind a notice which had been communicated to him orally and which he had omitted to include in the announcements made just before. To the surprise of the assembled students President McCosh continued, "And, O Lord, bless Professor Karge, whose French class will be held this morning at 9 o'clock instead of 9:30, as usual."

### A Large Salary.

Mr. X., a prominent lawyer of Philadelphia, was much addicted to the habit of lecturing his office staff, and the office boy came in for an unusual share of admonition whenever occasion demanded and sometimes when it did not. That his words were appreciated was made quite evident to Mr. X. one day when a conversation overheard on the elevator between Tommy and another office boy on the same floor was repeated to him.

"Whatcher wages?" asked the other boy.

"I get \$10,000 a year," said Tommy. "Aw, gwan!" ejaculated the other boy derisively. "Quitther kiddin'."

"Honest, I do," said Tommy; "\$4 a week in cash and the rest in legal advice."—*Harper's Weekly.*

### Blenheim.

A very "famous victory" was that of Blenheim, which is our corruption of Blindheim, the village on the upper Danube where John Churchill won his dukedom, his magnificent palace in Oxfordshire and his yearly pension of £5,000. This is still enjoyed by his heir, the present Duke of Marlborough, who annually places a French fleur-de-lis flaglet over the bust of his ancestor in the guardroom of Windsor castle, the condition of his tenure of the estate of Blenheim.—*London Answers.*
