MISSIONARY INSTITUTE.

To Be Held in Tarboro This Week.

The Missionary Institute to be held in St. James Methodist church next Thursday and Friday will be presided over by Rev. A. McCullen, presiding elder, and the preachers, of the district in attendance will participate in a discussion of the various subjects to be considered.

A most interesting program has been arranged. The opening sermon will be preached on Wednesday night by Rev. J. W. Autry, of Bethel.

The institute proper, will convene Thursday morning at 10:30 o'clock. Devotional services will be conducted by the presiding elder, after which at 11 o'clock, a sermon will be preached by Rev. G. F. Smith, of Wilson. On Thursday afternoon, the subjects discussed will be, "The most helpful Missionary Literature," and "Best Plans for Raising Missionary Funds." Rev. M. T. Plyler, of Washington, will open the discussion of the former subject, and Revs. B. E. Stanfield, of Spring Hope, and B. H. Black, of Fremont, the latter. Thursday night a sermon will be preached by Rev. D. H. Tuttle, of Rocky Mount.

Friday morning, Rev. E. C. Sell, of Nashville, will lead in the discussion of the subject, "Pastor and Missions," and Rev. R. E. Hunt, of Elm City, "Sunday Schools and Missions." At 11 o'clock a sermon will be preached by Rev. J. H. Shore, of Greenville.

Friday afternoon, "Woman's Work" will be considered. The work of the Woman's Foreign Missionary Society will be presented by Rev. R. H. Willis and that of Woman's Home Mission Society, by Rev. C. R. Canipe, of Aurora.

Friday night will be given over to the Laymen's Missionary Movement. Addresses will be delivered by Dr. D. B. Zollicoffer, of Weldon, conference leader of this movement, and by Col. J. F. Bruton, district leader.—Tarboro Southerner.

Niagara Falls Almost Out of Commission.

Niagara Falls, Feb. 15—Only a tiny rivulet, not deep nor swift enough to carry a pulp log over the brink, is flowing over the American side of Niagara Falls. A strong northeast wind which has blown since Friday, has held back the water and allowed the ice to gain a foothold.

A great wall of ice runs from the head of Goat Island to the American mainland through which only tiny streams are able to trickle. This wall has even encroached on the Canadian channel, extending out some 200 feet beyond the third Sister island and greatly diminishing the flow over the Horseshoe. Only the very apex of the Canadian fall is left, and that is robbed of half its flow. The gorge below is choked and the rapids have lost their fury, while the whirlpool is barely in motion.

This is only the third time that this combination of wind and ice has thus affected the falls since the white man came here. The other occasions were March 29, 1848, and March 22, 1903.

THE LEGISLATURE.

What Our Law Makers Are Doing at Raleigh.

THIRTY FIFTH DAY. SENATE.

Among the new bills introduced were:

To fix the punishment of safe crackers; to provide for furnishing school books to indigent children by the State board of education.

Senator Barringer's bill to put solicitors on salary having been killed he offered a new one providing that solicitors shall receive for their services \$120 a week, or any fraction thereof, for every criminal court which they attend and shall receive no other compensation, that the usual fees taxed for solicitors shall be put in bills of cost against defendants and paid into the State treasury.

HOUSE.

Among the new bills in this branch were:

To regulate the manufacture and sale of non-intoxicating drinks; to enlarge the state capital and issue \$500,000 in bonds; to promote sanitary conditions in tobacco warehouses; to regulate oyster dredging; to increase the pension appropriation from \$400,000 to \$500,000.

The drainage bill coming up on special order brought out the only real discussion of the day and was postponed for further consideration.

Game Durham Officer.

Durham, N. C., Feb. 15.—With thrice broken ribs and a badly bruised head, Officer J. H. Williams is in the hospital here from a fierce encounter yesterday morning with four negro gamblers.

Mr. Williams went into the fight single-handed. When he broke open the door two of the rascals overpowered him and beat him mercilessly, but he showed no signs of quitting. He tried to get his gun but negroes pinioned his hands. One of the gamblers turned officer and either fired at the policeman or an assailant; anyway, he got his man. Despite his wounds, the policeman led captive two of the men and the rest escaped. When he reached the police station Mr. Williams collapsed, but protested that he was all right. He was badly done up.

GREAT PREPARATIONS

Are Being Made to Receive Returning Battleships.

Washington, Feb. 15.—One week from today it is expected the Atlantic fleet will have completed its remarkable trip around the world and an noon will steam into Hampton Roads. The greatest armada of ships ever gathered at one time will be on hand to welcome the fleet. It is expected every vessel in sailing distance will steam to that place to welcome the men of the fleet. It is expected that fully forty ships of the American navy will be anchored along the route of the incoming fleet.

The president on the Mayflower will probably go out 12 or 13 miles. The Dolphin with members of congress will also go out some distance.

A hundred Washingtonians will leave here Saturday for Norfolk and it is almost impossible now to secure accommodations on any steamers plying between here and Norfolk, as all berths have been taken in advance.

GREENVILLE SHOULD HAVE LOWER FREIGHTS.

The difference in freight rates between Greenville and Washington certainly ought to arouse our people to action in the matter of taking advantage of the opportunity the river offers for a boat line and water competition. Take the rate by rail from Norfolk, for instance; The first class freight rate to Greenville is 61 cents while to Washington it is only 45 cents, and the difference in distance is only twenty miles. On other classes of freight the difference is in about the same proportion. Fertilizers cost \$2 per ton to Greenville and only \$1.50 to Washington. The railroad companies admit that this difference in rate is due to water competition, Greenville could have equally as good rates as Washington if our people would go at the matter right. The difference in freight to this point would pay for a boat in a short while.

Opinions of eminent sculptors and architects that the beauty of the North Carolina State house at Raleigh should not be spoiled by remodelling the building, is for the time being checking the sentiment that has been looking to that end. However, it is apparent that more room for conducting the State business, and better protection against the destruction of valuable records by fire is much needed. Perhaps a better solution of the matter will be to erect elsewhere such buildings as are needed and not mar the beauty of the capitol and grounds by making any change in that immediate locality.
