## ANIMALS AND EARTHQUAKES.

Foresight Displaced by Beasts Before Great Calamities.

A prominent Italian family in Messina was saved from death during the earthquake by a pet cat, says the Anderson Daily Mail. Several minutes before the shock came the cat aroused the father by unusual and continued cries and an attempt to get from the room.

Apprehending some great danger he pulled the wife and children from their beds in time to save them from the falling house. For a week he remained in Messina looking after the wounded. He never saw the cat after the shock.

When the earthquake destroyed Caracas a citizen owned a very fine stallion. He had become so vicious that he was confined in a large stall and taken out only when his keeper was on hand. Just before the earthquake came he tore down his stable, made a wild rush from the city and next morning he was found twenty miles away in the mountains.

## THE LEGISLATURE.

What Our Law Makers Are Doing at Raleigh.

FIFTY-THIRD DAY.

The senate passed, quite a number of bills on third reading in the effort to finish up the work of the session.

The thanks of the senate were extended to the Capital club of Raleigh for courtesies to the general assembly during its session.

A resolution of thanks to Lieutenant Governor Newland for the able manner in which he has presided over the senate was adopted. He was also presented a silver service.

Senator Whitehead Klutz, senator protem, was extended a vote of thanks, as were also the different clerks and their assistants.

The clerks presented Chief Clerk Maxwell a cane. The senators presented Mr. Staley, the sergeant-at-arms, with a watch and the laborers presented him a signet ring. Mr. DeBoy, assistant, was also presented a watch and signet ring, and he presented flowers to every senator, clerk, page and laborer of the body. Reading Clerk Squires was presented a cane.

The first business of the house that began early was to pass the omnibus magistrate bill. A large number of bills passed third reading, but one to tax dogs was tabled.

Reading Clerk Phillips was presented an Elk's badge; Mr. Kilpatrick, the sergeant-at-arms, a cane, and some of the clerks also received testimonials for their efficiency. Speaker protem Morton was presented a cane and assistant door keeper D. H. James a watch.

The house continued in the night session until after one o'clock trying to get through, but had to leave some business over for today.

Everything was finished up today and adjournment sine die of both branches was at 2 o'clock this afternoon.

## TWO BLIND TIGERS CAUGHT

Both Boarding With County in Default of Bond.

Chief of Police J. T. Smith run down and captured two "blind tigers" Saturday and Saturday night, both of them run by white men. Both of the "establishments" were what you might call "circulating," as they had no permanent den but roamed around the streets selling liquor from the pocket.

The first capture was Mack Mobley, who was selling in broad daylight, but slipping behind the corner of buildings to make the deal with his customers. Mobley was given a hearing before Mayor Whedbee Monday, and in default of \$200 bond for his appearance at Superior court was passed over to the keeping of Sheriff Tucker until the next criminal court convenes.

But Captain Smith had an eye on him, and this morning Dunn figured before Mayor Whedbee. There were two cases against him and he was asked to give bond in the sum of \$250 in each case, a total of \$500. The bond was not given and Dunn also went to jail to await the next term of court.

## A GALE BY ANOTHER NAME.

What the Sailorman Meant When He Told of an Adventure in Force 10.

No more legislature for two years, as it is not likely the one just adjourned will have to be called into extra session for anything.

The papers are now busy keeping up with what President Taft does on Sundays. Whether he rides or walks, or does anything Rooseveltian, makes an item for the watchful reporters.

A dispatch says ex-President Roosevelt is leading a simple life at Oyster Bay, and as an example gives his walking three miles through the slush to church Sunday morning. That was simple, sure enough, but he cannot be expected to keep it up.

The program committee of the teachers' meeting have been fortunate enough to secure the presence of Prof. J. Henry Highsmith for their meeting Saturday. Prof. Highsmith has charge of the Chair of Pedagogy at Wake Forest College and under him this department of the college work ranks with the very best in the State. We trust our people will attend in large numbers at this meeting Saturday.

The 1900 session of the General Assembly of North Carolina has been marked by its conservatism and wisdom. The members are certainly entitled to the thanks of the people of the entire State both for what they have done and what they did not do. There were able men in both branches, and their acts showed plainly that they were governed in their deliberations by conscientious convictions and not influenced by lobbyists or wielders of party lashes.

The reckless disregard for human life has gotten to the appalling standpoint. To end sorrow, sickness, and suffering of all kinds rather than to endure seems to be a growing tendency. It may be a weakness that affects both public and individual life, one can hardly tell; but it is true that it is a too prevalent practice. We have been taught from earliest day that it is murder for one to take his or her own life, and that the soul of such an one will be numbered with the damned. But this deduction can not be established as applying to all, though it may be the safest assumption to take. Suicide is not right and it tells of a morbid condition fraught with terrible ends. But that tendency for one man to shoot down his fellow man over any sort of dispute, business entanglement, or some real or imaginary offense is one that effects the country in a most terrible way. When a man commits murder, and court, lawyers and jury all combine to turn him loose, the crime is lessened and other men continue to commit murder. One can see all manner of weaknesses in our laws, the jury system and practices, but there is little being done to stop the evil. So many suicides and homicides have occurred in recent months within
