WOMAN'S CLUB OF GREENVILLE

A New Organization Among the Ladies of the Town.

An organization was a few days ago effected among the women of Greenville that doubtless means much for the advancement and general uplift of the town. Its name is "The Woman's Club of Greenville," and its object is "mutual improvement, and the promotion of such public interest as may seem to call for our attention."

The work of the club is embraced under six departments—education, literature, child study, civil and social service, household economics, music. The social meetings will be devoted to the consideration of some one of these departments, taking them in order or as their importance at a certain time may demand.

There will be two meetings each month, the second and fourth Thursdays, one meeting a month to be only for the transaction of business, and the other social and for the study of subjects under one of the departments. At none of the meetings will the serving of any refreshments be permitted, but the club will have an annual banquet.

Until arrangements can be made for a permanent meeting place, the meetings will be held at the home of some member.

Under the different departments of the club it can be made to bring much benefit to the community, and it should have the co-operation of all women interested in these things.

MORBID CURIOSITY.

"Every murder trial seems to collect its quota of human buzzards, who come early and stay late in order to catch some prurient testimony that no one would dare whisper aloud in a respectable drawing-room. It is a sad commentary on our times that the majority of these offenders of taste are women. They crane their ears for the horrible, and do not blush at the salacious. They feed on sensations that destroy the delicacy of womanhood.

It is a question, when testimony of a vitriating nature becomes a legal necessity, whether the judge in charge should not clear the court-room and go into executive session, so to speak. If the buzzard-like women will not protect themselves, the court should protect them. Testimony of doubtful character should not be made free to those who are supposed to be of the weaker and gentler sex."

"Oh! consistency thou art a jewel." What a truthful saying! The above is an editorial from The Boston Post, and in the same issue in which it appeared a long string of the vile testimony produced in the Hains-Annis trial was printed. Surely women and every one else, except those absolutely necessary for the trial of such cases, should be debarred from hearing "testimony of a doubtful character" in the court room. But what of the newspapers printing such testimony? Where there is only one woman in many hundreds who go to the court room, almost every woman in our land reads the newspapers. Not only that but the children of all of our homes read the newspapers in this modern time. Think of it! It is high time the newspaper was applying "higher morals" to itself. Thousands upon thousands of young men, young women and children who never saw the inside of a court room know the testimony to the utmost detail produced at the Thaw-White trial and the Hains-Annis trial, and it all came through the newspapers, which should promote the very best that humanity is capable of, instead of the very lowest. Yellow journalism is largely responsible for the "morbid curiosity" in our women.

WILD ELEPHANTS.

A Herd's Successful Raid on a Granary in Ceylon.

Some soldiers stationed at an outpost in Ceylon, says a Colombo paper, to protect a granary containing a large quantity of rice were sent off a few miles to quiet some unruly villagers, only two of the party remaining behind. No sooner had the soldiers departed than a herd of wild elephants, which had long been wandering about the neighborhood, appeared in front of the granary. Its walls were of solid brickwork, very thick, and the only opening into the building was in the center of the roof, which was reached by a ladder. On the approach of the elephants the two men clambered up into a lofty banyan tree to escape injury. Screened by the thick foliage, though unseen, by the elephants, they easily saw all that went on below. The sagacious animals began operations at the corners of the building. Two powerful elephants, after putting forth every effort, but in vain, to make an impression on the building, were forced to retire exhausted. A third came forward, and, applying his tusks as levers, he at length succeeded in dislodging a single brick. An opening once made, others of the herd advanced, and soon an entrance was obtained sufficiently large to admit them. As the whole company could not be accommodated at once, they divided into small groups of three or four. After satisfying themselves they retired and gave place to others until the whole herd, upward of twenty, had made a full meal. By this time a shrill sound was heard from one of the elephants, and those still in the granary rushed out and joined their companions. One of the first divisions, after leaving the building, had acted as sentinel while the others were taking their turn. He had perceived the troops returning from the village and gave the signal for retreat, when the whole herd, flourishing their trunks, moved rapidly into the jungle.

The soldiers found the animals had devoured the greater part of the rice. A ball from a fieldpiece was discharged at them in their retreat, but they only wagged their tails as if in mockery and were soon hidden in the recesses of their native forests.

TRAPPING A GORILLA

Story of a Vicious Struggle in the African Jungle.

A NET THAT FAILED TO HOLD.

The Snared Monster Broke Through Its Meshes and Was the Cause of One Death Before He Was Himself Killed by the Attacking Party.

Captain Fritz Duquesne, the Boer Ivory hunter, was commissioned by a German naturalist society to capture one of each species of African quadrumania. He was entirely successful in the work, except that he could obtain no gorilla. Finally a pygmy pointed out a portion of the dank jungle in which a gorilla had been seen.

The captain immediately arranged his camp and laid his plans and made preparations to trap the monster and get him alive if possible, though he fully realized the danger of the undertaking.

"For four days," said the captain, "we camped in this hotbed of disease. Beaters went out in all directions searching for the gorilla. At last some deep, wide scratches were found on a cluster of vines. On close examination the unmistakable hair of the gorilla was found on a broken twig.

"After some hours we found the tree where the gorilla lived. We could tell it by the greasy appearance of the bark, made so by the repeated rubbing of the gorilla's body. We could tell by the fresh marks, with sap still wet, that the animal had recently ascended the tree. The scratches were short and deep, showing that it had lifted itself up and had not slid down, which would have made a long, shallow scratch.

"We spread a strong net around the tree in a circle sloping upward on the outer side. Around the top of the net there were drawn ropes from four directions, held by half a dozen natives hidden in the bush. These were to bring the top of the net together and thus bag our game.

"After waiting some hours the leaves above rustled and then opened as a six foot male gorilla descended unsuspectingly and entered the trap. I signaled, the four ropes were pulled at once, and we had our animal—for a moment. He roared in fury, twisting, jumping and biting the rope into pieces. The natives were pulled about like dolls as he tried to reach first one and then another. The professor jumped about in excitement, trying to focus a camera on the infuriated animal.

"At last the mighty arms of the gorilla broke a hole through the net, and he tore the rest from him as though it were a rotten rag. Most of the natives fled in dismay. The professor dropped his camera and tried to escape. In a moment the gorilla grasped him in its terrible hands.

"I seized my rifle and fired in the air to frighten the animal. In my position I could not shoot at him without hitting my friend. For a moment the gorilla stood still, holding the now unconscious man as though he were a baby, the brute's lips drawn back from his glistening teeth.

"I thrust another cartridge in my rifle. As I did so there was a buzz in the air, and an arrow, shot by a native, pierced the gorilla's side. A roar burst from his red throat, and he dropped his victim. Like a flash, before I could shoot, a native sprang from the leaves and, half throwing, half thrusting, drove an assegai into the gorilla's heart. With a groan the brute fell dead.

"Examining the professor, I found that his right arm was broken and that some of his ribs were crushed into his lungs. We gave up the effort to get a live gorilla and, placing the injured man in a hammock, carried him back toward the east coast.

"He died on the road. Out on the veldt beside a native village a lonely little slab marked 'Carl Bloch' sticks up above the grass. It is the professor's grave. Hunting is not all exciting adventure and laughing, victory. It has its tears, like other things."—Hampton's Magazine.

DAYS OF THE WEEK.

At One Time They Were Designated Merely by Numbers.

Formerly the days of the week were numbered one, two, three, four, five and six, beginning with the Sabbath. Even now the custom still prevails among certain modern Greeks, the Slavs and the Finns. Many old-fashioned and orthodox Quakers, particularly in the north of England, still hold to this custom, which was the common one in the days of the apostles and down to the fourth century as well as usual among the Jews and the Arabs. The orthodox Quakers use the numerical system in preference to the ordinary on the ground that the gods and goddesses, from whom the names were taken, were not of the highest respectability in point of morals.

The week was originally only a convenient quarter of the lunar month; hence it began on Monday, or moon day. The Italians still call Monday the first and Sunday the seventh day of the week. Tuesday is derived from the Norse Tiw, who corresponded to Mars, the god of war, a most disreputable person in the eyes of Quakers. Thursday was Thor's day, Thor being a god warrior who was morally no better than he ought to be. Wednesday, again, was Woden's day, Woden being the god of battle rage. The Romans called this day Mercury's. Friday was supposed to be the luckiest day of the week—for women. It was called after the Norse Frigg, the goddess of love, and is the best day for weddings. For the pagan Romans it was also the day of Venus, though the Christian Romans called it the day of ill luck because Christ had been crucified on that day. Saturday was called after Saturn, and Sunday was known to the Christians as resurrection or sun day.

The week of seven days was imported from Alexandria into Greece and into Italy about the time of Christ. The Greeks had previously divided their month into sets of ten days, the Romans into sets of eight days, three and a half sets being equal to one month.—New York World.

An Author's Initials.

Initials are sometimes the resort of the writer who is anxious to conceal his identity, and a glance through any one of the 700 volumes that comprise the catalogue of the British museum reading room will discover some strange instances. A theological book, entitled "Inquiry into the Meaning of Demons in the New Testament," is attributed to T. P. A. P. O. A. B. I. C. O. S. Its real author was a certain Arthur Sykes, and the initials reveal his position as "the precentor and prebendary of Alton Borealls in the church at Salisbury."—London Chronicle.
