THE LONGFELLOW-SWIFT CASE.

MOST OF THE DAY TAKEN UP WITH TRIAL.

Case Continued—Longfellow Placed Under a \$3,000 Bond for His Appearance.

This morning the case of state against Longfellow, charged with bigamy, was called, and most of the day was taken up with affidavits and counter affidavits in the case. The state was represented by Loftin, Varser & Dawson and G. V. Cowper. The defense was carried on by E. R. Wooten and H. E. Shaw. Solicitor Duffy was compelled to leave the city today to attend his child who is very sick in New Bern.

When the case was called Mr. Wooten, for the defense, immediately asked the state for a bill of particulars, alleging that the indictment failed to supply facts that the defendant was entitled to know. After some argument, the judge ordered such a bill which was furnished, setting forth that the marriage in Norfolk took place on the first day of May between the hours of 5 and 9 o'clock p. m. and the ceremony was performed by Rev. Wingate. The defendant, Longfellow, then filed an affidavit asking a continuance to the August term. The affidavit denied a marriage and alleged the absence of a number of material witnesses and the impossibility of getting them here so as to properly make a defense at the present time.

Judge Allen then asked the state whether it proposed to present a counter-affidavit before the question of continuance was passed upon. Mr. L. R. Varser, for the state, announced that such would be the case. The judge then suggested to counsel for defense the advisability of the defendant, Longfellow, making and swearing to a statement relative to his marriage to Mrs. Longfellow No. 1. His honor then announced that the case would go over until 2 o'clock p. m.

When court re-convened at 2 o'clock the defendant's statement was sworn to and filed. The statement set forth the fact that Longfellow had on a certain date been legally married to his first wife in the city of Baltimore and that subsequent to that event there had been no grounds for divorce.

The counter-affidavit, which was being drawn up by counsel for the state was not ready to be presented.

At 20 minutes to 4, Mr. Varser on part of the state began to read the counter-affidavit. This affidavit denies emphatically every allegation made in the affidavit of the defense. It sets out in detail the circumstance of the movements of both Longfellow and Miss Swift or Mrs. Longfellow number two, Mrs. Longfellow number one also filed an affidavit denying some of the statements contained in Longfellow's affidavit. The counter-affidavit read by Mr. Varser and sworn to by Miss Swift contained reference to Mr. E. R. Wooten and this at the conclusion of the reading called, for a statement from Mr. Wooten in which he stated that Miss Swift had admitted facts to him that were antagonistic to statements she made in her affidavit.

After the affidavits had been read Judge Allen took the matter under consideration and decided to grant a continuance. Mr. Cowper, for the state, asked

IN DEFENSE OF CASTRO.

His Exclusion From Venezuela Declared Grossly Irregular.

If the harrings of Castro continues long enough; if the countries that have possessions around the Caribbean Sea persist in barring him from their ports or driving him away as soon as he lands, the situation will cease to be amusing and become a cause of mildly indignant wonder. Moreover, in time some people may reach the point of asking if it is not rather small business for the United States to lead in the hunting down of one man, and a sick man at that, particularly at the obvious fears of what he may do if he enters his own country or even gets near it are not only distinctly ludicrous in themselves, but they can fairly enough be interpreted as providing a conclusive argument for letting Castro go where he pleases and do what he can.

Venezuela either has or has not at the present time a government able to administer its own affairs and to protect its own dignity. In the one case there would seem to be no reason why it needs help against a single enemy; in the other the help is not deserved. The fact is, or at least so it begins to look, that Gomez, whom Castro left in charge as a trusted friend and subordinate officer, is much less the president of Venezuela by the choice of its people than as the propped up agent of certain foreigners with dubious claims and concessions, who think they can use him in the enforcement of their demands. However, Castro may have attained and kept the presidency, it was and is under both Venezuelan and international law, and the methods by which he is excluded from it are grossly irregular as the worst which he has been charged with using.

Castro is undoubtedly a villain, according to foreign notions, but his position is technically perfect and the excuse for interfering with his travels are all of the poor kind that cannot be openly avowed. He has a real grievance, and he seems likely to win general sympathy as a persecuted man.—New York Times.

An Acre of Strawberries That Will Yield \$500.

Mr. Joshua Barnes, who lives between two and three miles east of Lumberton, has a little patch of strawberries that has been the source of a nice little income for the last two or three weeks and looks as though it will last some time yet. Mr. Barnes has only one acre in berries, but they are of an extra variety, and have been selling for a good price. Up until Wednesday he had sold about 75 crates from which he realized \$3 per crate, after deducting shipping expenses. Mr. Barnes thinks he will realize \$500 from this one acre of berries, which is making money some. Mr. J. F. Thomas, express agent, says that has received several letters in the last few days from commission men at Richmond, Va., asking him to send them some of Barnes' berries. There is nothing like having the variety.—Lumberton Robesonian.

STATE NEWS.

Happenings of Interest in North Carolina.

Lexington, May 18.—This morning William Bowers, a well-known farmer, was struck by an engine and killed while crossing the track with his team at the lake near here. A freight train had just passed and was closely followed by the engine. The team was killed and wagon torn to pieces.

Beaufort, N. C., May 20.—The graded schools won in a third election today by a majority of 43. A big celebration will be had tonight throughout town. The people feel they have created a new atmosphere favorable to progress and have bedecked their independence in voting in the interest of their children.

Winston-Salem, May 19.—Mr. C. Bodenhamer, a well-known resident of Kernersville, was today convicted in the Superior Court here of the larceny of \$2,250 from the Kernersville Banking and Trust Company, and sentenced by Judge Webb to five years in the State penitentiary. His attorneys, Hustings & Linville, put a number of witnesses on the stand who testified to irrational acts of Bodenhamer, but the jury found him guilty after being out a short while.

Statesville, N. C., May 20.—News reached Statesville this afternoon that heavy rains in the mountains have so swollen the Catawba river that one hundred and sixty feet of the Southern Railway in the vicinity Greenlee has been washed away. Traffic will be badly delayed.

Salisbury, May 20.—President W. H. Taft en-route to Charlotte, made his first appearance in North Carolina here early this morning, where he was greeted by more than 1,000 citizens in a down-pour of rain. His special train stopped only a few minutes, and the President appeared on the platform and bowed in recognition of the ovation.

THE TWENTIETH AT CHARLOTTE.

TAFT GREETED BY THOUSANDS OF PEOPLE.

Rain Interfered With the Day's Program—President Laughed at 'Possum Float.'

A terrific cloud burst broke up the review of grand parade today at 1:30 o'clock. Fortunately the parade had just about passed the grand stand.

The rain came down in sheets. It had been drizzling pretty much throughout the entire review but when the torrent came, the president and Governor Kitchin were hustled into a landau; and taken to the hotel.

The gigantic crowd in the grand stand and all about it in the street, melted like metal in a white heat. Those on the grand stand fled precipitately up the amphitheatre-like terraces of the court house in the rear. Many huddled into the speaker's stand, which, covered with thick cloths fairly well protected the occupants.

The president took the situation philosophically and expressed his kindly regrets that Charlotte's splendid preparations had been so sadly interfered with.

No untoward incident marked the grand review, save for a moment when during the passing of the industrial part of the parade, a tall design broke loose a wire running past the reviewing stand. There was a telephone on the stand, and the 4C's in response to a warning, turned off the current.

As the head of the parade reached the grand stand, the enormous crowd in the stand rose to its feet and cheered and cheered again, and waved a myriad of flags, and the sight was inexpressibly beautiful. The president stood and faced the shouting multitude for a few minutes while the crowd passed.

The president was seated in the centre of the grand stand. His military aide, Capt. Butt sat next to him.

Others of the Washington party were all about him.

As Mrs. Jackson came on the stand, the President rose to greet her, the band played "Dixie," and again the multitude shouted.

Others on the stand were Senators Overman, Johnston, Congressmen Morehead and Webb, ex-Congressmen Thos. Settle, Mayor Hawkins, Chief Justice Clark, Maj. Hemphill, Mr. D. A. Tompkins, Lieut. Gov. McLeod, of South Carolina; Governor and Mrs. Kitchin, Mr. C. W. Tillett and a hundred or more distinguished people.

The U. S. troops were greeted by a kindly expression of obeisance by Mr. Taft. He and Gov. Kitchin stood side by side and removed their hats to the occupants of the floats. The beauty of the floral parade seemed to impress the President's sense of the artistic, and he commented to the Governor of the exquisite designs.

The tree full of opossums, in the Mecklenburg 'possum hunters' float, drew a laugh from the President.

The president noted with keen eye the floral parade. One of the most beautiful was the D. A. R. (Charlotte chapter) float—a mass of white snowballs. The insignia of the float was on the door in national blue colors. On the back were the words, D. A. R. Blue and white ribbons flew from lamp posts. Mr. H. H. TAFT STANDS FOR MECKLENBURG DECLARATION.

Mr. Taft is speaking this afternoon in the auditorium at 4 o'clock. Chairman E. B. Moore, of the Central Committee, made this change in the hour and place this afternoon at 2 o'clock.

Interest in the president's visit to Charlotte has centered in the attitude he would take toward the Mecklenburg Declaration of Independence.

Mr. Taft takes the position that regardless of the exact language of the declarations made in May, 1775, a full year before the signing of the Declaration at Philadelphia, July 4, 1776, the fact remains that there was a declaration of independence on the part of the citizens of North Carolina.

"It is not so material as to the exact language used," said the president today.

"The measure of declaration for the principles of civil liberty and self-government is not so much the abuse or denunciation of former controlling power, as provisions made for future form of government. The impressive thing about the North Carolina proposition is the sensible way the people of the state after deciding to sever relations with Great Britain went about the matter of setting up a government of their own.

The president in his speech late this afternoon does not undertake to reconcile long existing differences. The important thing, after all, he pointed out, is the ability of Anglo-Saxons to rule and the impressive way they always have gone about the setting up of simple and just forms of government and the means of maintaining civil liberty.—Charlotte News, 20th.

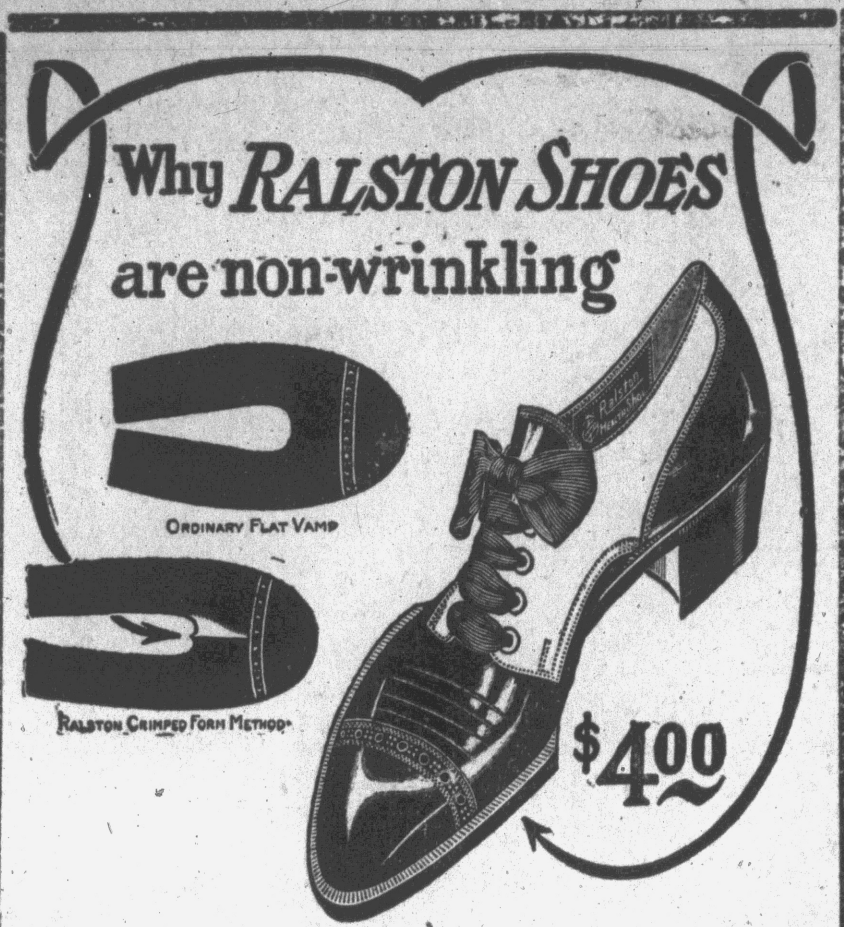
