DEMOCRATIC PRIMARIES.

To Select a Candidate for Mayor for Greenville.

The General Assembly of North Carolina at its recent session, having so amended the charter of the town of Greenville, as to provide for the election of the mayor of said town by a direct vote of the people, instead of by the board of aldermen elect, as heretofore provided, and the duty having devolved upon the undersigned as chairmen of the various ward executive committees of the town to provide some means for the nomination of a candidate for said office, to be voted for at the election to be held on the 7th day of June, 1909;

At a meeting of the various committeemen from the several wards held this day, it was ordered, that a voting primary be held at the court house by L. W. Lawrence and R. Hyman, on Tuesday, June 1st, 1909, from 2 p. m. to 8:30 p. m., at which any person who shall be legally entitled to vote at said election for mayor and alderman to be held on June 7th, 1909, shall be entitled to participate and vote for the person whom he favors for nomination for mayor.

It was also further ordered, that the usual primaries be held in the various wards of said town for nomination of aldermen, on Friday June 4th, 1909, at 8:30 p. m., at the following places:

"Old Harry," or whatever else you have a mind to call it, has broke loose in Georgia again. The Georgia Railroad in that State is completely tied up with a strike, all the engineers refusing to longer run their engines with negro firemen. Firing a locomotive is a job a negro seems well fitted for.

One good thing we hope to see come out of the automobile fever is an increased agitation for good roads. The things do run fine on a piece of good road, and the more there are will proportionately increase the advocates of better roads. May the tribe of motorists increase until the whole country is a net work of good roads.

The 4th of July is going to come on Sunday this year, but Greenville could do a good thing by starting a move right soon to have a big day with a big crowd here on either the 3rd or 5th. You business men take hold of this suggestion and push it, as you will be the ones to reap the greatest benefit from it. Here is a chance for you to do something.

Greenville throws her doors wide open to the delegates and visitors attending the State convention of The King's Daughters and extends them a most cordial welcome. These noble women are engaged in a noble work, and The Reflector hopes their stay in Greenville may be pleasant, and that their convention here may mark the greatest progress in the history of the State organization.

Chinamen and the Railroads.

Over in China they have a novel, but very effective way of collecting damages from railroads for the killing or injuring of a person. When a train runs over a citizen there is no appeal to the civil law, followed by a long delay through the courts. The Chinese know a more expeditious mode of collecting damages, though, to be sure, the compensation does not come from the party liable for the accident. Who pays is a secondary question with the Chinaman in such cases, the primary one being the getting in hand of the compensation at the earliest possible moment and in the most direct way. So the custom has been established that whenever a train runs over a Chinaman the friends of the deceased or badly injured individual gather at the place of accident in the time to intercept the next train, force it to stop and levy a contribution on all persons therein, including railway officials and employes and the passengers.

One would suppose that people who adopted such primitive means of obtaining what they considered their just dues would not have yet learned to "lie and to cheat" in the methods used; but the wily Celestial has learned a dodge which puts him clear abreast of his brother of the Western hemisphere in the matter of "doing the railroads." He has learned by observation that in the hurry of making up the contribution in order that the train may move on little attention is paid to the corpse by the roadside. The consequence is that after a train is held up, the body of a person who died a natural death is hastily shown as a victim of a preceding train, the price of the accident demanded and collected and the train allowed to move on.

We hear the cry from the honest American that such frauds should not be permitted. To whom we say, look over the court records and you will find many cases where railroad companies have suffered quite as badly at the hands of juries composed of enlightened and Christian men of the white man's country. The only difference is that one by force and without legal authority and the other under the guise of law.—Charlotte Observer.

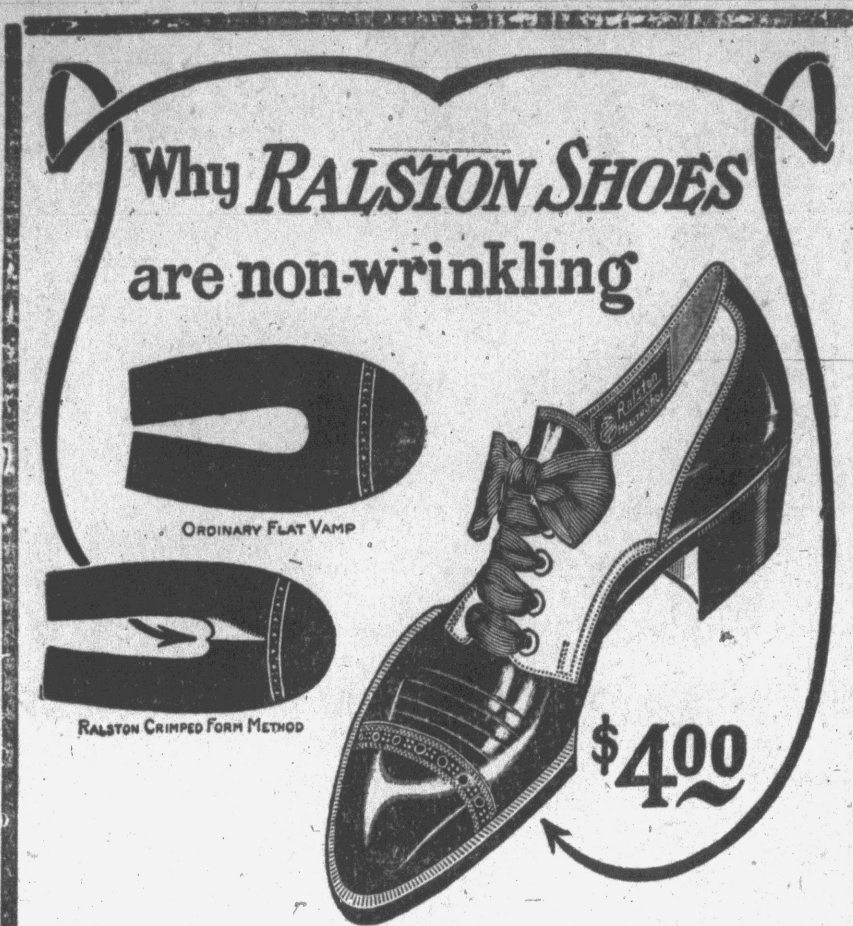
