EDITORS AT LAKE TOXAWAY.

One of the great pleasures of the North Carolina editors in connection with their meeting at Hendersonville last week, was a day spent at Lake Toxaway. The trip to this lovely spot in the Sapphire country was taken on Friday in the special car which the Southern Railway had provided for the use of the editorial party. Toxaway is 42 miles from Hendersonville and the trip there is through a beautiful valley with majestic mountains forming a background on either side. Brevard is about half way, and soon after passing that point the ascent begins, rising higher and higher as the valley narrows. In the last few miles before reaching Quebec, the nearest station to Toxaway, the train must climb an ascent of 800 feet, a part of the distance the track being walled in by rocky heights on one side, while on the other there is a gorge with a sparkling river hundreds of feet below. The scene here is beyond description.

Passing the summit of this immense climb up the mountain the grade becomes more even, winding around the hill sides until the view opens upon beautiful Toxaway Lake. It fills the visitor with wonder to find here at an altitude above 3,000 feet such a great body of water, seemingly to bring the mountains and sea together in one grand panorama. The lake has a shore line of about 30 miles. Nestled on a plateau on one side and almost hid in a stately grove is the palatial Toxaway Inn, among the finest hotels in the South. Nature did much toward making this place beautiful, and the artistic touch of man almost turned it into a paradise. The lake, which is artificial, was made by building a dam across a stream where it passed through a narrow gap between two mountains. Below the dam is a range of rocky cascades over which the water leaps as it speeds away, never stopping until it is lost in the Gulf of Mexico. In grandeur Toxaway is unsurpassed. The editors spent a day and night amid these lovely surroundings, and it was with a sigh of reluctance that many of them again boarded the special car early Saturday morning to turn back to the ordinary scenes of every day life.

From there the run was made to Asheville for a stop of five hours in the capital city of the mountains, when all set their faces homeward to resume their duties for another year until the next annual convention shall call them together again. We can only hope that the next gathering will be as delightful as the one at Hendersonville and the trip to Toxaway.

The cotton growers of the South have been given a sop in the tariff agitation by bagging getting on the free list.

It begins to look like they are about to come to an agreement and bring the tariff wrangle in congress to an end.

It was a long time ago when W. E. Breese tried to wreck that bank in Asheville, but he is not able to tell when he will get through being tried for it.

As the negro who shot Engineer Holt, escaped to Georgia where he was captured and brought back, has made confession of his crime, Durham may be able to convict one murderer.

Arthur L. Royster, who was chief clerk in the office of the superintendent of the Southern Railway, at Columbia, S. C., was drowned while out swimming and boating Sunday. His home was in Oxford, this State. This is the second death by drowning in the same family, a sister, Miss Ethel Royster, having lost her life some years ago attempting to cross a swollen stream.

Pardons.

The governor let two more of them out of the penitentiary yesterday. In a discussion on the conditional pardon, the Raleigh Times quotes from the State constitution to show that the conditional pardon is, in fact, the only sort that the governor can grant. Article 2, section 6 of the constitution provides that "the governor shall have power to grant reprieves, commutations and pardons, after conviction, for all offenses (except in cases of impeachment), upon such conditions as he may think proper, subject to such regulations as may be provided by law relative to the manner of applying for pardons." This is all the constitution says about pardons and it gives the governor free rein as to the number of pardons he may grant and the causes for which they may be granted. Governor Kitchin is young, yet. We hope he has not set in with a determination to empty the penitentiary altogether before he quits.—Charlotte Chronicle.

This has so far been a very discouraging season over a large part of our territory; but it is not worth while to get downhearted. There is still plenty of time to plant cowpeas and soy beans and sorghum and corn, and we can yet manage to make it a pretty good year. We shall have to work harder, of course, but we must take the bad seasons with the good ones. There has never yet been a complete failure of crops over any extensive area in the South, and we don't believe there is going to be "Seed time and harvest shall not fail," and we shall make a crop yet in spite of the rains and the grass.—Progressive Farmer.
