## GOOD EFFECTS OF PROHIBITION.

### Large Decrease in Cases Before the Mayor.

On the first of July prohibition under the state law had been in effect only six months. For some years previous to that time saloons had been closed in Greenville and the town had a dispensary. Even that change had brought about a noticeable difference in the sobriety of the people, and this has been all the more pronounced since the dispensary was closed and prohibition has prevailed.

To get at some statistics bearing upon the improved conditions, The Reflector called upon Mayor H. W. Whedbee to ascertain what his court dockets show before and since prohibition went into effect. The result of this investigation was marvelous and shows an improvement that is most gratifying. The period of examination covered the last six months that the dispensary was in operation, from July 1st to December 31st, 1908, compared with the first six months under prohibition, from January 1st to June 30th, 1909. The figures speak for themselves.

For the six months in 1908, July to December inclusive, the total amount of fines imposed by the mayor in cases before him was \$210.88, while for the six months in 1909, January to June inclusive, the amount was only \$23.15. For the same six months in 1908 the number of cases tried by the mayor that were for drunkenness or known to be caused solely by liquor was 90, while for the same six months in 1909, the number was only 20 including "blind tiger" cases.

The total number of cases of all kinds tried by the mayor during the six months of 1908 were 238, and the six months in 1909 they were only 74. Thus it will be seen that there has not only been a large falling off in whiskey cases, but the decrease in all manner of offenses against the law has been almost as great. It was also noticeable that of the cases the mayor has tried since prohibition went into effect a large majority of them were of such minor gravity that he did not impose fines exceeding a penny, deeming the payment of costs sufficient punishment for the offense.

## STATE NEWS.

### Happenings of Interest in North Carolina.

Durham, July 5.—Ex-Policeman L. D. O'Kelley met an awful death yesterday morning as the result of a mistaken drink, which proved to be carbolic acid. The unfortunate man had been ill during the night; and when he awoke in the morning he took what he thought was whiskey from the mantel board. In 40 minutes he was dead, despite every effort to save him.

Spencer, N. C., July 5.—Jim Miller, colored, of Asheville, died last night at a Salisbury hospital from gun-shot wounds inflicted by Detective Fitzgerald at Spencer in an encounter yesterday afternoon. The officer attempted to arrest Miller for beating a ride on a train. He was assaulted and badly beaten by the negro, who, it is said, was shot in self defense. Miller lived several hours after the shooting, and the officer surrendered and went to jail pending an investigation.

Winston-Salem, July 5.—At Advance, Davie county, this morning, the boiler of an engine operating a threshing machine, belonging to ex-Sheriff W. A. Bailey, exploded, killing outright A. A. Potts, aged 45, employed to operate the engine. A son, George Potts, aged 22, was also scalded and his injuries are regarded fatal. Failure to keep a sufficient amount of water in the boiler is given as the cause of the explosion.

Raleigh, July 5.—The management of the State Fair Association announces that Major N. H. McGeachy, of Fayetteville, has accepted the chief marshalship of the fair in October, and that the social side of this fair will be on an even more elaborate scale than any in the past.

### POSTOFFICE RECEIPTS.

#### Greenville Pressing on Towards Free Mail Delivery.

Postmaster R. C. Flanagan has furnished The Reflector some figures showing the growth of business of the Greenville postoffice. The receipts for the year ending March 31st, last, were \$8,867.78. When the annual receipts reach \$10,000, it means that Greenville will be entitled to free city delivery of mail. Taking the increase the second quarter of 1909—April, May and June—over the corresponding quarter of 1908 as a basis of growth, the next year will show Greenville in the class for free delivery. Here are the comparative figures of the three months:

No more general holiday until Thanksgiving.

Maybe when the senate and congress get tired of the game they will vote.

Read The Reflector news columns today and get some idea of what Greenville is doing. And remember it is "Our Greenville, yours if you come."

The press dispatches lately seem to have overlooked hunter T. Roosevelt in the African jungles. He has not had a top of column mention in some time.

The press dispatches contain a long list of 4th of July fatalities. When people go on risking their lives just for a little noise and so-called fun, they may expect to take the consequences.

The Durham Herald well suggests that the reform administration of Raleigh might have given attention to some of the real evils existing in that city before raising such a commotion over street preachers.

The negroes in the South who have had their mouths puckered for census jobs will likely be given a lemon to suck. Congressmen are urging President Taft to give instructions that only white enumerators shall be employed in districts south of the Mason and Dixon line. If the president looks at the situation right, as is very probable, he will heed the requests of the congressmen in this matter.

Those people who were opposed to prohibition and argued that no good would follow its going into effect, have only to read the article elsewhere in this paper giving statistics from the records of the mayor's court to be convinced of their error.

The figures showing the great falling off of cases tried since the advent of prohibition are strong argument of the good results arising from it. Conditions generally bear testimony equally as convincing. In the crowded days when the licensed sale of liquor was in vogue numbers of drunken people could be seen on the streets, but now an intoxicated person is a rare spectacle. People are more contented than formerly, they have more money to spend on their families, and all business is better than before we had prohibition.

### An Alaska Editor's Confession.

Our wife is gone. Gone to visit our mother-in-law. Gone back to the old home and the real cream. Back to the old oaken bucket and the mud pies of memory. We are not saying this to make other men envious whose wives are gone. But it is a sort of whistle to keep our courage up. For a long time the opportunity to hang out all night and make a monkey of

Now, with no restraint on our conduct, no tearful wife waiting to throw her hooks into our hair, no one to lie to, nobody to pacify with artful inventions, no person to care a whoop whether we go to the bughouse or not, now that the very hour and moment is pregnant with witchery and our horoscope is psychologically correct for a riotous period of debauchery, we get sleepy at 8:30 and mope off to bed like a mollusk.

We do not want to play poker or lick up suds or do any of the hundred disreputable things that a few days ago seemed so entrancing. If things had panned out as anticipated we would be an actor in the jollification drama instead of its playwright.—Ketchikan Daily Miner.

### A Suggestion That Should Receive Attention.

We understand that after the jury had rendered a verdict of acquittal in the case of Biggers for the murder of Hood, Saturday afternoon, the proposition to have Biggers committed to the State Hospital at Morganton, was discussed, but was found to be impracticable. In an interview in yesterday's Chronicle, Solicitor Heriot Clarkson outlined a plan that would quite effectively meet just such cases as that of Biggers. "Let the next session of the Legislature," he said, "pass a law giving our circuit court judges the power to send to the asylum for the criminal insane for a period of from two to 30 years, all prisoners charged with killing and who are declared by a jury 'not guilty' on the 'sinsanity plea.'" This suggestion is based on common sense. It is a matter that should be kept in mind and presented to the legislature. The outcome of the Charlotte trial shows the absolute necessity for it.—Charlotte Chronicle.

State-wide prohibition has been in effect in North Carolina for six months. Its enemies, if candid, must admit that their prophecies of wholesale violations of the law, and demoralization of business and morals, have proved groundless. We read the exchanges that come to this office from all over the State, and have searched them in vain for any evidence of injury to business resulting from the closing of the saloons and still-houses. A spirit of progress and optimism pervades the North Carolina papers, regardless of whether they be wet or dry. We read of new enterprises, new corporations, increase and enlargement.—Webster's Weekly.

Paraphrasing President Taft's pleasantry at Petersburg, we would say that, when a Democratic congressman from North Carolina favors a \$2 tariff on lumber for revenue, and a Republican congressman from Washington or Oregon favors a \$2 tariff on lumber for protection, they haven't any great amount of dispute between them.

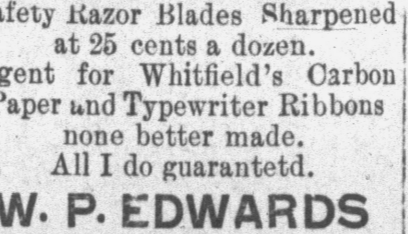
