## STATE NEWS.

### Happenings of Interest in North Carolina.

The State Firemen's Association will meet next year in New Bern.

The Capital Hose team of Raleigh, lowered the world's record and won first prize at the recent firemen's tournament in Asheville.

Some miscreant, whose deeds are certainly evil as he prefers darkness to light, stole nine of Snow Hill's street lamps Sunday night of last week.—Snow Hill Standard.

Roper, N. C., July 7.—Mr. B. S. Lucas, a prominent farmer and lumberman, accidentally shot himself Monday afternoon. He was riding in a buggy with a shot-gun between his knees. The muzzle pointed to his left arm when it fired cutting away most of the flesh near the body.

Winston-Salem, N. C., July 7. A mad dog scare has broken out in Davidson county. This morning a mule belonging to Columbus Beckel, of Enterprise, went mad. The animal was bitten two months ago when another mule owned by Beckel was bitten and killed. A dog owned by Allen Tesh showed symptoms of hydrophobia yesterday and it was tied. During the night it gnawed the rope in two and is now at large. Dogs in the neighborhood are being slaughtered without regard to pedigree.

Salisbury, N. C., July 7.—After spending a day in jail for killing Jim Miller, colored, at Spencer Sunday morning. Special officer R. G. Fitzgerald, of the Southern Railway force, was exonerated by a coroner's jury here yesterday afternoon. It was shown that the officer attempted to arrest the negro and that the latter beat him severely and struck him twice with a rock before he fired the fatal shot in self defense. Fitzgerald was liberated at once, and the negro buried at the expense of the county.

### Greenville vs. Tarboro.

On Friday, July 9, the Greenville boys will again go to Tarboro to cross bats with the local team there. Several additions to the Greenville team have materially strengthened it and the game Friday promises to be a battle royal, as the Greenville boys expect to play the game of their lives in order to defeat the heretofore victorious Tarboro team.

### Sheriff Tucker and Deputies Make a Haul.

## GREAT STORM DAMAGE.

### Floods in Several Western States Work Destruction.

Kansas City, Mo., July 8.—Disastrous floods are raging throughout this State, and also in Kansas, Illinois, Indiana, Nebraska and Colorado. Thirteen lives are reported lost in Missouri and hundreds of people are in danger from the floods. Hundreds of thousands of acres of wheat and corn have been ruined and starvation threatens to follow such destruction of crops. The State Industrial school for girls at Chillicothe is in peril and train service is demoralized by washouts and landslides.

### Suit to Annual Marriage.

Papers were fill today in the office of the clerk of court bringing suit to annual the marriage of J. S. Longfellow and Miss Bruce Swift, of this city. The marriage, which took place in Norfolk on May, first is sought to be annulled by the family of Miss Swift because of the fact that at the time it was entered into J. S. Longfellow had a wife living in Wilmington, N. C., from whom he was not legally separated. Longfellow is now under indictment and out on bond to appear at the August term of the Superior court of Lenoir county to answer to the charge of bigamy. The summons in the case for the annulment of the marriage was issued by the clerk of the court this afternoon.—Kinston Free Press, 7th.

### Oil Inspection Law is Held Up.

Asheville, N. C., July 6.—Judge Prichard, in the United States Circuit Court here today granted a temporary restraining order, enjoining the Board of Agriculture of North Carolina and Commission of Agriculture Graham from enforcing the "oil inspection law," passed by the last legislature until the hearing the of case on its merits before Judge Connor, in the United States district court. This means the matter will be fought out in the United States courts. The case was before the court on complaint of the Red C. Oil Manufacturing Company of Baltimore, with former Governor C. B. Aycock and Judge R. W. Winston appearing for the complainants.

If the oil inspectors lose their jobs there will be ten-filled with grief.

If reports coming from Washington are true the tariff bill is on the home stretch and it will soon be what it is going to be. The extra session of congress has been lengthy and has accomplished very little that is worth while.

Because some disgruntled fellow said he was going to blow up the New York cotton exchange with dynamite, a large squad of policemen have been guarding the building the last few days. In the meantime the operators inside went right on fleecing all who would bite.

Paper balloons used in celebrating the 4th of July in Raleigh, set fire to buildings and caused the destruction of \$80,000 worth of property. A church was among the buildings destroyed. That was an expensive celebration. We wonder if the city cannot be held responsible for the destruction of the property.

**A Hard Saying.**

The best thing that some men ever do for the world is to die, says the Lexington Dispatch. That is a hard thing to say about any human being, and yet with reference to the person at whom it is aimed, it is strictly true. The Dispatch is discussing, in the article from which we quote, the benefit of a funeral, now and then, to the progress of the community. In almost every town there is some old skinflint who owns property in the heart of the town that he will neither sell nor improve. His neighbors embellish their property and thus enhance the beauty and attractiveness of the town, but his stands in weeds and trash, unkempt and offensive, a blot on the neighborhood, a slander on the community, a challenge to decency and a block to all progress. An old pike like this is always opposed to schools, to good roads and smooth streets, to light and water and every element of progress to our civic life. He is generally a kicker to all moral progress, lining up with the saloon because it helps to pay the taxes that are wrenched from his unwilling hands. Of course, as the Dispatch says, any community is better off with such a man dead than alive. One trouble about these old soldiers is that they never die. They outlive everybody else, and they appear to find their highest joy in standing right across the path of progress. They are experts at standing. They are opposed to motion. When one of them does finally go the way of all the earth, those who hope to gather up a few of the fragments lift up their voices in lamentation, but few tears are shed by the public at large; and thus unhonored they go down to their graves, and then waste places they delighted to waste, are built up and blossom like the rose. It is a pity that they live so long, but a blessing that they

do not live forever. As we said at the beginning, this is a hard thing to say about the body but we are bound to confess that the Dispatch spoke the solemn truth. The best thing that some men ever do for the world is to die.—Charity and Children.

**Senator Overman's Victory.**

Senator Overman is to be congratulated on his victory in behalf of the cotton planters. In securing the adoption of his amendment to the tariff bill providing for a drawback on cotton ties shipped abroad he has saved many a dollar to the South. This amounts almost to putting on the free list such ties as are put upon cotton which is exported. There will necessarily be some expense attached and a lot of red tape proceedings to be gone through in getting back the money, but this is better than to have no compensation for such of the taxed ties as are used in exporting the cotton. Granting this drawback is an admission by the senate that the duty as imposed under the present law is unjust and, though wrung from the Republicans of that body with difficulty, still it puts them on record as making the admission. This amendment grants no relief to those whose taxed cotton is consumed by factories in this country, only that which is shipped abroad being virtually exempted by the return of the tax. This latter, however, is two-thirds of the total crop. Another and greater advantage may follow from Mr. Overman's victory. If it is seen that this amendment is likely to be incorporated in the bill on its final passage those who now oppose putting cotton ties on the free list may withdraw their objection and allow all duty to be taken off rather than have this somewhat complicated feature incorporated in the act.—Charlotte Observer.

## METAL MONEY.

The Greeks Started Coining Long Before the Christian Era.

The invention of coinage is due to the Greeks, most probably to the bankers of Halicarnassos and adjacent Asia Minor Greek colonies, who toward the end of the eighth century B. C. began stamping the small gold and silver ingots which passed through their hands as currency with a mark of some sort intended to guarantee the weight and purity of the metal. Such ingots very soon assumed a round and more regular shape, which we find already in the older silver coins from Aegina, nearly contemporary with the Asia Minor "beans."

Curious to say, none of the surrounding peoples with whom the Asiatic and European Greeks were in constant communication, political or commercial, took up the wonderful invention which at present seems to us of such obvious necessity that we scarcely realize how the civilized world of old can ever have got on without it. As a matter of fact, however, neither the Phoenicians, with their practical commercial sense, nor the Lydians nor the Persians, who claimed the supremacy over the very cities where the new currency was initiated, nor, of course, the Egyptians, ever had coinage till the conquests of Alexander disseminated the Greek civilization all through the eastern world.

The Romans came to know of it through the Greek cities in Sicily and Magna Graecia and began striking silver coins toward the beginning of the third century B. C. In the meantime with the Greeks die sinking, like everything else, had fallen within the domain of art, and their coins, above all those struck during the fifth and fourth centuries B. C. by the Dorians of Sicily at Syracuse and Agrigento, have never been equaled and remain forever a standard of beauty for the artist and a model of perfection for the die sinker.—London Saturday Review.
