STATE NEWS.

Happenings of Interest in North Carolina.

Kinston, July 9.—The board of aldermen have called an election on a bond issue of \$50,000 for extending the water, sewer and electrical lines of the city.

Passenger train No. 7 from Lake Toxaway to Asheville, was wrecked near Etowah station about ten miles below Hendersonville at 4:45 o'clock Saturday afternoon, and while none of the passengers were killed eleven were more or less seriously hurt.—Asheville Citizen.

A fowl with four legs and feet is a freak, although they are sometimes seen. Mr. R. W. Brewer, of Aurelian Springs, Halifax county, has a turkey with four well developed legs and feet, and makes use of all of them in the act of locomotion. The fowl is two months old and with the exception of the excess of feet and legs is not unlike the other members of the brood and is perfectly well and hearty.—Henderson Gold Leaf.

Lincolnton, July 9.—Mr. J. A. Lingerfelt, of this place, met with a tragic death yesterday in the western part of county. He was going with a threshing machine, of which he was part owner, when at an unlevel place in the road the machine showed signs of turning over and he sought to steady it by bracing himself against it, but he was unable to do so and the machine turned over on him inflicting injuries from which he died a few hours later.

Charlotte, N. C., July 10.—Chief Christenburg was summoned hurriedly to Second street yesterday afternoon on a report that a man had been cut to pieces and only his legs were left. The chief went to the scene and picked up a leg. There was no blood nor signs of an accident, but the gruesome find annoyed him. No one could explain the extra leg. An investigation was instituted and it was learned that recently at one of the city hospitals a leg had been amputated from a patient. The head nurse had turned the superfluous limb over to a rusty negro who was directed to bury it. The funeral service were duly held and the leg placed under soil, but the hole made was not deep enough and a vagabond dog had unearthed the thing and dragged it to the place above named.

Anti-Prohibition Wins.

Bristol, Va., July 8.—By the narrow majority of 38 out of a total of 844 votes polled, the anti-prohibitionists won the local option election held here today, following one of the most hotly contested campaigns of its kind known in the South. There were 401 votes against and 439 in favor of the granting license.

Pandemonium reigns here to night in that part of Bristol which lies in Tennessee as well as in the half of which city has declared for the sale of liquor after a dryness of two years. Preparations are already being made for opening up of saloons and wholesale houses for supplying not only the immediate territory but the half dozen nearby States which are in the prohibition column.

MR. J. T. ABRAMS DEAD.

A Good Man Passes Away After a Brief Illness.

Mr. J. T. Abrams died at the hospital in Kinston Saturday night at 12:30 after a brief illness of just one week. He was taken the previous Sunday with peritonitis and his condition getting worse until Tuesday, when he was taken to the hospital to undergo an operation, but was too weak to stand it. He gradually grew weaker until the end came.

Mr. Abrams was 57 years old and leaves a widow, and six children, one brother and five sisters to mourn their loss. His children are, Mesdames J. E. Forbes, W. T. Phelps, A. W. Barber, of Greenville; H. W. Renfrew, of Rocky Mount; J. F. Smith, of Goldsboro; and Miss Donie Abrams, of Greenville.

Mr. Abrams was a member of the Free Will Baptist church, of 22 years standing, and a consistent Christian gentleman. Elder W. H. Laughinghouse conducted the funeral services at the residence in West Greenville at 3:30 o'clock Sunday afternoon, after which the remains were taken in charge by Covenant Lodge I. O. O. F., of which he was a member, and taken to the Barber burial grounds, where he was entered by the lodge with the burial ceremony of the order. The pall bearers were: Messrs. A. B. Ellington, T. R. Moore, W. J. Turnage, James Brown, J. R. Corey and C. E. Moore.

Of Interest to Automobile Owners.

It may be of interest to automobile owners in this State—to both those who have paid the State tax due the first day of this month and also to those who have not yet done it—that the Supreme Court of Ohio has declared that a license tax in addition to the one imposed by the State is unconstitutional on the ground that it constitutes a double tax. In some sections of this State there is a double tax on these machine. We expect to see the question of this tax taken to the courts to test its legality. But automobiles are not the only species of property in the State which is subjected to a double tax, as any of the merchants and other business men can eloquently testify. All mortgaged property is in effect taxed twice (the property itself and the mortgage) and some businesses are taxed three or four times over.—Charlotte Observer.

THE AUTOMOBILE TAX.

Possibility of Suit to test its Validity—Mr. Schenck Becomes Sarcastic.

A correspondent writing from Raleigh under date of the 2nd said that up to that time 274 licenses had been issued for automobiles at \$5 each, making a total of \$1,370. The number of machines in the State is problematical.

In applying for a license Mr. John F. Schenck, of Lawndale, Cleveland county, informed the Secretary of State that suit would be brought to test the constitutionality of the act on the ground that one county, New Hanover, is exempted from its provisions (New Hanover has a special law applying to automobiles.) Mr. Schenck further expressed regret at having made the mistake of buying an auto—instead of a traction engine that would have been so much easier on the roads. And in the event the tax on automobiles stood the test of a suit he said he would probably have his machine exchanged for a traction engine, reaper, mower or some other motor vehicle of the "hornysons of toil" variety, on which politicians will scarcely ever dare to levy a special tax. He regretted possessing a machine in the class of "autos, liquor and lawyers, evidently regarded as such nuisances as to merit special taxes where permitted at all.—Statesville Landmark.

CARE OF THE CEMETERY.

The people of a town are often more or less judged by the care they show for the burial place of their dead. When such places are objects of special care and attention it betokens a tender hearted, devoted people. In this respect Greenville does not make as good an impression as it might do. Cherry Hill Cemetery does not show such care and attention as is creditable to the town, and the purpose of this mention of it is in the hope of awakening a spirit of improvement and to make some suggestions as to how this may be brought about.

Naturally the cemetery here is a pretty place, and with proper care could be made a spot of real beauty. The chief detriment is that no method has been used in its care. The only funds that have been available for use in the cemetery has been the proceeds arising from the sale of lots. This the aldermen have kept separate from other funds and used in keeping up fences, laying out and maintaining walks and cleaning the unsold lots. Even this work was done only at intervals when absolutely necessary, and there has been very little system about it. Whenever a lot was sold the care of that particular lot then devolved upon the owner, and the aldermanic cemetery committee had no further interest in it. There has never been any concerted action among the lot owners as to cleaning or beautifying the lots, each individual doing this whenever it suited his convenience or pleasure. Hence it is an exception when the cemetery as a whole presents anything approaching a creditable appearance, but the rule is that when some of the lots are clean others are rank with weeds, the unsightly ones detracting from the others.

But now the bulk of the lots have been sold and soon there will be no more funds from this source to do even the little work heretofore done. Then it is evident that some other plan must be devised to care for the cemetery, and it is with this in view that The Reflector has a suggestion to offer.

The aldermen should employ a regular keeper of the cemetery, paying him a stipulated monthly salary, who should do all the work there. It should be his duty not only to care for the walks and few unsold lots, but also for the sold lots, and the individual lot owners should be assessed a small annual tax to help pay the salary of the keeper. The keeper should also dig the graves and for each of these there should be a stipulated fee to apply as a part of his salary. In this way the cemetery would be practically self-sustaining, or so nearly so that there would be

little additional to pay. The aldermen could readily enact cemetery ordinances carrying out this plan if it is deemed best, and under this the entire cemetery could be kept in good conditions all the time.

Reclamation and Conversion.

When the reclamation of the swamp lands of North Carolina shall have been accomplished with practical application of the approved methods in today's engineering it will mean to the people of the State the arrest of waste areas that will reach the approximate figure of three million acres in the Eastern part of the State. Ohio capitalists have recently bought fifty thousand acres of Lake Mattamuskeet, at an average price of two dollars per acre, conditioned on the formation of a corporation of themselves and domestic hold-holders for the drainage of a vast district adjoining. The initial step means direct added funds in the safe hands of the State Board of Education and the appreciable improvement of educational conditions within North Carolina. The swamp country, as it is, lies idle with a dormancy of possibilities that one may scarce know, only in so far as actual results have been proven in a series of lesser reclamations elsewhere. The region is one that is a wealth mint by reason of natural fertility. The close lying lands have already been converted into a veritable truckers paradise and the establishment of permanent new farming acreage where thousands of plows shall furrow out millions of added wealth to a thrifty and painstaking people, and a virgin tract shall call for the occupancy of thousands of new occupants, means still greater strides in placing North Carolina further along in the lists of commonwealth betterment. A people long inured to boats and dug-outs for transportation of themselves and their products will soon know the whistling of the trolley wheel and the click of iron wheels over roadbeds of steam railways, learn the agitation for good roads and become nasal adepts at trailing the automobile.—Piedmont Industries.
