CHAMBER OF COMMERCE.

Has Interesting Meeting and Discusses Important Meeting.

There was a large attendance of business men of the town at the meeting of the Chamber of Commerce in the court house, Tuesday night, and a number of interesting matters were up for consideration.

President Wooten in calling the meeting to order, referred to the letter of Congressman Small in regard to a meeting to be held in Washington, Thursday night in the interest of waterways. After discussion, a motion was adopted that the president select a committee of six or more to attend the meeting in Washington.

The committee appointed at last meeting to confer with the chairman of the executive committee of the training school trustees in regard to the public celebration, made its report. Gov. Jarvis was present and told what had been done at the training school, and paid high compliment to the Chamber of Commerce for the part the organization took in securing the establishment of the school. He said the public celebration to be held Nov. 12th will be the greatest day Greenville has ever known, and asked the co-operation of the chamber in making the town on that day surpass any former effort at entertainment. On motion authority was given the president to appoint a committee to co-operate with the executive committee and faculty of the school in arranging for the celebration.

Dr. Charles Laughinghouse spoke of the need of improving the river road eastward from Greenville, and it was discussed by several others, resulting in a motion to arrange a meeting of people living along the road with the Chamber of Commerce to devise plans to improve the road.

Prof. H. B. Smith suggested the advisability of the chamber having an advertising committee, and a motion was made that the president appoint such committee.

The names of all committees provided for at this meeting will be announced later.

The term of three directors—Dr. E. A. Moye, H. A. White and E. G. Flanagan having expired they were re-elected.

His elegant country home has around it an air of prosperity, while within there is found all that goes to make life pleasant and happy, and judging from the broad acres of cotton etc., and one could tell by riding along the road that the spirit of progressiveness and advancement along with agricultural lines, was a notable characteristic of the man. May he live to see many Harvest Moons yet, and the full fruition of his heart's fondest desire in agriculture, his life's work.

MAYOR OF NEWPORT SHOT.

Folly Murdered While Entering His Home.

Mayor A. Z. Newberry, of Newport, was shot from ambush and instantly killed Saturday night at 10 o'clock, just as he started to enter his home after doing some shopping down the street. A heavy charge of buck shot lodged in his left breast, producing instant death.

The crime aroused great indignation in the community and a message was dispatched to Tarboro to secure blood hounds to track down the murderer. The dogs were taken and put on trail Sunday and followed tracks to the home of Jack Sanders, with whom the mayor recently had trouble. Sanders threatened the life of Newberry, some time ago, for his activity in prosecuting the illicit manufacture and sale of whiskey in and around Newport. He also had it in for Newberry because of Newberry's interference when Sanders undertook to assault a United States deputy marshal.

It is said that strong corroborative evidence of the dogs trailing Sanders was found. Fifteen shells heavily loaded with buck shot similar to the ones found in the body of Newberry were found at Sanders' home, and the wad corresponded to the wad in the charge that killed the mayor. Other circumstances, it is said, make a strong case against Sanders and his brother, who is also implicated in the shooting. Both were placed under arrest and carried to Beaufort and lodged in jail.—Kinston Free Press.

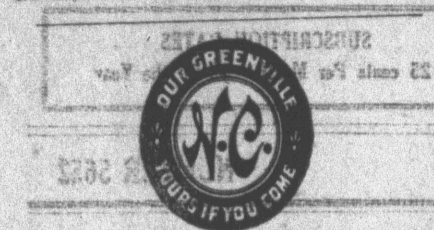

PERSONAL WORD

The attention of The Reflector has been called to a circular, as large and closely printed as a page of a newspaper, that is being sent out by Capt. J. R. Hutchings purporting to be an open letter to Mr. O. L. Joyner, president of the Farmers Consolidated Tobacco Company. The only reason we have for noticing this circular is that Capt. Hutchings brings The Reflector in it, and makes assertions about this paper and its editor that are wilfully malicious and absolute falsehoods from beginning to end, therefore will not be permitted to pass unanswerred.

The circular begins with an introduction reading as follows:
Greenville, N. C.

"Dear Sir:—I am submitting an article for your consideration, a letter to O. L. Joyner.

I wish to say I desired to make this publication in my own town paper, the Greenville Reflector, but the editor gave me to understand that he did not desire to publish any article of a nature of an attack on Joyner, on account of personal reasons. I have also learned that the editor has been made a present of \$50 worth of stock of the Consolidated Tobacco Company and of course he could not consistently grant my request. Very truly,
J. R. Hutchings."

As to The Reflector being asked to print this "open letter" we will say that on Wednesday, 6th inst., as the editor was returning from dinner to the office, he was approached by Mr. W. H. Allen, who said, "Have you seen the piece written by Capt. Hutchings? He has written a letter giving Olthas Joyner—and is going to take it to you to print," with some other remark about there being money in it to print it. He was told that we knew nothing about it, and not caring to discuss the matter with him, we left him and went on to the office, not anticipating at the time that he was the forerunner to feel the way for what was to follow.

The same afternoon a little before 5 o'clock Capt. Hutchings came to The Reflector office and asked for a private conference with the editor. This was given him, and he said he had written an open letter to Mr. Joyner and asked if he could get it printed in The Reflector. We asked to be shown the letter, when he said it was in his desk at the warehouse. We told him it would be impossible to say whether the letter would be printed in The Reflector until we had read it to see what it contained. He then said two other papers (naming them) were going to print it for him,

but he preferred it to appear first in The Reflector. We told him other papers could do as they pleased, but no answer would be made to printing anything in The Reflector until we had first read it.

He then asked if we would meet him at the warehouse that night to read it, as he wanted it published the next day, and was informed that other engagements for the night would prevent this, but we would wait an hour then at the office for him to bring the letter down. He began discussing his letter, going off in a round of abuse of Joyner, when we told him if his "open letter" was along the line he was talking, we would have to tell him The Reflector was not open to the publication of libelous matter or personal attacks on the character of anyone. To this he replied "awfully," "Well, you know we are both Baptists, and I think you ought to give me a hearing through your paper." Suppressing a feeling of indignation at such an unworthy suggestion, our reply to this was that church relations had no place in matters of this kind, and no answer would be given as to the publication of his letter until after reading and passing upon its merits.

With this he left, as we thought to go after the letter, but never came back and nothing more was heard of it until we saw the printed circular.

As to his assertion "that the editor had been made a present of \$50 worth of stock in the Consolidated Tobacco Company," we will simply state this is a lie. The editor of The Reflector owns some stock in the Farmers Consolidated Tobacco Company which he paid for dollar for dollar. We bought this stock because we believed it a good investment, and the result has been so satisfactory that our only regret along that line is that we did not have more of it. It can be said also that no member of this company has asked me to buy the stock, but the sale was made at our own personal solicitation. We had faith in the company, we wanted stock in it, we bought the stock and paid for it, and any intimation to the contrary is a malicious falsehood.

In the "open letter" to Mr. Joyner is this further reference: "Upon frequently seeing editorials in the Greenville Reflector, appearing as from that paper, in regard to the Farmers Consolidated Tobacco Company," and being informed by the editor

that these articles are your (Mr. Joyner's) product, and paid for as advertisements." The editor has given Capt. Hutchings no such information, and this assertion of his is another absolute falsehood. The editor of The Reflector writes his own editorials, on just such subjects as he pleases without being beholden to any man, and there has never been a penny paid for any editorial in this paper. But of the local and general advertising departments of the paper Mr. Joyner has been a liberal patron. He believes in printer's ink, writes his own advertisements whenever he chooses to do so, and in the last fifteen years has paid The Reflector more money for advertising than any other patron.

As to what Capt. Hutchings says about Mr. Joyner, we suppose that gentleman is able to take care of himself, and we are only answering the malicious misrepresentations of the editor because he could not be used as a tool.

HOW A HORSE GALLOPS.

The Natural Way and the Conventional Pose in Art.

How does a horse gallop? Owing to the rapidity of action it cannot be seen by the human eye. However, just as the individual spokes of a rapidly revolving wheel can be made visible by a flash of lightning, so the action of a galloping horse can be and has been analyzed by instantaneous photography.

The statuette of Sysonby, the thoroughbred, has been made from photographs taken at the instant when all four legs are off the ground. The back is arched, the hind feet are directed forward, the fore feet backward, so that all are tucked under the animal's body.

When the limbs again touch the ground the first to do so is one of the hind feet, which is thrust far forward so as to form an acute angle with the line of the body and thus serve the purpose of a spring in breaking the force of the impact of the hoof when the horse is going at top speed.

In the conventional mode of representing a galloping horse all four legs are off the ground at once, but the front pair are extended backward in such a way that the undersurfaces of their hoofs are directed skyward, the body being at the same time brought near the ground. This conventional pose appears to have been derived from a dog running, when the front and hind pairs of legs are respectively extended forward and backward, with the soles of the hind feet turned upward.

This pose, it is thought, was adopted to represent the gallop of the horse by the goldsmiths of Mycenaee between 800 and 1000 B. C., whence it was transmitted by way of Persia and Siberia to China and Japan, to return in the eighteenth century as the result of commercial relations to western Europe.—Chicago Tribune.

The Word Grottesque.

"Grottesque" is derived curiously from the word "grotto." Ancient Roman families often had artificial grottoes in their grounds, and these were decorated with quaint paintings and whimsical figures, such as we should term "grotesque." Commonly these were fanciful and incongruous combinations of parts of plants or animals. Conspicuous examples of the grotesque in classical art were the centaur, a horse's body joined to a man's head and shoulders; the griffin, a monster combining a lion and an eagle, and Scylla, a sea monster with a woman's head and a fish's tail, a peril, as ancient poets sang, to mariners sailing between Sicily and Italy. In mediaeval times her place in grotesque art was taken by the mermaid, a more poetical fancy. The middle ages used the grotesque chiefly in ecclesiastical gargoyles, the best of which are the "devils" of Notre Dame referred to in Victor Hugo's "Quasimodo." The idea of the devil as a man with horns, hoofs and a tail is probably drawn from grotesque art.

Lucky He Had a Lone Trump.

Joe Cowell in his "Recollections of the Stage" tells a story characteristic of the days now passed away. While on a Mississippi river steamer he was sitting near a table watching a game of euchre. Another onlooker was making it his business to spy out the trumps in one player's hand and telegraph the information to his opponent by laying the same number of fingers carelessly on the table. Of course one lost and the other gained steadily for a considerable time until at a deal the loser received one trump. The fact was duly signaled by the forefinger laid on the table, which the losing gentleman very coolly but adroitly cut off with a heavy knife.

"Hello, stranger! What are you about? You have cut off one of my fingers!" cried the dismembered man.

"I know it," said the amputator coolly, "and if I'd had more trumps you'd have lost more fingers."
