His cotton gin, grist mill, saw mill, planing mill and shingle mill were all destroyed by fire. We learn that Mr. Coley's loss is about one-half covered by insurance.—Wilson Times.

Wilmington, Dec. 28—Rose Hill, a small town between Wilmington and Goldsboro, was visited by a disastrous conflagration this morning. Private advices received at this city stated that the fire raged five hours before it was suppressed. The Bank of Rose Hill was destroyed, as were 13 business houses. Papers, currency, and documents in the bank were saved. The building was insured. Aggregate loss of other structures, beyond the amount of insurance carried, is \$40,000.

**Repeal of Lien Law.**

The repeal of the lien law which has been operative in South Carolina, goes into effect on January 1. The effect of this repeal on the farming interests of that State, will be watched with interest. With this law repealed, the farmer cannot give a lien or mortgage on his crop which does not exist. The merchant cannot take liens on crops to be planted or on growing crops. Until the crops are gathered and in actual possession of the farmer, he cannot give a mortgage on them. The Spartanburg Journal thinks the State will prosper under the new conditions. It thinks it will have the effect of making the people who have depended on liens more anxious to work the year round. Heretofore, many of that class would give about eight months to making and gathering their crops and they would do little the other four months. Now they will see the necessity of putting in all their time. During January and February, when the weather is not suitable for farm work, they will hire to neighbors in order that they may have a little money to keep them going. On the whole, the Journal thinks the repeal of the lien law will make better tenants and laborers and it will bring the landlords up to building better houses for tenants. There will be a general improvement on farms, and after the first year no one will want the lien law restored.—Charlotte Chronicle.

**Reform in Christmas Giving Needed.**
