HEADING OFF BLINDNESS.

State Board Seeking to Prevent Infection at Birth.

"A special committee of the New York Association for the blind which was appointed to investigate the causes of preventable blindness and to cooperate with physicians in seeking measures of prevention, has reported that the State Board of Health has taken steps to insure against the widespread cause of blindness through infection at birth.

"The committee has found that about one-half of all blindness is due to preventable causes, and that about one-third of the cases of blindness in children is caused by ophthalmia neonatorum, a preventable infectious disease occurring at birth. A drop of a 1 per cent solution of silver nitrate dropped into the eyes of a child at birth is a sufficient preventive of this infection. The use of this antiseptic has been recommended by the American Medical Association, and the committee of the New York Association for the blind has united with the State Commissioner of Health in enforcing the general use of this precaution. The State Commissioner of Health will endeavor to provide this solution through local health officers to any physician and midwife applying for it.

"Birth certificates issued by the State department now bear the query: 'What preventive for ophthalmia neonatorum did you use?' If none, state the reason therefor." It has been enacted that these notifications of birth be returned in thirty six hours instead of ten days, as heretofore. It is believed that if a physician or midwife has failed to use such a preventive the reminder on the birth certificate will in most instances prove effective."

The above is a clipping taken from a recent issue of the New York Sun. It tells its own story. It shows that the authorities of at least one State are alive to the appalling condition which confronts the commonwealth. Nor is New York the only State in which active efforts are being put forth to "head off" one of the most distressing calamities which can befall a human being. And to realize that much of this distress can be prevented is a loud call to every citizen in the nation.

There are enrolled the present session in the North Carolina State school for the blind and deaf 268 blind children (besides 100 deaf children). At least one fourth of these need never have been blind, and would not have been, if proper preventive remedies had been employed within twenty four hours after the birth of the child. Gentle reader, do you realize that there are from sixty-five to ninety children in this school doomed to a life of darkness and a handicap in the race for bread-winning all their days—some of them to lead the lives of helpless dependents, if not abject paupers? And there are still at least 128 more blind children in the State who have not been enrolled in our school at all. This will make the figures the more appalling—one hundred and thirty blind children in North Carolina whose sight might have been preserved with a little care exercised, and almost without expense!

Is it not high time that the legal and medical authorities of our State were taking steps to prevent this condition of affairs?

All of the addresses were excellent. In his address President Flanagan gave a brief record of the Baraca class for the last quarter of the past year. The collections for quarter were \$38.05, an average of \$2.94 each Sunday. The class supports one orphan at the orphanage. The attendance was 563, averaging 43 each Sunday. W. P. Edwards, C. B. Whichard and Alexander Harper had not missed a Sunday. Number of visitors 38.

After the exercises in the church all went to the city hall where the banquet was served in charge of the ladies of the church. The Baracas have cause for congratulation upon the success of the celebration.

Farmville Gets Greenville Policeman

Policeman G. A. Clark, who has been assistant on the force here for some years, has given the aldermen notice of his resignation, to take effect Feb. 1st, at which time he will go to Farmville to take the position as chief of police of that town. He makes a good officer.

In the meantime will not the parents of all infants see to it that immediately after birth the eyes shall be thoroughly washed and then have one drop of the solution of no greater strength than one per cent of silver nitrate put in each eye not later than twenty-four hours after birth? This is a precaution and preventive which if properly applied, is harmless and may prevent your child from becoming blind.

And let every physician and midwife in North Carolina supply himself or herself with this preparation and attend to its proper administration in every case. Care should be taken that the solution shall not be stronger than one per cent.

There is yet one other phase of this situation. It costs at least \$200 annually to properly teach a blind child and not less than \$20 to clothe him. For ninety blind children this aggregates \$19,800 annually; and for 130 children \$28,600 annually. What a saving to the State this would be! And in the course of the ten years covered by our curriculum this would amount to a saving to the State of \$286,000. Is this worth considering?

THE HOME B. & L. ASSOCIATION

Makes a Creditable Showing of Its Business.

The attention of our readers is called to the annual statement of the Home Building and Loan Association, published elsewhere in this paper, showing the condition of the association for the year ending Dec. 31st. This statement shows that the association, though not yet four years old, has 1878 shares in force, and the surplus to the credit of the shareholders is \$4,319.37. It has loans to shareholders amounting to \$57,143.66 which shows the great benefit it is in helping people to build or buy their homes.

An institution that can make such a showing as this is entitled to the support of every person in the community. It pays to have shares in it, to say nothing of the good the association is to the community.

The association is well officered and its affairs are managed economically, as the statement shows. The board of directors also give the association their personal attention, and every transaction comes under their observation. Greenville has no institution that is doing more for the general good and progress of the town.

A SCHOOL PROBLEM.

(Contributed)

If an uneducated man earns \$1.50 a day for 300 days in a year, he does very well. If he keeps it up for forty years, he earns \$1,500x300x40, or \$18,000 in a lifetime. An educated man is not generally paid by the day, but by the month and the year.

If you will strike an average of the earnings of educated men, beginning with the governor, whose salary is \$4,000 per year, and run the scale till you come to the lower walks of life, you will find that \$750 per year is a low average for the annual earnings of educated labor. For forty years you have \$30,000 as the earnings of an educated man. Subtract \$18,000 from \$30,000 and the difference \$12,000 must represent the average value of a boy's time in school.

If your town maintains a public school of 160 days to the year for a term of 10 years, or 1,600 days, every day of school is worth, to the average boy, \$7.50.

Brother, how about keeping your boy out of school, or letting him remain out of school, for all sorts of frivolous or useless reasons? How about if when he is so mean his teacher has to send him home occasionally to bring him to his senses? And how about letting him drop out when he reaches the sixth or seventh grade, when he ought by every reason of good judgment, or even of dollars and cents, to remain in school till he graduates? Don't you know that this is an age when the victory is going to educated energy and intelligent effort?

CAN EDUCATE WITHOUT WHISKEY

We notice some papers, especially those published in towns where dispensaries were operated before prohibition went into effect, are saying that the terms of the public schools of their counties will have to be shortened because of the loss of revenue that heretofore came from the dispensaries. Whether these papers are saying this merely to state a condition, or to create sentiment favorable to a return to the licensed sale of liquor, we are not prepared to say. But The Reflector has no sympathy with such statements. This paper feels as much interest in public education as any other can claim, and would do as much to advance it, but if the schools cannot be run longer than four months in the year without help from whiskey selling, then it is better that the schools should run only four months. The shorter school term might make it a little harder or take a little longer to get an education, but this would be better if along with it comes a higher type of manhood and morality. Away with the suggestion that our children cannot be educated without the help of whiskey selling to debauch them! But there is no need for alarm along this line. North Carolina has declared for prohibition and will stand by this declaration. If there is a temporary shortening of school terms the people will find a way to remedy this without returning to the evils of licensed whiskey selling.

Of course you can never tell what a year has in store, but if this new year does not bring large things Greenville's way here is one who will be surprised at the outcome. Proper activity will make the town go forward as never before, and we believe that activity will be shown.

Announcement is made that Maj. J. C. Hemphill, who for twenty years has edited the Charleston News and Courier, has resigned to become editor of the Richmond Times-Dispatch.

BURNED PAPER MONEY.

Source of Great Profit to the Government and Banks.

At the redemption windows of the treasury and of the subtreasuries of the country any silver coin that has not been mutilated willfully and which still is recognizable as from the mints of the United States will be redeemed at face value, this in spite of the fact that the silver in the worn coin may not be worth half its face value. As to gold coin, the government stands only a small portion of the loss from abrasion; but, according to weight, these worn gold coins always are redeemable.

In the case of the paper currency two-fifths of a note must be presented if it shall be redeemed or a new note issued, and, no matter what the evidence may be as to total destruction of this paper currency, the government regards it as the holder's individual loss with which it is no further concerned. Fire may melt \$1,000 worth of silver coins and it is worth its metal value. It may melt \$1,000 in gold coins and the mint will pay \$1,000 in new twenty dollar gold pieces for the mass. But the ashes of \$1,000 in paper currency is without value.

In the thousands of fires over the country every year involving office buildings, factories, business houses and family residences an untold total of legal tender notes of all kinds are destroyed. Every piece of such paper lost is loss to the holder and gain to the government or to a national bank. It is a promissory note hopelessly lost to the holder. It is even more, for in many cases an individual man might redeem his debt obligation if he were assured by the holder of it that the piece of paper to which he had signed his name had been destroyed by accident and by no chance could turn up again against him.—Chicago Tribune.

The "Trading" Rat.

An animal whose instinct teaches it to give something in return for that which nature has taught it to steal should be capable of a business education. A curious statement is made about the "trading" rat, which is one of the unique and interesting animals met with in the Rocky mountains.

Miners of the region declare that, although these rats enter houses, camps and mines and take things that do not belong to them, they never take an article without leaving something in its place. They conduct a trade, and hence their name.

They enter dwellings at night and steal anything they can find, carrying away spoons, knives and forks, but invariably leaving a chip, stick or stone in place of each article taken away.
