CASHED HIS OWN CHECK.

A Slick Trick Worked on a Greenville Merchant by a New York Sharp.

Wilson, Jan. 15.—A party from Greenville was in Wilson this morning who told of how a New York "sharp" pulled the wool over the eyes of Mr. Frank Wilson, a prominent merchant of Greenville, a short while after last Thanksgiving day. What Mr. Wilson did would have been done by any other merchant under similar circumstances.

A well known drummer for the New York clothing house of Schloss, who had been calling on the merchants of Eastern Carolina, had sent in his usual report in which he stated that business in his line was at a standstill; that many of his customers who usually gave him large orders were holding off until the new year set in. Among the customers who failed to favor him with an order was Mr. Frank Wilson. For a previous order Mr. Wilson had given the drummer a check for \$273, which was drawn in favor of the New York house. This was also sent in with the report by the drummer.

A few days after this a man called on Mr. Wilson, introducing himself as a brother of the New York clothier. Mr. Wilson made the remark: "I didn't know Mr. Schloss had a brother so young." "Oh, yes," said the slick article, "I'm the baby boy; my brother has sent me down here to find out why it is that his agent in Eastern Carolina is sending in so few orders; he believes the fellow has gone to sleep on his job. From the drummer's last report my brother was surprised to find that you, too, Mr. Wilson, had failed to place an order and he is at a loss to account for it. If the tightness of money matters is the cause—forget it; we'll carry you until you get in position to pay." Mr. Wilson assured the oily-tongued fellow that it was no fault of the drummer, that he had all the goods he cared to carry.

"Well, I'm glad that my brother's agent has been doing his duty: I'm glad to have met you, Mr. Wilson; I must be going, as I have got to get to Washington, your next town, this afternoon." "And," as an afterthought, he said: "Wilson, I left New York on Thanksgiving day, the banks being closed, my brother handed me this check, yours, saying if I ran short of funds to have it cashed, if I should happen at some little place and find myself in a predicament: would you mind cashing your own check?"

Mr. Wilson cashed the check thinking he was accommodating a gentleman, but he was soon made wise to the fact by a drummer who called a little later in the day, who told him that Mr. Schloss had no young brother.

Mr. Wilson then called up New York and got into communication with Mr. Schloss, himself. When Mr. Schloss was made acquainted with the facts he yelled back through the phone:

"Who is de tam rascal, Mr. Wilson; nine frient, I tell you plainly, I haf no brudder dat I send down tere—he's a tam rascal."

The supposition in Greenville is that the fellow who represented himself to be Schloss' brother purloined the check and letters of the firm he had in his possession from the desk of Mr. Schloss and that he went to Greenville for the express purpose of swindling Mr. Wilson.

BARN AND STABLES BURN.

A Horse and Quantity of Corn and Fodder Lost With Buildings.

About 4 o'clock Sunday morning a barn and stables at the home of Frank Moye, a colored tenant on the farm of Mr. J. G. Moye, 2 miles from town, were destroyed by fire. A valuable horse was burned in the stable, and about 25 barrels of corn, 2,000 pounds of fodder, a carriage and farming implements. The total loss was about \$600. Mr. Moye had only \$100 insurance on the building, but the colored man had no insurance at all on his corn and farm implements. The loss is a heavy one on him.

OUTRAGE ON COMMUNITY.

So Says Judge O. H. Allen of Longfellow Verdict.

Kinston, N. C., Jan. 15.—In the Lenoir Superior court today J. S. Longfellow was acquitted of the charge of bigamy for which he has been on trial for several days and for the second time, a former trial having resulted in a mistrial. Upon announcement of the verdict the solicitor demanded a poll of the jury and each juror for himself voted "not guilty."

Judge O. H. Allen, who presided, reprimanded the jury for the verdict in severe language, declaring that in order to reach this verdict the jury had to decide that the defendant lied when he stated repeatedly that he and Miss Bruce Swift were man wife. He declared that it was an outrage upon the community when a man could come into a Kinston home, wreck the honor of one of its most beautiful young women and go scot free, after living in her own home as the self-avowed husband of the young woman.

The public generally are much disappointed over the outcome of the trial. Immediately after the verdict was rendered Longfellow was taken into custody upon a charge of fornication and adultery by fraud upon Miss Swift and in which charge the young lady is not included. He was required to give a cash bond of \$2,000 in default of which he is in jail. It is not doubted that a marriage ceremony took place as testified to by the young woman, but as she was unable to produce the usual legal proof it must have been a mock ceremony.

STATE NEWS.

Happenings of Interest in North Carolina.

Kinston, Jan. 15.—The sales and livery business of J. C. Quinerly & Pro., was destroyed by fire this morning at an early hour. The loss to the business is estimated at \$2,500, consisting of hay, harness and other equipment. The loss to the building, which belonged to Mr. J. A. Pridgen, was slight and was fully covered by insurance. In this fire Mr. Frank Quinerly lost a fine automobile and his valuable driving horse was so badly burned that it will probably die. The Quinerly brothers had no insurance.

Raleigh, Jan. 15.—The bulletin of the North Carolina Board of Health, just out, reports cases of small pox in the state from 12 counties; Diphtheria in 72 counties and typhoid fever in 60 counties during December. Pneumonia was reported from 31 counties and the new and much discussed pellagra from only one county. The latter was three cases in Rowan county.

In the course of an article on the importance of teaching health in the public schools it is stated with reference to prevalence of non-contagious diseases among children that 15 to 20 per cent. of all school children have defective eyes, that about 5 per cent. have defective ears; 5 to 20 per cent. have adenoids; 90 per cent. teeth that need attention and that "in North Carolina a very large per cent. of children in our rural schools have hookworm disease."

JANUARY SUPERIOR COURT.

Judge R. B. Peebles Presiding—Charges the Grand Jury.

The January term of Pitt Superior court began this morning with Judge R. B. Peebles presiding and Solicitor C. L. Abernethy representing the state. In calling the jurors for the term, Calvin McLawhon was excused on account of deafness, J. W. Higgs and J. A. Fornes for sickness, J. M. Dixon because of the death of a sister, and T. E. Hooker absent in hospital.

Following were drawn as grand jurors: Wiley Brown, foreman; C. T. Watson, G. W. Venters, S. I. Dudley, Joshua Nobles, B. J. Pulley, J. C. Dilda, O. C. Daughtry, J. E. Warren, F. A. Elks, J. H. Harris, R. L. Warren, J. A. Elks, E. R. Dudley, A. E. Tucker, E. I. Fleming, J. W. Gay, O. C. Nobles.

In beginning his charge to the grand jury Judge Peebles said when we consider the age of our country, that it is but one hundred and fifty years old, and in that short time it has become the most powerful nation in the world, and its friendship more sought than any other by all other nations, it should make us justly proud. This is not due to our having a greater population than others, for China far outnumbers us, nor is it due to our having greater wealth than other nations. We must look for some other reason for the position we hold among the nation, and that reason is because we have the best laws and those laws are better executed. Here every man stands on an equal footing before the law, and man has the right to do what he pleases with that which is his own, provided in so using it he does not bring injury to others or trespass upon their rights.

Judge Peebles then spoke of the oath the jurors had taken, especially emphasized that portion of it that they should guard with secrecy their deliberations in the grand jury room.

The home of the aged and infirm is one of the greatest charities known to our people, and it is the duty of the jury to visit this home and see that the inmates are well and comfortably cared for. While such institution is a charity, it ceases to be a charity and becomes "a hell on earth" when the unfortunates there are improperly treated and not provided with necessary comforts of life.

Under the head of the five capital crimes in this state, while speaking of the placing of obstructions on railroad tracks causing the wrecking of a train resulting in loss of life, he said people are not careful enough to instruct their children as to what the law in this respect is. He has known of small boys being brought in court for placing obstructions on a railroad track, when they were only prompted by curiosity to see a wreck, not realizing that they were committing a felony. Proper instruction on the part of parents would prevent this.

Judge Peebles said he would not consume time to instruct the grand jury on all crimes, as they understood most of them in a general way, but he spoke of the illegal sale of liquor, the burning of woods, cruelty to animals and a few such matters as he thought should be enlarged upon.

The docket was taken up immediately after the completion of Judge Peebles' charge, and the disposition of cases begun. The first case was Henry Moye,

The Eternal Struggle.

The great problem of modern times is how to bring again the ownership of capital and the returns from capital into the hands of those who use it. With the passing away of household manufacturers and the growth of the factory system, capital passed out of the hands of the laboring classes. Today 90 per cent of the people are well nigh propertyless, and nearly all the income from a wonderful growth of capital goes to comparatively few people. The introduction of machinery has not limited the hours of labor to the extent that one would expect. Did not the users of the machine organize and by their associated effort compel a reduction of hours, the situation would be far worse than it is. Indeed, the argument sometimes advanced in favor of the introduction of machinery, is that it ultimately provides more work for more people. The users of machinery should have a greater return from its use. The owner of it should be rewarded for his judgment and supervision in the management of it, but should not receive all the income simply because his name is attached to the property

or because his father's name was attached to it. The internal struggles of ancient Rome were over land ownership and the injustices arising therefrom. The French revolution was the result of unjust privileges. The revolution threatening the modern world is that arising over the inequitable ownership of capital and the glaring social and economic inequalities that exist today. To avoid the impending crisis will require the most careful thought and the wisest legislation.—Paul L. Vogt, of the Department of Commerce and Labor.

The county physician of Union publishes in the Monroe papers a list of homes in Union county where smallpox exists, and the location of these homes. He also gives the essential points of the quarantine and vaccination laws, and in doing so, manifests the fact that he is an alert and an energetic county doctor. There is entirely too much carelessness in the handling of the smallpox situation in this State. The plan of the Union county official is to be commended to every county physician in the State.—Charlotte Chronicle.

A COLUMBUS STATUE.

The Story of a Brass Founder's Transformation of Gambinus.

A story is told of a brass founder who was one day visited by a friend acting as agent for one of the cities of Central America. The agent asked what it would cost to cast a statue of Christopher Columbus for the public square of the city. The amount was far in excess of the sum which the man had at his disposal. He was about leaving in despair of being able to secure the statue when the brass founder said: "Come back in the junk yard and let us see what can be found there."

He went back, and the brass founder showed him a colossal statue of Gambinus, recently removed from the front of a large brewing establishment. Under his feet rested a beer keg, in his hand was a large and overflowing schooner, his beard was long and shaggy, and about his brow was wreathed a garland of barley and hops. "Why, this will never do," said the commission merchant. "I want a statue of Columbus."

"Wait until I have touched this one up. Come back in about a week and see what you think of it. If it suits you, you can have it for the amount you have at your disposal." As soon as the visitor had gone the brass founder set two men at work on the figure of Gambinus. They removed the beer keg from under his right foot and placed there an anchor and a coil of rope, from his hand they removed the goblet and substituted a globe, with the continents traced on it; from his brow they took the wreath of barley and hops and substituted a wreath of laurel and then proceeded to trim up his whiskers. The finishing touch consisted in putting at the base of the statue "Cristoforo Colombo."

When the commission merchant came he was delighted with the figure and, purchasing it, shipped it to the Central American city, where it adorns the public square and is looked upon with veneration by the citizens of that town.—New York Times.
