AT FEBRUARY MEETING MONDAY

Engage Special Smallpox Physician—
Jurors for March Court.

At the February meeting of the Board of County Commissioners there was a large amount of routine business to transact, as well as settling the costs of the last term of criminal court. J. P. Quinerly, chairman of the board and Sheriff L. W. Tucker were appointed a committee to purchase a carpet for the court room and to have the interior of the room repainted.

It appearing to the Board of Commissioners that there are several cases of smallpox in the county, and that the town of Greenville has employed a special physician, Dr. J. E. Nobles, of said town, and the board wishing to co-operate with the town in doing everything possible to stamp out and prevent the spread of said disease throughout the county; it is ordered by the unanimous vote of the Board of Commissioners of Pitt county that Dr. J. E. Nobles be and he is hereby engaged as special physician to look after the smallpox condition throughout the county until our next regular monthly meeting, and that the regular superintendent of health be relieved of this part of his work.

WILLIAM JAMES KILPATRICK.

The Tribute of a Friend to His Memory.

On Thursday, January 27th, William James Kilpatrick died at the home of his daughter, Mrs. Moses Spivey, near Grifton. Knowing his extreme illness, all of his immediate family had gathered to be with him at the end.

William James Kilpatrick was the son of John Bryan and Sarah Tucker Kilpatrick, and was born Dec. 23rd, 1843. He was confirmed by Bishop Atkinson about 1866. On Nov. 26th, 1867, he was married to Annie Harding Perry, of Chocowinity.

Mr. Kilpatrick was survived by five daughters; Mrs. T. S. Bender, of Pollocksville, N. C., Mrs. Moses Spivey, Misses Nettie, Mabel and Katie Kilpatrick, of Grifton, and two sons, Mr. W. H. Kilpatrick, of Grifton, and Mr. Edgar Kilpatrick, of Norfolk, Va.

The other members of the immediate family are his brother, Mr. F. M. Kilpatrick and his sister, Miss Sarah Kilpatrick, both of La Grange.

The funeral services were held in St. John's church, Pitt county, and the remains were laid to rest in St. John's cemetery, Friday, Jan. 28th, Rev. J. H. Griffith, of Kinston, and Rev. B. F. Huske, of Greenville, officiating.

He will be sorely missed by his family, his friends, and his church which he served faithfully and loved devotedly.

He died in the blessed hope of the Christian faith. "Blessed are the dead who die in the Lord."

Newsy Items of Interest Condensed for Busy Readers.

Winston-Salem, Feb. 8.—Mrs. Martha Stoltz, of Bethania, aged 65, was gored and seriously injured by her cow today. Mrs. Stoltz went in the stable to milk when the mad animal rushed upon her. With blood flowing from her face she crawled out of the stable. Owing to her age fatal results are feared.

Thomasville, Feb. 8.—It will be a source of deep sorrow throughout North Carolina to know that there are today fifteen cases of smallpox at the Thomasville Baptist Orphanage. The fact was discovered a few days ago by Dr. Julian, the orphanage physician, and the disease has spread to some extent. Miss Olive, one of the teachers, also has it, along with 14 of the orphans.

Elizabeth City, Feb. 8.—News was brought here today of the horrible burning of an aged man at Chapanoke Sunday morning. The old man, who gave his name as Ben Goodwin, father of Pete Goodwin, of Norfolk county, Va., arrived at Chapanoke Saturday night and hung around the store of Mr. Tow. He told Mr. Tow and others that he was sixty years old and had worked his way from Norfolk county, where he had escaped from the county home and was bound for Edenton, where he had a daughter residing. About eleven o'clock he was directed to a vacant tenement house, where he was told he should spend the night and some sympathizers started a fire for his comfort. At two o'clock the neighborhood was alarmed by his screams for help, and citizens rushing out found the old man wrapped in flames. Blankets were thrown around him and medical aid summoned, but his condition was beyond human aid. He lived, however, in terrible agony until eleven o'clock last night. The old man's remains were taken in charge by the Perquimans county authorities and buried.

Vital Statistics.

There is a rare opportunity awaiting some legislative representative at the next general assembly in the introduction of a bill providing for the recording of county vital statistics—births, marriages and deaths. As conditions are now in this county marriages are recorded, but no particular pains are taken "to keep the records straight" in the matter of births and deaths. Most of the States in the union, we believe require that a strict record of these statistics be kept, and every county in North Carolina should see to it that the register of deeds keep such a record.

The law should require every physician to report all births and deaths to the register of deeds within twenty four hours. This would impose no hardship on the profession, nor would it be giving to the public information to which it is not entitled. If for no reason than that a man might, at some period of his life, be called upon to prove his birthplace, the records of births should be kept by the proper officials, and other reasons, which need not be gone into here, should prompt similar action in the matter of deaths.

While on this subject it is interesting to note that Governor Noel, of Mississippi, a few days

ago sent a special message to the State legislature urging the establishment of a bureau of vital statistics, and his recommendation was favorably acted upon. North Carolina cannot afford to be behind in this matter, and The Citizen believes that the next legislature can pass a law along the lines mentioned with credit to itself and the State—Asheville Citizen.

A Striking Resemblance.

The board of aldermen, at a meeting last Tuesday night, fixed the license for near-beer saloons at \$1,000 a year. The aldermen have to grant license for the abominable "ni beer" joints, and we have no quarrel with them about the matter. The law is written by the legislators and is interpreted by the courts and it says that the authorities shall grant license to those applying for such to sell near beer. But, honestly, a near beer joint in prohibition times and an old-fashioned barroom in wide open, free-for-all times are so much alike that their own daddy, the devil, himself, cannot tell one from the other and furthermore he doesn't care which one lives and flourishes." THE BARBER'S TRADE.

Men Who Followed It and Afterward Rose to Fame.

Perhaps the best known of all barbers who have attained fame were Arkwright, the improver of the spinning jenny, who is said to have turned to mechanics when the wigmaking trade fell off, and Jeremy Taylor, who was brought up in his father's shaving shop at Cambridge.

Edward Sugden, afterward made Baron Saint Leonards, was the son of a hair cutter in a shop in Lincoln's inn, London. A story is told to the effect that once when Sugden was addressing a crowd in the interest of his candidacy to parliament a man called out to know what soap cost and how lather was made. "I am particularly obliged to that gentleman," Sir Edward is reported to have said, "for reminding me of my lowly origin. It is true that I am a barber's son and that I myself was once a barber. If the gentleman who so politely reminded me of these facts had been a barber he would have continued to remain one till the end of his life."

Charles Abbott, Baron Tenterden, was also a barber's son, and it is related how, when he was made a peer of England, he took his own son to a little Westminster shop and bade him remember it was there that his grandfather had been accustomed to shave others for a penny.

William Falconer, the poet, was a poor barber in Edinburgh until his poem "The Shipwreck" brought him renown and incidentally a commission in the royal navy. Crags, associated with the south sea bubble, was a barber turned promoter. He became enormously wealthy. But when the south sea crash came his fortune dwindled, and in despair he committed suicide.

Giovanni Belzoni of Padua was a barber with a varied and interesting history. Belzoni set up a shop in England, but soon found more profit in posing at Sadler's Wells as the "Patagonian Samson." Being of thrifty temperament, Belzoni accumulated quite a fortune as the discoverer of interesting relics in the tombs of Egypt and as a traveler.—Chicago Record-Herald.

A BARNUM TRICK.

Getting His Posters Into Canada Without Paying Duty.

One of P. T. Barnum's most successful feats of bamboozlement was played upon the Canadian customs authorities. The veteran showman's tours were always planned far in advance, and one winter he made up his mind to take his great circus and menagerie through Canada during the summer after the next. This gave him about two years in which to mature his plans.

One important item of a showman's expenses consists of his advertising placards, and Mr. Barnum was always lavish with these gaudy prints. He was aware that the Canadian government imposed a high duty on this class of imports, and yet he wanted to paint Canada red, yellow, blue and green with a lavishness that no showman had ever displayed in that country before.

Now, there was no printing house anywhere in Canada that could begin to turn out the kind of work that Mr. Barnum required either in size, color or finish. Nevertheless his immense posters came under the same classification as much smaller lithographs and printed colored matter did, and he knew that the Dominion custom authorities would not abate one jot of the full toll, but would rather rejoice at the opportunity to mulct the foreigner who would convey so much money out of a country.

So Barnum studied the question awhile and finally sent on at once a great lot of circus posters of the most gorgeous designs whereon yellow lions and clawed striped tigers and brown bears fought with blue hippopotamuses till gore flowed into beautiful crimson backgrounds. No agent appeared when the posters were detained by the Canadian customs officers to pay the duty. They were accordingly held for twelve months, then duly advertised for sale for three months more and finally put up at auction with a lot of other unclaimed parcels and were designated in the catalogue merely as "colored prints."

Nobody took any interest in them when the auctioneer called for a bid, and finally the whole batch was knocked down for a song to a secret agent of the circus who had been sent up by Mr. Barnum for that express purpose.

The Almanac.

The word "almanac" is derived from the Arabic "aland manah," which means to count and thus aptly applies to measurements of time. In ancient days almanacs were employed by the Alexandrian Greeks, but it is uncertain as to when they were actually introduced in Europe. In 1150 A. D. Solomon Jarchus issued an almanac in script, but the first printed one was brought to Vienna in 1457 by the great astronomer, Purbach. The most celebrated almanac maker was an adept in the so called black art, Nostradamus, and since his time, somewhere toward the middle of the fifteenth century, almanacs with predictions have been in vogue, and their pictorial prophecies and weather lore have invariably appealed to a large number of people.
