HAPPENINGS WITHIN THE OLD NORTH STATE

Newsp Items of Interest Condensed for Busy Readers.

Wadesboro, N. C., Feb. 18.—While Mr. A. J. Springer, of Cedar Hill, was running a saw the emory stone he was using burst, and a piece of it struck him in the face, inflicting a painful wound. After having the wound dressed Mr. Springer procured another stone, and this, too, burst after a few minutes use. A piece of this stone also struck him in the face, but as it was a glancing blow it did not hurt him so badly.

Winston-Salem, Feb. 18.—Since the death of E. T. Ketner, one of the Forsythe's successful farmers, two weeks ago, members of the family have found over \$2,800 hidden by the head of the household before his last illness. Two thousand in gold and silver was unearthed from a fruit jar, buried in one corner of the smoke house, while more than \$500 was found in a wheat box in the granery. Various other amounts were gathered from outbuildings and in the old man's clothing.

Wilson, Feb. 18.—At a called meeting of the board of Aldermen of Wilson last evening Mr. B. F. Lane, one of our most progressive citizens, who always keeps abreast of the times, appeared and asked that the board consider a proposition from a capitalized syndicate of Norfolk, asking for a franchise for the building of a street car line in Wilson. BUILDING UP THE SOUTH.

What the Several Railways Are Doing to Help.

A recent dispatch from Washington says: That the railroads are giving much attention to the upbuilding of the South is evident to all who have given the subject consideration. Necessarily, the work of the railroad company which does not possess a land grant must be general in its scope in order to serve all the districts its lines represent. The recent campaign of Dr. S. A. Knapp, of the federal government, which was made under the auspices of the Southern Railway company, is but one of the many moves made by that company looking to the betterment of farm conditions in the South. The lecture tour referred to comprehends more than is generally supposed. Every southern state reached by the Southern railway was visited, and the several masterly, practical talks made by Dr. Knapp will be far reaching in their effect. Many thousand farmers and others in the States visited were reached either directly or indirectly, through the press, and thereby stimulated to practice better methods of farming.

M. V. Richards, the land and industrial agent of the Southern railway, who suggested and organized the tour, in discussing the purposes and effect of the trip, said:

"The Southern Railway company has for years endeavored to do its part in promoting the further development of the country along its lines. Its policy is to treat all sections alike, co-operate with the people in every county in their effort to build up the country. The farming sections have not been overlooked. The railway company realizes the value of a full development of the rural districts in order to obtain the best development of the towns and cities which serve the country."

Mr. Richards rightly advocates the importance of the town people and the country people standing close together if the best results for all are to be obtained, and this recent trip tends to bring closer harmony between classes. The merchant, manufacturer and farmer alike were interested in the talks made during the trip. Mr. Richards says that while the towns have a powerful attraction for the people on the farms he believes that that feeling is at a minimum in the south, and that his company, especially, has in view promoting a sentiment among the people to "stick to the farm."

He argues that the South will again be the great farm home section of the United States. "The South is the ideal large and small farm home region; the standard of comfort and happiness is found to be higher and more general in the South than elsewhere on account of the attractive features of the rural home surroundings, when once developed, commensurate with the possibilities of that part of the country. Only those who have had to do with the practical side of promoting the development of the South appreciate the obstacles which have stood in the way of advancing the best interests of those already established in the South and drawing others to that section. We desire to inculcate in the minds of every young farmer in the South the idea that he should buy a piece of land and intelligently and industriously work his own holdings; that he should also be

THE SPITE FENCE.

Barger Versus Barringer Again in Court.

The fence case of Barger versus Barringer, which has attracted a good deal of attention over the State, has been tried over again in Catawba Superior court. This time the plaintiff gets \$33 50 damages.

The history of the case is as follows: Barger and Barringer live on adjoining lots in West Hickory. Barringer put up a solid board fence, eight feet high, on his own land, a few feet from the line, and Barger claimed that it cut off his view of the street east of his house and cut off the view of the people approaching from that direction, of his house, and his property was consequently damaged.

When the case came up the first time it was non-suited by the presiding judge. The Supreme court reversed this decision and held that a man could not use his own property in such a way as to damage a neighbor. In the trial at this court the fight over the case was as to whether the fence was built through malice and whether Barger's property was damaged. The jury decided in favor of Barger and awarded damage to the extent of \$33.50.

The amount of money involved was not very considerable, but an important principle of law has been adjusted, and the case in the North Carolina Reports will be a precedent that lawyers and judges will hold in much importance.—Newton Enterprise.

It seems that investigations of political dishonesty is the order of the times.

In the bribery line, the New York legislature is about to get in the class with Pennsylvania.

In the death of ex-Judge Thomas B. Womack Raleigh loses another one of its best citizens and the State one of its greatest men.

Judge Ferguson, who is holding the present term of Beaufort county Superior court at Washington, spoke of the inadequacy of the court house to meet the needs of the county and instructed the grand jury to indict the board of county commissioners for failing to perform their duty in providing a suitable court house. Following this suggestion of Judge Ferguson, the grand jury returned a bill of indictment against the county commissioners.

We thought he was lost in the shuffle, as he had been quiet for a time, but Senator Jeff Davis, of Arkansas, has been heard from again. In a speech the other day he wanted to consign poor old man John D. Rockefeller to hades and have him roasted over a fire made of Standard oil products. If the senator had just taken time to think, he might have reached the conclusion that Standard oil is not needed in the region to which he wants to send poor John D.

Just see what an inequality they make in women in the matter of alimony in divorce cases. In the recent Brokaw proceedings Mrs. Brokaw was given the divorce asked for and the modest allowance of \$15,000 a year, though she asked for just twice that much. In another prominent divorce case in Norfolk the woman's alimony was stipulated at \$75 per month. While that may be sufficient for her to live on, she will not have the privilege of putting on as much style as ex-Mrs. Brokaw.

A Possible Result

The legislature has passed the bill requiring mileage coupons to be accepted on trains. We do not know what the result of this will be, but those who have demanded such a law would feel much chagrined if the railroads would quit selling mileage. The railroad officials have claimed that the rule requiring mileage coupons to be exchanged for tickets has resulted in material increase of their revenues and it does seem that if this is true the legislature should not have required them to abolish the rule. —Anderson Mail

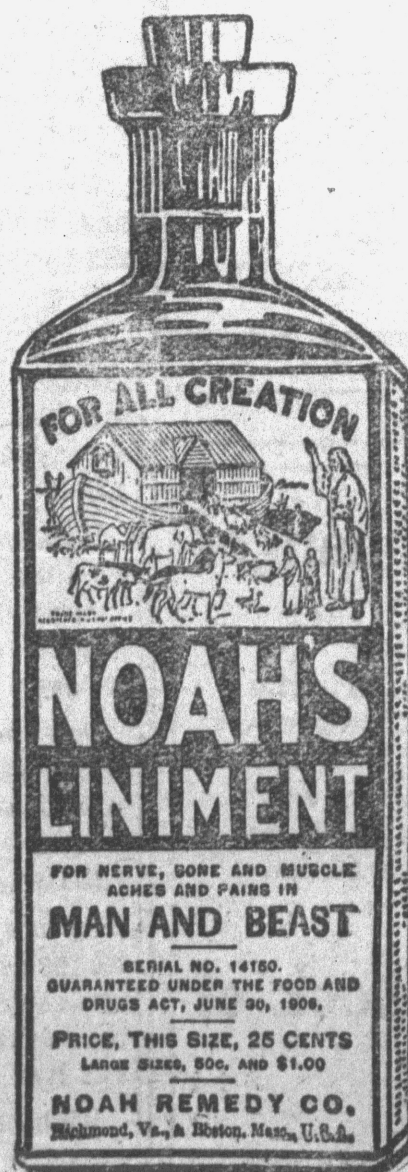
