## UNIVERSITY NOTES.

Chapel Hill, N. C., Feb. 28. — The winter number of the University Record has just been issued. The feature of the issue is President Venable's report. Among the interesting changes in the faculty as reported by him which have occurred in the last twelve months are the resignation of Dr. C. A. Smith as head of the English department and dean of the graduate school to go to the University of Virginia; the resignation of Prof. J. D. Bruner of the department of romance languages to become president of Chowan Institute; of Prof. J. E. Latta, of the electrical engineering department, to go into commercial engineering in New Jersey; of Dr. R. O. E. Davis to go into the bureau of soils at Washington. The following additions are among those reported: Dr. Edwin Mims, fifteen years professor of English in Trinity College, elected professor of English; Dr. Wm. Dey, acting head of romance language department in the University of Missouri, elected professor of romance languages; A. E. Woltz, superintendent of Goldsboro schools, elected bursar to succeed Major W. T. Panterson, for twenty five years bursar; C. T. Woolen appointed proctor; Dr. C. L. Raper, dean of the graduate school; Dr. H. M. Wagstaff promoted to be full professor of history; and Prof. E. K. Graham elected head of the department of English and dean of the college.

Registrar T. J. Wilson's report shows following enrollments: 1906, 683; 1907, 731; 1908, 783; 1910, 820. By schools, the enrollment in 1910 is as follows: in the college 586, in the graduate school 27, in the law school 105, in the medical school 72, and in the pharmacy school 41. Ninety two and one fourth per cent of the total 820 are from North Carolina. Seventy of the number come variously from Virginia, South Carolina, Georgia, Tennessee, Florida, Oklahoma, Alabama, New Hampshire, New York, Pennsylvania, Maryland, Kentucky, District of Columbia, Mississippi, Texas, Ohio, Cuba and Japan. Counties having as many as ten are: Mecklenburg 34, Wake 34, Guilford 32, Orange 30, New Hanover 16, Durham 26, Cumberland 22, Forsyth 21, Pasquotank 18, Johnson 17, Wayne 17, Buncombe 16, Iredell 14, Roberson 14, Burke 13, Pitt 13, Alamance 12, Rowan 11, Surry 11, Davidson 10, Edgecombe 10, and Gaston 10. There are 259 Methodists, 184 Baptists, 146 Presbyterians, 123 Episcopalians, 22 Lutherans, 21 Christians, 15 Roman Catholics, 7 Hebrews, 5 German Reformed, 5 Moravians, 2 Friends, 1 Adventist, 1 Disciple and 1 Unitarian. Of the Freshmen 123 came from public schools, 26 from private schools and 10 from colleges.

### Gentle Pats From a Powder Puff.

Remember that powder works its way into the skin and leaves the pores much enlarged and coarsened.

That it is not washed from the face at night it will eventually ruin the texture of the skin.

Never put powder on the face in lieu of water, or apply it to cover dirt.

The evils that lurk in the constant use of the powder puff are many.

A puff is not antiseptic, according to one of the medical authority, and endangers the health of the skin.

It is wiser to use little pads of sanitary cotton when one essays to obliterate the shine, so that when they become even slightly soiled they can be thrown away.

Avoid the highly scented and colored varieties of face powder. They are both harmful and in poor taste.

### WASH THE HANDS.

And Do It as Frequently as the Opportunity Offers.

Civilized man touches a hundred things with his hands to every one with any other part of his body. Literally he sticks the former into everything. It follows, as Dr. Eccles points out in the Dietetic and Hygienic Gazette, that hands probably play a very important part in the spread of disease. From this the further corollary may be drawn that washing the hands is a sanitary process of great importance. It affords an imperfect but partial disinfection.

Pretty much everything touched by the hands may be infected—money, newspapers, books, street car straps, restaurant knives and forks and tumblers, other people's hands, door handles, public pens and pencils, and so on, ad infinitum. Every one of these touches may, and some of them actually do, result in a transfer of germs. Fortunately most of the newcomers will be harmless, but occasionally a "batch" arrives analogous to the Black Handers, and if they find any cut or minute abrasion of the skin or if the imbecile carelessness of their host rubs them into his eyes or mouth the possibility of a death or at least an expensive illness in the latter's family becomes imminent.

Therefore wash your hands as often as opportunity offers. You can't overdo it. Clean hands are of far more importance hygienically than aesthetically. Washing them after handling some dangerously infected object may save your own or some one else's life. As you have no way of distinguishing infected from uninfected things, banknotes, for instance, the hands should always be washed as a matter of routine before they are carried to the eyes or lips.

What Dr. Eccles would like to see adopted is antiseptic hand washing involving the routine use of some fairly strong germicide. This is a counsel of perfection that cannot be hoped for. A more frequent use of soap and water will be soon enough for a first step. The Medical Record agrees with Dr. Eccles as to the necessity for a hand washing crusade.
