## HAPPENINGS WITHIN THE OLD NORTH STATE GATHERED FROM OUR EXCHANGES TODAY

### Newsy Items of Interest Condensed for Busy Readers.

The Laundrymen's Association of the Carolinas is scheduled to meet in Greensboro March 21 and 22. Laundrymen's Association of Virginia and West Virginia will meet with the association of the Carolinas at this time.

Henderson, March 7.—Fire of unknown origin, which was discovered after midnight, practically destroyed the entire plants of the Henderson Manufacturing Company, the Corbit Backer Company and the Carolina Bagging Company, entailing a loss of \$70,000.

More than 2,500 whiskey prescriptions were filled in this city during the month of February just ended. To be more correct there were just exactly 2,596 as shown by the weekly records turned in to the police department—and February has only 28 days.—Charlotte News.

Mr. C. H. Maness, whose store in the silk mill village was burned on the night of January 31st, was arrested today at the instance of Mr. W. A. Scott, deputy State insurance commissioner, who arrived here from Raleigh this morning to investigate the recent incendiary fires in Fayetteville. He also arrested Irving Maynard, driver for Maness, as an accessory. Maness had not heretofore been suspected by the public and he has been the object of much sympathy.—Fayetteville Observer.

### Pastor Resigns at Wilson.

On yesterday morning at the First Baptist church, the Rev. James Manning Dunaway, Th. D. presented his unconditional resignation as pastor to become effective the last of March. This was great surprise to the congregation, and a sore grief to the church. Dr. Dunaway came here last October.

The cause of Dr. Dunaway's resignation is the condition of his health. Since coming here he has been greatly troubled with rheumatism, and he fears that our climate is the cause of this. He has decided to seek a drier climate.

Dr. Dunaway's pastorate has been exceedingly successful. His congregations have steadily grown. Rev. C. W. Blanchard of Manning, S. C., was unanimously called as his successor, and hopes are entertained that Mr. Blanchard will come as he is not a stranger to our people.—Wilson Times, 7th.

## UNIVERSITY NOTES

Chapel Hill, N. C., Mar. 7.—The preliminary contest for places on the team to represent Carolina in debate with Washington and Lee was held last week. The contestants were H. E. Stacy, W. R. Edmonds and E. A. Pharr. Stacy was a member of the Carolina team that defeated Tulane in debate last spring in New Orleans. Edmonds won the Bingham medal in the commencement debate between the Di and Phi societies last June. Pharr is a graduate of Erskine college, where he won the oratorical medal. The debate with Washington and Lee will be held April 8th in Greensboro. The same night a debate with Georgia will be held in Chapel Hill. The preliminary contest for the Georgia debate will be held this week. Those who have entered for the contest are A. H. Wolfe, C. E. McIntosh, Ney McNeely, John H. Boushall and F. N. Cox. Wolfe is president of the senior class and a speaker of ability. McIntosh is an experienced debater who has successfully represented the Di society against the Phi. Boushall and Cox have both done good work in their societies. McNeal has been trained not only in the hall of the Di society but also in the assembly hall of the North Carolina legislature, in which he represented Union county.

The annual Soph-Junior debate was held Friday night between the Di and Phi societies. The question was woman's suffrage and the cause of the suffragette won. W. F. Hendricks and I. C. Moser of the Di opposed, and L. H. Johnson and J. A. McGooga of the Phi championed the cause of woman. The debate was close and spirited from start to finish.

E. W. Turlington and W. F. Taylor have been chosen to represent the Phi society and C. L. Williams and G. R. Thompson, the Di society, in the annual inter-society debate commencement.

The Dialectic and Philanthropic societies are training camps of future debaters and statesmen. The training that James K. Polk got as president of the Dialectic society stood him in good stead as speaker of the house of representatives. Vance said that he has been a member of every deliberative body from the town council to the United States senate and that he had never participated in the proceedings of a more dignified and orderly body than the Dialectic society. Albert Boushall Hart, head of the department of history at Harvard, said that the Dialectic and Philanthropic societies of the University of North Carolina took rank along with those of Yale and Harvard and the old Whig and Clio societies of Princeton.

The Di and Phi societies have had a part in training a president and vice president of the United States, ten cabinet officers, ten ministers to foreign countries, eighteen United States senators, five Confederate senators, ninety-two congressmen, twenty-nine governors, thirty-five justices of the Supreme Court, and nine hundred and fifty members of the legislatures of the various states. The Di and Phi societies have trained debaters who have won for Carolina 19 out of 27 inter-collegiate debates with Georgia, Vanderbilt, Virginia, Tulane, George Washington, John Hopkins and Pennsylvania.

## POLICEMAN DUNN'S FUNERAL

### Attended by Thousand People—Business of Town Suspended.

Scotland Neck, N. C., Mar. 8.—The funeral of Policeman C. W. Dunn, who died yesterday from the wound inflicted by Mr. E. E. Powell in the tragedy here last Friday, took place at 11 o'clock this morning. The body was followed to the cemetery, a mile from town, by fully 1,000 people, many here from all sections of the county and even from adjoining counties. The entire business of the town was suspended during the hour of the funeral. Both Governor W. W. Kitchin and Congressman Claude Kitchin were present. Representative A. P. Kitchin, one of the wounded men, is improving rapidly and is expected to be out in a few days. Senator Travis is also reported better today, the danger of lockjaw that was feared yesterday having passed.

### RATHER GO TO THE PEN.

#### For Five Years Than Live With His Wife.

About the only interesting case on the docket and one with a human-interest side and withal amusing had to do with a charge against a citizen of Madison for abandonment and failure to support his wife. The defendant went into court unrepresented by counsel; the wife made her statement under oath; the defendant when asked by the court if he had any evidence in rebuttal; any witnesses, replied no; neither did he care to go on the stand; that he guessed what had been testified to was about the fact. Judge Justice, however, directed an attorney to represent the man, but his efforts to induce the defendant to put up any defense was a complete failure. The defendant was told that the judge might send him to the chain-gang out this prospective dire punishment failed to even impress the alleged wife-deserter. In an effort to arouse interest in his unresponsive client the attorney went at him with a hot shot; in effect that the judge might send the defendant to the penitentiary for a term of five years; that abandonment and failure to provide support was a mighty serious thing. At this the defendant manifested a bit of interest but of a different sort from what might have been expected. His face sort of brightened and in reply he said something to this effect: "Well, by gad, I'd rather go to the penitentiary for five years than to have to live with that woman." That was a clincher and all effort at defense was abandoned. The man was of course convicted but Judge Justice tempered punishment with mercy; he neither sent the man to the penitentiary nor back to live with the wife. Provision was made that the man pay unto his wife every month a stipulated sum and that they be allowed to live apart.—Asheville News Gazette.

Former U. S. Senator Thomas C Pratt, of New York, died Sunday. He was for many years a prominent national figure in Republican politics.

So far we fail to see any movement to beautify the park strips left between the concrete sidewalks and the streets. They could be made pretty strips with a little attention.

The belief that Peary is a worse faker than Cook is growing stronger. He is very careful not to let the Copenhagen University inspect his report. The effort to get him pensioned by the government was sidetracked until he has established more credibility than has so far developed.

There are now something like one hundred thousand employees of different trades in Philadelphia who have walked out in sympathy with the street car strikers. This is demoralizing and hurtful to business generally, and is carrying a strike situation entirely too far. The government certainly ought to interfere in such disturbances and suppress them.

Greenville has reached that stage in her progress where factories are a necessity. The business of the town needs more consumers, and to get these there should be opportunities of giving profitable employment. It will be no trouble to increase the population of the town if the people who come can find employment, and nothing provides this so readily as factories. In the matter of suitable sites, material and labor for factories, Greenville has good advantages which our men of means should utilize. Factories can be operated as profitably here as elsewhere, and the town certainly needs them.

### The Earliest Lotteries.

The lotteries are generally said to have had their origin in Italy, but in Crowe and Cavalcaselle's "Early Flemish Painters" reference is made to a lottery drawn at Bruges on Feb. 24, 1446 (1445 old style). This is the earliest of which the scheme, list of prizes and accounts are known to be in existence. In 1530 a lottery was drawn in Florence, the object being to meet the state expenses. Nine years afterward they were legalized in France by Francis I. and called "blanques." The lotteries instituted at Paris by the Duke d'Invernois in 1572 and 1578 were for providing marriage portions for the young women belonging to his estate.

The first lottery known in England was drawn at the west door of St. Paul's cathedral in 1569. The amount was £20,000, which in those days was very considerable. It consisted of 40,000 tickets at 10 shillings each, and the profits of the speculation were to be appropriated to the repair of the harbors of the kingdom.

### The Air We Breathe.

A person requires twenty cubic inches of fresh air at each respiration, or an average of 400 per minute. In ten hours' sleep he consumes 130 cubic feet of air. The air of a bedroom ten feet square, having its doors and windows closed and occupied by one person, would become unfit for respiration in four hours.
