COMMISSIONERS VISIT HALIFAX

Inspect New Court House and Get Valuable Ideas—Historical Relics.

The county commissioners of Pitt, and those who went with them, had a pleasant visit in Halifax on Thursday. The purpose of the commissioners in going there was to inspect the new court house the county of Halifax is building and to get some ideas to help them in planning for the new court house. Pitt must soon have, Halifax certainly has a beautiful and well arranged court house. Work commenced on it last July and it is now nearing completion. The first court will be held in it the latter part of this month.

Our commissioners were taken in charge by Mr. S. M. Gary, clerk of Superior court of Halifax, who showed them every courtesy. Clerk Gary is very proud of the new court house of his county, and justly so. He broke the first ground for the building and has watched every step in its progress. He has placed on the wall in his office in the new building a marble table containing the name and date of service of every Superior court clerk Halifax has had. His own term began in 1894 and has continued without interruption until now, and from the way his fellow countymen speak of him he is likely to serve many years more, it not for life.

After being shown over every nook and corner of the new court house from basement to dome, the visitors were taken to the Masonic hall that contains many historical relics. There is a beautiful hand carved and inlaid Worshipful Master's chair that has been in the lodge there since 1765. George Washington once sat in that chair. There is also the charter from England, dated 1770, appointing Joseph Montfort the first provincial master in North Carolina. There are other articles in the lodge furniture that are more than a century old. The visitors greatly enjoyed the day in Halifax, and the going there of the commissioners to inspect the court house was well worth while, for they obtained ideas that will be valuable in the work they are about to undertake here at home.

Solicitor Abernethy.

Solicitor Charles L. Abernethy was phenomenally successful here last week in convicting those up for offense against the law. Not a case was given the jury that he failed in securing a conviction. He received the congratulation of his friends on every hand for the able and splendid manner in which he handled the State's interests.

Mr. Abernethy, who has been a splendid prosecuting officer all the while, is growing in ability. He holds a man as long as there is a scintilla of a chance to convict him, but when he sees he can't the State and county are not put to needless expense. A few more courts like the last and lawbreakers will hunt a healthier clime.—Standard Laconic, Snow Hill.

AT CHARLOTTE ON JULY 14.

State Democratic Convention Will Meet.

The Democratic State convention will meet this year in Charlotte on Thursday, July 14, the county conventions in every county will be held on Saturday, July 2, and the precinct meetings in the various townships on Saturday, June 25. This was the determination reached by the State executive committee last night at its meeting here, Charlotte winning over Greensboro by a vote of 33 to 21, while Raleigh, saying it was not prepared this year to take care of the convention as it desired, gave notice that in 1912 it would be prepared to do this in handsome style and would urge the convention to meet here at that time.

Besides this the State committee adopted a revised plan of party rules, which provides that county elections to state, congressional and judicial convention be held at a uniform time and that as the counties choose the election may be by precinct meetings, primaries or mass conventions. At all times the meeting of the committee was marked by harmony and the deliberations were such as to work for the best interests of the Democratic party. It was nearly two o'clock this morning when the committee adjourned.—Raleigh News and Observer.

Will be Electrocuted.

Attorneys T. N. McDearmind and C. B. Skipper, both of Lumberton, were here yesterday to ask Governor Kitchin to commute Walter Morris, but the governor declined.

Morris will be the first man to die in the electric chair, which has already been installed at the State's prison, and his electrocution will take place one week from today.

It is said that when Morris saw his attorneys yesterday morning, he fell on his knees and begged them to save his life.

Already the prisoner has been reprieved several times, but it now looks like he will go to the chair next Friday, March 18, as Governor Kitchin does not find the facts in his case sufficient to justify executive clemency.—News and Observer.

The Thoughtful Stork.

On a tree close to a house, within a short distance of a river or canal, there was a stork's nest, with young ones. The roof of the house caught fire one day, and though the flames did not actually reach the tree, the heat became scorching. So the mother stork flew down to the water, got into it and drenched her breast; then, returning to her young, she spread the mass of cool, wet feathers all over them. Our women are certainly to be commended for the indefatigable efforts they put forth for the welfare and advancement of Greenville, and they should receive the aid and encouragement of everyone. A few years ago the End of the Century Club established a public library here which had a struggling existence until the fire February 24th, when it was almost entirely destroyed without insurance. Everyone knows of the benefits derived from this library. The larger part of the expenses of the institution was borne by the good women and a large part of the monetary loss by fire was theirs, too. Now they have decided to re-establish the library as stated in an article in Wednesday's Reflector, barring all discouragements of past experience, shows fine spirit doesn't it? Why do they start on such an arduous task as the re-establishment of a public library in Greenville when the former one was so near a failure from the lack of support of the public? Simply because they believe in Greenville and are willing to work long and hard for its advancement. They are going to have that library back, and some day it will be one that we all shall be proud of. Lend them a helping hand.

Pay of Commissioners.

A suit that is of State-wide interest was tried in Greensboro. In its news report of the suit, The Greensboro News says:

"A civil suit, instituted solely for the purpose of having the highest judicial authorities of the State pass upon the act defining the compensation of county commissioners was begun

yesterday before Justice of the Peace D. H. Collins. The plaintiff in the action is J. A. Davidson, chairman of the county board of commissioners, and the defendant is the county of Guilford, the amount involved being \$3.80. In rendering his decision yesterday Justice Collins held that the plaintiff was entitled to the amount sued for."

Editorially, The News explains that Mr. Davidson did not bring this suit because he wanted the money, it was brought in reality at the instance of the board, says The News, "for the purpose of testing the question by an appeal to the Supreme court as to whether or not under the law a member of the board is entitled to per diem and mileage for days on which he is actually at work on county business, under the direction of the board, but on which the board as a board is not in session." The News understands that all the members of the board have been making these charges in the past, "but on account of a similar question being raised in another matter which has attracted considerable public attention, this is now determined to settle the question once and for all." While the money involved is a small matter, the point of law at issue is quite an important one - Charlotte Chronicle.

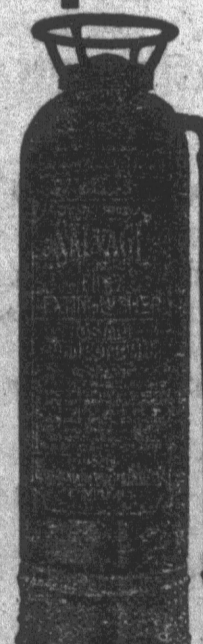

NAMES OF CITIES.

They Are Frequently Misalled by Travelers Abroad.

"How far are you going?" asked my fellow traveler as we came across the St. Gotthard. "To Paris," I replied. He looked puzzled. Then I recollected that he was an Italian and that he had told me he had never been out of Italy before. "Parigi," I said, smiling, and he knew at once what I meant.

Then it occurred to me to mention London to him and see if he understood. He obviously did not. "Londra," I translated. "Ah, Londra!" he repeated. "Yes, yes." Here were two of us journeying together across Europe in an age which is supposed to have broken down the barriers that once hindered free intercourse, yet we were not even agreed as to the names of the principal places on our route.

He called Milan Milano, Florence Firenze, Turin Torino, Naples Napoli. For Basle he said Basilea and Lucerna for Lucerne (which the Swiss themselves call Luzern, pronouncing the "z" like ts).

Stop a moment, though. When I say he called Florence Firenze, and so on, I am laying myself open to misconception and the charge of insular intolerance. Rather should I put it that we English call Firenze Florence, just as we call Padova Padua and Livorno Leghorn. We cannot even give the Eternal City its proper beautiful name. Instead of Roma we say Rome, which is only a trifle better than the Germans, who deep down in their throats grunt out "Rom."

The Germans are very bad offenders in this matter of miscalling places, for they give them often such cacophonous equivalents as one would never think of connecting with the real name. The first time I went to Italy I let the train leave Bellinzona without me. I was drinking a cup of coffee and it slipped off. I thoroughly enjoyed a sunny September afternoon's ramble amid vineyards and along the shore (so far as I recollect) of an enchanting little lake. Then I went back to the station to catch the evening service to Milan.

Presently a long and important looking train thundered in. On it were boards—"Berlin-Mailand." I regarded them idly, wondering where Mailand was and why I had never heard of it before. It was only when I saw a friendly porter wildly summoning me to enter and heard a guard crying out, "Chiasso, Como, Milano," that I realized the situation and understood Mailand to be German for the city we call Milan. The German for Venice is even more ill sounding—"Venedig." Who would ever associate that harsh trisyllable with the glories and loveliness of the miracle city of the lagoons?—London Mail.

Grim Scot Wit.
A Scottish minister had among his parishioners a man who dealt in old horses, alternating his spells of labor with heavy sleeps. During the period of depression which followed each overindulgence John habitually took to bed and there diligently studied the family Bible. During one of these fits of attempted reformation his condition prompted his wife to call in the Rev. Mr. Wallace, the parish minister, who at the time happened to be passing.

"Oh, Minister Wallace, come in and see our John; he's real bad!"
"What's wrong wi' him?"
"He's feart to meet his Makker," said Mrs. John.

Quick as fire came the crushing reply:
"Humph! Thell'm he need na be feart for that; he'll never see'm."

The Taj Mahal.
The Taj Mahal, at Agra, India, is said to be the most beautiful structure in the world. It was built by Shah Jehan as a tomb for his wife and is of the purest white marble. It shines so dazzlingly in the sun that you can scarcely look at it except in the morning or evening. Every part is inlaid with the most exquisite designs in marble of different colors, the finish being so perfect that the entire building may be said to resemble in the delicacy of its workmanship one of those Chinese caskets of ivory and ebony which are now so common in Europe and America.—New York American.

Rapid Army Mobilization.
The finest example of rapid organization of an army was certainly the mobilization of the German army in 1870. On July 17 in that year the famous telegram, the shortest and most momentous ever dispatched, "Krieg. Mobil." went forth from the headquarters at Berlin, and within a fortnight an army of 500,000 men, fully uniformed, equipped and provided with commissariat, was on its way to the French frontier. Of course it must be remembered that all these men had been previously warned and that all had been through their period of military training.—London Standard.

GRACE BEFORE MEALS.

A Prayer That Was Retrospective as Well as Prospective.

Most small boys—and many other people, too—have experienced the mortification that comes from beginning a meal before the blessing is said. The usual reason for such a breach of etiquette is that the small boy—or the other person—did not know that the blessing was going to be said. The awkward feeling that is sure to follow such a blunder cannot be helped, but it may be mitigated. On one occasion, says Mr. Adlai E. The friends, who thought Corot partial to the dish, always gave it when he dined with them. At last, in reply to the painter's query, they admitted that they detested the dish, but supposed he liked it.

Corot was grinning broadly. "My dear fellow, if you only knew how I hate the sight of it even. But Adele, my cook, simply adores haddock and potatoes. And it is no good—I dare not go against her wishes. It is as much as my place is worth. Not for worlds would my awe of Adele induce me to undecieve her as regards the value I attach to this one particular article of diet."

And for the sake of Adele this little group of great painters had for thirty years been eating a dish they could none of them bear.

The Shillalah.

The shillalah is not a mere stick picked up for a few pence or cut casually out of the common hedge. Like the Arab mare, it grows to maturity under the fostering care of its owner.
