## STUDYING THE COMET

Dr. Hooper Says Halley's is 160,000,000 Miles From Earth.

Members of the Maryland Academy of Sciences, after careful study and much calculation, have concluded that Halley's comet will not be as brilliant as is popularly supposed when it is nearest the earth, May 18, 19 and 20. They argue that the comet will have receded somewhat from the sun so that it will have begun its fading process, and dawn and twilight will interfere with its brightness.

Dr. John R. Hooper, chairman of the astronomical section, says that the coma surrounding the nucleus will appear large and will be high enough in the western sky the last of May to be above the low mist and smoke. He says the comet is now coming toward the earth and will appear above the western horizon May 19 or 20 very rapidly for several days and then appear to move more slowly in a southerly direction. During April and the early part of May, says Dr. Hooper, the comet will appear to move very slowly, and in the last of May it will be visible in this section. During this period, says Dr. Hooper, the comet will appear somewhat stationary.

At the present time, according to Dr. Hooper, the comet is obscured by the sun, behind which it passed March 25, at a distance of 80,000,000 miles from it. In other words, he explains that the comet is at present 160,000,000 miles from the earth.

The following table prepared by Dr. Hooper shows the respective distances of the comet at given dates and the approximate time of the visibility of the comet both morning and evening:

## STATE NEWS.

Newsy Items of Interest Condensed for Busy Readers.

Spencer, April 6.—Extensive preparations have been made for the celebration of Daniel Boone Day at the cave of the noted pioneer on the banks of the Yadkin river, near Spencer, on April 30. It is expected that many thousand visitors will attend the ceremonies on that day.

Raleigh, April 6.—A commission went today from the executive office of Governor Kitchin, to H. H. Granger, Kinston, designating him as a director of the Atlantic and North Carolina Railroad company to succeed his father, the late J. W. Granger.

People who were at Wrigglesville Beach Sunday afternoon tell of a narrow escape from drowning, the victims of a trying experience being Dr. N. A. Culbreth, of this city, and a friend, Mr. G. W. Jordan, of Ebbsville, Ia., who had gone out for a ride in the sound, the boat having swamped with them. Both gentlemen retained their self-possession until persons on shore launched a boat and went to their rescue. The most remarkable incident in connection with the accident is that it is reported that Mr. Jordan, as the result of his experience, was completely restored the power of speech, having been a mute for many years before that time.—Wilmington Star.

From a correspondent the Daily News ascertains that the South Creek section was visited by one of the severest hail storms in years Sunday afternoon, last. The Irish potato vines are beaten almost to pieces. Corn was damaged but not near so much as the potatoes. The correspondent writes that the hail completely covered the ground. Some of the stones were as large as hen eggs.—Washington News.

Rocky Point, N. C., April 5.—Messrs. G. P. Duncan and W. W. Pearsall claim to have discovered an oil well in locating a driven pump at 40 feet depth. The water has quite a distinct oily smell and taste and after exhausting supply two days later more oil is pumped up.

## LOWER STANDARD OF LIVING.

That is the Best Way to Defeat the Present System of High Prices.

There is very little improvement in sight toward lowering the high prices, declares Professor Frank J. Goodnow of Columbia University in The Delinquent for May. When Eastern farms were cultivated at a profit, prices of agricultural commodities were much higher (allowances being made for the then purchasing power of a dollar) than now. And prices will have to go considerably higher than now before those farms can again be profitably cultivated.

It would appear that in the meantime the people will be obliged to adjust themselves to the changed conditions. This will probably involve a lowering of the standard of living, the increase of the rural as compared with the urban population, the development of Eastern agricultural lands and of local markets everywhere throughout the country, and the abandonment of our present expensive system of distribution.

It will inevitably be accompanied by considerable distress, particularly in the cities. The suffering due to this process of adjustment may undoubtedly be somewhat alleviated by energetic action on the part of the government with reference to the violation of laws prohibiting monopoly and restraint of trade, and by the removal at once of all duties on food products.

But, until the adjustment has been made, prices will probably continue to increase, and, after it has been made, will remain higher than they used to be. For it is hardly conceivable that agricultural commodities can permanently be sold at the prices to which the present generation has been accustomed unless some almost revolutionary changes in agricultural methods are made.

## What Prohibition Did.

The disastrous (?) effects of prohibition on a town are strikingly illustrated by the workings of the prohibition law in Wilmington, the leading North Carolina seaport, last year. The law went into effect there January 1, 1909, and perhaps in no other seaport city has it been so well enforced. The results are that the number of arrests in 1909 was only 1,218 as compared with 1,968 with saloons the year before; in spite of increased population, there was a decrease in the number of deaths and cases of insanity; bank deposits showed the remarkable increase from \$7,200,000 to \$9,960,000 for the single twelve months, the increase in bank clearings being greater than for any other leading Southern city except Atlanta (which is also prohibition); the number of building permits and their value more than doubled; and in spite of losing a \$600 license tax on sixty-three saloons each (and voting an extra tax for schools), the total tax rate was reduced 8 cents on the \$100.—Raleigh, (N. C.) Progressive Farmer and Gazette.

German immigrants, the Scotch, the Swedes and the Swiss as a rule, prove good workers and good citizens, and there is no reason why many of these could not be induced to come to the South and take up the farming proposition. Wherever a colony of Germans has been established, for instance, you find effective and productive efforts. Some of these colonies have been remarkably prosperous, while providing a large supply of food products to the country hundreds of miles around.—Birmingham News.

A bill has been introduced in congress providing for the reduction of members' mileage from twenty cents a mile to five cents. We would like to have the honest opinion of the introducer of the bill as to its prospects of passage. We doubt if he even believes he will get a roll call vote on it. It will be defeated, but there will be no record to show who were the members voting against it. The author of the measure will get some credit at home as an advocate of retrenchment at his own cost, and that is all he expects to come of it.—Charlotte Observer.
